3. All licensees have submitted documentation of good standing from the Secretary of the Commonwealth, Department of Revenue, and Department of Unemployment Assistance, if applicable.
4. All licensees have paid the appropriate annual license fee.
5. The licensees, when applicable, have been inspected over the previous year. Commission staff certify that, to the best of our knowledge, no information has been found that would prevent renewal of the licenses mentioned above pursuant to 935 CMR 500.450.

RECOMMENDATION

Commission staff recommend review and decision on the above-mentioned licenses applying for renewal, and if approved, request that the approval be subject to the licensee remaining in compliance with the Commission regulations and applicable law.

1. Apotho Therapeutics Plainville, LLC (#MRR205798) (MR282388)
 - a. Upon renewal, the licensee shall provide Commission staff with a Plan to Positively Impact Disproportionately Harmed People and Diversity Plan that are separated.



2. Curaleaf Massachusetts, Inc. (MRR205808) (MR282183) / (MRR205807) (MR282052)
 - a. Within 90 days, the applicant shall provide to Commission staff, an amended Plan to Positively Impact Disproportionately Harmed People that provides a plan on how the applicant intends to remedy the initial partnership with C3RN as it relates to the \$12,000 in scholarships and to provide clarification if the scholarship will still be available through another partner agency.
3. Ganesh Wellness, Inc. (MRR205819) (MR282740)
 - a. Upon renewal, the licensee shall submit a Plan to Positively Impact Disproportionately Harmed People that provides data from the licensed entity specific to this renewal, once operational.
4. JustinCredible Cultivation, LLC (MCR140043) (MC281313)
 - a. Upon renewal, the licensee shall provide an updated Plan to Positively Impact Disproportionately Harmed People with supporting documentation that clarifies the objective as it relates to the goal.
5. Pure Lowell, Inc. (#MRR205815) (MR282815)
 - a. Within 90 days, the applicant shall submit to Commission staff an update Plan to Positively Impact Disproportionately Harmed Individuals that identifies if the goal to donate \$5,000 to Old Colony in Lowell will apply to this license only or if an additional donation will be made on behalf another license that the licensee is associated with, under the name of Pure Industries, Inc., (MPR243648).
6. Solar Therapeutics, Inc. (#MPR243636) (MP281464) / (MPR205785) (MR282948)
 - a. The applicant shall submit to Commission staff additional clarification regarding the donation to the Forever Paws Animal Shelter, and how the donation correlates to Commission-designated areas and individuals disproportionality impacted by marijuana.
