• Within 90 days please provide a breakdown to the Commission regarding its 66% of staff diversity.



Resinate, Inc. (#MRR205979)

• Within 90 days the licensee should clarify partnership/mentorship initiative on how it relates to the Marijuana Establishment mentioned within the renewal under the Diversity Plan success. The establishment should be concise and clear with its response and edits for clarification and provide the Commission with an update.
