

- 5. The licensees, when applicable, have been inspected over the previous year. Commission staff certify that, to the best of our knowledge, no information has been found that would prevent renewal of the licenses mentioned above pursuant to 935 CMR 500.450.

RECOMMENDATION

Commission staff recommend review and decision on the above-mentioned licenses applying for renewal, and if approved, request that the approval be subject to the licensee remaining in compliance with the Commission regulations and applicable law.

- 1. CTDW LLC (MR281844) (MRR205999)
 - a. Within 90 days, the licensee shall provide an updated Plan to Positively Impact Disproportionately Harmed People that clarifies how a donation to the Salem Sound Coastwatch will promote and encourage full participation in the regulated cannabis industry by individuals from communities disproportionately harmed by cannabis prohibition and enforcement and to positively impact those communities under M.G.L. c. 94G, § 4 in Massachusetts.
- 2. Hudson Botanical Processing, LLC (MP281588) (MPR243750)
 - a. Within 90 days the licensee shall provide an updated Plan to Positively Impact Disproportionately Harmed People, to include their plan for the upcoming year that promotes and encourages full participation in the regulated cannabis industry by individuals from communities disproportionately harmed by cannabis prohibition and enforcement and to positively impact those communities under M.G.L. c. 94G, § 4 in Massachusetts.

- b. Licensee should include an additional goal for their update Plan to Positively Impact Disproportionately Harmed People.
- c. Licensee to clarify who is volunteering from the establishment and provide the frequency of their volunteer time.

3. Z&T Inc (MR283213) (MRR205990)

- a. Within 90 days the licensee shall provide an updated Plan to Positively Impact Disproportionately Harmed People, to include their plan for the upcoming year that promotes and encourages full participation in the regulated cannabis industry by individuals from communities disproportionately harmed by cannabis prohibition and enforcement and to positively impact those communities under M.G.L. c. 94G, § 4 in Massachusetts.
- b. Licensee should include an additional goal for their update Plan to Positively Impact Disproportionately Harmed People besides beach clean-ups, that were not accomplished due to weather conditions.
