# **RECOMMENDATION**

#### Patriot Care Corp. (MC281265)

1. The licensee shall, within 60 days, submit an updated report on the progress or success of their diversity plan.

### Patriot Care Corp. (MP281308)

1. The licensee shall, within 60 days, submit an updated report on the progress or success of their diversity plan.

#### Patriot Care Corp. (MR281282)

- 1. The licensee shall, within 60 days, submit an updated report on the progress or success of their diversity plan;
- 2. The licensee shall, as a co-located medical and adult-use retail Marijuana Establishment, within 60 days, submit the licensee's policies and procedures for ensuring maintenance of a sufficient quantity and variety of marijuana products for patients, consistent with the requirements of 935 CMR 500.140(10); and
- 3. The licensee shall, as a co-located medical and adult-use retail Marijuana Establishment, within 60 days, provide the licensee's policies and procedures for determining what qualifies as a reasonable substitution for a marijuana product under 935 CMR 500.140 (10).

#### Patriot Care Corp. (MR281283)

- 1. The licensee shall, within 60 days, submit an updated report on the progress or success of their diversity plan;
- 2. The licensee shall, as a co-located medical and adult-use retail Marijuana Establishment, within 60 days, submit the licensee's policies and procedures for ensuring maintenance of a sufficient quantity and variety of marijuana products for patients, consistent with the requirements of 935 CMR 500.140(10); and

3. The licensee shall, as a co-located medical and adult-use retail Marijuana Establishment, within 60 days, provide the licensee's policies and procedures for determining what qualifies as a reasonable substitution for a marijuana product under 935 CMR 500.140 (10).

# CDX Analytics, LLC (IL281275)

1. The licensee shall, within 60 days, submit an updated report on the progress or success of their positive impact and diversity plan. The current documentation provided illustrates actions that will be taken in the future. A report is required to illustrate actions that have been taken to date.

### Northeast Alternatives, Inc. (MC281319)

1. Commission staff shall undertake an investigation and make a determination on the licensee's continued suitability for licensure.

### Northeast Alternatives, Inc. (MP281319)

1. Commission staff shall undertake an investigation and make a determination on the licensee's continued suitability for licensure.

### Alternative Therapies Group (MR281344)

1. The licensee shall, within 60 days, provide to the Commission a description of its practices on employee's self-identifying for the purposes of showing progress or success towards its Diversity Plan.
