 - No other entity appears to have ownership or control over this proposed Marijuana Establishment.
- 5. The applicant executed a Host Community Agreement with Uxbridge (Cultivation and Product Manufacturing) on May 15, 2019. Additionally, the applicant executed a Host Community Agreement with Framingham (Retail) on June 13, 2019.
- 6. The applicant conducted a community outreach meeting on April 29, 2019 (Uxbridge Cultivation and Product Manufacturing). Additionally, the applicant conducted a community outreach meeting on August 16, 2019 (Framingham Retail) and provided documentation demonstrating compliance with Commission regulations.
- 7. The Commission received a municipal response from Uxbridge (Cultivation and Product Manufacturing) on June 8, 2020 stating the applicant was in compliance with all local ordinances and bylaws. Additionally, The Commission sent the municipal notice to the City/Town of Framingham on June 4, 2020. To date, the Commission has not received a response.
- 8. The applicant proposed the following goals for its Positive Impact Plan:

1	Cultivate Holdings will host two (2) networking events through the "Cultivate
	Launch Program" which will benefit past or present residents of areas of
	disproportionate impact; Massachusetts residents who have past drug
	convictions; and Commission-designated Economic Empowerment Priority
	Applicants by providing a select number of participants with exclusive
	access to the company's training programs. During the first year, five (5)
	participants will be recruited. Programs will include an employee training
	program, manager training program, hands on training as a responsible
	vendor, methods of production and information of the various strains (and
	effects) of cannabis.
2	One (1) day monthly, Cultivate Holdings will donate 10% of the company's
	gross sales to charities that provide services to past or present residents of
	areas of disproportionate impact or, who help Massachusetts residents with
	past drug convictions. Charities may include One Life at a Time, Community
	Servings Food Heals and One Mission, Project New Hope, Cultivate Care
	Farms and Project Place.

SUITABILITY REVIEW

9. There were disclosures of past civil or criminal actions, occupational license issues, or marijuana-related business interests in other jurisdictions. None of the disclosures raised suitability issues.



10. There were no concerns arising from background checks on the individuals or entities associated with the application.

MANAGEMENT AND OPERATIONS REVIEW

- 11. The applicant states that it can be operational upon receipt of provisional licensure.
- 12. The applicant's proposed hours of operation are the following:

Monday – Sunday: 6:30 a.m. – 4:30 p.m. (Cultivation and Product Manufacturing) Monday – Sunday: 10:00 a.m. – 8:00 p.m. (Retail)

- 13. The applicant submitted all applicable and required summaries of procedures for the operation of the proposed Medical Marijuana Treatment Center. The summaries were determined to be substantially compliant with the Commission's regulations.
- 14. The applicant disclosed that it plans to perform home deliveries to registered patients. The summary of the applicant's plan is consistent with the Commission regulations and guidance documents.
- 15. The applicant proposed the following goals for its Diversity Plan:

1	Give hiring preference to individuals identifying as minorities, women, veterans
	and/or people with disabilities. Cultivate Holdings seeks to comprise their
	workforce of at least 40% of individuals falling in the above listed
	demographics.
2	Mandatory Sensitivity Training which will require all employees to complete
	this training within ninety (90) days of hire, and once annually thereafter.

16. Summary of cultivation plan:

The applicant submitted a summary of a cultivation plan that demonstrated the ability to comply with the regulations of the Commission.

RECOMMENDATION

Commission staff recommend provisional licensure with the following conditions:

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations;
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws and local codes, ordinances, and bylaws;
- 3. Final licensure is subject to the applicant providing Commission staff, upon inspection, with an updated Positive Impact Plan that specifies the cohort the licensee seeks to impact, provide clarification as to why the licensee intends to reach out to Boston City Councillors when facilities are located in Central Massachusetts, and provide clarification on how donations to the Leukemia & Lymphoma Society, Chrons & Colitis Foundation, One Mission, Project Place, and Home base will directly impact the specific cohorts;
- 4. Final licensure is subject to the applicant providing Commission staff, upon inspection, with a detailed list of all proposed products to be produced with specific information as to types, forms, shapes, colors, and flavors;
- 5. Final licensure is subject to the applicant updating its Security Plan and Standard Operating Procedures to ensure full compliance with 935 CMR 501.110(9) as it pertains to notification to the Commission and local law enforcement regarding inventory discrepancies;
- 6. The applicant shall cooperate with and provide information to Commission staff; and
- 7. Provisional licensure is subject to the payment of the appropriate license fee.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
