 - The Chairman recognized a quorum and called the meeting to order.
 - The Chairman gave notice that the meeting is being recorded.
- 2) Chairman's Comments and Updates
 - The Chairman gave an overview of the Senate Ways and Means budget as it relates to the Commission and thanked the Senators for their support and confidence in the Commission.
 - The Chairman also thanked the Joint Committee on Cannabis Policy for hearing the Commission on its concerns relating to Host Community Agreements.
 - The Chairman gave an overview of the agenda.

- 4) Executive Director's Report 00:06:33
 - The Executive Director gave an overview of license data, located on <u>page 171 of the Meeting packet</u>.
 - The Chairman noted with respect to patient registration, the number of patients has leveled off, compared with the spike seen initially when adult-use operations were closed in the early part of the Pandemic and asked whether that was a reasonable conclusion.
 - The Executive Director said that was correct and it would be telling to see how many of those patients seek to renew their patient registration.
 - O Commissioner Concepcion asked with respect to the 880 applications that the Commission has considered, whether all those would be deemed "active" licenses and all other applications listed in the slide would be non-active.
 - The Executive Director clarified that those 880 total applications considered by the Commission, whether approved or denied and includes



pre-certification, the latter being a process specific to the Marijuana Courier license type.

- Commissioner Camargo asked a clarifying question regarding the total number of Social Equity Program applications as the numbers differed on the licensing slides.
 - The Executive Director apologized for the typo and clarified that he will confirm the correct figure for the Social Equity Program applications.
- The Chairman with respect to the 7 pending Marijuana Research Facility applications.
 - The Executive Director confirmed that these license types are pending and on hold awaiting the adjustment in the application within the licensing portal, which was brought on by the regulatory change.
- The Executive Director gave a hiring update with respect to the Director of Equity Programming and Community Outreach, Chief Technology and Innovation Officer, Investigators, and Licensing Specialist. The Executive Director announced new positions being posted including: Receptionist/Office Manager, Executive Assistant, Project Coordinator, Community Outreach. The Executive Director also announced the hiring of Tara Smith as Press Secretary.
 - o The Chairman asked a clarifying question regarding the volume of applicants for both the Investigators and Licensing Specialists' positions.
 - The Executive Director estimated that the Commission received anywhere from 200 to 250 applications for the Investigator positions and around 100 applications for the Licensing Specialist positions.
 - o Commissioner Camargo asked a clarifying question regarding the closing date for both the Receptionist/Office Manager and Executive Assistant(s) positions.
 - The Executive Director clarified that the Receptionist/Office Manager position closes on May 14th, and the Executive Assistant(s) position closes on May 17th.
 - Commissioner Concepcion asked a clarifying question about the two Executive Assistant positions, noting that they were both advertised in one post and both positions would be filled from the responses to that single post.

- Commissioner Camargo followed up that she had received information with respect to the previous question she had asked about Social Equity Program license applicants, noting that the difference in the slides represents 4 precertification applications which fit the category of the first slide, but not the second, and thus the difference.

- The Chairman recognized Commissioner Camargo for her work taking a deep dive into Renewals, working with licensing staff.
- Commissioner Camargo thanked the licensing staff for helping her learn the process for renewal, in particular with respect to Diversity Plans and Positive Impact Plans. For licensees, Commissioner Camargo wanted to stress that Diversity Plans and Positive Impact plans should receive the same attention and energy as operational plans. Commissioner Camargo noted a trend that as renewal approaches, it seems licensees are scrambling to act on their Diversity and Positive Impact plans. Commissioner Camargo echoed the quote "with great power comes great responsibility" and stated that owners of cannabis businesses are in a position of power and therefore, along with the Commission under its statutory mandate, have a responsibility to the individuals and communities disproportionately impacted by cannabis prohibition, and therefore these plans should not be approached as simply checking a box.



- Commissioner Stebbins echoed the sentiments of Commissioner Camargo and said that it will be interesting to see the additional progress that folks will make as their renewals come up, especially considering Covid 19.
- The Chairman noted that Renewals will be considered as one or more rosters, subject to a Commissioner's request for individual treatment.
