- 7. The applicant and municipality executed a Host Community Agreement on December 1, 2022.
- 8. The applicant conducted a community outreach meeting on January 9, 2023, and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission received a municipal response from the City of Boston on February 22, 2023, stating the applicant was in compliance with all local ordinances or bylaws.

RECOMMENDATION

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations.
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws, local codes, ordinances or bylaws, and local licensing requirements.
- 3. The applicant shall cooperate with and provide information to Commission staff.
- 4. Provisional licensure is subject to the payment of the appropriate license fee.
- 5. Prior to final licensure, in accordance with 935 CMR 500.140 (6)(g) please include information for substance use disorder treatment programs and the phone number for the Massachusetts Substance Use Helpline on your consumer education.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
