- 7. The applicant and municipality executed a Host Community Agreement on January 7, 2019.
- 8. The applicant conducted a community outreach meeting on September 30, 2019 and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission sent the municipal notice to the City/Town of Freetown on August 13, 2020. To date, the Commission has not received a response.
- 10. The applicant proposed the following goals for its Positive Impact Plan:

#	Goal
1	Provide mentoring for individuals facing systemic barriers within the target
	communities. Specifically, Fall River and New Bedford. AmeriCann Brands
	will develop specific initiatives to mentor and teach individuals from the
	target communities about technical aspects of cannabis cultivation and
	manufacturing. Additionally, AmeriCann Brands will mentor local residents
	from target communities around employment opportunities and entry into the
	cannabis market. This program will include one (1) half-day workshop and
	two (2) evening training sessions.
2	Give hiring reference to further reduce barriers to entry in the cannabis
	market. AmeriCann seeks to comprise its staff of 20% of employees being
	past or present residents of Fall River or New Bedford.

#### **RECOMMENDATION**

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations;
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws and local codes, ordinances, and bylaws;
- 3. Final licensure is subject to the applicant providing Commission staff, upon inspection, with a detailed list of all proposed products to be produced with specific information as to types, forms, shapes, colors, and flavors;
- 4. Final licensure is subject to the applicant ensuring that all remaining required individuals be fingerprinted pursuant to previous Commission notifications;
- 5. The applicant shall cooperate with and provide information to Commission staff; and
- 6. Provisional licensure is subject to the payment of the appropriate license fee.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
