- 8. The applicant conducted a community outreach meeting on December 6, 2022, and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission received a municipal response from the Town of Palmer of on February 21, 2023, stating the applicant was in compliance with all local ordinances or bylaws.
- 10. The applicant proposed the following goals for its Plan to Positively Impact Disproportionately Harmed People:

- 5. Prior to Final Licensure, review Positive Impact Plan and consider strategies for programming in nearby Areas of Disproportionate Impact designated communities of Monson, Amherst and Holyoke and provide any update in accordance with 935 Code Mass. Regs. § 500.101(1)(a)11.
- 6. Prior to final licensure, in accordance with 935 CMR 500.140 (6) please include the phone number for the Massachusetts Substance Use Helpline on your consumer education.
