Provisional License Executive Summary 1



The MTC business will be co-located with the adult-use business in Worcester. The MTC has a Final Certificate of Registration for dispensing, cultivating, and processing.

7. The applicant and municipality executed a Host Community Agreement on September 28, 2018.
8. The applicant conducted a community outreach meeting on April 24, 2018 and provided documentation demonstrating compliance with Commission regulations.
9. The Commission received a municipal response from the municipality on May 2, 2019 stating the applicant was in compliance with all local ordinances and bylaws.
10. The applicant proposed the following programs for its Positive Impact Plan:
 - a. Conduct at least two (2) industry-specific educational/recruitment seminars annually;
 - b. Institute hiring practices that prioritize the hiring of individuals from Worcester and Boston; and
 - c. Host quarterly in-store donation drives, including direct giving and ongoing food, toiletries and clothing drives to benefit charities.

SUITABILITY REVIEW

11. There were no concerns arising from background checks on the individuals or entities associated with the application.
12. There were disclosures of any past civil or criminal actions, occupational license issues, or marijuana-related business interests in other jurisdictions. None of the disclosures raised suitability issues.

MANAGEMENT AND OPERATIONS REVIEW

13. The applicant states that it can be operational within two (2) months of receiving its provisional license.
14. The applicant's proposed hours of operation are the following:

Monday – Sunday: 10:00 a.m. – 7:00 p.m.
15. The applicant submitted all applicable and required summaries of plans, policies, and procedures for the operation of the proposed establishment. The summaries were determined to be substantially compliant with the Commission's regulations.



16. The applicant proposed the following programs for its Diversity Plan:

- a. Participate in career fairs in underrepresented and minority communities two (2) times annually;
- b. Provide cultural training on cultural sensitivity and recognizing unconscious bias at least once per year; and
- c. Utilize suppliers who are committed to diversity and inclusion.

17. Summary of cultivation plan (if applicable):

The applicant submitted a detailed cultivation plan that demonstrated the ability to comply with the Commission's regulations.

18. Summary of products to be produced and/or sold (if applicable):

- a. Flower;
- b. Pre-rolls;
- c. Vape cartridges;
- d. Wax;
- e. Oil;
- f. Oral tincture;
- g. Tropical salve;
- h. Mints; and
- i. Capsules

19. Plan for obtaining marijuana or marijuana products (if applicable):

The applicant is a vertically integrated MTC that has also applied for adult-use licenses for cultivation and product manufacturing operations. The applicant plans to obtain marijuana from its affiliated licenses. If the need arises, it will contract with other licensed establishments for additional product.

20. ISO 17025 Certifying Body and Certificate Number (if applicable):

Not applicable.

RECOMMENDATION

Commission staff recommend provisional licensure with the following conditions:

1. Final license is subject to inspection to ascertain compliance with Commission regulations;
2. Final license is subject to inspection to ascertain compliance with applicable state laws and local codes, ordinances, and bylaws;
3. The applicant shall cooperate with and provide information to Commission staff;
4. Provisional licensure is subject to the payment of the appropriate license fee; and



5. Final license is subject to the applicant amending its Positive Impact Plan to provide more specific information on the bullet point within the plan: “[o]ffering assistance to individuals coming from areas of disproportionate impact.” This amended plan shall be provided to Commission staff upon inspection.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
