- 7. The applicant and municipality executed a Host Community Agreement on October 28, 2019.
- 8. The applicant conducted a community outreach meeting on October 29, 2019 and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission received a municipal response from the municipality on July 8, 2020 stating the applicant was in compliance with all local ordinances or bylaws.

- 13. The applicant states that it can be operational within six (6) months of receiving the provisional license(s).

- 15. The applicant submitted all applicable and required summaries of plans, policies, and procedures for the operation of the proposed establishment. The summaries were determined to be substantially compliant with the Commission's regulations.

17. Plan for obtaining marijuana or marijuana products (if applicable):

MME Newton Retail, LLC will obtain marijuana and marijuana products from cultivators and product manufacturers selling wholesale and duly licensed by the CCC under 935 CMR 500.000.

### **RECOMMENDATION**

Commission staff recommend provisional licensure with the following conditions:

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations;
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws and local codes, ordinances, and bylaws;
- **3**. Final licensure is subject to the applicant ensuring that all remaining required individuals be fingerprinted pursuant to previous Commission notifications;
- 4. Final licensure is subject to the applicant submitting a statement, upon inspection, from company leadership responding to a pattern of allegations of misconduct and steps the company will take toward preventing that pattern from continuing in Massachusetts;
- 5. The applicant shall cooperate with and provide information to Commission staff; and
- 6. Provisional licensure is subject to the payment of the appropriate license fee.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
