RECOMMENDATION

Commission staff recommend provisional licensure with the following conditions:

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations.
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws, local codes, ordinances or bylaws, and local licensing requirements.
- 3. Final licensure is subject to the applicant providing Commission staff, upon inspection, with a detailed list of all proposed products to be produced with specific information as to types, forms, shapes, colors, and flavors.
- 4. Final licensure is subject to the applicant ensuring that all remaining required individuals be fingerprinted pursuant to previous Commission notifications.
- 5. The applicant shall cooperate with and provide information to Commission staff.
- 6. Provisional licensure is subject to the payment of the appropriate license fee.
- 7. Final license is subject to the applicant providing clarification to CCC Licensing staff whether the Plan to Positively Impact Disproportionately Harmed People referenced educational sessions require an admittance fee and if educational sessions are related to recruiting potential employees.
- 8. Final License is subject to the applicant providing the Commission with a strategy for outreach to residents of the nearby Disproportionately Impacted designated community of Lowell for employment and provide updates to the Commission as appropriate.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
