5. List of all required entities and their roles in the Marijuana Establishment:

CSAC Acquisition, Inc. — Owner of Sira Naturals, Inc.

CSAC Holdings, Inc. — Holder of 100% of the voting control and majority ownership in CSAC Acquisition, Inc.

Cannabis Strategies Acquisition Corp. (CSAC) — Holder of 100% of the control and equity of CSAC Holdings, Inc.

Mercer Park CB, L.P. — Holder of 10% of CSAC ownership and 63% of CSAC voting interest.

Mercer Park CB GP, LLC — Sole general partner of Mercer Park CB, L.P.

6. Applicant's priority status and information pertaining to co-located operations:

MTC Priority (RP201855)

MTC has Final Certificate of Registration for dispensing, cultivation and processing. This adult-use establishment will not be co-located with an MTC.

- 7. The applicant and municipality executed a Host Community Agreement on September 10, 2018.
- 8. The applicant conducted a community outreach meeting on October 4, 2018 and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission received a municipal response from the municipality on April 17, 2019 stating the applicant was in compliance with all local ordinances and bylaws.
- 10. The applicant proposed the following programs for its Positive Impact Plan:
 - a. Give priority status to Social Equity and Economic Empowerment participants in the Sira Accelerator program, which is a small business advisory program.

SUITABILITY REVIEW

- 11. There were no concerns arising from background checks on the individuals or entities associated with the application.
- 12. There were no disclosures of any past civil or criminal actions, occupational license issues, or marijuana-related business interests in other jurisdictions.



MANAGEMENT AND OPERATIONS REVIEW

- 13. The applicant states that it can be operational within four (4) months of receiving its provisional license.
- 14. The applicant's proposed hours of operation are the following:

Monday – Sunday: 24 hours per day

- 15. The applicant submitted all applicable and required summaries of plans, policies, and procedures for the operation of the proposed establishment. The summaries were determined to be substantially compliant with the Commission's regulations.
- 16. The applicant proposed the following programs for its Diversity Plan:
 - a. Recruit a diverse workforce; and
 - b. Implement retention strategies through the utilization of education, training, and counseling.
- 17. Summary of cultivation plan (if applicable):

The applicant submitted a detailed cultivation plan that demonstrated the ability to comply with the Commission's regulations.

RECOMMENDATION

Commission staff recommend provisional licensure with the following conditions:

- 1. Final license is subject to inspection to ascertain compliance with Commission regulations;
- 2. Final license is subject to inspection to ascertain compliance with applicable state laws and local codes, ordinances, and bylaws;
- 3. The applicant shall cooperate with and provide information to Commission staff;
- 4. Provisional licensure is subject to the payment of the appropriate license fee; and



5. Final license is subject to the applicant providing Commission staff with demonstrable proof of compliance with all advertising regulations contained within 935 CMR 500.000 as they apply generally to the establishment and to any program instituted by the licensee.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
