Three Public Listening Sessions

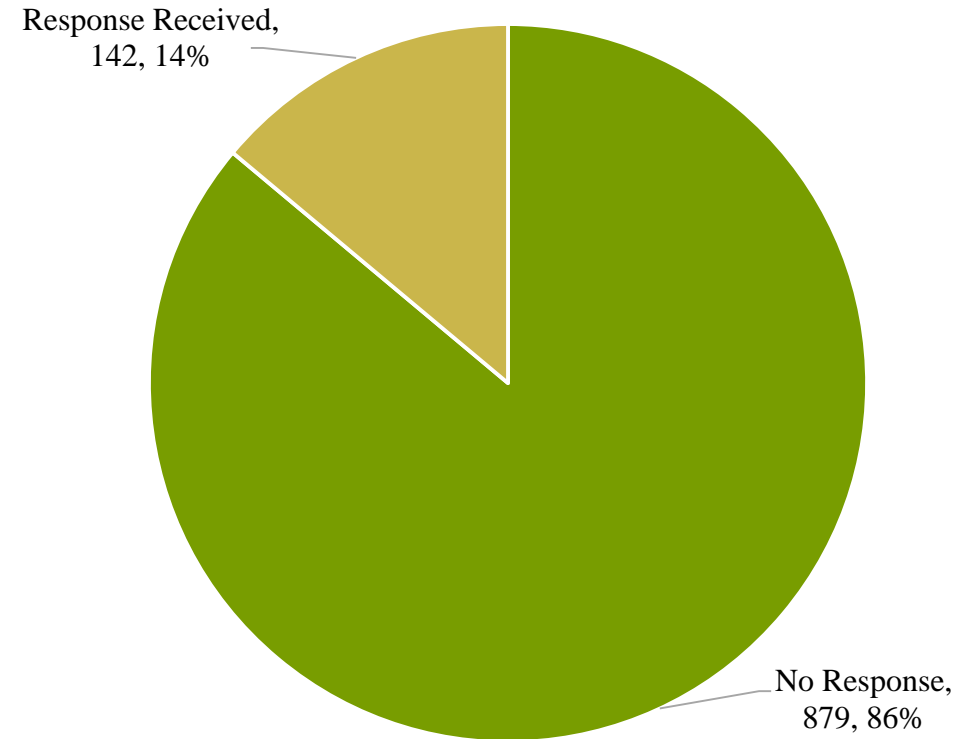
