PUBLIC MEETING MINUTES

- 1) Call to Order
 - The Chairman recognized a quorum and called the meeting to order.
 - The Chairman gave notice that the meeting is being recorded.
- 2) Chairman's Comments and Updates
 - The Chairman gave an overview of the agenda and the format for the agenda.
 - The Chairman thanked staff, in particular Deputy General Counsel Pauline Nguyen for work preparing these recommended changes and meeting documents.
- 3) Commission Discussion and Votes 8:48
 - a) Topic: Greenhouse Definition 8:50
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.
 - b) Topic: Fingerprint Checks 9:09
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments
 - c) Topic: Equity Ownership Threshold for SEP Participants to Receive License-related Benefits 9:50
 - The Chairman gave an overview of the topic.
 - Commissioner McBride asked about the definition of Small Business, and suggested striking the words "initial or," given that without a license there would be no revenue to use for this measurement.
 - Commissioner Title accepted that change.
 - The Chairman noted that \$15 million might not actually be a small business and in other contexts might be a midsize business.



- Commissioner Title noted that the definition was borrowed from OSD Regulations on small business procurement program, but she would be open to making it smaller.
- The Chairman said that he would go down to \$10 or \$5 million.
- Commissioner Title suggested \$5 million.
- Commissioners McBride and Flanagan both agreed with Commissioner Title's suggestion.
- The Executive Director noted that there might be some forecasting, similar to the concerns about not having revenue, that the OSD certification won't apply until the business is operating.
- The Chairman noted that these were good points and should be subject to public comment.
- d) Topic: Social Equity Program 15:46
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comment.
- e) Topic: Diversity Plans 16:19
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.
- f) Topic: Delivery Licenses and Delivery Endorsements 16:43
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.

 - The Executive Director noted that as a matter of process, upon promulgation of the regulations, the Executive Director will ask the Commission to vote to renew previous delegations and to affirm those spelled out in the regulations.
 - The Chairman asked that such a vote include what the reporting requirements pursuant to those delegations would be.
- j) Topic: Receivership 5221:50



- Commissioner McBride had some questions about how these provisions would play out, in particular, what the Commission is envisioning the role of the receiver to be and what the Commission's role is with respect to receivers.
 - General Counsel Baily gave an overview of the envisioned process and role of the Commission and the necessity of a Receiver to follow the Commissions regulations and laws.
 - The Chairman added additional context with respect to the unavailability of Bankruptcy Courts and the essence of time when circumstances of receivership arise.
- Commissioner McBride expressed her concerns around the court appointed nature of a Receiver. Commissioner McBride ask that the Commission look closely at this section and make sure it is consistent with the process for receivership under current law.
 - O General Counsel Baily said that she can, in coordination with Executive Director, work with stakeholders to ensure these provisions are what the Commission needs and will follow up with a legal opinion.
- k) Topic: Craft Marijuana Cooperatives –29:50
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comment.
- 1) Topic: Marijuana Research Facility License and Research Permit 30:26
 - Thee Chairman gave an overview of the topic.

 - For medical add "to specifically support patients"
 - For adult "people disproportionately harmed by prohibition."



- Commissioner Flanagan suggested including areas of disproportionate impact in addition to disproportionately impacted people.
- Commissioner Title accepted this suggestion.
- General Counsel Baily clarified that on the patient side, it should be patients and caregivers.
- p) Topic: Priority Review and Expedited Review 39:39
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.
- q) Topic: Social Consumption/Delivery Application Requirements 40:36
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.
- r) Topic: Delivery: 41:15
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comment.
- s) Topic: Responsible Vendor Training 43:34
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.
- t) Topic: Personnel Policy Code of Ethics and Whistleblower Policy 44:15
 - The Chairman gave an overview of the topic.
 - The Commissioners had no comments.
- u) Topic: Workplace Safety 45:20

 - Commissioner McBride said she would like to see a definition of "Impassable Barrier."
 - Commissioner Title said that that the intent was a barrier that blocks pedestrian travel but is open to adding a definition.
 - Commissioner Flanagan suggested contacting the Department of Transportation to see if they have a type of definition for this type.
 - The Chairman welcomed public comment on this topic and indicated the buffer zone provisions may modified in the final regulations.
- z) Topic: Advertising, Marketing and Branding 49:55
 - The Chairman gave an overview of the topic.
 - Commissioner McBride said she would like to add a provision requiring that any Marijuana Establishment participating in brand name sponsorship retain data on audience composition that the Marijuana Establishment relied on to determine that it complied with regulatory requirements. Commissioner McBride offered language for this change.
 - Commissioner Flanagan asked whether the composition data is currently inspected as part of investigations/enforcement.
 - Commissioner McBride said she does not know that that is the case, and given the changes of the provisions, it is important to make it clear and set a minimum retention time frame.
 - The Executive Director clarified that the Commission would have access to audience composition data if investigators asked for it, but the Commission does not review it in the ordinary course.

hh) Topic: Sampling of Product – 1:01:55

- The Chairman gave an overview of the topic.
- The Commissioners had no comment.

ii) Topic: Product Shape and Color – 1:02:50

- The Chairman gave an overview of the topic.
- Commissioner McBride raised concerns about individual wrapping rather than stamping, and there are some questions about providing the appropriate alert with respect to the product's contents. She wants to raise this concern for public comment.
- Commissioner Flanagan expressed that she shared Commissioner McBride's concern but noted that some products are so small that printing a stamp might not have the desired effect.
- Commissioner McBride appreciated the context and asked that this be considered in coordination with the product database considerations and the inclusion of edibles in the product database as those are phased in.
- The Executive Director noted that it makes sense to consider these requirements in conjunction with the product database. With respect to those small items that Commissioner Flanagan mentioned, in the product database we would want to see the image of the wrapper and the individual item out of the wrapper so that the items can be identified in either form.

jj) Topic: Product Database – 1:08:10

- The Chairman gave an overview of the topic.
- Commissioner Flanagan expressed that she would prefer that the Product Database be mandatory rather than optional.
- Commissioner McBride clarified that using the database is required, but the packaging preapproval is the optional aspect of this in order to avoid operational bottlenecks.

- The Commissioners had no comments.

11) Topic: Contactless Ordering – 1:11:30

- The Chairman gave an overview of the topic.
- The Commissioners had no comment.

mm) Topic: Testing – 1:12:10

- The Chairman gave an overview of the topic.
- Commissioner Title asked with respect to the testing for heavy metal, whether there is a time frame prior to sale when the testing would need to be completed.
- Commissioner McBride said the idea was prior to it appearing on a shelf.
- Commissioner Title clarified that her question was with respect how recent before going on the shelf the testing would have to occur.
- Commissioner McBride noted that no such specific time frame was proposed because they couldn't land on the right time frame and therefore, public comment would be very helpful in this context. There is also a sub regulatory protocol that really fleshes out what is included in the vaporizer and testing regulations. Narrowing down that time frame would be appropriate for that document.
- The Executive Director noted that there is a holistic approach to the testing regulations and the protocol or guidance breathe life into the regulations, so it is helpful to consider them in conjunction. The Executive Director also noted that all testing is valid for one year and the Commission requires retesting after that, but also acknowledged Commissioner Title's point with respect to potential leeching of heavy metals for into products through the associated devices.

nn) Topic: Patient Certification and Registration – 1:20:45

- The Chairman gave an overview of the topic.
- Commissioner Flanagan asked whether the Commission will determine which Hardships will be allowed to go to a biannual certification.
- Commissioner Title noted that the only biannual certifications are social security, disability insurance or supplemental income, or if a Certifying Healthcare Provider diagnoses a patient after an in person visit with a Terminal Illness or Permanent Disability and certifies the patient for two years.
- Commissioner Flanagan asked with respect to the addition of telehealth to the certification process, whether there will still be required a single in person visit per year.
- Commissioner Title suggested that the regulations be revised so that the initial certification had to be in person.
- The Chairman asked the Executive Director to summarize the current telehealth options under the administrative order relating to COVID-19.
- The Executive Director noted that during the public health emergency telehealth is allowed, provided that prior to renewal there is an in-person visit.



- Commissioner Flanagan said she wants new patients to have an in person meeting with doctor, but telehealth is alright once the relationship is established.
- Commissioner Title said she thought was reasonable and noted that there would need to be revision to the proposed language to accommodate this approach.
- Commissioner McBride agreed with the approach.

oo) Topic: Personal Caregivers, Hardship Cultivation – 1:29:00

- The Chairman gave an overview of the topic.
- Commissioner Flanagan said that she is concerned that 1 Caregiver may be overwhelmed by being connected with 10 patients.
- Commissioner Flanagan said that she is concerned about removing the residency requirement for patients, except for those who come to Massachusetts for end of life care. Given the number of states that now have medical marijuana, the need to remove a residency requirement may be moot.
- Commissioner Title said that both of Commissioner Flanagan's comments makes sense and get at what was intended by the provisions and anticipates strong public comment.
- Commissioner Title suggested limiting out of state patients to those receiving end of life care and cancer treatment in Massachusetts.
- Commissioner Flanagan said there may be other illnesses that would be left out in naming specific illnesses.
- Commissioner McBride noted the importance of public comment on this topic.
- Commissioner Title noted that a physician had specifically mentioned cancer patients in recommending this possibility.
- The Chairman suggested that the draft will include "end of life" and "cancer" in order to solicit public comment.
- Commissioner McBride commented, with respect to the caregiver ratio, the draft
 included allowance for a 500 square foot canopy. Commissioners McBride asked about
 the operational implications of maintaining such a canopy, such as inspections and
 municipal authority. Commissioner McBride also expressed her interest in public
 comment on this topic.
- Commissioner Title said that the canopy size was based on Maine's limits, but agrees that the Commission may want to flesh out some of the requirements, in particular with respect to fire safety and record keeping. Commissioner Title said that the Commission needs to strike a balance between not wanting to put too much on a caregiver relative to a commercial cultivator while also making sure any sort of cultivation is done responsibly.
- The Chairman recommended that the regulations go forward as written but could be reconsidered after receiving public comment.
- Commissioner McBride wanted to make sure that this topic gets internal comment at the Commission in addition to public comment to address some of her questions on this.
- Commissioner McBride asked with respect to the definitions of immature plant and vegetative plan in the regulations how establishing those definitions is congruent with the statutory definition of "Marijuana."



- Commissioner Title said that they were trying to ensure there was a standard that lay people could understand while remaining consistent with the statutory definition. Staff helped use current definitions to delineate between categories of plants.
- Commissioner McBride said that she sees the utility in providing additional definition around these topics to help prevent misinformed law enforcement interactions and other issues surrounding a home grow.
- Commissioner Title said that the goal was to have clear categories that folks could rely on, relying on existing definitions as a starting point and expand on them after public comment.
- The Executive Director commented on what implementation would look like for out state registrations, noting that it can be fleshed out further on during comment period. The new patient portal has certain functions to allow automation and allowing out of state patients would require manual registration verification and the ability to timely and accurately provide information and materials.

pp) Topic: Home Delivery – 1:54:40

- The Chairman gave an overview of the topic.
- The Commissioners had no comments.

The Commission took a 30 minute Break.

- qq) Topic: Definitions 2:29:40
 - The Chairman gave an overview of the topic and read through the new or revised definitions.
 - The Commissioners had no comments.

rr) Topic: Colocated Regulations

- The Chairman gave an overview of the topic.
- The Commissioners had no comments.

ss) Additional issues.

- Commissioner McBride asked whether there was consideration with respect to vertical integration and removing that requirement for MTCs.
 - The Chairman gave an overview of the options that came out of Commissioner Doyle's writing group.
 - o General Counsel Baily gave an overview of her legal opinion on the options.
 - Commissioner McBride asked about the option to allow for endorsement without a statutory change.
 - o General Counsel Baily did not think that this was a feasible option because it would not be consistent with the statutory limitations on license ownership.
 - o Commissioner McBride disagreed with that reading of the provisions and anticipates public comment on this issue.



- Commissioner Title raised the idea of delivery applicants sharing space to find efficiencies.
- Commissioner Title also reiterated her support for delivery licensees having the ability to wholesale and warehousing.
- Approving the regulations.
 - Commissioner McBride moved to approve the three sets of draft regulations and changes made as a result of the Commission's deliberations and for the regulations to be finalized and filed with the Secretary of the Commonwealth's Regulations and Publication Division, including 935 CMR 500.000: Adult Use of Marijuana, 935 CMR 501.000: Medical Use of Marijuana, and 935 CMR 502.000: Colocated Adult-Use and Medical-Use Marijuana Operations.
 - o Commissioner Flanagan seconded the motion.
 - o The Commission unanimously approved the motion.
- Delegation to staff.
 - Commissioner Title moved to allow the Executive Director and his delegees to finalize the regulations, make further changes consistent with the Commissions deliberations and votes, the Commission's governing laws, and the Regulations Division's requirements, and any additional changes necessary to file the draft regulations with the regulations division, to provide notice and seek public comment on the draft regulations, and to eventually make recommendations to the Commission on final regulations.
 - o Commissioner Flanagan seconded the motion.
 - The Commission unanimously approved the motion.

- The Chairman gave an overview of the remainder of the regulatory review process.
- The next meeting will be August 6, 2020.

1) Call to Order

- The Chairman recognized a quorum and called the meeting to order.
- The Chairman gave notice that the meeting is being recorded.
- The Chairman thanked the staff for their work getting the meeting set up.
- 2) Chairman's Comments and Updates



- The Chairman thanked the Treasure for advocating for the SAFE Banking Act, which impacts a lot of the Commission's operations.
- The Chairman gave an overview of the agenda.
- The Chairman noted that the Commission will go into executive session at the end of the meeting and adjourn from executive session.

3) Minutes for Approval – 5:00

- April 9, 2020
 - o Commissioner Title asked for a change.
 - Commissioner Title commented that going back to October 2018 she had been collecting and reviewing Host Community Agreements (HCAs) and abstained from votes in which she felt the associated HCA went beyond the law. Commissioner Title said she will no longer continue that practice for the sake of time. Commissioner Title thanked her Commissioners, legislators, and various stakeholders who have pushed for the requisite change.
 - Commissioner Title moved to approve the minutes subject to the change requested by Commissioner Title.
 - o Commissioner McBride seconded the motion.
 - The Commission unanimously approved the minutes subject to the change requested by Commissioner Title.
- June 4, 2020
 - o Commissioner Flanagan moved to approve the minutes.
 - o Commissioner Title seconded the motion.
 - The Commission unanimously approved the minutes.

4) Executive Director's Report – 8:15

- a. Licensing Highlights 8:15
 - The Executive Director indicated that the full licensing data is in the meeting packet.
 - o 10 licenses awaiting initial review in the cue.
 - o The longest licensees have waited is 29 days, well below the 60 day goal.
- The Commission has received 25 applications for delivery precertification, 16 of which have been reviewed and approved.
- The Executive Director highlighted that these are only available to EEAs and SEP participants, so will receive priority or expedited review.
- 82,201 certified active patients, which is a continued uptick.
- The Chairman suggested that with some frequency, the Commission start going through the full data overview. The Chairman also highlighted some good news found in that information for this meeting.
 - Chairman shared that between all the Provisional and Final Licenses, the Commission has issued 477 licenses.
 - o This meeting will likely put the Commission over 500 licenses.



 The Chairman noted that some applications, including disadvantaged business enterprises (DBE) and laboratories, that were previously underrepresented are starting to fill up.

b. Budget Update

- The Executive Director said there is not much to report at this time, which is the report in and of itself.
- Given the significant revenue shortfall resulting from the COVID-19 related economic downturn, Massachusetts, like many states, is struggling to complete their budget.
- The Commission's total budget was \$14.2 million. The coming year will be done on a month to month basis based on previous year (called 1/12th budget). The Commission had asked for a budget increase, but the Commission will have to wait on some of that growth.
- The Chairman asked if this uncertainty is to be expected for some time.
 - The Executive Director confirmed that it is expected to be a long term circumstance.
- Commissioner Title raised a concern about the budget stating that it appears to her that there is not sufficient resources to support the Social Equity Program given the growth of the program and asked how can the Commission ensure that the program can still growi and is of a quality it should be and asked how the program is adequately resourced.
 - O The Executive Director noted that one thing that is helpful, the previous curriculum can be used as a good foundation. This is helpful, but by no means sufficient to support ongoing needs. The Executive Director noted that when a cohort completes the program, there is still Commission involvement. The Executive Director said there are some ways that integrating the equity mission throughout the Commission can be helpful. That, however, is not sufficient and there will be a need for more money.
 - o Commissioner Title asked when there would be a written plan.
 - The Executive Director said that that work is ongoing, and he will make himself available to discuss the details as it is developed.
- Commissioner Title asked how she can be of assistance and when can a written plan be expected.
 - The Executive Director said that that is a natural follow up to this discussion and it will be important to have conversations with other staff as well and will make himself available to the Commissioners to discuss the ongoing budget considerations.
- Commissioner McBride said that it is incredible that we have a cohort that is growing. As we think about the program, what is the underpinning for the program, and how are we planning for that program. Commissioner McBride asked whether the Commission has done the budgetary work to understand how we grow the program and what the cost will be to drive quality programing, not just quantity of programing.
- Commissioner Flanagan commented that in these struggling times, this budget cycle is not the only one that will be impacted by the economic downturn from covid-19.



- Commissioner Flanagan wanted to acknowledge that this is a long term problem and the Commission may have to face tough financial choices over the coming budget cycles.
- The Chairman said that the legislature has usually given us what we want, both because of the work that Commission accomplishes as well as the Commission as a net revenue generator. The Chairman asked the Executive Director to provide a data driven report to the Commission's plan to weather these fiscally lean times with respect to the agency as a whole and in particular to the Social Equity Program.
- Commissioner Flanagan said that a report could be helpful, but given the uncertainty of the times, she cautioned getting too detailed, as the budget may continue to fluctuate.
- The Executive Director agreed with Commissioner Flanagan remarks, but indicated that there is a plan for a 1/12th budget and the Commission has been bracing for the varying scenarios. The Executive Director expressed concern that presenting various options in a report could create a false impression of "this or that" rather than some combination of options that are right for the circumstances that ultimately arise.
- Commissioner Flanagan said that she agrees that a Commission discussion is important, but it may make sense to have that conversation after the legislature starts to finalize a budget and has even a ballpark figure.
- The Chairman appreciated the feedback and said that he will keep them in mind as he considers whether such a discussion should be on the next meeting agenda but emphasized the importance of having a Commission conversation on the budget, which has to happen at a public meeting.
- The Executive Director made a final comment about the Social Equity Program, noting that one of the helpful aspects is follow up from the first cohort to learn from past experience. But it is unknown how large the program could get. The current cohort has doubled compared to last, which may only be the beginning with continued outreach to the targeted communities. It will also be important to find efficiencies.

c. Vaping Update – 45:05

• The Executive Director gave an update on the vaping quarantine order. The units that were under quarantine underwent substantial testing. Vitamin E acetate was not found in the products, but what was found was lead in the products, and second tests did not make it clear the cause. That being said, since discovering this, there is a full panel of testing that includes heavy metals in order to ensure the safety of product. That initial inventory represents a substantial investment by industry, and it could expire while being held out of the market, therefore the Commission has put a question to the public about the circumstances under which the product should be released. That being said, the primary focus is public health and safety.

d. Job Description – 49:03

- The Executive Director gave an overview of the Constituent Services Associate.
- Commissioner Title moved to approve the job description for the Constituent Services Associate.
- Commissioner McBride seconded the motion.



 The Commission unanimously approved the job description for the Constituent Services Associate.

5) Enforcement Actions – 51:07

 The Chairman gave an overview of the discussion and thanked enforcement counsel for its work.

a. Garden Remedies, Inc.

- Commissioner McBride asked for a summary for the stipulated agreement terms and agreed upon action going forward as context for public viewers.
- Associate Enforcement Counsel Lopez gave an overview of the alleged violations and terms of the settlement agreement.
- Commissioner McBride thanked the enforcement staff for the work that went into the agreements and investigations.
- Commissioner Title disclosed that she was previously on the Board of Garden Remedies, but after analysis, her involvement does not rise to the level of recusal.
- Commissioner Title also asked about deterrence and howv oky7 penalties serve that purpose.

• Commissioner Title invited other Commissioners to join her in requesting the legislature to allow donations and fines to go to funding the Social Equity Program. Commissioner



- Title gave an overview of the issue and referenced a one-page background memo that was sent to the commissioners July 7 summarizing previous discussions and facts demonstrating why the change is necessary in her judgment.
- This included that numerous licensees have committed to donating part of their revenue to the Commission's efforts as part of their positive impact plans, but the Commission lacks a formal mechanism to accept it. In some cases, the funds are currently sitting unused in escrow.
- Commissioner Title suggested that the commission notify the legislature of this technical challenge, particularly at a moment when leaders at all levels are being more thoughtful about how to be equitable.
- Commissioner Title noted that the number of Social Equity Program participants had more than doubled, but program funding had remained the same since 2017 at \$300,000 per year. She stated that in her judgment, more funding and resources would be necessary to meet statutory mandates.
- Commissioner Title noted that a mechanism to accept the funds was reviewed by the executive director and previously introduced in a bill which was provided to the commissioners on July 7.
- Commissioner Flanagan commented that she does not think it is the role of the Commission to lobby the legislature. Commissioner Flanagan thinks that the legislative process will not allow this push to have the intended impact.
- Commissioner Flanagan also expressed her concern about having last minute agenda items added and how that is not in the spirit of open meeting laws.
- Commissioner Flanagan also said that she does not want to have a vote.
- Commissioner McBride expressed her frustration that this was a last minute addition.
- Commissioner McBride said this is a policy discussion that requires appropriate staff preparation and Commissioner preparation, and she doesn't feel prepared for this discussion at this time.
- The Chairman accepted the feedback about adding new agenda items and commits to addressing the issue.
- The Chairman also expressed that this is an important policy issue that requires staff analysis and reflection for Commissioners and an appropriate public debate.
- The Chairman asked Commissioner Title to allow for these aspects to be developed and he commits that it will be on a future agenda.
- Commissioner Title noted that there had not been any substantive objections.
- Commissioner Title expressed that she too shared frustration with the shortness of time but noted that the legislative session would be coming to an end before the next meeting, so this is a time sensitive matter.
- Commissioner Title noted that she had brought the subject up previously.
- Commissioner Title stated that the commission had lost staff due to a lack of support and resources dedicated to outreach and equity.
- Commissioner Flanagan expressed her concerns about rushing this through the legislature and the Commission should take more time to work with the legislature.



- Commissioner Title thanked Commissioner Flanagan for her expertise and clarified that what she is asking is to express a uniform position of the Commission, rather than to tell the Legislature what to do.
- Commissioner Title moved that the Commission write a letter to the legislature asking it to create a mechanism to receive and use donations and fines and apply those funds to the Commission's equity efforts, similar to Senate Bill 1708.
- The Chairman seconded the motion.
- Commissioner McBride expressed her frustration with what feels like a false choice.
- Commissioner Title expressed that a vote against the motion should not be construed as a lack of support for the equity programs.
- The Commission voted against the motion due to a tie, with one vote in favor (Title) and one against (Flanagan) and two abstentions (McBride and Hoffman).
- The Chairman made a commitment that this would go on the next meeting agenda, provided the conversation can be done in a way that Commissioners are comfortable with and can be productive.







Report as mandated by Chapter 55 of the Acts of 2017, An Act to Ensure Safe Access to Marijuana



LEGISLATIVE MANDATE

Under Chapter 55 of the Acts of 2017, *An Act to Ensure Safe Access to Marijuana* (Act), the Cannabis Control Commission (Commission) is charged with implementing the statutory and regulatory schemes governing the adult-use, and now medical-use, marijuana programs. The following report is issued pursuant to Section 31 of the Act, which provides in relevant part:

"The commission shall annually submit a complete and detailed report of the commission's activities, including a review of the implementation and enforcement of this chapter and the governance structure established in this chapter, not more than 90 days after the end of the fiscal year to the governor, the attorney general, the treasurer and receiver-general, the clerks of the house of representatives and the senate, the chairs of the joint committee on marijuana policy and the chairs of the house and senate committees on ways and means." St. 2017, c. 55, § 31.

EXECUTIVE SUMMARY

Purpose

This report provides information regarding the implementation under the Act of the adultuse marijuana program pursuant to the aforementioned legislative mandate, inclusive of the medical-use program, which the Commission successfully transferred from the Department of Public Health on December 24, 2018.

Findings

The Commission continues to focus on the legislative mandate to establish and implement the adult-use marijuana program. To that end, the Commission made significant progress in the operational areas identified by the Legislature, including in the areas of licensing and enforcement, communications, equity programs, constituent services, public records, finance, personnel, technology, research, and office space.



INTRODUCTION

On November 8, 2016, Ballot Question 4 "Legalize Marijuana" passed with 53.6% of the vote. At that time, Massachusetts joined seven other states, in addition to the District of Columbia, which legalized marijuana for adult-use (a.k.a., recreational use). That number has risen to 11 states as well as some territories. The resulting law, Chapter 334 of the Acts of 2016, *The Regulation and Taxation of Marijuana Act*, which was amended by Chapter 55 of the Acts of 2017, *An Act to Ensure Safe Access to Marijuana*, delegated to the Commission authority over the adult-use program. In September 2017, the Governor, Treasurer, and Attorney General appointed five Commissioners to serve in full-time positions. The Executive Director began in November 2017 and the agency is currently staffed by a total of 68 employees, including Commissioners and the Executive Director.

The mission of the Commission is to honor the will of the voters of Massachusetts by safely, equitably and effectively implementing and administering the laws enabling access to medical and adult use marijuana in the Commonwealth.

The Commission continues to foster the creation of a safely regulated industry that creates entrepreneurial and employment opportunities and incremental tax revenues in and to communities across the Commonwealth and already serves as a best practice model for other states. The Commission developed policies, procedures, and a regulatory structure to encourage and enable full participation in the marijuana industry by people from communities that were previously disproportionately harmed by marijuana prohibition and enforcement and positively impact those communities. The Commission has also built robust data collection methods to monitor and measure progress toward these statutory goals and objectives, most notably through an Open Data Platform. With these programs and regulations in place, the Commission continues to build an industry that prioritizes participation by small and large participants and with full and robust participation by people of color, women, and veterans.

IMPLEMENTATION OF ADULT-USE & MEDICAL MARIJUANA PROGRAMS

Law

<u>Promulgation of the Adult-Use Regulations.</u> On March 23, 2018, the first iteration of regulations, 935 CMR 500.000: *Adult Use of Marijuana*, were published in the Massachusetts Register. At the time of this report, the Commission is in the midst of a regulatory review phase where the experience garnered since the adult-use market came online will be implemented into the existing regulations. This regulatory review phase is anticipated to be completed before the start of the new calendar year and will be the Commission's third round of regulatory review.

<u>Promulgation of Medical-Use Regulations</u>. On December 24, 2018, the Medical Marijuana Program was successfully transferred from the Department of Public Health to the Commission, as was mandated by Section 64 of the Act. In its current regulatory review phase



mentioned above, the Commission is also making updates to the Medical-Use Regulations.

<u>Guidance</u>. In addition to the regulations, the Commission regularly drafts and adopts guidance for licensing and other administrative processes implicated by its legislative mandate. To date, the Commission has issued over 20 guidance documents designed to assist consumers, patients, applicants, business owners, and local officials. Guidance documents are available at https://mass-cannabis-control.com/guidancedocuments/. The Commission will continue to issue guidance documents from time to time as matters arise in order to aid the public with navigating and complying with the various regulations.

Licensing & Enforcement

Through the adult-use program, the Legislature required the Commission to certify priority applicants, license Marijuana Establishments, register marijuana agents and laboratory agents, and approve applicants for the Social Equity program. To that end, the Commission and its vendors designed and implemented Massachusetts Cannabis Industry Portal (MassCIP), its electronic registration system, and its electronic seed-to-sale tracking system, Metrc. As of January 2020, Medical Marijuana Treatment Center (MTC) application and licensing information also transitioned to an electronic-based process completed through MassCIP, further integrating the medical program that was previously governed by the Department of Public Health into the operations of the Commission.

<u>Priority Applicants</u>. Between April 17, 2018, and May 22, 2018, the Commission completed the application process for priority certification. In total, 322 applications were submitted, with 81 MTC (formerly referred to as RMD) applicants and 122 economic empowerment applicants ultimately granted priority certification. The Commission issued two commence operations approvals to economic empowerment priority applicants in March and May of 2020. The first Social Equity Program applicant received a commence operations approval in March of 2019. To date, 28 Social Equity Program applicants have secured at least a provisional license.

Provisional & Final Applicants. As of August 18, 2020, 22,832 applications for licensure as an adult-use Marijuana Establishment and for registration as a marijuana establishment and laboratory agent were opened with the Commission. More specifically, Commission staff are presently reviewing 250 applicants and further reviewing and inspecting 418 provisional licenses. The following is a summary breakdown of the 856 license applications submitted to the Commission as of July 29, 2020:

- 240 MTC Priority Applicants (which is an MTC previously approved by the Department of Public Health and had at least obtained a MTC provisional license as of April 1, 2018);
- 37 Economic Empowerment Applicants (as certified by the Commission in 2018);
- 52 Social Equity Participant Applicants (as approved through the Commission's Social Equity Program);



 110 Expedited Applicants (as allowed through Commission policy in November 2019 as part of a process for certain businesses to receive expedited review. These applicants consist of minority-, women-, and veteran-owned businesses as certified by the Supplier Diversity Office as well as Independent Testing Laboratories, Outdoor Cultivators. Marijuana Microbusinesses, and Craft Marijuana Cooperatives); and

As of August 18, 2020, 135 licensees have received commence operations notices, meaning that they have been authorized by the Commission to begin business operations, 35 have been granted final licenses, and 418 have been granted provisional licenses.

In addition to regulating the adult-use industry, the Commission has overseen the medical-use program since being transferred from the Department of Public Health in December of 2018 as required pursuant to Chapter 55 of the Acts of 2017.

As of August 18, 2020, the medical-use industry currently is comprised of the following: 60 provisional licensees, 14 final licensees, and 64 additional licensees who have commenced full operations to serve registered patients and caregivers through vertically integrated medical marijuana treatment centers (MTCs). There are 21 medical-use license applicants under review for consideration by the Commission.

Emergency Orders Related to Vaping and EVALI

417 General Applicants.

During the period of July 1, 2019-July 1, 2020, the Commission issued three industry-wide emergency orders in response to reported occurrences of e-cigarette, or vaping, product use-associated lung injury (EVALI) in the Commonwealth and across the nation.

On November 12, 2019, the Commission issued a <u>Quarantine Order</u> Applying to Vaporizer Products requiring all licensees to quarantine all vaporizer products based on the agency's determination that additional testing of products for Vitamin-E Acetate and other substances of concern was necessary to protect the public health, safety, and welfare.

On December 12, 2019, the Commission issued a First Amended Quarantine Order Applying to Vaporizer Products with Conditions authorizing licensees to sell newly manufactured vaporizer products, but requiring that vaporizer products manufactured before December 12, 2019 remain subject to quarantine. Approximately 619,362 individual units of vaporizer product were held in virtual quarantine as a result of the First Amended Quarantine Order.

On August 3, 2020, the Commission issued a <u>Second Amended Quarantine Order</u> Applying to Vaporizer Products providing several options for addressing quarantined products manufactured prior to December 12, 2019. The Second Amended Order permitted licensees to voluntarily dispose of vaporizer products, release vaporizer products from quarantine for sale if first retested, or repurpose quarantined vaporizer products into other Marijuana Products after



reclaiming marijuana oil from the quarantined product. The Second Amended further required mandatory disposal for vaporizer products that had failed two rounds of Commission-initiated tests for heavy metals in connection with an investigation carried out by the Commission's Investigations and Enforcement Department during December 2019-March 2020.

Communications

The Commission is in regular contact with members of the public through various formats and platforms. Beyond the monthly public meeting schedule, Commissioners regularly attend and present at public events. In the last year, Commissioners have made or participated in over 100 presentations or panel discussions before stakeholder groups that included community organizations, chambers of commerce, public health organizations, travel and tourism bureaus, attorneys, municipal officials, and law enforcement. Participation in related events continued virtually through the COVID-19 State of Emergency declared in Massachusetts in March.

The Commission's website (www.MassCannabisControl.Com), received more than 1,170,000 - page views and 882,000 unique visits throughout FY20. In addition to information on the Commission and the Cannabis Advisory Board, the site provides regular updates concerning Massachusetts law, regulations, guidance, and licensing. The Commission also oversees the Medical Use of Marijuana Program website (www.Mass.Gov/MedicalMarijuana). This fall, the agency expects to complete and launch a website redesign of www.MassCannabisControl.Com that will integrate the medical- and adult-use cannabis program's content to better serve all Commission constituents throughout the Commonwealth. New features of the website design will include unique user-driven experiences using color-coded wayfinding and a range of visitor personas (e.g. patients, government officials, and parents); integrated web copy for improved searchability; stronger web accessibility standards; and embedded data compiled from external resources such as the Commission's Open Data Platform, currently available at https://opendata.mass-cannabis-control.com/.

The Commission sent, on average, 11 email campaigns to subscribers per month, a 450 percent increase from the previous fiscal year. The Commission has expanded its social media presence to include Instagram (@CannabisControlCommission, 2,437 followers) and LinkedIn (@CannabisControlCommission, 1,932) in addition to Twitter (@MA_Cannabis, 7,514 followers) and Facebook (@MassCCC, 2,391 followers). Through these various channels, the Commission continues to communicate with the public regarding the work of the agency and the emerging industry.

Public Awareness Campaign

The Commission continues to build upon its state-mandated public awareness campaign, More About Marijuana (www.MoreAboutMJ.Org), pursuant to Section 51 of the Act. The campaign has been developed in partnership with MORE Advertising, and utilizes third-party



research, surveys, and focus groups of Massachusetts residents to complete the implementation of new content.

Key focuses of the initial public awareness campaign included youth prevention and responsible adult-use consumption. Over FY20, More About Marijuana continued to promote those messages and incorporated new educational materials about the <u>dangers of home manufacturing</u>, COVID-19 safety tips for cannabis consumers, and the risks of vaping, in response to statutory requirements and developing health emergencies over the last year. Animated home manufacturing content launched in the spring, followed by new COVID-19 safety ads published through social media, the Department of Transportation's billboard network, and community-based newspapers. An informational video about the risks of consuming illicit market vapes is expected to roll out this fall.

Overall, the Commission distributed its 2020 integrated communications plan utilizing broadcast media (tv and radio), out-of-home (billboards and transit posters), and digital (social media, search engine marketing, and display ads). Print collateral and branded outreach materials continue remain accessible to the public through the Massachusetts Health Promotion Clearinghouse (https://massclearinghouse.ehs.state.ma.us/category/Cannabis.html). In addition to two previously available "Guides to Marijuana in Massachusetts" for parents and consumers, the Clearinghouse now includes a "Guide to Growing and Making Marijuana Products in Massachusetts." The Commission also collaborated with the Department of Fire Services to advise and distribute their public awareness campaign on Fire Safety for Cannabis.

From April to June alone, the Commission's public awareness campaign generated more than 90,000 MoreAboutMJ.Org views, 552,695 campaign views, and 65,040 campaign ad clicks across content available on Facebook, Google, YouTube, Snapchat and Twitter.

The Commission's Communication's and Research departments also spearheaded the release and review of pre-campaign surveys that will inform future direct-to-youth campaign messaging that enhances the campaign's ongoing focus on the risks of underage consumption.

Equity Programming & Community Outreach

The Commission has spent its outreach efforts in the last year with a focus on the evaluation of the first cohort of the nation's first statewide Social Equity Program (Program), the planning, promotion, and launch the second cohort of the Program. While this has been the main focus, it has not been the only. The Commission continues to build collaborative partnerships with communities, constituencies, and organizations throughout the Commonwealth in order to increase engagement with the Commission, particularly including communities disproportionately harmed by marijuana arrests and incarceration, and engage with people of color, women, veterans and farmers, in accordance with the state law and the Commission's mission statement.



Social Equity Program. The Program is designed to build a pathway into the cannabis industry for individuals disproportionately impacted by prohibition to enter the cannabis industry. The Program focuses on those most impacted by the War on Drugs, marijuana prohibition, disproportionate arrests and incarceration, and provides education and entry into the industry across four areas: entrepreneurship, entry- and managerial-level workforce and professional development, and ancillary business support. Its overall mission is to decrease the disparities in life outcomes for impacted individuals and improve the quality of life in areas of disproportionate impact.

The goals of the Program are to:

- Reduce barriers to entry in the commercial marijuana industry, regardless of desired specialty within the industry;
- Provide professional and technical services as well as mentoring for individuals and businesses facing systemic barriers; and
- Promote sustainable, socially, and economically reparative practices in the commercial marijuana industry in Massachusetts.

To qualify for the Program, an applicant must meet <u>one</u> of the following criteria:

- Residency in an area of disproportionate impact for at least 5 of the past 10 years and income may not exceed 400% of the Area Median Income in the applicant's respective town/city.
- Applicant has a past drug conviction, continuance without a finding, or an equivalent conviction in other jurisdictions, and residency in Massachusetts for at least the preceding 12 months; or
- Applicant has been married to or is the child of a person with a drug conviction, a continuance without a finding, or an equivalent conviction in other jurisdictions, and applicant residency in Massachusetts resident for at least the preceding 12 months.

The application for the Program's first cohort opened in December of 2018 with 143 participants. After a robust procurement and selection process, six vendors were chosen to participate in the Program's first cohort. The Commission launched the Program in the summer of 2019 by holding three exclusive orientation seminars across the Commonwealth for accepted applicants. The Program's first cohort completed programming in April of 2020. After reviewing constituent, participant, and vendor feedback regarding the income limits under Qualification 1, the Commission decided to increase the income limit from 400% of the federal poverty level, to 400% of the Area Median Income in the applicant's respective town/city. Based on that change, Commission staff reviewed all applications that were not accepted into the first cohort for potential acceptance into the second cohort in addition to all new applications. The Program's second cohort was subsequently finalized at the beginning of July of 2020.

Participant and vendor feedback led to several additional changes to the Program for the second cohort. Namely, the Commission streamlined the programming, implemented a virtual learning management system, and decreased the number of Program vendors from six to three.



While there was a reduction in vendors, the number of accepted participants in the second cohort was twice that of the first cohort (285) and all at a reduced cost, thanks in part to the new virtual environment. The Program's second cohort began in July of 2020 with an orientation seminar followed by an exclusive business valuation seminar with Chairman Steven Hoffman. Programming for the second cohort will continue through May 2021. The Commission anticipates opening the application for the third cohort of the Program in early 2021, following a reevaluation of the 29 currently designated Areas of Disproportionate Impact.

Constituent Services

The Commission handles inquiries from the public and ensures a timely response. Constituents may email, call, or write in with their opinions, questions, comments, and concerns. The Commission generally receives an average of 50-60 inquiries per day. The Director of Constituent Services liaises with other departments and staff to resolve constituent cases that require their review. Prior to the pandemic, staff also attended community meetings and events to ensure that people can speak directly with Commission representatives. Constituents generally have questions and comments regarding the medical marijuana program, compliance with marijuana laws, marijuana policy, the industry, marijuana establishments and related state laws. While the Commission cannot and does not provide legal or business guidance, the staff attempts to answer constituents' questions as completely as possible or refer them to the appropriate resources.

To further emphasize the importance of accessible and responsive government, the Commission assigned, as one of the Executive Director's 10 goals, an initial response time of 24 hours for all inquiries. To assist in meeting that objective, the Commission recently developed a deployed a robust case relationship management (CRM) system, explained in further detail below.

Patient Support for Medical Use of Marijuana Program

On December 24, 2018, the Medical Use of Marijuana Program transferred from the Department of Public Health, and the program is now a fully integrated part of the Commission. Commission staff routinely responds to patient inquiries in addition to processing patient, provider, and caregiver registrations.

As of August 2020, the Medical Use of Marijuana Program is made up of 86,197 certified active patients, 7,815 active caregivers and 358 certifying health care providers. The Patient Support Center is comprised of three patient support representatives and one manager who ensure patients, caregivers, and providers are correctly registered and who troubleshoot technical issues as they arise.

Significant technical upgrades were made in FY20, the details of which can be found below. These changes also included a link to the Registry of Motor Vehicles (RMV) database to facilitate automatic patient registrations, which has significantly reduced wait times, as well as



the transition of the pediatric application process from paper to the MassCIP as a digital application.

Public Records and Transparency

During FY20, the Commission's Records Access Officer received and responded to approximately 146 requests for public records. Although certain materials are withheld during the licensing and investigative process, the Commission's goal is to promote transparency. To that end, it regularly posts the following:

The Commission has posted to its website the applications of Marijuana Establishments that have commenced operations. Additionally, the Commission launched its Open Data Platform in order to provide readily available information to the public. The Open Data Platform can be located at https://opendata.mass-cannabis-control.com/. The Commission is continuing to explore technological solutions to increase the public's access to Commission records.

Finance

The Commission is supported through the Marijuana Regulation Fund, which is subject to appropriation. In FY20, the Legislature appropriated \$14.2M across three line items for the Commission's operations: \$9.9M for the Commission's Operations, \$3.3M for the Medical-Use of Marijuana Program, and \$1M for the Public Awareness Campaign stipulated by section 51 of chapter 55 of the acts of 2017. In total, the Commission spent \$12.6M in FY20. The Commission continues to grow, hire additional staff, and implement legislative mandates as the industry matures. That growth is demonstrated in the Commission's FY21 budget request.

The Commission's request to the Joint Committee on Ways and Means for FY 2021 is \$16.2 million in total. This includes \$12.4 million for the CNB Operations line item (1070-0840), which represents a \$2.8 million increase over the FY 2020 available funding of \$9.6 million. Beginning this fiscal year and continuing through FY 2021, the Commission plans to increase its staffing to improve the efficiency of the licensing process and anticipate the need for growth in compliance and enforcement as new, diverse establishments open in Massachusetts. This budget request will enable the Commission to complete a planned 34 FTE new hires. In combination with IT and operational enhancements, hiring more Investigators and Licensing Specialists will enable the Commission to process applications on a quicker timeline while also ensuring compliance with state law and adherence to our mission. With the funding in the FY



2021 proposal, the Commission would also implement both technical changes to streamline processing and improve the user experience and increase staffing to meet demand for licensing. These changes would support all licensing types, notably farmers, small businesses and cooperatives, laboratories, and outdoor cultivation, which are key areas of the Commission's statutory mandate. The Commission's request also includes \$1 million for the aforementioned Public Awareness Campaign (1070-0841). This funding level will ensure that we can continue our efforts to educate the public about the responsible use of adult-use marijuana through a multi-media campaign. In addition, the Commission requests \$2.8 million for the Medical Use of Marijuana Program (1070-0842), which will support the operations of this program, including serving more than 67,000 registered patients annually and ensuring the compliance of 58 operational medical marijuana treatment centers

Revenue

The Commission's revenue from application, licensing, fines and other fees, along with marijuana sales and excise tax revenue, is deposited into the Marijuana Regulation Fund. The Commission collected \$17.1M in revenue in FY20. Through May 2020, the Massachusetts Department of Revenue reported a total of \$30M in marijuana sales tax revenue and \$51.7M in marijuana excise tax revenue for FY20. In total, these revenues have generated a \$98.8M contribution to the Marijuana Regulation Fund.

Personnel

The Human Resources department is responsible for creating and implementing policies, processes and programs to support the Commissions' mission and strategic vision and creating a great place to work. The Commission has a strong commitment to attracting, rewarding, developing and retaining an inclusive, diverse, and talented workforce. At the time of this report, the Commission employs 68 staff of which 61% are female and 39% persons of color. In addition, our management team is 60% female and 46% persons of color.

Technology

The Commission's licensing platform, MassCIP, has managed the intake of applications, as well as the issuance of licenses. On November 20, 2018, the first Marijuana Retail stores opened. Both locations provided sales and marijuana tracking data to the Commission's seed-to-sale system, Metrc, which is closely coupled with the licensing platform. In addition, all functionality related to badging of registered agents has been implemented via MassCIP.

At the end of 2019, the Commission migrated to a new technology environment (@CCCMass.com) in the Microsoft Government Cloud. This migration laid the foundation for a fully remote workforce that was monumental when faced with the COVID-19 pandemic. Commission operations were 100% stable with all employees and the patient support center working remotely immediately and seamlessly following the Executive Director's work-fromhome notice in March 2020. This technology also improved the Commission's ability to



strengthen security through Palo Alto artificial intelligence (AI) security platforms, advanced threat protection, and always on virtual private networks (VPN). The Commission's technology staff continues to address the needs of the organization by enhancing the network technology and standardizing desktop and laptop computers, desk, and cell phones.

The technology team assisted in the successful build-out of the Commission's headquarters at Union Station in Worcester and the satellite office in Boston. Both offices are situated with best-in-class technology to enable employees to be productive regardless of their location. In the Boston office, technology was implemented to allow for bookable offices for mobile employees, and conference room technology that enabled face to face meetings regardless of the participant's location.

In January 2020, the Commission migrated the Patient Portal to a new Amazon AWS Government cloud-hosted solution that enables faster software changes, enhanced auto approvals, and the integration with the RMV. The system is now integrated into the same environment as MassCIP; a step that will drive the consolidation of the two systems in the future. This migration assisted in reducing the cycle time for a patient to receive their medical identification card and also allowed for the introduction of an electronic application for pediatric applicants for the first time in program history.

The Commission continues to expand data on our Business Intelligence and Open Data technology that supports operational insight and transparency related to (1) marijuana establishment licenses and (2) marijuana establishment agent registrations. The portal has been deployed to the public under https://opendata.mass-cannabis-control.com/.

Lastly, the Commission has implemented a CRM system that allows for a single source record of operations across the Commission. The system, using the Microsoft Dynamics 365 platform, is a case management platform that supports various work streams such as constituent services, patient support, legal case management, contract management, investigations, licensing workflow, suitability reviews, IT ticketing, HR, enforcement, and public records requests. While development is complete, adoption continues through various departments throughout this year.

Research

Section 17(a) of the Act requires the Commission to develop a research agenda to better understand the social and economic trends of cannabis in the Commonwealth. The law identifies at least seven categories of study and authorizes an expansion of that scope with the aim of informing future decisions that would aid in the closure of the illicit marketplace and monitoring the public health impacts of cannabis and cannabis legalization.

The Commission's Research Department stratifies categories of study into separate reports. Between July 1, 2019- July 1, 2020, the Commission released five of these comprehensive research reports (Table 1 below). All reports include original data analysis and extensive state-of-science literature reviews. The aims of each research report are fourfold: (1)



establish a baseline prior to adult-use cannabis legalization to provide a point of reference for future years; (2) assess gaps in systematic data collection in the Commonwealth that is needed to fulfill the statutorily required annual research mandate, (3) discuss strategic plans for upcoming reports, and (4) present considerations for the Commonwealth based on a comprehensive assessment of items included in each report and as outlined in the Act. [See Table 1 below for c. 55(2017), § 17(a) research agenda items assessed and descriptions of each report].

Additionally, work is underway to conduct a baseline assessment of impacts to the healthcare system, an assessment of adult-use cannabis behaviors, an assessment of the utility in using public safety data to assess social equity provisions, an assessment of legal and illicit market cannabis use behaviors, an assessment of cannabis-related disciplinary actions in schools, as well as continuing the primary collected surveys included in the Marijuana Baseline Health Study (MBHS). These agenda items will be included in the 2020-2022 reports, scientific manuscripts and national scientific meeting presentations.

The Research Department continues to work internally, as well as collaborate with various state agencies, academic researchers, and other research entities and stakeholders to employ primary and secondary data collection methods to examine a spectrum of items. As cannabis policy research gains interest nationwide across diverse stakeholders and academic disciplines, the Commission set both long- and short-term goals to ensure the research is of high quality, impactful, comprehensive, and collaborative. Thus, in addition to Research Reports, the Commission's Research Department has published two academic peer-review manuscripts (see Table 2 below) and presented Commission research at two National Scientific Meetings (see Table 3 below).

Office Space

In 2019, the Commission, through the Division of Capital Asset Management and Maintenance (DCAMM), moved to its headquarters in Worcester and a satellite office in downtown Boston to accommodate both the medical-use and adult-use programs. Also, in 2019, and as previously outlined, the Commission invested in computer hardware and transitioned off the Mass.gov backbone to an independent, secure system which enabled the Commission's COVID-19 response. In March 2020, in response to the COVID-19 pandemic, the Commission closed its offices to staff and the public and began an agency-wide remote work initiative.

COVID-19 Response

On March 12, 2020, the Executive Director closed the Commission's offices to staff and the public and directed all staff to work from home. Thanks to the aforementioned investments in IT and equipment, Commissioners and staff have been working remotely since March 13, 2020. During this time, the Commission continued to implement its spending and hiring plans, including welcoming eight new hires while working remotely. To maintain medical marijuana operations, the Executive Director issued administrative orders to permit curbside pick-up and telehealth visits with certifying providers. Investigative and compliance staff started virtual inspections and visits to continue with the Commission's licensing and compliance responsibilities. Public meetings continued online, consistent and compliant with the Governor's executive order relative to the Open Meeting Law, including a public hearing on revisions to the adult-use and medical marijuana regulations. The Commission also created a web page specific to COVID-19 updates and actions taken by the Commission in order to keep the public informed. The Commission continues to receive, review, and process all license applications; in fact, in 2020, the Commission saw its highest number of provisional and final licensing applications.

CONCLUSION

This 3rd annual report identifies the operational activities of the Commission in the third year since establishment as well as the ongoing operational needs implicated by the continued build out of the industry, both medical- and adult-use. As the report demonstrates, the Commission has anticipated needs, created significant efficiencies, and continues to meet statutory requirements.





PROPOSED MOTION TO DELEGATE APPROVAL AUTHORITY FOR DELIVERY ENDORSEMENTS

BACKGROUND

Delivery Endorsement applications are currently available to Marijuana Microbusiness licensees, on an exclusive basis, that are controlled by and with majority ownership comprised of Economic Empowerment Priority Applicants or Social Equity Program Participants. These Marijuana Microbusiness licensees, including all Persons or Entities Having Direct or Indirect Control, shall previously been vetted and approved by the Commission for licensure.

However, following licensure, approval authority for Delivery Endorsements currently rests with the Commission. A comparative administrative action, such as the approval of MTC home delivery operations associated with Commission-approved MTC licenses, has previously been delegated to the Executive Director to approve for administrative efficiency. Other similar delegated administrative approval delegations to the Executive Director include the approval of change of name and waiver requests. Additionally, in the current draft regulations, other similar administrative actions are further proposed to be delegated to the Executive Director (i.e. change of location and certain change of ownership/control requests).

Therefore, Commission staff recommend that the Commission delegate authority to the Executive Director to approve applications and authorize operations for Delivery Endorsements associated with Commission-approved Marijuana Microbusinesses licensees for the following reasons:

- a. To be consistent with other similar administrative actions; and
- b. To ensure a timely response to Marijuana Microbusiness licensees from the Commission on their approval to perform deliveries.

PROPOSED MOTION

Therefore, Commission staff recommend the following motion:

The Commission moves to delegate authority to the Executive Director to approve applications and authorize operations for Delivery Endorsements pursuant to 935 CMR 500.050(5) for licensed Marijuana Microbusinesses that have complied with Commission requirements pertaining to delivery operations.


