### Minutes:

- I. Call to Order
  - The Acting Chair (AC) recognized a quorum, called the meeting to order and noted that Commissioner Concepcion would be joining the meeting at a later point remotely.
  - The AC gave notice that the meeting is being recorded.
  - The AC gave an overview of the agenda.
- II. Commissioners' Comments & Updates 00:01:42
  - Commissioners thanked staff for prepping the days meeting.
- III. Commission Discussion and Votes 00:03:25
  - 1. Executive Director Goals for CY 2025
    - Executive Director (ED) Travis Ahern provided a high-level overview of his goals for CY 2025. He stated that he would include the Governance Charter as a discussion item at a future Public Meeting and noted that goals six through eleven could be impacted by budget constraints. Commissioner Roy requested an edit to goal number three to indicate that the ED would continue holding meetings of the Cannabis Advisory Board (CAB) after the first full meeting was scheduled. She requested



further edits to replace "guidelines" with "protocols, guidance documents and regulations" in goal number four and to add "adhere to statutory, regulatory and internal deadlines" after "Commission's goals" in goal number twelve.

- Commissioner Camargo moved to approve the amended ED goals for CY 2025 and allow for any grammatical or non-substantive Changes.
- Commissioner Concepcion seconded the motion.
- The AC took a roll call vote:
  - Commissioner Camargo Yes
  - Commissioner Concepcion Yes
  - Commissioner Roy Yes
  - AC Stebbins Yes
- The Commission unanimously approved the motion.
- The Commission took a brief recess. (Returned at 00:39:34.)
- 2. Administrative Order Requiring Licensees to Upload Certificates of Analysis in METRC
  - Commissioner Roy stated that this discussion topic was brought to the board in the interest of public health, transparency and standardization. Chief of Investigations and Enforcement Nomxolisi Jones (Chief Jones) explained that the changes since the last time the Administrative Order had been presented incorporated stakeholder feedback. Interim Director of Testing Timothy Barwise (Interim Director Barwise) explained the changes: an edit to No. 3 to prevent Independent Testing Laboratory's (ITL's) agents names from being public; references to "kill-steps" had been stricken from No. 5, which now used the words "sanitization treatment" with a reworked definition; an edit to clarify ITL's client's responsibility to disclose sanitization treatment; and edits to No. 6 to match the language of No. 5. Chief Jones confirmed that Licensees would be put on notice by email as well as by notification through Metrc.
  - Commissioner Roy moved to approve the Administrative Order Requiring Licensees to Upload Certificates of Analysis in METRC and direct the ED and Chief of Investigations and Enforcement to take all necessary steps to effectuate its implementation.
  - Commissioner Camargo seconded the motion.
  - The AC took a roll call vote:
    - Commissioner Camargo Yes
    - Commissioner Concepcion Yes
    - Commissioner Roy Yes
    - AC Stebbins Yes
  - The Commission unanimously approved the motion.
- 3. Delivery to Consumers in Restricted Municipalities Opt-In Template Form
  - Commissioner Camargo stated that the intent of the form was to provide more business opportunities for delivery operators. Director of Government Affairs and Policy Matt Giancola (Director Giancola) explained the regulatory restriction on delivery operators to deliver solely in the municipality which they are located, any municipality which voted yes on Question 4 and any municipality which opted into

delivery after initially voting no on Question 4. He said that a letter to municipalities notifying them of the option would be presented to Commissioners for their review at a future meeting and that, in order to opt-in, municipalities would need to update their by-laws. Commissioner Camargo asked how to best get this information to municipalities and the ED explained that besides direct communication, the Massachusetts Municipal Association (MMA) could help as well as town counsel. Commissioner Concepcion suggested using this as an educational opportunity to inform municipalities of the benefits of opting-in as well as the fact that medical-use deliveries are already allowed across the state. Commissioner Roy suggested explaining that the vehicles used for delivery are highly secure, the number of communities which allowed delivery, that there had been no security incidents and how delivery could reduce the illicit market.

- Commissioner Camargo moved to approve the Delivery to Consumers in Restricted Municipalities Opt-In Template and direct the ED and Department of Government Affairs and Policy to provide a formal communication and copy of the template to those identified restricted communities and develop other communication strategies as needed.
- Commissioner Concepcion seconded the motion.
- The AC took a roll call vote:

- The Commission unanimously approved the motion.
- The Commission took a brief recess. (Returned at 01:29:09.)
- 4. Discussion and Review of Draft Regulations
  - Deputy General Counsel Michael Baker (DGC Baker) began review of the draft regulations beginning with 935 Code Mass. Regs. § 500.141(2)(e). Commissioner Roy requested an edit to indicate that accessories could be stored in addition to Marijuana and Commissioner Concepcion asked if other states had similar requirements for allowing storage of Marijuana not purchased from the Social Consumption Establishment (SCE). Enforcement Counsel Timothy Goodin (EC Goodin) noted that this would present liabilities for the Licensee who would have to securely store the Marijuana. Commissioners discussed the security concerns of Licensees being responsible for products which they had not sold and the AC suggested that they circle back on the topic after public comment.
  - The Commission took a brief recess. (Returned at 03:18:45.)
  - The AC resumed discussion of 935 Code Mass. Regs. § 500.141(2)(e), read aloud an amended version and discussed the amendment with staff. Commissioners agreed to incorporate the edit as a new (e) to read: "Procedures to ensure that only Marijuana or Marijuana Products purchased at the SCE are consumed on the Premises." and a new (f) to read: "Procedures that ensure only Marijuana Accessories provided or sold by

the Social Consumption Establishment are utilized on the Premises." Commissioners agreed to include the sentence indicated that SCEs may store Consumer's product which had not been sold by the SCE in the draft regulations for the purpose of seeking public comment. Paralegal Ivannia Coralis Solis (Paralegal Coralis Solis) continued reading the redline amendments and there were no requested edits until 935 Code Mass. Regs. § 500.141(2)(g) where Commissioner Roy asked if SCEs would be responsible for disposal of product which they had stored but not sold. Associate General Counsel Philip Schreffler (AGC Schreffler) suggested an edit to read: "Procedures for the storage of Marijuana or Marijuana Products including, but not limited to, disposal procedures for unconsumed or abandoned Marijuana or Marijuana Products." Commissioners discussed how Licensees would deal with unfinished products which were left behind by Consumers and Chief Jones suggested discussing the topic with Metrc. They agreed to incorporate AGC Schreffler's proposed edit. Commissioners discussed (g) and whether Licensees should be required to establish a business relationship with a taxi, car service or rideshare service as well as what would constitute a "reasonable effort" to obtain transportation for a person who had overconsumed. The AC suggested circling back to the topic after he revised this section and there were no objections.

- The Commission took a brief recess. (Returned at 05:07:04.)
- The AC suggested that the Social Consumption working group revise 935 Code • Mass. Regs. § 500.141(2)(i) and Paralegal Coralis Solis resumed reading the redline amendments beginning with (j) where AGC Schreffler suggested an edit for the section to read: "Emergency response procedures where the Social Consumption Establishment shall contact emergency responders if a Consumer demonstrates signs of unresponsiveness, significant impairment, or medical distress; provided that the procedures shall require Agent(s) to remain with the Consumer until emergency responders arrive." Regarding 935 Code Mass. Regs. § 500.141(2)(1)1.- 4., DGC Baker said that he would carry over edits from earlier meetings regarding impermeable barriers and PPE and Commissioner Roy noted that "eliminate" in 4. should be changed to "mitigate" to mirror other edits. Pursuant to discussion in earlier meetings, the AC explained that 935 Code Mass. Regs. § 500.141(2)(m) would be stricken and Paralegal Coralis Solis continued reading the amendments at (n). Commissioner Roy agreed to work offline with DGC Baker on this section to see if another citation was needed; she further suggested striking "qualifications and" in (r) and there were no objections. DGC Baker gave background on discussions he had with the Department of Public Health (DPH) who had suggested striking "as it is defined in the 2013 Retail Food Code" in 935 Code Mass. Regs. § 500.141(3)(b). He and AGC Schreffler summarized some of the conflicts that the working group had run into when discussing how to provide infused edibles relating to controlling dosage when mixing ingredients. EC Goodin noted that the citation to 105 Code Mass. Regs. 590.001(A) may not be correct, and DGC Baker stated he would work offline to confirm. Commissioners agreed to circle back to 935 Code Mass. Regs. § 500.141(3)(c) and the next requested edit was in (e) where the AC requested

including "non-infused" after "shall sell", AGC Schreffler suggested switching the first "shall" to "may" and Commissioner Roy suggested striking "other than Edibles". The Commissioners agreed to circle back to this section after having a policy discussion on whether other Licensees should be allowed to sell non-infused shelf-stable products. Commissioners discussed (f), agreed to strike the first sentence and suggested that EC Goodin and DGC Baker work on the second sentence offline. Commissioner Roy stated that when they revisited this section, she would suggest including hemp products.

- Commissioner Camargo thanked staff for preparing the day's meeting. Commissioner Roy thanked Senators Michael Rodrigues, Daniel Donahue, Peter Durant, Pavel Payano as well as Representative Michael Soter and staff from the Governor's Office for meeting to discuss the Commission's budget as well as Cannabis policy. The AC highlighted the State of Cannabis event and recent meetings with Department of Public Health (DPH) Commissioner Robert Goldstein, staff from the Division of Banks (DOB) as well as the Alcoholic Beverages Control Commission (ABCC).

  - Executive Director (ED) Travis Ahern provided updates on the procurement of an accounts receivable auditor which had been contracted and a systems and organization controls auditor which had been posted. He provided an update on the FY2026 budget, which had been allocated at \$19.88 million, noting that the deadline for the conference committee was the following day. He stated that there had been two voluntary tier relegations an Outdoor Cultivator had gone from Tier 6 to Tier 2 and an Indoor Cultivator had gone from Tier 11 to Tier 2. He provided an update on his goals and stated that he had reviewed and proposed edits for the Governance Charter which he suggested discussing at the May 22<sup>nd</sup> meeting. He highlighted the landing page for Chapter 180 resources, which had just launched. Commissioner Roy asked if the System and Organization Control audits could be performed under a single contract and the ED stated it would likely be two separate procurements and that he would have more information at the May 22<sup>nd</sup> meeting on the procurement of a testing consultant.
  - Director of Licensing Olivia Koval (Director Koval) provided highlights from licensing data and explained for Commissioner Roy that there was not yet an expected timeline for the Marijuana Research Facility to commence operations. Director Koval continued and presented the data on the current maximum licensed canopy and on Host Community Agreements (HCAs). Commissioner Roy requested that Director Koval's presentation be circulated offline.

The AC asked about the fourth option listed in the equitable relief form indicating that the Licensee may request private mediation with the HC and GC Chattopadhyay noted that both parties would need to consent to mediation. The AC suggested meetings with Commissioners offline to review the request which would be acted on at the May meeting.

- I. Call to Order
  - The Acting Chair (AC) recognized a quorum and called the meeting to order.
  - The AC gave notice that the meeting is being recorded.
  - The AC gave an overview of the agenda.
- II. Commissioners' Comments & Updates 00:01:30
  - Commissioners thanked staff for prepping the meeting and thanked Commissioner Camargo for her service.
- III. Commission Discussion and Votes 00:04:35
  - 1. Discussion and Review of Draft Regulations
    - Deputy General Counsel Michael Baker (DGC Baker) began by suggesting that 935 Code Mass. Regs. § 500.141(3) be moved to section (4), there were no objections and Paralegal Rachel Ferrara (Paralegal Ferrara) began reading the redline regulations. Commissioner Roy requested an edit to 935 Code Mass. Regs. § 500.141(4)(a)2. to change "make available" to "readily display" and to change "determined" to "reviewed" in the second to last sentence. Chief of Investigations and Enforcement Nomxolisi Jones (Chief Jones) suggested an additional edit to indicate that



information cards could be available either in the Consumption Area or at the point of sale and Commissioner Camargo requested information on how other states handled this issue. Commissioners discussed and agreed to develop a model Consumer information card and to strike the second sentence of 935 Code Mass. Regs. § 500.141(4)(a)2. Director of Investigations Katherine Binkoski (Director Binkoski) suggested making the readily available Consumer information cards a requirement for all Licensees and DGC Baker volunteered to work on this topic with Commissioner Roy and Director Binkoski offline. DGC Baker walked the group through the policy considerations of 935 Code Mass. Regs. § 500.141(4)(b), noting potential conflicts in an instance where an entity which was licensed to sell alcohol, acted as a Host for a temporary event was prohibited from selling alcohol outside of the Consumption Area. Commissioners discussed and agreed on a new (b) to read: "A Social Consumption Establishment shall not allow the consumption of alcohol or the smoking of tobacco, or the sale of alcohol or tobacco on the Premises of a Supplemental License." and a new (c) to read: "A Social Consumption Establishment shall not allow the consumption of alcohol or the smoking of tobacco or the sale of alcohol or tobacco at the designated Social Consumption Area of a Hospitality or Event Organizer License." Commissioners discussed the policy considerations as well as the topic of Consumers entering Social Consumption Establishments (SCEs) after consuming alcohol.

- The Commission took a brief recess. (Returned at 01:22:19.)
- The AC stated that Commissioners would circle back to the policy considerations • which were deliberated before the recess and there were no objections. Regarding 935 Code Mass. Regs. § 500.141(4)(b), Chief Jones suggested amendments to clarify Premises, Social Consumption Area and space throughout the regulations and DGC Baker stated that he would work offline with staff on the topic. Paralegal Ferrara continued reading the redline regulations and there were no requested edits until 935 Code Mass. Regs. § 500.141(c) where Commissioners discussed the appropriate timeframe for sales at SCEs and agreed to replace "shall" in the last sentence with "may" and to extend sales hours to 12:00 a.m. Enforcement Counsel Timothy Goodin (EC Goodin) noted that the language in 935 Code Mass. Regs. § 500.141(4)(e) was unique to SCEs and suggested developing more detailed requirements for incentivizing electronic payments and the AC suggested circling back to this topic. DGC Baker stated that he would work on 935 Code Mass. Regs. § 500.141(4)(g) offline and provide an updated version in the next draft of the regulations. Paralegal Ferrara continued reading the redline regulations until 935 Code Mass. Regs. § 500.141(6)(e)4. where Commissioner Roy asked how camera coverage would apply to Marijuana Event Organizer Licensees. Commissioners discussed potentially implementing bodycams and agreed to circle back on the topic.
- The Commission took a brief recess. (Returned at 03:09:14.)
- Paralegal Ferrara continued reading the redline amendments beginning with 935 Code Mass. Regs. § 500.141(6)(f). Regarding (j), the AC requested to strike "and

Marijuana Establishment Agents". Commissioners discussed whether it was necessary to permit the Executive Director (ED) to approve new consumption devices and agreed on a new (j) to read: "Notwithstanding 935 CMR 500.141(10)(e) and 935 CMR 500.105(1) the Social Consumption Establishment Licensee shall update its Standard Operating Procedures when utilizing new consumption technologies in its Indoor Smoking Consumption Areas in order to limit second-hand smoke or vapor." Paralegal Ferrara read 935 Code Mass. Regs § 500.141(7)(b) and Commissioners discussed how to ensure that disposal of joints at SCEs did not pose a fire hazard. The ED suggested including a reference to fire codes and DGC Baker volunteered to work offline with Commissioner Roy to work on language to address this topic. Additionally, he noted that he would be striking 935 Code Mass. Regs. 500.141(9)(d). Paralegal Ferrara continued reading 935 Code Mass. Regs. 500.141(10) and there were no requested edits until the AC requested to strike "and Agents" in section (c).

- The Commission took a brief recess. (Returned at 04:27:30.)
- Commissioners discussed the Personal Protective Equipment (PPE) referenced in 935 • Code Mass. Regs. § 500.141(10)(d) and Chief Jones volunteered to reach out to the Occupational Safety and Health Administration (OSHA) to develop new language. Paralegal Ferrara continued reading the redline amendments until 935 Code Mass. Regs. § 500.141(10)(e)5. where the AC requested to reformat 10(f) with a revised last sentence to read: "Combustion, heat, vaporization, and aerosolization of Marijuana or Marijuana Products in an Indoor Smoking Consumption Area may resume once the filtration system has been repaired and functioning properly and the Social Consumption Establishment shall provide notice to the Commission." EC Goodin suggested a separate amendment to clarify the notification requirements regarding filtration system failures and the AC suggested that DGC Baker work on new language offline. DGC Baker explained that the language in 935 Code Mass. Regs. § 500.141(11) had been pulled from the Department of Public Health's (DPH's) regulations regarding smoking tobacco outdoors and EC Goodin requested to strike "thorough" and "be presumed" in (a). DGC Baker suggested adding "or" after the semicolon in (11)(a)1, removing the "and" at the end of (11)(a)2, and changing (11)(a)3. to (11)(b) and there were no objections. Commissioner Roy asked how 935 Code Mass. Regs. § 500.141(11)(c) could be enforced and discussed the matter with staff. Commissioners agreed to circle back to the topic and Paralegal Ferrara completed reading (11) with no further requested edits. Regarding 935 Code Mass. Regs. § 500.145, DGC Baker explained that technical amendments had been made to allow Marijuana Couriers to purchase Marijuana and Marijuana Products from SCEs. Commissioners discussed and Commissioner Camargo requested a recess.

- The AC stated that the SCE working group's intent regarding the amendments in 935 Code Mass. arguments in Public Meeting were not provided for in the regulations. He explained that this matter started when a summary suspension order was issued regarding an unapproved change of control after which the Licensee requested a hearing. The recommendation was contained in the board book and Commissioners had the option to approve, modify or amend, reject or reverse, or to remand for further fact finding. GC Chattopadhyay clarified for Commissioner Roy that informal or formal rules were prescribed for certain scenarios while in others the parties could choose which set to follow.

- Commissioner Camargo moved to approve the Hearing Officer's recommended decision and direct the General Counsel the appropriate steps to finalize the decision.

- VII. Request for Equitable Relief 00:31:06
  - GC Chattopadhyay provided an overview of Deerfield Naturals, Inc.'s request for equitable relief. He explained that this was a collaborative effort between Legal and Enforcement and that this matter had been started after the Licensee had paid licensing fees, after which the municipality had informed them that they were no longer interested in acting as a Host Community (HC). Commissioner Roy requested a recess.
  - The Commission took a brief recess. (Returned at 01:04:50.)
  - Enforcement Counsel Timothy Goodin (EC Goodin) explained that, since the request • was initially made, Deerfield Naturals, Inc. had indicated that they were solely interested in the refund of their licensing fees. Commissioner Concepcion asked for clarification on whether the staff's recommendation had changed after receiving further information from the Licensee and EC Goodin explained the Commission's options had not changed, but that the Licensee likely wanted to no longer pursue licensure and the preference was simply being passed along. Commissioner Roy asked if the language in 935 Code Mass. Regs. § 500.050(1)(a) barred refunding License fees and if there was any mechanism to direct funds from the Marijuana Regulation Fund back to a Licensee. Chief Financial and Accounting Officer Lisa Schlegel (Chief Schlegel) confirmed that there was a Standard Operating Procedure (SOP) for refunding payments made in error. Commissioner Camargo suggested discussing the matter offline to develop policies and Commissioner Roy concurred. Executive Director (ED) Travis Ahern noted that the budget did not allow for a refund and Commissioner Camargo suggested reviewing the meetings where equitable relief was discussed. Commissioner Roy requested information if other agencies had been consulted when drafting the refund SOP and for a report on

potential financial impact. The AC and Commissioner Concepcion agreed with the suggestions and GC Chattopadhyay confirmed that there were no upcoming deadlines.

- Commissioner Camargo moved to table the request for equitable relief of Deerfield Naturals, Inc. until June 12<sup>th</sup>.

    - The AC stated that he was bringing this topic in light of the new Social Consumption Establishment (SCE) License types to ease the regulatory burden. His suggestion was to align 935 Code Mass. Regs. § 500.029(6) and 500.030(8), with the goal of not losing industry workers and to ease the transition of employees between Marijuana Establishments (MEs). The AC explained that considerations in updating Agent Registration were the timeline and background checks. Commissioner Concepcion explained that she had considered moving ownership of Agent Registrations to the Agents themselves so that they could take them to new MEs. Commissioner Roy asked for information on how other states had handled this issue and requested a report from the Government Affairs and Policy department. The AC proposed amending 935 Code Mass. Regs. § 500.029(6) and 500.030(8) and including the edits in the draft Social Consumption regulations. Additionally, he wanted to seek input from stakeholders and discuss who should be responsible for Registered Agent fees as well transitioning to digital cards and updating the Responsible Vendor Training (RVT) requirements. The ED noted that this would result in a decrease in revenue and Commissioner Roy suggested holding a public listening session.

  - 2. Job Description: Complaint Resolution Administrator and FY 2025/2026 Budgetary Impact
    - The ED explained that this position had arisen during discussions regarding establishing a centralized tipline for complaints. Chief People Officer Debra Hilton-Creek (CPO Hilton-Creek) explained that any applicants for this position would need in-depth knowledge of the Commission and the ED added that the position would be housed in the Investigations and Enforcement department to ensure redundancy. He added that centralizing external calls would make the process more efficient and potentially generate fines and revenue. He further recommended posting the job description internally, evaluating the position's impact after it had been filled and to institute a hiring freeze. Commissioner Roy requested a minor grammatical edit and

suggested issuing a press release announcing the hiring freeze. The ED explained that the position would be insulated from conflicts of interest by routing Human Resources (HR) complaints directly to HR rather than their supervisor. He clarified that all jobs which were posted which would be unaffected by the hiring freeze, but backfilling internal applicants would not be possible.

He described how he had tried to streamline the document by excising sections which were better described in SOPs and narrow its focus by addressing how Commissioners effectively utilize organizational resources. He began reviewing the document beginning with No. 1(e)(vi) under Roles and Responsibilities, where he noted that Commissioner's authority to approve job descriptions related more to the budget implications rather than the description itself. Commissioners discussed and Commissioner Roy suggested potentially using the language from G.L. c. 10, § 76 (j),

although the ED noted he was voicing his thoughts and not necessarily suggesting an edit. Regarding No. 2(a), he noted a minor edit striking "all" to clarify the responsibilities of the Chair and ED. Regarding No. 2(f), Commissioner Roy expressed concern that the ability of Commissioners to elect an Acting Chair if the Chair was removed or suspended overrode the enabling statute. Commissioners discussed and the ED continued to the rest of his edits under No. 3(c)(ii) to clarify that review meetings involving the Treasurer and Chief Financial Accounting Officer (CFAO) would occur through the ED and under No. 5(f) where more detail was provided regarding the timeline on which the ED would be responsible for alerting Commissioners of urgent public health matters. Regarding No. 6 under the Interactions Between and Among Commissioners, Executive Director, and Staff section, the ED explained his edits to make it clearer that requests for staff and Commissioners time to prepare for a Public Meeting would go through the ED. Continuing to No. 8, he explained an edit to indicate that not all project charters may include Commissioners and an addition to the end of No. 13 to indicate that Commissioners would attend annual Open Meeting Law (OML) trainings. The ED concluded his review in the Accountability, Checks and Balances section where he had edited Nos. 4 and 5 so that the process of reporting complaints regarding a Commissioner or the ED to their reporting authorities was mirrored.

- The AC brought the conversation back through the edits and Commissioners agreed to leave "all" in No. 2(a) under Roles and Responsibilities, to edit footnote eight to cite G.L. c. 94G, § 4(a)(i) and there were no objections to the remainder of the ED's edits. Commissioner Roy suggested that statutory amendments were necessary to address issues within the Commission. She asked why the Charter had been discussed in Executive Session and read into the record a determination from the Office of the Attorney General's Division of Open Government which found that Executive Session had been used improperly on April 24, 2023. She explained her position that she would not vote affirmatively to ratify the Charter. GC Chattopadhyay noted that recordings of those Executive Session had been made public and that every effort had been made to redact them as minimally as possible. Commissioners thanked the ED for his work familiarizing himself with the document and his edits and he confirmed that he had received no objections regarding the Charter from the appointing authorities.
- Commissioner Camargo moved to approve the Governance Charter as amended subject to ministerial edits.
- Commissioner Concepcion seconded the motion.







### **Tier Relegations in Massachusetts**

<u>Tier Relegation</u>. The Commission may reduce the Licensee's maximum Canopy to a lower tier if the Licensee sold less than 70% of what it produced during the six months prior to the application for renewal for an indoor cultivator or during the harvest season prior to the application for renewal for an outdoor cultivator.

<u>**Tier Factors**</u>. When determining whether to allow expansion or relegate a Licensee to a different tier, the Commission may consider factors including, but not limited to:

1. Cultivation and production history, including whether the plants/inventory suffered a catastrophic event during the licensing period;

- 2. Transfer, sales, and excise tax payment history;
- 3. Existing inventory and inventory history;
- 4. Sales contracts; and

5. Any other factors relevant to ensuring responsible cultivation, production, and inventory management.

#### **California**

<u>Upon Renewal</u> – The Department shall allow a Licensee to change to a different cultivation license type with a maximum canopy size smaller than the Licensee's original cultivation license type. Provisional Licensees may apply for smaller license type at election of Licensee.

<u>One-time Change</u> - CA additionally allows Licensees to request a reduced-sized cultivation license when making a <u>one-time change</u> to the license's expiration date outside of the renewal process. If approved, the reduced-sized cultivation license **must remain at the reduced-size for the duration of the license term and utilize same type of lighting as the original cultivation license.** 

#### **Colorado**

<u>**Upon Renewal**</u> – Licensees may voluntarily decrease their cultivation tier (total plant count). CO Data Team runs automated scripts within three (3) months of renewal.

#### **Factors Considered:**

1. The Licensee has **sold less than 70% of the Licensee's inventory** reported as packaged in the seed-to-sale Tracking system during any 180-day period;

2. On average during the previous 180 days, that the Licensee **actually cultivated less than 90% of the maximum number of plants** authorized by the next lower production management tier;

3. Whether the Licensee's plants/inventory suffered a catastrophic event during the review period;

4. Licensee's excise tax payment history;

5. Licensee's existing inventory and inventory history; and

6. Licensee's sales' contracts including wholesale records for the previous two (2) quarters and cultivation records for the previous 180 days.

7. Any other factors relevant to ensuring responsible cultivation, production and inventory management (how the cultivation, production and inventories are being operated). Catch-all provision which provides flexibility when assessing and making determinations, i.e. -a Licensee is having issues maintaining sanitary conditions due to the number of plants the Licensee currently has.

#### **Connecticut**

CT largely avoided Tier Relegations and let the Licensees indicate themselves the appropriate tier level. Encountered challenges with quantifying tier relegations and focus instead on security of the overall cultivation facility.

#### **Factors Considered:**

Evidence that holder's licensed cultivation facility **contains at least 5,000 sq. ft.** of grow space

Evidence that such holder has a detailed business plan and buildout schedule to cultivate, grow and propagate cannabis at a licensed establishment containing **at least 15,000 sq. ft.** of grow space on or before December 31, 2025.

If a cultivator with a final license fails to cultivate, grow and propagate cannabis at an establishment containing at least 15,000 sq. ft. of grow space on or before December 31, 2025,  $\rightarrow$  Licensee must pay a \$500 extension fee every day the establishment doesn't satisfy requirement.

#### <u>Illinois</u>

The Department of Agriculture may authorize a **decrease** of flowering stage cultivation space in increments of 3,000 sq. ft. by rule **based on market need, craft grower capacity, and the licensee's history of compliance or noncompliance**, with a maximum space of 14,000 sq. ft. for cultivating plants in the flowering stage, which must be cultivated in all stages of growth in an enclosed and secure area.

The Department **may decrease** a craft grower's canopy space by 3,000 sq. ft. if the craft grower **has sold** less than 50% of its packaged product consistently over the previous two (2) fiscal quarters preceding the notice to decrease canopy space.

The Department shall not decrease a craft grower's canopy space more than once in any twelve-month period.

The Department may not reduce a craft grower's canopy space below 5,000 sq. ft.

#### **Maine**

**<u>Upon Renewal</u>** – Licensee may submit request for a tier reduction.

#### **Factors Considered:**

The Licensee has **over the current period** (**up to 2 years**) **of licensure sold/transferred at least 85%** of the cannabis cultivated by the Licensee.

If the office determined that the Licensee has failed to satisfy requirements for the applied-for tier, the office shall consider renewing the license at the current tier.

#### <u>Montana</u>

Regulations are mostly silent on tier relegation criteria.

<u>Licensing Limitation</u> - A marijuana business that has not been issued a license before July 1, 2025, **must be initially licensed at a Tier 2 canopy license or lower**.

#### **New Jersey**

A cannabis cultivator applying for a conditional or annual standard cannabis business license **may choose its tier in its application and shall include an explanation** of the anticipated demand for its products that justify such tier choice.

#### New York

<u>Upon renewal</u> – Cultivator can request tier/canopy reduction. Any change to the type of cultivation and or canopy tier requires application to the Office and prior written approval.

<u>Factors Considered</u> - Licensee has to demonstrate that it is in good standing and has sold/transferred at least 80% of its total canopy.

(1) cultivation **canopy utilization rates** and **harvested product sale history** over a minimum period of the **previous twelve (12) months** 

Licensee has to demonstrate that it is in good standing and has sold/transferred at **least 80% of its total canopy during this time frame**;

(2) whether the licensee's plants or inventory suffered a catastrophic event during the licensing period;

#### (3) cannabis transfers and sales history;

(4) existing inventory and a licensee's inventory history;

(5) adherence to any plan required pursuant to this Title, including, but not limited to, the licensee's operating plan, energy and environmental plan, and community impact plan;

(6) the criteria set forth in subdivision (b) of section 120.7 of this Part (Application Eligibility and Evaluation); and

(7) any other factors determined by the Board (catch-all provision).

#### **Rhode Island**

Any request to expand or modify the premises, scope or scale of approved and/or licensed activity **further requires explanation by the cultivator that the request to expand is justified by the projected needs of qualifying patients.** The licensed cultivator must seek pre-approval from DBR by means of requesting a variance.

#### <u>Vermont</u>

A Licensee may apply to change to a different tier within their license type at any time by filing a renewal application. Upon renewal, the licensee must pay the associated fees.

September 25, 2024 – Cannabis Control Board voted to temporarily close the window for new retail and Tier 2 cultivation operations.

Due to seasonal closure, seasonal oversupply shock with the arrival of the 2024 outdoor crop and concerns regarding oversaturation.

October 25, 2024 – application deadline for new Tier 2 indoor operations.

Tier 1 applications will remain open as part of the CCB's effort to preserve the small-scale, craft nature of the market. Larger tiers will all remain closed to new applications while the Board and policymakers **evaluate data and consider strategies for better production management and improved market access** for smaller operators.

Tiers 3-5 were previously closed to new applications by the Board. All outdoor and mixed cultivation licenses are currently in seasonal closure.

### **Overall Takeaways**

- Few other jurisdictions have maximum tiers/canopies levels comparable with Massachusetts (New York, Illinois). Most other jurisdictions' highest available tier/canopy is lower than Massachusetts.
- Some jurisdictions designate the maximum number of cannabis plants allowable, rather than designating specific tiers/canopies based on square footage (California partially), Colorado, Michigan)
- Most jurisdictions allow consideration of tier relegations at the time of license renewal.
  - California allows a one-time change to size of cultivation outside of initial renewal period.

### **Overall Takeaways**

- Some jurisdictions have "catch-all" provisions that allow the regulating agency flexibility when determining other factors to consider (Massachusetts, New York, Colorado).
- Other jurisdictions have taken a more conservative approach either through:
  - Limiting total canopy of highest tier available
  - Indicating/limiting which tier Licensees may be initially licensed as (Montana)
  - Pausing/halting acceptance of applications for new cultivation Licensees/operations (Vermont)
- Other jurisdictions' regulations appear to be more prescriptive regarding Licensees increasing tier/canopy size than relegating/reducing. Many of the same factors are considered however (sales/transfer history, market need, etc.)

#### **Current Policy**

• Non-cannabis, shelf-stable food products are not permitted to be sold in retail Marijuana Establishments. This is a policy carried over from the original Commissioners.



#### **Other Jurisdictions**

- **California**: Generally, dispensaries can sell non-cannabis items, but they must comply with local health and safety regulations.
- **Colorado:** They are often more lenient, allowing such sales, but still require compliance with health code requirements. In areas allowing on-site consumption, those without a license to prepare food can serve hot beverages, pastries, and prepackaged food.
- **Oregon:** Similar to California, dispensaries can sell non-cannabis items, through local jurisdictions may have additional rules.
- **Illinois:** In localities that permit on-site consumption, prepackaged food may be served, but it cannot be prepared on-site.

#### **Massachusetts Draft Regulations**

- In areas with licensed cannabis consumption sites, only pre-packaged and shelf-stable food and drink are allowed to be sold.
  - a) Sale of Shelf-stable Products. A Social Consumption Establishment shall sell food and drink items that are pre-packaged and Shelf-stable, other than Edibles, and seek all licenses and permits to do so. A Social Consumption Establishment shall not sell alcohol or tobacco products.
  - b) Opportunity for alignment for retail MEs with Social Consumption DRAFT regulations
  - c) Policy consideration and decision

#### **Massachusetts Draft Regulations**

- Currently there are a number of retail MEs attempting to sell non-cannabis shelfstable food items. I&E would like the Board to provide clarity. Commission laws and regulations neither explicitly allow nor prohibit MEs from selling noncannabis, shelf-stable food products.
- 500.140(5)(g) A retailer shall adopt separate accounting practices at the point of sale for Marijuana and Marijuana Product sales, and non-Marijuana sales.



#### **Proposed Motion Language**

"Move that staff be instructed to integrate regulatory language that would permit retail MEs the ability to sell non-infused food and drink items that are pre-packaged and Shelf-stable during the Commission's next regulatory submission. Regulatory language shall require MEs to seek all licenses and permits to do so and adopt separate accounting practices at the point of sale for non-marijuana sales."







Demographics of Approved and Pending Medical Marijuana Treatment Center Agents






