

# **OPERATING AGREEMENT OF**

# TEN-TEN LLC

THIS OPERATING AGREEMENT is made and entered into as of September 21, 2018 by and among Ten-Ten LLC (the "Company") and the Member(s) signing below.

# ARTICLE I DEFINITIONS

The following terms used in this Operating Agreement shall have the following meanings:

"Articles of Organization" shall mean the Articles of Organization of the Company as filed with the Secretary of Commonwealth of Massachusetts, as amended from time to time.

"Capital Contribution" shall mean any contribution to the capital of the Company in cash or property by the Member(s) whenever made.

"Cash Flow" shall mean the gross cash proceeds from the operation of the Company's business less the portion thereof used to establish Reserves for or to pay Company expenses, debt payments and capital expenditures. "Cash Flow" shall include any net cash proceeds from the sale or disposition of Company property and from the refinancing of indebtedness of the Company, shall be increased by any reduction of Reserves previously established by the Member(s), and shall not be reduced by depreciation, cost recovery, amortization or similar non-cash deductions.

"Company" shall refer to Ten-Ten LLC

"Entity" shall mean any general partnership, limited partnership, limited liability partnership, limited liability company, corporation, joint venture, trust, business trust, cooperative, association, foreign trust, foreign business organization or other business entity.

"Fiscal Year" shall mean the period terminating on December 31 of each year during the term hereof.

"Initial Capital Contribution" shall mean the initial contribution to the capital of the Company pursuant to Paragraph 7.01 of this Operating Agreement.

"Limited Liability Company Law" shall mean the Massachusetts Limited Liability Company Law, as amended from time to time.

"Manager" has the meaning ascribed to such term in Paragraph 4.01 of this Operating Agreement.

"Member" shall mean the Person who has executed a counterpart of this Operating Agreement as a Member and any Person who may hereafter become a member of the Company.

"Net Profits" and "Net Losses" shall mean the income, gain, loss, deductions and credits of the Company in the aggregate or separately stated, as appropriate, as of the close of each Fiscal Year.

"Operating Agreement" shall mean this Operating Agreement as originally executed and as amended from time to time.

"Person" shall mean any individual or Entity, and the heirs, executors, administrators, legal representatives, successors and assigns of such "Person," where the context so permits.

"Representative" shall mean the legally appointed guardian of a mentally incapacitated Member, the conservator of a mentally incapacitated Member's assets or the legally appointed and qualified executor or personal representative of the estate of a deceased Member. In the event no such guardian, executor or personal representative is appointed, then the Representative shall mean the spouse of such incapacitated or deceased Member, or if such Member does not have a spouse or the spouse is not then living or is unable or unwilling to act, such Member's then living lineal descendants who are willing and capable of acting, one at a time in descending order of age but in no event younger than 21 years of age or, if none, such Member's then-living lineal ancestors who are willing and capable of acting, one at a time and in ascending order of age.

"Reserves" shall mean funds set aside or amounts allocated to reserves which shall be maintained in amounts deemed sufficient by the Manager for working capital and to pay taxes, insurance, debt service or other costs or expenses incident to the ownership or operation of the Company's business.

# ARTICLE II FORMATION OF COMPANY

- **2.01 Formation**. The Company shall be, or has been, organized as a Massachusetts State limited liability company by executing and delivering Articles of Organization to the Massachusetts Secretary of the Commonwealth in accordance with and pursuant to the Limited Liability Company Law.
  - 2.02 Name. The name of the Company is "Ten-Ten LLC."
- **2.03 Principal Place of Business**. The principal place of business of the Company is 775 N. Main Street, Sheffield, MA 01257. The Company may locate its places of business and registered office at any other place or places as the Manager may deem advisable.
- 2.04 Registered Office and Registered Agent. The Company's initial registered office shall be at the office of its registered agent as contained in the Articles of Organization and the name of its initial registered agent shall be as contained in the Articles. The registered office and registered agent may be changed by the Manager by filing the address of the new registered office and/or the name of the new registered agent with the Massachusetts Secretary of the Commonwealth pursuant to the Limited Liability Company Law.

**2.05** Term. The term of the Company shall be perpetual, unless the Company is earlier dissolved in accordance with either the provisions of this Operating Agreement or the Limited Liability Company Law.

# ARTICLE III BUSINESS OF COMPANY

3.01 Purpose. The business of the Company shall be to conduct any lawful business whatsoever that may be conducted by limited liability companies pursuant to the Limited Liability Company Law.

# ARTICLE IV MANAGEMENT OF THE COMPANY

- 4.01 Management of Company. The management of the Company shall be vested solely in a Manager selected by the Member(s) (the "Manager"). The Manager shall have the exclusive power and authority on behalf and in the name of the Company to carry out the purposes of the Company to perform all acts and enter into and perform all contracts and other undertakings which it may deem necessary or advisable in connection therewith and to take any and all actions not inconsistent with the limitations contained in this Agreement necessary to operate the business of the Company. The initial Manager of the Company shall be Scot Trifilo. The initial Manager shall serve until resignation, incapacity or death. In the event of resignation, the Manager shall select the successor Manager. In the event of death, the remaining Members or, if there are none, the estate administrator of Mr. Trifilo's estate shall select a successor. In the event of incapacity, the other Members, if any, shall select a successor Manager or, if there are no other Members, Mr. Trifilo's attorney shall select a successor Manager, and in any case such successor Manager shall serve until such time as the initial Manager is no longer incapacitated. The term "incapacity" shall mean that the Manager is unavailable or unable to perform their duties due to health reasons for a period of time in excess of thirty (30) or more calendar days.
- **4.02** Removal. The Manager may be removed as Manager at any time, with or without cause, by an affirmative vote of the Member(s), but no such removal shall affect the contract and/or ownership rights, if any, of the Person so removed.
- 4.03 Compensation and Reimbursement of Expenses. The Company shall reimburse the Manager for all ordinary, necessary and direct expenses incurred by the Manager on behalf of the Company in carrying out the Company's business activities. The Manager shall not receive compensation for its services unless approved by the Members.
- **4.04** Execution of Documents. Any document or instrument of any and every nature, including without limitation, any agreement, contract, deed, promissory note, mortgage or deed of trust, security agreement, financing statement, pledge, assignment, bill of sale and certificate, which is intended to bind the Company or convey or encumber title to its real or personal property shall be valid and binding for all purposes only if executed by the Manager.
- 4.05 Action without Meeting. Any action required to be taken by or on behalf of the Company may be taken without a meeting if a consent, in writing, setting forth the action so

taken, shall be signed by the Manager and the Member(s) holding a majority of the membership interests.

- **4.06 Officers**. The Manager may from time to time appoint officers of the Company and assign in writing titles of such individuals. The officers shall exercise such powers and perform such duties as are prescribed by the Manager. Any number of offices may be held by the same person, as the Manager may determine.
- **4.07** Term of Office. The officers shall hold office for the term for which they were appointed and until their successors are elected and qualified; provided, however, that any officer may be removed at any time with or without cause by the Manager.
- **4.08** Limitation on Liability. The Manager will not be personally liable for any obligations, liabilities, debts or losses of the Company, whether arising in tort, contract or otherwise, except as otherwise required by law. The Manager and shall be entitled to indemnification by the Company as provided in this Article V.
- 4.09 Standard of Care. No Manager shall be liable to the Company or to any Member for any loss or damage sustained by the Company or any Member except loss or damage resulting from intentional misconduct or knowing violation of law or a transaction for which such Manager received a personal benefit in violation or breach of the provisions of this Operating Agreement. The Manager shall be entitled to rely on information, opinions, reports or statements, including but not limited to financial statements or other financial data prepared or presented by: (a) any one or more Members, officers or employees of the Company whom the Manager reasonably believes to be reliable and competent in the matter presented, (b) legal counsel, public accountants, or other persons as to matters the Manager reasonably believes are within the Person's professional or expert competence, or (c) a committee which the Manager is not a member, and if the Manager reasonably believes the committee merits confidence.
- 4.10 Manager Has No Exclusive Duty to Company. The Manager shall not be required to manage the Company as the Manager's sole and exclusive function, and the Manager may have other business interests and may engage in other activities in addition to those relating to the Company as long as Manager discharges its duties under this Operating Agreement in a professional and diligent manner, and such activities do not compete, directly or indirectly, with the Company. Neither the Company nor any Member shall have any right, by virtue of this Operating Agreement, to share or participate in such other investments or activities of the Manager or to the income or proceeds derived therefrom. The Manager shall incur no liability to the Company or to the Member(s) as a result of engaging in any other business or ventures.

# ARTICLE V ADDITIONAL RIGHTS AND OBLIGATIONS

5.01 Right to Indemnification. Subject to the limitations and conditions provided in this Article V and in the Limited Liability Company Law, each Person ("Indemnified Person") who was or is made a party or is threatened to be made a party to or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative, arbitrative or investigative ("Proceeding"), or any appeal in such a Proceeding or any inquiry or

investigation that could lead to such a Proceeding, by reason of the fact that she or he was or is a Manager, a Member, or an officer of the Company or she or he was or is the legal representative of or a manager, director, officer, partner, venturer, proprietor, trustee, employee, agent or similar functionary of a Member or of an officer of the Company, shall be indemnified by the Company against judgments, penalties (including excise and similar taxes and punitive damages), fines, settlements and reasonable costs and expenses (including, without limitation, attorneys' fees) actually incurred by such Indemnified Person in connection with such Proceeding if such Indemnified Person acted in good faith and in a manner she or he reasonably believed to be in, or not opposed to, the best interest of the Company and, with respect to any criminal action or proceeding, had no reasonable cause to believe her or his conduct was unlawful. The termination of any action, suit or proceeding by judgment, order, settlement, conviction, or upon a plea of nolo contendere or its equivalent, shall not, of itself, create a presumption that the Indemnified Person did not act in good faith and in a manner which she or he reasonably believed to be in or not opposed to the best interests of the Company or, with respect to any criminal action or proceeding, that the Indemnified Person had reasonable cause to believe that her or his conduct was unlawful.

- 5.02 Survival. Indemnification under this Article V shall continue as to a Person who has ceased to serve in the capacity which initially entitled such Person to indemnity hereunder. The rights granted pursuant to this Article V shall be deemed contract rights, and no amendment, modification or repeal of this Article V shall have the effect of limiting or denying any such rights with respect to actions taken or Proceedings arising prior to any such amendment, modification or repeal.
- 5.03 Advance Payment. The right to indemnification conferred by this Article V shall include the right to be paid or reimbursed by the Company for the reasonable expenses incurred in advance of the final disposition of the Proceeding and without any determination as to the Indemnified Person's ultimate entitlement to indemnification; provided, however, that the payment of such expenses incurred in advance of the final disposition of a Proceeding shall be made only upon delivery to the Company of a written affirmation by such Indemnified Person of her or his good faith belief that she or he has met the standard of conduct necessary for indemnification under this Article V and a written undertaking, by or on behalf of such Indemnified Person, to repay all amounts so advanced if it shall ultimately be determined that such Indemnified Person is not entitled to be indemnified under this Article V or otherwise.
- 5.04 Nonexclusivity of Rights. The right to indemnification and the advancement and payment of expenses conferred by this Article V shall not be exclusive of any other right which a Person may have or hereafter acquire under any law (common or statutory), provision of the Articles of Organization or Operating Agreement, agreements, vote of members or otherwise.
- 5.05 Savings Clause. If Paragraph 5.01 or any portion thereof shall be invalidated on any ground by any court of competent jurisdiction, then the Company shall nevertheless indemnify and hold harmless each Indemnified Person as to costs, charges and expenses (including attorneys' fees), judgments, fines and amounts paid in settlement with respect to any action, suit or proceeding, whether civil, criminal, administrative or investigative to the full extent permitted by any applicable portion of this Article V that shall not have been invalidated and to the fullest extent permitted by applicable law.

# ARTICLE VI MEMBERS

- **6.01 Members.** Scot Trifilo is the initial sole Member of the Company. Exhibit A attached hereto shall list all Members of the Company and shall be amended as needed to update the Members. A Member's membership Interest may be transferred, sold or assigned with the written approval of the Manager. The Company may create more than one class of membership interests and/or options for membership interests, upon the approval of the Member(s) and the Manager.
- **6.02** Transferees Bound. Any transferee of a membership interest in the Company shall be bound by all of the terms and restrictions of this Operating Agreement.
- **6.03 Limitation of Liability.** No Member or agent of the Company (nor any Person acting in one or more of those capacities) shall be liable for any debts, obligations or liabilities of the Company or each other, whether arising in tort, contract or otherwise, solely by reason of being such a Member or agent or acting (or omitting to act) in such capacities or participating (as an employee, consultant, contractor or otherwise) in the conduct of the business of the Company.
- **6.04** Indemnification. The Company shall indemnify and hold harmless each Member from and against all claims and demands to the maximum extent permitted under the Limited Liability Company Law.
- 6.05 Annual Meetings. Meetings of the Members shall be held annually in the month of January. Meetings of Members may be held at the principal place of business of the Company or such place or places, within or without the State of Massachusetts, as shall be determined by a majority of the Membership Interests and stated in the notice thereof. Members of the Company may participate in a meeting by means of conference telephone or similar communications equipment by means of which all persons participating in the meeting can hear each other, and such participation shall constitute presence in person at such meeting.
- 6.06 Special Meetings. A meeting of the Members for any purpose or purposes may be called at any time upon the written request of a majority of the Membership Interests entitled to vote at such meeting. Notice of such meeting shall be sent to all Members. Such notice shall state the purpose for which such meeting is to be called, the day, time, location and telephone or video conference number for attendance.
- 6.07 Quorum. Members holding not less than a majority of all Membership Interests, represented in person or by proxy, shall constitute a quorum at any meeting of Members. In the absence of a quorum at any meeting of Members, a majority of the Membership Interests so represented may adjourn the meeting from time to time for a period not to exceed sixty days without further notice. However, if the adjournment is for more than 60 days, or if after the adjournment a new record date is fixed for the adjourned meeting, a notice of the adjourned meeting shall be given to each Member of record entitled to vote at such meeting. At an adjourned meeting at which a quorum shall be present or represented, any business may be transacted that might have been transacted at the meeting as originally noticed. The Members present at a meeting may continue to transact business until adjournment, notwithstanding the

withdrawal during the meeting of Membership Interests whose absence results in less than a quorum being present.

- **6.08** Manner of Acting. If a quorum is present at any meeting, the vote or written consent of Members holding not less than a majority of Membership Interests shall be the act of the Members, unless the vote of a greater or lesser proportion or number is otherwise required by the Limited Liability Company Law, the Articles of Organization or this Agreement.
- 6.09 Voting, Actions by Written Consent. Any action required or permitted to be taken at a meeting of Members may be taken without meeting, without prior notice and without vote, if a consent in writing, setting for the action so taken, shall be signed by all Members.

# ARTICLE VII CONTRIBUTIONS TO THE COMPANY

- 10.06 Heirs, Successors and Assigns. Each and all of the covenants, terms, provisions and agreements herein contained shall be binding upon and inure to the benefit of the parties hereto and their respective heirs, legal representatives, successors and assigns.
- 10.07 Creditors. None of the provisions of this Operating Agreement shall be for the benefit of or enforceable by any creditors of the Company or of the Member(s).

TEN-TEN LLC ("TEN-TEN") has developed marijuana and marijuana product quality control processes, product safety plans and testing procedures to ensure that TEN-TEN is compliant with all regulatory and legal requirements, including, but not limited to 935 CMR 500.101(1)(c), sanitary practices in compliance with 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements, 105 CMR 590.000: State Sanitary Code Chapter X – Minimum Sanitation Standards for Food Establishments, 310 CMR 7.00: Air Pollution Control, M.G.L. c. 94G, §  $4(a\frac{1}{2})(xxvi)$ , 935 CMR 500.105, 935 CMR 500.130, 935 CMR 500.160, and 21 CFR 1.908(c) and that protect the safety of our customers, our surrounding community and our employees.

Pursuant to 935 CMR 500.105(3), TEN-TEN has developed the following requirements for the handling of marijuana:

TEN-TEN shall process marijuana in a safe and sanitary manner. TEN-TEN shall process the leaves and flowers of the female marijuana plant only, which shall be:

- 1. Well cured and free of seeds and stems;
- 2. Free of dirt, sand, debris, and other foreign matter;
- 3. Free of contamination by mold, rot, other fungus, pests and bacterial diseases and satisfying the sanitation requirements in 105 CMR 500.000: Good Manufacturing Practices for Food, and if applicable, 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments;
- 4. Prepared and handled on food-grade stainless steel tables with no contact with bare hands; and
- 5. Packaged in a secure area.

TEN-TEN shall also comply with the following sanitary requirements:

- Any marijuana establishment agent whose job includes contact with marijuana or non-edible marijuana products, including cultivation, production, or packaging, is subject to the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements;
- 2. Any marijuana establishment agent working in direct contact with preparation of marijuana or non-edible marijuana products shall conform to sanitary practices while on duty, including:
  - a. Maintaining adequate personal cleanliness; and
  - b. Washing hands thoroughly in an adequate hand-washing area before starting work, and at any other time when hands may have become soiled or contaminated.
- 3. Hand-washing facilities shall be adequate and convenient and shall be furnished with running water at a suitable temperature. Hand-washing facilities shall be located in TEN-TEN's

- production areas and where good sanitary practices require employees to wash and sanitize their hands, and shall provide effective hand-cleaning and sanitizing preparations and sanitary towel service or suitable drying devices;
- 4. There shall be sufficient space for placement of equipment and storage of materials as is necessary for the maintenance of sanitary operations;
- 5. Litter and waste shall be properly removed, disposed of so as to minimize the development of odor and minimize the potential for the waste attracting and harboring pests. The operating systems for waste disposal shall be maintained in an adequate manner pursuant to 935 CMR 500.105(12);
- 6. Floors, walls, and ceilings shall be constructed in such a manner that they may be adequately kept clean and in good repair;
- 7. There shall be adequate safety lighting in all processing and storage areas, as well as areas where equipment or utensils are cleaned;
- 8. Buildings, fixtures, and other physical facilities shall be maintained in a sanitary condition;
- 9. All contact surfaces, including utensils and equipment, shall be maintained in a clean and sanitary condition. Such surfaces shall be cleaned and sanitized as frequently as necessary to protect against contamination, using a sanitizing agent registered by the US Environmental Protection Agency (EPA), in accordance with labeled instructions. Equipment and utensils shall be so designed and of such material and workmanship as to be adequately cleanable;
- 10.All toxic items shall be identified, held, and stored in a manner that protects against contamination of marijuana products. Toxic items shall not be stored in an area containing products used in the cultivation of marijuana. The Commission may require TEN-TEN to demonstrate the intended and actual use of any toxic items found on the premises;
- 11.TEN-TEN's public water supply shall be sufficient for necessary operations;
- 12.Plumbing shall be of adequate size and design, and adequately installed and maintained to carry sufficient quantities of water to required locations throughout TEN-TEN's facilities. TEN-TEN's plumbing shall properly convey sewage and liquid disposable waste. There shall be no cross-connections between the potable and wastewater lines;
- 13.TEN-TEN shall provide its employees with adequate, readily accessible toilet facilities that are maintained in a sanitary condition and in good repair;
- 14.Products that can support the rapid growth of undesirable microorganisms shall be stored in a manner that prevents the growth of these microorganisms;
- 15. Storage and transportation of finished products shall be under conditions that will protect them against physical, chemical, and microbial contamination as well as against deterioration of finished products or their containers; and
- 16.All vehicles and transportation equipment used in the transportation of marijuana and marijuana products or edibles requiring temperature control for safety must be designed, maintained, and equipped as necessary to provide adequate temperature control to prevent the

marijuana, marijuana products or edibles from becoming unsafe during transportation, consistent with applicable requirements pursuant to 21 CFR 1.908(c).

In addition to the general operational requirements for TEN-TEN required under 935 CMR 500.105, pursuant to 935 CMR 500.130, TEN-TEN has developed the following additional requirements for the handling of marijuana products:

- 1. TEN-TEN's production of edible marijuana products shall take place in compliance with the following:
  - a. All edible marijuana products shall be prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments, and with the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements; and
  - b. Any Marijuana Product that is made to resemble a typical food or beverage product must be packaged and labelled as required by 935 CMR 500.105(5) and (6).
- 2. TEN-TEN shall meet all applicable environmental laws, regulations, permits and other applicable approvals including, but not limited to, those related to water quality and quantity, wastewater, solid and hazardous waste management and air pollution control, including prevention of odor and noise pursuant to 310 CMR 7.00: Air Pollution Control, and use additional best management practices as determined by the Commission in consultation with the working group established under St. 2017, c. 55, § 78(b) or applicable departments or divisions of the EOEEA to reduce energy and water usage, engage in energy conservation and mitigate other environmental impacts.
- 3. TEN-TEN, when selling or otherwise transferring marijuana and marijuana products to another marijuana establishment, shall provide documentation of its compliance, or lack thereof, with the testing requirements of 935 CMR 500.160, and the standards established by the Commission for the conditions, including time and temperature controls, necessary to protect marijuana and marijuana products against physical, chemical, and microbial contamination, as well as against deterioration of finished products during storage and transportation.
- 4. In addition to the written operating policies required under 935 CMR 500.105(1), TEN-TEN shall maintain written policies and procedures for the production and/or distribution of marijuana and marijuana products, as applicable, which shall include, but not be limited to:
  - a. Methods for identifying, recording, and reporting diversion, theft, or loss, and for correcting all errors and inaccuracies in inventories. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(8);
  - b. Policies and procedures for handling voluntary and mandatory recalls of marijuana and/or marijuana products. Such procedures shall be adequate to deal with recalls due

- to any action initiated at the request or order of the Commission, and any voluntary action by TEN-TEN to remove defective or potentially defective marijuana and/or marijuana products from the market, as well as any action undertaken to promote public health and safety;
- c. Policies and procedures for ensuring that any outdated, damaged, deteriorated, mislabeled, or contaminated marijuana and/or marijuana products are segregated from other product and destroyed. Such procedures shall provide for written documentation of the disposition of the marijuana and/or marijuana products. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(12);
- d. Policies and procedures for transportation. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(13);
- e. Policies and procedures to reduce energy and water usage, engage in energy conservation and mitigate other environmental impacts. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(15);
- f. Policies and procedures for the transfer, acquisition, or sale of marijuana and/or marijuana products between marijuana establishments;
- g. Policies and procedures to ensure that all edible marijuana products are prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments, and with the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements; and
- h. Policies and procedures for maintaining a product catalog identifying all types of marijuana products actively manufactured at the facility. The catalog shall include a description of the product, photograph or illustration, packaging design, and dosage amounts, including expected cannabinoid profile.
- 5. Notwithstanding a stricter municipal or state regulation, TEN-TEN shall identify the method of extraction (e.g., Butane, Propane, CO2) on a physical posting at all entrances. The posting shall be a minimum of 12" x 12" and identify the method of extraction in lettering no smaller than one inch in height. TEN-TEN shall also post a copy of a permit to keep, store, handle or otherwise use flammable and combustible gasses at each place of keeping, storing, handling or using such gasses within the facility.
- 6. Production of edible marijuana products shall take place in compliance with the following:
  - a. Any edible marijuana product that is made to resemble a typical food or beverage product must be packaged and labeled as required by M.G.L. c. 94G, § 4(a½)(xxvi), and 935 CMR 500.105(5) and (6).
  - b. The manufacture or sale of edibles in the following shapes and types is prohibited:
    - 1. The distinct shape of a human, animal, or fruit; or

- 2. A shape that bears the likeness or contains characteristics of a realistic or fictional human, animal, or fruit, including artistic, caricature, or cartoon renderings.
- c. Edible marijuana products that are geometric shapes and simply fruit-flavored are not considered fruit and are permissible.
- 7. Sanitary Requirements: All edible marijuana products shall be prepared, handled, and stored in compliance with the requirements in 935 CMR 500.105(3) and 935 CMR 500.105(11).
- 8. Additional labeling and packaging requirements for edible marijuana products:
  - a. In addition to the requirements set forth in M.G.L. c. 94G, § 4(a½)(xxvi), and 935 CMR 500.105(5) and (6), TEN-TEN shall ensure that the following information or statement is affixed to every container holding an edible earijuana product:
    - 1. If the retail edible marijuana product is perishable or time and temperature controlled, a statement that the edible marijuana product must be refrigerated.
    - 2. The date on which the edible marijuana product was produced.
    - 3. A nutritional fact panel that must be based on the number of THC servings within the container.
    - 4. Information regarding the size of each serving for the product by milligrams, the total number of servings of marijuana in the product, and the total amount of active THC in the product by milligrams (mgs). For example: "The serving size of active THC in this product is X mg(s), this product contains Y servings of marijuana, and the total amount of active THC in this product is (X\*Y) mg(s)."
    - 5. A warning that the impairment effects of edible marijuana may be delayed by two hours or more.
- 9. Once a label with a use-by date has been affixed to a container holding an edible marijuana product, TEN-TEN shall not alter that date or affix a new label with a later use-by date.
- 10.TEN-TEN shall ensure that each single serving of an edible marijuana product is physically marked in a way that enables a reasonable person to intuitively determine how much of the product constitutes a single serving of active THC.
- 11.Each serving of an edible marijuana product within a multi-serving package of edible marijuana products must be easily separable, in order to allow an average person twenty-one (21) years of age or older to physically separate, with minimal effort, individual servings of the product.
- 12.Each single serving of an edible marijuana product contained in a packaged unit of multiple edible marijuana product shall be marked, stamped, or otherwise imprinted with a symbol or easily recognizable mark issued by the Commission that indicates the package contains

marijuana product.

- 13.TEN-TEN shall not prepare or deliver, sell or otherwise distribute an edible marijuana product with potency levels exceeding the following, as tested by an independent marijuana testing facility licensed in accordance with M.G.L. c. 94G, § 15:
  - a. For a single serving of an edible marijuana product, five milligrams (5.00 mg) of active tetrahydrocannabinol (THC);
  - b. In a single package of multiple edible marijuana product to be eaten, swallowed, or otherwise ingested, not more than twenty (20) servings or one hundred (100) milligrams (100.00 mg) of active THC; and
  - c. The THC content must be homogenous, or evenly distributed throughout the edible marijuana product. A retail marijuana product shall be considered to not be homogenous if ten percent (10%) of the infused portion of the marijuana product contains more than twenty (20%) of the total THC contained within entire marijuana product.

#### **Quality Control**

TEN-TEN shall comply with the following sanitary requirements:

- Any TEN-TEN agent whose job includes contact with marijuana or nonedible marijuana
  products, including cultivation, production, or packaging, is subject to the requirements for food
  handlers specified in 105 CMR 300.000, and all edible marijuana products shall be prepared,
  handled, and stored in compliance with the sanitation requirements in 105 CMR 500.000, and
  with the requirements for food handlers specified in 105 CMR 300.000.
- 2. Any TEN-TEN agent working in direct contact with preparation of marijuana or nonedible marijuana products shall conform to sanitary practices while on duty, including:
  - a. Maintaining adequate personal cleanliness; and
  - b. Washing hands thoroughly in an adequate hand-washing area before starting work, and at any other time when hands may have become soiled or contaminated.
- 3. TEN-TEN's hand-washing facilities shall be adequate and convenient and shall be furnished with running water at a suitable temperature. Hand-washing facilities shall be located in TEN-TEN's production areas and where good sanitary practices require employees to wash and sanitize their hands, and shall provide effective hand-cleaning and sanitizing preparations and sanitary towel service or suitable drying devices;
- 4. TEN-TEN's facility shall have sufficient space for placement of equipment and storage of materials as is necessary for the maintenance of sanitary operations;
- 5. TEN-TEN shall ensure that litter and waste is properly removed and disposed of so as to minimize the development of odor and minimize the potential for the waste attracting and harboring pests. The operating systems for waste disposal shall be maintained in an adequate manner pursuant to 935 CMR 500.105(12);

- 6. TEN-TEN's floors, walls, and ceilings shall be constructed in such a manner that they may be adequately kept clean and in good repair;
- 7. TEN-TEN's facility shall have adequate safety lighting in all processing and storage areas, as well as areas where equipment or utensils are cleaned;
- 8. TEN-TEN's buildings, fixtures, and other physical facilities shall be maintained in a sanitary condition;
- 9. TEN-TEN shall ensure that all contact surfaces, including utensils and equipment, shall be maintained in a clean and sanitary condition. Such surfaces shall be cleaned and sanitized as frequently as necessary to protect against contamination, using a sanitizing agent registered by the US Environmental Protection Agency (EPA), in accordance with labeled instructions. Equipment and utensils shall be so designed and of such material and workmanship as to be adequately cleanable;
- 10. All toxic items shall be identified, held, and stored in a manner that protects against contamination of marijuana products;
- 11. TEN-TEN shall ensure that its water supply is sufficient for necessary operations, and that such water supply is safe and potable;
- 12. TEN-TEN's plumbing shall be of adequate size and design, and adequately installed and maintained to carry sufficient quantities of water to required locations throughout the marijuana establishment. Plumbing shall properly convey sewage and liquid disposable waste from the marijuana establishment. There shall be no cross-connections between the potable and waste water lines;
- 13. TEN-TEN shall provide its employees with adequate, readily accessible toilet facilities that are maintained in a sanitary condition and in good repair;
- 14. TEN-TEN shall hold all products that can support the rapid growth of undesirable microorganisms in a manner that prevents the growth of these microorganisms; and
- 15. TEN-TEN shall store and transport finished products under conditions that shall protect them against physical, chemical, and microbial contamination, as well as against deterioration of finished products or their containers.

TEN-TEN's vehicles and transportation equipment used in the transportation of marijuana products or edibles requiring temperature control for safety shall be designed, maintained, and equipped as necessary to provide adequate temperature control to prevent the marijuana products or edibles from becoming unsafe during transportation, consistent with applicable requirements pursuant to 21 CFR 1.908(c).

TEN-TEN shall ensure that TEN-TEN's facility is always maintained in a sanitary fashion and shall comply with all applicable sanitary requirements.

TEN-TEN shall follow established policies and procedures for handling voluntary and mandatory recalls of marijuana products. Such procedures are sufficient to deal with recalls due to any action initiated at the request or order of the Commission, and any voluntary action by TEN-TEN to remove defective or potentially defective marijuana products from the market, as well as any action undertaken to promote public health and safety.

Any inventory that becomes outdated, spoiled, damaged, deteriorated, mislabeled, or contaminated shall be disposed of in accordance with the provisions of 935 CMR 500.105(12), and any such waste shall be stored, secured, and managed in accordance with applicable state and local statutes, ordinances, and regulations.

TEN-TEN shall process marijuana in a safe and sanitary manner. TEN-TEN shall process the leaves and flowers of the female marijuana plant only, which shall be:

- Well-cured and generally free of seeds and stems;
- Free of dirt, sand, debris, and other foreign matter;
- Free of contamination by mold, rot, other fungus, and bacterial diseases;
- Prepared and handled on food-grade stainless steel tables; and
- Packaged in a secure area.

All edible products shall be prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: Minimum Sanitation Standards for Food Establishments.

## **Testing**

In compliance with 935 CMR 500.160(1), TEN-TEN shall not sell or otherwise market marijuana or marijuana products that are not capable of being tested by Independent Testing Laboratories, except as otherwise allowed under 935 CMR 500.000: Adult Use of Marijuana.

Pursuant to 935 CMR 500.160(1) testing of TEN-TEN's Marijuana Products shall be performed by an Independent Testing Laboratory in compliance with protocol(s) established in accordance with M.G.L. c. 94G, § 15 and in a form and manner determined by the Commission including, but not limited to, the Protocol for Sampling and Analysis of Finished Medical Marijuana Products and Marijuana-infused Products.

Pursuant to 935 CMR 500.160(1), testing of environmental media (e.g., soils, solid growing media, and water) shall be performed in compliance with the Protocol for Sampling and Analysis of Environmental Media for Massachusetts Registered Medical Marijuana Dispensaries published by the Commission.

Pursuant to 935 CMR 500.160(2), TEN-TEN's marijuana shall be tested for the cannabinoid profile and for contaminants, as specified by the Commission, including, but not limited to, mold, mildew, heavy Marijuana and Marijuana Product Quality Control Processes, Product Safety Plans, and Testing Procedures 8

metals, plant growth regulators, and the presence of pesticides. The Commission may require additional testing.

Pursuant to 935 CMR 500.160(3), TEN-TEN has a written policy for responding to laboratory results that indicate contaminant levels are above acceptable limits established in the protocols identified in 935 CMR 500.160(1).

Pursuant to 935 CMR 500.160(3)(a), TEN-TEN's policy includes, but is not limited to:

- 1. notifying the Commission within 72 hours of any laboratory testing results indicating that the contamination cannot be remediated and disposing of the production batch.
- 2. notifying the Commission of any information regarding contamination as specified by the Commission or immediately upon request by the Commission.

Pursuant to 935 CMR 500.160(3)(b), TEN-TEN's policy requires the notification referred to above be from both TEN-TEN and the Independent Testing Laboratory, separately and directly.

Pursuant to 935 CMR 500.160(3)(c), TEN-TEN's policy requires the notification from TEN-TEN describe a proposed plan of action for both the destruction of the contaminated product and the assessment of the source of contamination.

Pursuant to 935 CMR 500.160(4), TEN-TEN shall maintain the results of all testing for no less than one year. Testing results shall be valid for a period of one year. Marijuana or marijuana products with testing dates in excess of one year old shall be deemed expired and may not be dispensed, sold, transferred or otherwise conveyed until retested.

Pursuant to 935 CMR 500.160(5), seeds sold by TEN-TEN is not subject to the above testing provisions.

Pursuant to 935 CMR 500.160(6), clones are subject to these testing provisions, but are exempt from testing for metals.

Pursuant to 935 CMR 500.160(7), all transportation of marijuana and marijuana products to and from Independent Testing Laboratories providing marijuana testing services shall comply with 935 CMR 500.105(13).

Pursuant to 935 CMR 500.160(8), any excess marijuana and/or marijuana products shall be disposed in compliance with 935 CMR 500.105(12), either by the independent testing laboratory returning the

excess marijuana and/or marijuana products to TEN-TEN for disposal, or by the independent testing laboratory disposing of it directly.

#### **Quality Control Standard Operating Procedures**

TEN-TEN shall implement standard operating procedures (SOPs) relating to quality control processes to ensure product quality and safety. Once TEN-TEN's volume justifies the appointment of a Quality Assurance Manager, TEN-TEN shall appoint same, who shall be responsible for the development, implementation, oversight and updating, as necessary, of TEN-TEN's quality control processes.

In the interim, TEN-TEN's owner, Scot Trifilo, shall personally oversee TEN-TEN's on-site quality control processes, with the assistance of TEN-TEN's off-site independent testing laboratory. TEN-TEN's quality control and product safety processes shall incorporate employee, community, and customer product quality and safety considerations and shall require strict adherence in TEN-TEN's daily activities.

TEN-TEN's extensive quality control processes address a myriad of product safety requirements including, but not limited to, employee training requirements, proper equipment usage and equipment maintenance protocols, sanitation standards, cultivation protocols, component and product handling and storage, quality control testing, child-resistant packaging, product inserts, label disclosures and product traceability requirements.

TEN-TEN's SOPs shall be updated as often as necessary to ensure compliance with the laws and regulations that govern TEN-TEN. TEN-TEN's owner, Scot Trifilo, or his designate, with the support and input of his managers, shall be personally responsible for updating TEN-TEN's SOPs to incorporate any additions or amendments to the laws and regulations affecting TEN-TEN, as well as incorporating any guidance or directives published by regulatory agencies as they apply to TEN-TEN.

All employees shall be required to have proper training on the SOPs applicable to their duties. Each employee shall be required to demonstrate their understanding of the critical processes which apply to their duties and responsibilities. Additionally, all third-party contractors shall be required, by contract, to perform their duties in compliance with TEN-TEN's policies and procedures and regulatory agency regulations.

Any employee or contractor who fails to perform their duties in compliance with TEN-TEN's policies and procedures and regulatory agency regulations shall be reprimanded and/or terminated, depending on

the severity of the offense. All employees and contractors shall be required, as a condition of employment and/or contract, to report any observed compliance issues to the appropriate TEN-TEN manager.

#### **TEN-TEN's Recordkeeping Policies and Procedures**

#### General Overview

TEN-TEN LLC ("TEN-TEN") has established policies and procedures regarding recordkeeping and record retention in order to ensure the maintenance, safekeeping, and accessibility of critical documents. Written records shall be stored in a locked room designated for record retention. Electronic records shall be stored on the TEN-TEN server, in on-site and off-site backup, and in the cloud, as necessary. All written and electronic records shall be available for inspection by the Commission upon request.

#### Recordkeeping in compliance with 935 CMR 500.105(9):

Written records that are required and are subject to inspection include, but are not necessarily limited to, all records required in any section of 935 CMR 500.000, in addition to the records identified below.

To ensure that TEN-TEN maintains and retains all records as required by this policy, a review by management of Corporate Records, Business Records, Personnel Records, and Financial Records to ensure completeness, accuracy, and timeliness of said records shall occur quarterly. Financial recordkeeping is addressed in a separate section of the Management and Operations Profile.

In addition, TEN-TEN's operating policies and procedures shall be updated, as needed, on an ongoing basis, and undergo a review by management on an annual basis. Updated policies and procedures shall be provided to the Commission pursuant to 935 CMR 500.104(2).

TEN-TEN's records include, but are not limited to:

- All other contracts
- Commission Requirements:
  - Annual Agent Registration
  - Annual Marijuana Establishment Registration
  - Policies and Procedures
- Local Compliance:
  - Host Community Agreements
  - Certificates of Occupancy
  - Special Permits
  - Variances
  - Site Plan Approvals
  - As-Built Drawings
- Corporate Governance:
  - Annual Reports
  - Secretary of State Filings
- Business Records in compliance with 935 CMR 500.105(9)(e), including but not limited to, written and/or electronic records of:
  - Assets and liabilities;
  - Monetary transactions;
  - Books of accounts, which shall include journals, ledgers, and supporting documents, agreements, checks, invoices, and vouchers;
  - Sales records including the quantity, form, and cost of marijuana products;
  - Salary and wages paid to each employee, or stipend, executive compensation, bonus, benefit, or item of value paid to any persons having direct or indirect control over the marijuana establishment.
- Personnel Records in compliance with 935 CMR 500.105(9)(d), including but not limited to, written and/or electronic records of:
  - Job descriptions for each agent, as well as organizational charts consistent with the job descriptions;
  - Personnel records for each marijuana establishment agent. Such records shall be maintained for at least twelve (12) months after termination of the agent's affiliation with TEN-TEN and shall include, at a minimum, the following:
    - All materials submitted to the Commission pursuant to 935 CMR 500.030(2);

- Documentation of verification of references:
- The job description or employment contract that includes duties, authority, responsibilities, qualifications, and supervision;
- Documentation of all required training, including training regarding privacy and confidentiality requirements, and the signed statement of the individual indicating the date, time, and place he or she received said training and the topics discussed, including the name and title of presenters;
- Documentation of periodic performance evaluations;
- A record of any disciplinary action taken; and
- Notice of completed responsible vendor and eight-hour related duty training.
- A staffing plan that demonstrates accessible business hours and safe cultivation conditions;
- o Personnel policies and procedures; and
- All background check reports obtained in accordance with M.G.L c. 6 § 172, 935 CMR 500.029, 935 CMR 500.030, and 803 CMR 2.00: Criminal Offender Record Information (CORI).
- Records of Testing of marijuana and marijuana products in compliance with 935 CMR 500.160(3).
- Inventory Records in compliance with 935 CMR 500.105(8)(b), including but not limited to:
  - Real-time inventory maintained as specified by the Commission and in 935 CMR 500.105(8)(c) and (d) including, at a minimum, an inventory of marijuana plants; marijuana plant-seeds and clones in any phase of development such as propagation, vegetation, and flowering; marijuana ready for dispensing; all in-progress and finished marijuana products; and all damaged, defective, expired, or contaminated marijuana and marijuana products awaiting disposal.
  - The record of each inventory shall include, at a minimum, the date of the inventory, a summary of the inventory findings, and the names, signatures, and titles of the agents who conducted the inventory.
- Seed-to-Sale Tracking Records in compliance with 935 CMR 500.105(9)(c) and as required by 935 CMR 500.105(8)(e).
- Incident Reporting Records in compliance with 935 CMR 500.110(9), including, but not limited to:

- Written notice provided to the Commission by TEN-TEN within ten (10) calendar days of any incident described in 935 CMR 500.110(9)(a), by an incident report, in the form and manner prescribed by the Commission, which details the circumstances of the event, any corrective action taken, and confirmation that the appropriate law enforcement authorities were notified.
- All documentation related to an incident that is reportable pursuant to 935 CMR 500.110(9)(a) shall be maintained by TEN-TEN for not less than one year or the duration of an open investigation, whichever is longer, and made available to the Commission and law enforcement authorities within their lawful jurisdiction on request.
- Waste Disposal Records in compliance with 935 CMR 500.105(9)(f) & in compliance with 935 CMR 500.105(12)(d), including, but not limited to:
  - When marijuana, marijuana products or waste are disposed of or handled, TEN-TEN shall create and maintain an electronic record of the date, the type and quantity disposed or handled, the manner of disposal or other handling, the location of disposal or other handling, and the names of the two TEN-TEN agents present during the disposal or handling, with their signatures. TEN-TEN shall keep these records for at least three (3) years. This period shall automatically be extended for the duration of any enforcement action and may be extended by an order of the Commission.
- Security Records in compliance with 935 CMR 500.110, including, but not limited to:
  - 935 CMR 500.110(4)(e): All outside vendors, contractors and visitors shall obtain a visitor identification badge prior to entering a limited access area and shall be escorted at all times by a TEN-TEN agent authorized to enter the limited access area. All visitors must be logged in and out and that log shall be available for inspection by the Commission at all times.
  - 935 CMR 500.110(5)(a)(5): Recordings from all video cameras which shall be enabled to record 24 hours each day and be available for immediate viewing by the Commission on request for at least the preceding 90 calendar days or the duration of a request to preserve the recordings for a specified period of time made by the Commission, whichever is longer. Video cameras may use motion detection sensors to begin recording, so long as the motion detection sensor system provides an alert to designated employees of TEN-TEN in a manner established in TEN-TEN's written security procedures and approved by the Commission or a Commission Delegee. If a TEN-TEN receives notice that the motion

detection sensor is not working correctly, it must take prompt action to make corrections and document those actions. Recordings shall not be destroyed or altered, and shall be retained as long as necessary if TEN-TEN is aware of a pending criminal, civil or administrative investigation or legal proceeding for which the recording may contain relevant information.

- o 935 CMR 500.110(5)(b) and 935 CMR 500.110(6)(b): All security system equipment and recordings shall be maintained in a secure location so as to prevent theft, loss, destruction and alterations.
- 935 CMR 500.110(5)(e) and 935 CMR 500.110(6)(d): A current list of authorized agents and service personnel that have access to the surveillance room shall be made available to the Commission upon request.
- 935 CMR 500.110(6)(a)(5): 24-hour recordings from all video cameras that are available for immediate viewing by the Commission on request and that are retained for at least ninety (90) calendar days. Recordings shall not be destroyed or altered, and shall be retained as long as necessary if TEN-TEN is aware of a pending criminal, civil or administrative investigation or legal proceeding for which the recording may contain relevant information.
- All documentation related to an incident that is reportable pursuant to 935 CMR 500.110(9)(a) shall be maintained by TEN-TEN for not less than one year or the duration of an open investigation, whichever is longer, and made available to the Commission and law enforcement authorities within their lawful jurisdiction on request.
- Transportation Records in compliance with 935 CMR 500.105(13), including, but not limited to:
  - 935 CMR 500.105(13)(a)(11): In the case of an emergency stop during the transportation of marijuana and marijuana products, a log must be maintained describing the reason for the stop, the duration, the location, and any activities of personnel exiting the vehicle.
  - 935 CMR 500.105(13)(b)(1): TEN-TEN agents must document and report any unusual discrepancy in weight or inventory to the Commission and law enforcement authorities not more than twenty-four (24) hours following the discovery of such a discrepancy.
  - 935 CMR 500.105(13)(b)(2): TEN-TEN agents shall report to the Commission and Law Enforcement Authorities any vehicle accidents, diversions, losses, or other reportable incidents that occur during transport, not more than twenty-four (24) hours following such accidents, diversions, losses, or other reportable incidents.

- 935 CMR 500.105(13)(c)1: Records that a vehicle used for transporting marijuana and marijuana products is owned or leased by TEN-TEN and properly registered, inspected, and insured in the Commonwealth, which shall be made available to the Commission on request.
- 935 CMR 500.105(13)(e)8: The originating location must have a
  Marijuana Establishment Agent assigned to monitoring the GPS unit and
  secure form of communication, who must log all official communications
  with TEN-TEN agents transporting marijuana products.
- 935 CMR 500.105(13)(f)(5): TEN-TEN shall retain all transportation manifests for no less than one (1) year and make them available to the Commission upon request.
- Records of Responsible Vendor Training in compliance with 935 CMR 500.105(2)(b)5, including, but not limited to:
  - TEN-TEN shall maintain records of Responsible Vendor Training Program compliance for four (4) years and make them available to inspection by the Commission and any other applicable licensing authority on request during normal business hours.
- Records following closure, in compliance with 935 CMR 500.105(9)(g), including, but not limited to:
  - All records shall be kept for at least two (2) years at TEN-TEN's expense in a form (electronic, hard copies, etc.) and location acceptable to the Commission. In addition, TEN-TEN shall communicate with the Commission during the closure process and accommodate any additional requests the Commission or other agencies may have.
- Written Operating Policies and Procedures in compliance with 935 CMR 500.105, including but not limited to:
  - Written Operating Procedures: TEN-TEN shall have and follow a set of detailed written operating procedures which shall be updated on an ongoing basis, as necessary and undergo a review by management on an annual basis.
  - Operating procedures shall include, but need not be limited to the following:
    - Security measures in compliance with 935 CMR 500.110;
    - Emergency policies and procedures for securing all product following any instance of diversion, theft or loss of marijuana and marijuana products, and conduct an assessment to determine

- whether additional safeguards are necessary, in compliance with 935 CMR 500.110(1)(m);
- Employee security policies, including personal safety and crime prevention techniques;
- A description of TEN-TEN's hours of operation and after-hours contact information, which shall be provided to the Commission, made available to law enforcement authorities on request, and updated pursuant to 935 CMR 500.000;
- Storage and waste disposal of marijuana and marijuana products in compliance with 935 CMR 500.105(11);
- Description of the various strains of marijuana to be cultivated, processed or sold, as applicable, and the form(s) in which marijuana will be sold;
- Price lists for marijuana and marijuana products and any other available products;
- Procedures to ensure accurate recordkeeping, including inventory protocols for transfer and inventory in compliance with 935 CMR 500.105(8) and (9);
- Plans for quality control, including product testing for contaminants in compliance with 935 CMR 500.160;
- A staffing plan and staffing records in compliance with 935 CMR 500.105(9)(d);
- Emergency procedures, including a disaster plan with procedures to be followed in case of fire or other emergencies;
- Alcohol, smoke, and drug-free workplace policies;
- A plan describing how confidential information and other records required to be maintained confidentially will be maintained;
- A policy for the immediate dismissal of any TEN-TEN agent or employee who has:
  - Diverted marijuana, which shall be reported to law enforcement authorities and to the Commission;
  - Engaged in unsafe practices with regard to TEN-TEN's operations, which shall be reported to the Commission; or
  - Been convicted or entered a guilty plea, plea of nolo contendere, or admission to sufficient facts of a felony drug offense involving distribution to a minor in the Commonwealth, or a like violation in any other jurisdiction.
- Policies and procedures for the handling of cash on TEN-TEN's premises including, but not limited to, storage, collection

- frequency, and transport to financial institution(s), to be available on inspection;
- Policies and procedures to prevent the diversion of marijuana and marijuana products to individuals younger than twenty-one (21) years old;
- Policies and procedures for energy efficiency and conservation that shall include:
  - Identification of potential energy use reduction opportunities (including, but not limited to, natural lighting, heat recovery ventilation and energy efficiency measures), and a plan for implementation of such opportunities;
  - Consideration of opportunities for renewable energy generation including, where applicable, submission of building plans showing where energy generators could be placed on the site, and an explanation of why the identified opportunities were not pursued, if applicable;
  - Strategies to reduce electric demand (such as lighting schedules, active load management and energy storage);
     and
  - Engagement with energy efficiency programs offered pursuant to M.G.L. c. 25, § 21, or through municipal lighting plants.
- Policies and procedures to promote workplace safety consistent with applicable standards set by the Occupational Safety and Health Administration, including plans to identify and address any biological, chemical or physical hazards. Such policies and procedures shall include, at a minimum, a hazard communication plan, personal protective equipment assessment, a fire protection plan, and an emergency action plan.
- An operational plan for the cultivation of marijuana, including a detailed summary of the policies and procedures for cultivation, consistent with state and local law including, but not limited to, the Commission's Guidance on Integrated Pest Management effective November 1, 2019.
- Written policies and procedures for the cultivation, production, transfer or distribution of marijuana and marijuana products, as applicable, which shall include but not be limited to:
  - Methods for identifying, recording, and reporting diversion, theft, or loss, and for correcting all errors and inaccuracies in inventories.

- The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(8);
- Policies and procedures for handling voluntary and mandatory recalls of marijuana and marijuana products. Such procedures shall be adequate to deal with recalls due to any action initiated at the request or order of the Commission, and any voluntary action by TEN-TEN to remove defective or potentially defective marijuana or marijuana products from the market, as well as any action undertaken to promote public health and safety;
- Policies and procedures for ensuring that any outdated, damaged, deteriorated, mislabeled, or contaminated marijuana or marijuana product is segregated from other marijuana and marijuana products and destroyed. Such procedures shall provide for written documentation of the disposition of the marijuana and marijuana products. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(12).
- Policies and procedures for transportation. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(13);
- Policies and procedures to reduce energy and water usage, engage in energy conservation and mitigate other environmental impacts. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(15).
- Policies and procedures for the transfer, acquisition, or sale of marijuana and marijuana products between Marijuana Establishments:
- Policies and procedures to ensure that all marijuana products are prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments, and with the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements; and
- Policies and procedures for maintaining a product catalogue identifying all types of marijuana products actively manufactured at the facility. The catalog shall include a description of the product, photograph or illustration, packaging design, and dosage amounts, including expected cannabinoid profile.

- Records related to Recording Sales, in compliance with 935 CMR 500.140(5)(d), 830 CMR 62C.25.1: Record Retention and DOR Directive 16-1 regarding recordkeeping requirements, including, but not limited to:
  - A retailer shall conduct a monthly analysis of its equipment and sales data to determine that no software has been installed that could be utilized to manipulate or alter sales data and that no other methodology has been employed to manipulate or alter sales data. A marijuana retailer shall maintain records that it has performed the monthly analysis and produce it on request to the Commission.

#### **TEN-TEN's Maintenance of Financial Records**

TEN-TEN LLC.'s ("TEN-TEN") operating policies and procedures ensure financial records are accurate and maintained in compliance with 935 CMR 500.105(9)(e). Financial records maintenance measures include policies and procedures requiring that:

- Confidential information shall be maintained in a secure location, kept separate
  from all other records, and shall not be disclosed without the written consent of
  the individual to whom the information applies, or as required under law, or
  pursuant to an order from a court of competent jurisdiction; provided however,
  the Commission may access this information to carry out its official duties.
- All recordkeeping requirements under 935 CMR 500.105(9) are followed, including:
  - Maintaining financial records in accordance with generally accepted accounting principles, consistently applied; and
  - Keeping written business records available for inspection by the Commission, on request, including but not limited to all records required in any section of 935 CMR 500.000, in addition to manual or computerized records of:
    - Assets and liabilities;
    - Monetary transactions;
    - Books of accounts, which shall include journals, ledgers, and supporting documents, agreements, checks, invoices, and vouchers;
    - Sales records including the quantity, form, and cost of marijuana products; and
    - Salary and wages paid to each employee and any executive compensation, bonus, benefit, or item of value paid to any persons having direct or indirect control over TEN-TEN.
- All sales recording requirements under 935 CMR 500.140(5) are followed, including:
  - Utilizing a point-of-sale (POS) system approved by the Commission, in consultation with the DOR, and a sales recording module approved by DOR;
  - Ensuring that sales data is not manipulated or altered;
  - Conducting a monthly analysis of TEN-TEN's equipment and sales data to determine that no software has been installed that could be utilized to manipulate or alter sales data and that no other methodology has been employed to manipulate or alter sales data;
  - Maintaining records that TEN-TEN has performed the monthly analysis and produce them on request to the Commission;

- If TEN-TEN determines that software has been installed for the purpose of manipulation or alteration of sales data or other methods have been utilized to manipulate or alter sales data:
  - TEN-TEN shall immediately disclose the information to the Commission;
  - TEN-TEN shall cooperate with the Commission in any investigation regarding manipulation or alteration of sales data; and
  - TEN-TEN shall take such other action directed by the Commission to comply with 935 CMR 500.105.
- Complying with 830 CMR 62C.25.1: Record Retention and DOR Directive 16-1 regarding recordkeeping requirements;
- Adopting separate accounting practices at the point-of-sale for marijuana and marijuana product sales, and non-marijuana sales;
- Allowing the Commission and the DOR to audit and examine the point-of-sale system used by TEN-TEN in order to ensure compliance with Massachusetts tax laws and 935 CMR 500.000.
- Additional written business records shall be kept, including, but not limited to, records of:
  - Compliance with liability insurance coverage under 935 CMR 500.105(10);
  - Compliance with surety bond or escrow requirements under 935 CMR 500.105(16);
  - Fees paid under 935 CMR 500.005 or under any other section of the Commission's regulations; and
  - Fines or penalties, if any, paid under 935 CMR 500.550 or under any other section of the Commission's regulations.

## TEN-TEN's Qualifications and Intended Trainings for Owners, Managers and Marijuana Establishment Agents

Pursuant to 935 CMR 500.101(1)(c)9, TEN-TEN LLC ("TEN-TEN") provides below a detailed description of the minimum qualifications and intended training(s) for marijuana establishment agents who shall be employees.

#### **Minimum Qualifications**

Pursuant to 935 CMR 500.030(1), all employees of TEN-TEN shall:

- (a) be 21 years of age or older;
- (b) have not been convicted of an offense in the Commonwealth involving the distribution of controlled substances to minors, or a like violation of the laws of Other Jurisdictions; and
- (c) be determined suitable for registration consistent with the provisions of 935 CMR 500.802.

Pursuant to 935 CMR 500.802, all employees of TEN-TEN shall meet the suitability standards for registration as a marijuana establishment agent for a marijuana retail establishment, as these are the most stringent suitability standards:

- (1) In accordance with M.G.L. c. 94G, § 4(a½)(iii), the Commission has established qualifications for licensure and minimum standards for employment that are directly and demonstrably related to the operation of a marijuana establishment and similar to qualifications for licensure and employment standards in connection with alcoholic beverages as regulated under M.G.L. c. 138; provided, that a prior conviction solely for a marijuana-related offense or for a violation of M.G.L. c. 94C, § 34 shall not disqualify an individual or otherwise affect eligibility for employment or licensure in connection with a marijuana establishment, unless the offense involved the distribution of a controlled substance, including marijuana, to a minor.
- (2) For purposes of determining suitability based on background checks in accordance with 935 CMR 500.030 and 935 CMR 500.101:
  - (a) All conditions, offenses, and violations are construed to include Massachusetts law or like or similar law(s) of other jurisdictions.
  - (b) All criminal disqualifying conditions, offenses, and violations include the crimes of attempt, accessory, conspiracy and solicitation.
  - (c) Juvenile dispositions shall not be considered as a factor for determining suitability.

- (d) Where applicable, all look back periods for criminal conditions, offenses, and violations included in 935 CMR 500.801: Table B commence on the date of disposition; provided, however, that if disposition results in incarceration in any institution, the look back period shall commence on release from incarceration.
- (e) Unless otherwise specified in 935 CMR 500.801: Table B, a criminal condition, offense or violation shall include both convictions, which include guilty pleas and pleas of *nolo contendere*, and dispositions resulting in continuances without a finding or other disposition constituting an admission to sufficient facts, but shall exclude other non-conviction dispositions. All suitability determinations will be made in accordance with the procedures set forth in 935 CMR 500.800. In addition to the requirements established in 935 CMR 500.800, the Commission shall:
  - 1. Consider whether offense(s) or information that would result in a presumptive negative suitability determination under 935 CMR 500.801: Table B renders the subject unsuitable for registration; and
  - 2. Consider appeals of determinations of unsuitability based on claims of erroneous information received as part of the background check during the application process in accordance with 803 CMR 2.17: Requirement to Maintain a Secondary Dissemination Log and 803 CMR 2.18: Adverse Employment Decision Based on CORI or Other Types of Criminal History Information Received from a Source Other than the DCJIS.
- (3) Registered agents shall remain suitable at all times a license or registration remains in effect. An individual subject to 935 CMR 500.802 shall notify the Commission in writing of any charge or conviction of an offense that would result in a presumptive negative suitability determination or mandatory disqualification under 935 CMR 500.801: Table B within ten (10) days of such individual's arrest or summons, and within ten (10) days of the disposition on the merits of the underlying charge. Failure to make proper notification to the Commission may be grounds for disciplinary action. If the Commission lawfully finds a disqualifying event and the individual asserts that the record was sealed, the Commission may require the individual to provide proof from a court evidencing the sealing of the case.

If TEN-TEN determines that one of TEN-TEN's registered marijuana agents has not properly notified the Commission in accordance with 935 CMR 500.802(3), or has otherwise become unsuitable for registration as a retail marijuana establishment agent and/or employment as a marijuana establishment agent, TEN-TEN shall immediately terminate the marijuana establishment agent's employment and shall notify the Commission within one (1) business day that the marijuana establishment agent is no longer suitable for registration as a retail marijuana establishment agent and no longer associated with TEN-TEN.

#### **Training**

As required by 935 CMR 500.105(2)(a), TEN-TEN shall ensure that all of TEN-TEN's agents has successfully completed a comprehensive training program that is tailored to the roles and responsibilities of their job, prior to performing their job functions, including, but not limited to the Responsible Vendor Training Program. Agents responsible for tracking and entering product into the Seed-to-sale SOR must receive training in a form and manner determined by the Commission. At a minimum, TEN-TEN staff shall receive eight hours of on-going training annually.

In compliance with 935 CMR 500.105(2)(b)(1), at the time of licensure, all of TEN-TEN's current owners, managers, and employees shall have attended and successfully completed a Responsible Vendor Training Program operated by an education provider accredited by the Commission to provide the annual minimum of two hours of Responsible Vendor Training to marijuana establishment agents.

Qualifications and Intended Trainings for Owners, Managers and Marijuana Establishment Agents 5

In compliance with 935 CMR 500.105(2)(b)(2), TEN-TEN's new owners, managers, and non-administrative employees shall complete the Responsible Vendor Training Program within ninety (90) days of the date they are hired.

In compliance with 935 CMR 500.105(2)(b)(3), TEN-TEN's owners, managers, and non-administrative employees shall successfully complete the program once every year thereafter.

TEN-TEN shall also encourage employees who are not owners, managers, or who do not handle or sell marijuana, to take the Responsible Vendor Training Program on a voluntary basis.

In compliance with 935 CMR 500.105(2)(b)(5), TEN-TEN shall maintain records of Responsible Vendor Training Program for at least four (4) years and made them available during normal business hours for inspection by the Commission and any other applicable licensing authority upon request.

In compliance with 935 CMR 500.105(2)(b)7, and as part of the Responsible Vendor Training Program, TEN-TEN's owners, managers, and non-administrative employees shall receive yearly training on a variety of topics relevant to marijuana, marijuana products, and marijuana establishment operations, including but not limited to the following:

- a. Discussion concerning Marijuana's effect on the human body. Training shall include:
  - i. Scientifically based evidence on the physical and mental health effects based on the type of Marijuana Product;
  - ii. The amount of time to feel impairment;
  - iii. Visible signs of impairment; and
  - iv. Recognizing the signs of impairment.
- b. Diversion prevention and prevention of sales to minors, including best practices;
- c. Compliance with all tracking requirements;
- d. Acceptable forms of identification. Training shall include:
  - i. How to check identification;
  - ii. Spotting false identification;
  - iii. Provisions for confiscating fraudulent identifications; and
  - iv. Common mistakes made in verification.
- e. Other significant state laws and rules affecting operators, such as:
  - i. Local and state licensing and enforcement;
  - ii. Incident and notification requirements;
  - iii. Administrative and criminal liability;
  - iv. License sanctions;

- v. Waste disposal;
- vi. Health and safety standards;
- vii. Patrons prohibited from bringing marijuana onto licensed premises;
- viii.Permitted hours of sale;
- ix. Conduct of establishment;
- x. Permitting inspections by state and local licensing and enforcement authorities:
- xi. Licensee responsibilities for activities occurring within licensed premises;
- xii. Maintenance of records;
- xiii.Privacy issues; and
- xiv.Prohibited purchases and practices.
- f. Such other areas of training determined by the Commission to be included in a Responsible Vendor Training Program.

Pursuant to 935 CMR 500.105(9)(d)2(d) and (g), TEN-TEN shall maintain documentation of all required training, including training regarding privacy and confidentiality requirements, and the signed statement of the individual indicating the date, time, and place he or she received said training and the topics discussed, including the name and title of presenters, as well as a notice of completed responsible vendor and eight-hour related duty training.

### <u>TEN-TEN LLC's Plan for Restricting Access to TEN-TEN's Production Facilities to</u> Individuals Age Twenty-one (21) and Older

Pursuant to 935 CMR 500.110(1)(a) and TEN-TEN's Safety and Security Plan, no individuals under the age of twenty-one (21) shall be permitted in any of TEN-TEN's Marijuana Establishments. Pursuant to 935 CMR 500.030(1), all board members, directors, employees, executives, managers, and employees of TEN-TEN shall be registered Marijuana Establishment Agents, and all such individuals shall be twenty-one (21) years of age or older. Pursuant to 935 CMR 500.110(1)(a) and TEN-TEN's Safety and Security Plan, TEN-TEN shall not admit visitors under the age of twenty-one (21) to TEN-TEN's Production facilities.

### Written Procedures Required to Ensure that Individuals Under Twenty-one (21) Years of Age are Not Admitted to TEN-TEN's Facilities

In accordance with 935 CMR 500.105(1), TEN-TEN shall develop and maintain a set of detailed written operating procedures, including, but not limited to those required by statute and CCC regulations, which shall specifically include processes to ensure that individuals under twenty-one (21) years of age are not admitted to TEN-TEN's facilities.

Pursuant to TEN-TEN's Safety and Security Plan:

All outside vendors, contractors and visitors shall obtain a visitor identification badge from TEN-TEN Security personnel prior to entering a limited access area and shall be escorted at all times by a Marijuana Establishment Agent authorized to enter the limited access area. The visitor identification badge shall be visibly displayed at all times. All visitors must be logged in and out and that log shall be available for inspection by the Commission at all times. All visitor identification badges shall be returned to TEN-TEN on exit. (935 CMR 500.110(4)(e))

Individuals under the age of twenty-one (21) are not allowed on TEN-TEN's premises or in TEN-TEN's facilities. TEN-TEN shall employ security policies and procedures to ensure that individuals under the age of twenty-one (21) do not gain entry to TEN-TEN's premises and facilities.

All TEN-TEN premises and facilities shall have a sign posted at their entrances and exits that shall be a minimum of twelve inches by twelve inches (12" x 12") and which states in **bold** type: "No one under twenty-one (21) years of age permitted. All persons shall present a valid, current government-issued photo identification card with a clearly visible, unaltered date of birth." in lettering no smaller than one inch (1") in height. Security personnel shall verify that the age of every visitor is twenty-one (21) years or

older, and log information regarding the visitor, including but not limited to the visitor's name, contact information, and numbered visitor identification badge issued, time of arrival and departure, purpose of visit, facilities and areas to be accessed, the names of any employees visited, as well the names of the Marijuana Establishment Agent or Agents escorting the visitor. If the visitor is a regulatory agent, a law enforcement agent, or an emergency responder visiting TEN-TEN on a non-emergency basis, the visitors' log shall also reflect their badge number. The visitors' log shall be available for inspection by the Commission and law enforcement agencies at all times.

#### Parties at TEN-TEN Responsible for Ensuring that the Above is Enforced

Once TEN-TEN has achieved a sufficient volume of sales to justify the hiring of a Compliance Manager, the Compliance Manager shall be responsible for developing and maintaining a set of detailed written operating procedures, which shall specifically include the above processes, to ensure that individuals under twenty-one (21) years of age are not admitted to TEN-TEN's facilities, in accordance with 935 CMR 500.105(1) and 935 CMR 500.105(1)(p).

Until such time as TEN-TEN achieves a sufficient volume of sales to justify the hiring of a Compliance Manager, the TEN-TEN Security Manager shall be responsible for the responsibilities of the Compliance Manager.

#### Overview of TEN-TEN's Personnel Policies including Background Checks

TEN-TEN LLC ("TEN-TEN") has established policies and procedures regarding recordkeeping and record retention in order to ensure the maintenance, safekeeping, and accessibility of critical documents.

To ensure confidentiality, written personnel records shall be stored in a locked area designated for record retention. Electronic records will be password protected and shall be stored on the TEN-TEN server, in on-site and off-site backup, and in the cloud, as necessary. All written and electronic records shall be available for inspection by the Commission upon request in compliance with 935 CMR 500.105(1).

The Personnel (Staffing) Records will be kept in compliance with 935 CMR 500.105(9)(d), including but not limited to, written and/or electronic records of:

- Job descriptions for each agent, as well as organizational charts consistent with the job descriptions;
- Personnel records for each marijuana establishment agent. Such records shall be maintained for at least twelve (12) months after termination of the agent's affiliation with TEN-TEN and shall include, at a minimum, the following:
  - All materials submitted to the Commission pursuant to 935 CMR 500.030(2);
  - Documentation of verification of references:
  - The job description or employment contract that includes duties, authority, responsibilities, qualifications, and supervision;
  - Documentation of all required training, including training regarding privacy and confidentiality requirements, and the signed statement of the individual indicating the date, time, and place he or she received said training and the topics discussed, including the name and title of presenters;
  - Documentation of periodic performance evaluations;
  - A record of any disciplinary action taken; and
  - Notice of completed responsible vendor and eight-hour related duty training.

TEN-TEN's Written Operating Policies and Procedures are in compliance with 935 CMR 500.105, and include, but are not limited to:

- TEN-TEN is an alcohol, smoke, and drug-free workplace, pursuant to 935 CMR 500.105(1)(k);
- Any TEN-TEN agent or employee shall be immediately terminated, pursuant to 935 CMR 500.105(1)(m), who has:

- Diverted marijuana, which shall be reported to law enforcement authorities and to the Commission;
- Engaged in unsafe practices with regard to TEN-TEN's operations, which shall be reported to the Commission; or
- Been convicted or entered a guilty plea, plea of nolo contendere, or admission to sufficient facts of a felony drug offense involving distribution to a minor in the Commonwealth, or alike violation in any other jurisdiction.
- TEN-TEN's job descriptions comply with 935 CMR 500.105(9)(d)(1);
- Background Checks: All agents, employees, and owners of TEN-TEN will undergo a detailed background investigation by the Cannabis Control Commission ("CCC") and/or TEN-TEN, prior to being granted access to a TEN-TEN facility or beginning work duties;
- TEN-TEN's Staffing plan is in compliance with 935 CMR 500.105(9)(d) and 935 CMR 500.105(1)(i):
  - Until licensed and in full operation, not all positions detailed below will be filled. Instead, a limited number of individuals will assume the responsibilities of the unfilled positions. The job descriptions for potential positions are provided below.
    - CULTIVATION (INDOOR) STAFFING PLAN:
      - Initially, four (4) individuals and eventually eight to ten employees, including a Cultivation Manager, Cultivation Associates, and required Security Personnel.
    - CULTIVATION (OUTDOOR) STAFFING PLAN:
      - Initially, the staff from the Indoor Cultivation will be utilized for the Outdoor growth as that will primarily be for Mothers plants to be exposed to natural sunlight, and required Security Personnel. Eventually, there will be six to eight employees for the Outdoor Cultivation in addition to
    - RETAIL STAFFING PLAN:
      - Six to eight employees to open the Retail Establishment including a Retail Manager, Retail Associates, and required Security Personnel.
    - o PRODUCTION STAFFING PLAN:
      - Two to four employees to begin the Production Establishment including a Production Manager, Production Associate, and required Security Personnel.

#### <u>Job Descriptions in compliance with 935 CMR 500.105(9)(d)(1):</u>

<u>Security Manager</u>: Under the supervision of senior management, the Security Manager is responsible for the safety and security of TEN-TEN's owners; employees; agents; visitors, vendors, and contractors while on TEN-TEN property; TEN-TEN's property, facilities, assets, inventory, raw materials, equipment, and waste; TEN-TEN's host community, as affected by TEN-TEN's safety and security. The Security Manager is also responsible for the development, implementation, administration, maintenance, and management of TEN-TEN's Security Policies

and Procedures. The Security Manager supervises the security staff (once hired) and performs their duties and responsibilities until the security staff is hired, and subsequent to their hiring, as necessary. In addition, the Security Manager shall be responsible to:

- With the Human Resource Manager, ensure that TEN-TEN performs and maintains the records of the required background checks, in accordance with M.G.L c. 6 § 172, 935 CMR 500.029, 935 CMR 500.030, 803 CMR 2.00: Criminal Offender Record Information (CORI), and 935 CMR 500.105(9)(d)5.
- With the Retail Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.050(8)(b) and 935 CMR 500.140.
- With the Human Resources Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(1).
- With the Human Resources Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(2)(a) and (2)(b).
- With the Inventory Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(8).
- Ensure that TEN-TEN is in compliance with 935 CMR 500.110(1) or (2), 935 CMR 500.110(4) to 935 CRM 500.110(7), and 935 CMR 500.110(9) and (10).
- With the Retail Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.140(2).
- Ensure that TEN-TEN is in compliance with its Plan for Restricting Access to Age 21 or Older and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Safety and Security Plan and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Plan for Prevention of Diversion and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Storage and Waste Disposal Plan and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Shipping, Receiving and Transportation Plans and update those plans as necessary.
- Ensure that TEN-TEN is in compliance with its Inventory Procedures and update those procedures as necessary.
- Ensure that TEN-TEN is in compliance with its Retail Establishment Procedures and update those procedures as necessary.
- Ensure that TEN-TEN is in compliance with its Qualifications and Intended Trainings for Owners, Managers and Marijuana Establishment Agents and update as necessary.
- Ensure that TEN-TEN is in compliance with all safety and security requirements contained in the relevant CMRs and in TEN-TEN policies and procedures which are not referenced above and update TEN-TEN's policies and procedures as necessary.

- Develop, implement and update and health and safety policies, procedures, programs and responsibilities for the security agents.
- Train the security agents in the health and safety policies, procedures, programs and responsibilities for security staff.
- With the Human Resources Manager, assist the management staff in developing, implementing, updating and training staff in health and safety policies, procedures, and programs for their respective areas, ensure those policies, procedures, and programs are implemented and followed, including, but not limited to conducting regular and random health and safety checks.
- Hire, train, oversee, promote, discipline, and terminate security staff, with the assistance of Human Resources.
- Assume the responsibilities of the Inventory Manager and the Compliance Manager, until such time as TEN-TEN's business operations are of such size that TEN-TEN is able to fill those positions.
- Perform any and all other duties, as directed by senior management.

<u>Security Agent</u>: The duties and responsibilities identified below will be performed by the Security Manager until the Security staff has been hired, and, subsequent to their hiring, as necessary. Security staff supports the Security Manager in the performance of his or her duties, monitors TEN-TEN's security systems, including but not limited to the alarm and surveillance systems, and monitors and maintains the access control systems. Security staff are responsible for ensuring that only authorized individuals are permitted access to TEN-TEN's facilities by verifying ID cards and other forms of identification. In addition, security staff perform the following duties and any and all other duties, as assigned:

- Investigate, communicate, and provide leadership in the event of an emergency, such as an intrusion, fire, or other threat that jeopardizes TEN-TEN staff, agents, customers, visitors, vendors, and contractors and TEN-TEN'/s host community.
- Respond to and investigate security situations and alarm activations; clearly document any incidents in written reports.
- Oversee the entrance to TEN-TEN's facilities and verify the credentials of each person seeking access to TEN-TEN facilities.
- Manage the flow of staff, agents, customers, visitors, vendors, and contractors, including maintaining the visitor log and issuing and collecting visitor badges.
- Escort authorized visitors, vendors, and contractors while in restricted access areas.
- Answer routine inquiries.
- Perform security and health and safety checks at designated intervals and at random.
- Escort TEN-TEN agents, employees, visitors, vendors and contractors from TEN-TEN's facility to their vehicles during non-business hours.

Inventory Manager: The Inventory Manager is responsible for implementing inventory controls, maintaining inventories of in-process and finished marijuana and marijuana products using the BiotrackTHC (or its equivalent) and metrc systems on a day-to-day basis, as well as performing and/or overseeing the performance of the shift, daily, weekly, monthly, quarterly and annual inventory counts. The Inventory Manager is also responsible for maintaining inventories of raw materials, supplies, equipment, and physical assets. The Inventory Manager is responsible for labeling, tracking, and reporting on inventories of in-process and finished marijuana and marijuana products, as well as of raw materials, supplies, equipment, and physical assets. Further, the Inventory Manager is responsible for maintaining all records relating to TEN-TEN's inventory. Additionally, the Inventory Manager, along with the other Managers, is also responsible for ensuring the Commission's storage and waste disposal requirements are implemented and maintained. The Inventory Manager shall perform any and all other duties, as directed by senior management. In addition, the Inventory Manager shall be responsible to:

- With the Security Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(8).
- Ensure that TEN-TEN is in compliance with 935 CMR 500.105 (9), and (13).
- Ensure that TEN-TEN is in compliance with its Plan for Prevention of Diversion and update that plan as necessary.
- Ensure, with management counterparts, that TEN-TEN is in compliance with its Storage and Waste Disposal Plan and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Shipping, Receiving and Transportation Plans, and update that plan as necessary.
- Ensure, along with management counterparts, that TEN-TEN is in compliance with its Inventory Procedures and update those procedures as necessary.
- Ensure, along with the Retail Manager, that TEN-TEN is in compliance with its Retail Establishment Procedures and update those procedures as necessary.
- Develop, implement, and update and health and safety policies, procedures, programs, and responsibilities for the inventory associates.
- Train the inventory associates in the health and safety policies, procedures, programs, and responsibilities for the inventory associates.
- Hire, train, oversee, promote, discipline, and terminate inventory associates, with the assistance of Human Resources.

<u>Inventory Associate</u>: Inventory associates support the Inventory Manager in the performance of his or her responsibilities.

<u>Human Resources Manager</u>: TEN-TEN's Human Resources (HR) Manager will support the senior management and the line managers to ensure effective implementation of all personnel policies and procedures for TEN-TEN, including TEN-TEN's hiring processes. The HR Manager

will develop, implement, update, and enforce TEN-TEN's Personnel Policy Manual, and will ensure that TEN-TEN adheres to the policies herein. Until such time as TEN-TEN's businesses have grown large enough to support the hiring of an HR Manager, the HR responsibilities will be handled by Scot Trifilo, TEN-TEN's owner, or his designee. Additionally, the HR Manager will:

- With the Security Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(1).
- With the Security Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(2)(a) and (2)(b).
- With the Security Manager, ensure that TEN-TEN performs and maintains the records of the required background checks, in accordance with M.G.L c. 6 § 172, 935 CMR 500.029, 935 CMR 500.030, 803 CMR 2.00: Criminal Offender Record Information (CORI), and 935 CMR 500.105(9)(d)5.
- Oversee hiring, training, promotions, management, disciplinary actions and terminations of TEN-TEN personnel.
- Ensure that TEN-TEN is in compliance with the Diversity Plan submitted to the Commission, and update that plan as necessary.
- Ensure that Ten-Ten is in compliance with the Plan to Positively Impact Areas of Disproportionate Impact submitted to the Commission and update that plan as necessary.
- Develop, implement and update trainings, training policies and training schedules for TEN-TEN's employees.
- With the Security Manager, assist the management staff in developing, implementing, updating and training staff in health and safety policies, procedures, and programs for their respective areas, ensure those policies, procedures and programs are implemented and followed, including, but not limited to conducting regular and random health and safety checks.
- Ensure compliance with any and all workplace laws, rules, and regulations, including but
  not limited to state and federal anti-discrimination statutes and Equal Employment
  Opportunity Commission (EEOC) requirements; state and federal leave laws and
  regulations; state and federal workplace safety laws and regulations, state and federal
  workers compensation laws and regulations; state and federal minimum wage
  requirements; and any and all other applicable local, state, or federal employment laws,
  rules, or regulations.
- Perform any and all other duties, as directed by senior management.

<u>Cultivation Manager</u>: TEN-TEN's Cultivation Manager will be responsible for the operations and maintenance of TEN-TEN's Indoor and Outdoor Cultivation facilities. Additionally, the Cultivation Manager will:

• Ensure, with the Production Manager, that TEN-TEN is in compliance with the Policies and Procedures for Cultivation submitted to the Commission and update those policies and procedures as necessary.

- Ensure, with the Production Manager, that TEN-TEN is in compliance with the general operational requirements under 935 CMR 500.105 and the additional operational requirements under 935 CMR 500.120.
- Ensure, with the Production Manager, that TEN-TEN is in compliance with the minimum energy and equipment standards as promulgated by the Commission.
- Ensure, with the Production Manager, that TEN-TEN is in compliance with the Marijuana and Marijuana Product Quality Control Processes, Product Safety Plans, and Testing Procedures submitted to the Commission and update those processes, plans and procedures as necessary.
- Ensure, with management counterparts, that TEN-TEN is in compliance with the Storage and Waste Disposal Plans submitted to the Commission and update those plans as necessary.
- Develop, implement, and update policies and procedures for the operations and maintenance of the cultivation facilities, including but not limited to the HVAC and dehumidification systems.
- Train the cultivation associates in the operations and maintenance of the cultivation facilities, including but not limited to the HVAC and dehumidification systems.
- Develop, implement and update health and safety policies, procedures, programs, and responsibilities for the indoor and outdoor cultivation facilities.
- Train the cultivation associates in the health and safety policies, procedures, programs, and responsibilities for the indoor and outdoor cultivation facilities.
- Develop, implement and update cleaning, maintenance, planting, irrigation, fertilization, pruning, trimming, potting, re-potting, integrated pest management (IPM), lighting and harvesting policies, procedures and schedules, and marijuana, soil and growth media testing policies, procedures and schedules.
- Train the cultivation associates in cleaning, maintenance, planting, irrigation, fertilization, pruning, trimming, potting, re-potting, integrated pest management (IPM), lighting and harvesting policies, procedures and schedules.
- Train the cultivation associates in marijuana, soil and growth media testing policies, procedures and schedules.
- With the Production Manager, develop, implement, and update policies and procedures to transition harvested plant material from the cultivation rooms to the trim room.
- Train the cultivation associates in the policies and procedures to transition harvested plant material from the cultivation rooms to the trim room.
- With the Production Manager, develop, implement, and update policies and procedures to ensure prompt transfer of marijuana trim to the production of pre-rolled joints.
- Train the cultivation associates in the policies and procedures to ensure prompt transfer of marijuana trim to the production of pre-rolled joints.
- Develop, implement, and update policies and procedures for storage and waste disposal for TEN-TEN's cultivation facilities.

- Train the cultivation associates in the policies and procedures for storage and waste disposal.
- Hire, train, oversee, promote, discipline and terminate cultivation staff, with the assistance of Human Resources.
- Coordinate with the Production Manager to ensure a steady flow of marijuana to meet TEN-TEN's needs.
- Maintain a database of information regarding indoor and outdoor cultivation environmental conditions, including but not limited to temperature, humidity, precipitation, irrigation, lighting, fertilization, pruning, trimming, potting, re-potting, pests and integrated pest management (IPM), and biological contaminants.
- Maintain a database of information regarding quantity and quality of indoor and outdoor harvests of flower and trim.
- Cross-reference the two databases to allow the Cultivation Manager, Production Manager
  and senior management to develop, implement and update the most effective strategies to
  produce the highest possible number and quality of crops, considering quality, quantity and
  consistency of flower and trim produced.
- Perform any and all other duties, as directed by senior management.

<u>Cultivation Associate</u>: Cultivation associates assist the Cultivation Manager in the performance of his or her responsibilities as above, as well as:

- Operate and maintain the cultivation facilities, including but not limited to the HVAC and dehumidification systems.
- Follow the health and safety policies, procedures, programs, and responsibilities for the indoor and outdoor cultivation facilities.
- Follow the cleaning, maintenance, planting, irrigation, fertilization, pruning, trimming, potting, re-potting, integrated pest management (IPM), lighting and harvesting policies, procedures and schedules.
- Follow the marijuana, soil and growth media testing policies, procedures and schedules.
- Follow the policies and procedures for storage and waste disposal.
- Perform all other duties as assigned.

<u>Production Manager Marijuana and Production Manager Marijuana Products</u>: For the purposes of this policy, the duties and responsibilities of the Production Manager for Marijuana and those of the Production Manager for Marijuana Products are combined. TEN-TEN, at its option, may choose to divide those duties and responsibilities, based on TEN-TEN's business needs. The Production Manager is responsible for all post-harvest handling of marijuana and the manufacturing of all marijuana products. The Production Manager coordinates with the Cultivation Manager to ensure a steady flow of marijuana to meet TEN-TEN's needs. ## <u>TEN-TEN LLC's Plan for Restricting Access to TEN-TEN's Production Facilities to</u> <u>Individuals Age Twenty-one (21) and Older</u>

Pursuant to 935 CMR 500.110(1)(a) and TEN-TEN's Safety and Security Plan, no individuals under the age of twenty-one (21) shall be permitted in any of TEN-TEN's Marijuana Establishments. Pursuant to 935 CMR 500.030(1), all board members, directors, employees, executives, managers, and employees of TEN-TEN shall be registered Marijuana Establishment Agents, and all such individuals shall be twenty-one (21) years of age or older. Pursuant to 935 CMR 500.110(1)(a) and TEN-TEN's Safety and Security Plan, TEN-TEN shall not admit visitors under the age of twenty-one (21) to TEN-TEN's Production facilities.

# Written Procedures Required to Ensure that Individuals Under Twenty-one (21) Years of Age are Not Admitted to TEN-TEN's Facilities

In accordance with 935 CMR 500.105(1), TEN-TEN shall develop and maintain a set of detailed written operating procedures, including, but not limited to those required by statute and CCC regulations, which shall specifically include processes to ensure that individuals under twenty-one (21) years of age are not admitted to TEN-TEN's facilities.

Pursuant to TEN-TEN's Safety and Security Plan:

All outside vendors, contractors and visitors shall obtain a visitor identification badge from TEN-TEN Security personnel prior to entering a limited access area and shall be escorted at all times by a Marijuana Establishment Agent authorized to enter the limited access area. The visitor identification badge shall be visibly displayed at all times. All visitors must be logged in and out and that log shall be available for inspection by the Commission at all times. All visitor identification badges shall be returned to TEN-TEN on exit. (935 CMR 500.110(4)(e))

Individuals under the age of twenty-one (21) are not allowed on TEN-TEN's premises or in TEN-TEN's facilities. TEN-TEN shall employ security policies and procedures to ensure that individuals under the age of twenty-one (21) do not gain entry to TEN-TEN's premises and facilities.

All TEN-TEN premises and facilities shall have a sign posted at their entrances and exits

that shall be a minimum of twelve inches by twelve inches (12" x 12") and which states in **bold** type: "No one under twenty-one (21) years of age permitted. All persons shall present a valid, current government-issued photo identification card with a clearly visible, unaltered date of birth." in lettering no smaller than one inch (1") in height. Security personnel shall verify that the age of every visitor is twenty-one (21) years or older, and log information regarding the visitor, including but not limited to the visitor's name, contact information, and numbered visitor identification badge issued, time of arrival and departure, purpose of visit, facilities and areas to be accessed, the names of any employees visited, as well the names of the Marijuana Establishment Agent or Agents escorting the visitor. If the visitor is a regulatory agent, a law enforcement agent, or an emergency responder visiting TEN-TEN on a non-emergency basis, the visitors' log shall also reflect their badge number. The visitors' log shall be available for inspection by the Commission and law enforcement agencies at all times.

#### Parties at TEN-TEN Responsible for Ensuring that the Above is Enforced

Once TEN-TEN has achieved a sufficient volume of sales to justify the hiring of a Compliance Manager, the Compliance Manager shall be responsible for developing and maintaining a set of detailed written operating procedures, which shall specifically include the above processes, to ensure that individuals under twenty-one (21) years of age are not admitted to TEN-TEN's facilities, in accordance with 935 CMR 500.105(1) and 935 CMR 500.105(1)(p).

Until such time as TEN-TEN achieves a sufficient volume of sales to justify the hiring of a Compliance Manager, the TEN-TEN Security Manager shall be responsible for the responsibilities of the Compliance Manager.

# TEN-TEN's Marijuana and Marijuana Product Quality Control Processes, Product Safety Plans, and Testing Procedures

TEN-TEN LLC ("TEN-TEN") has developed marijuana and marijuana product quality control processes, product safety plans and testing procedures to ensure that TEN-TEN is compliant with all regulatory and legal requirements, including, but not limited to 935 CMR 500.101(1)(c), sanitary practices in compliance with 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements, 105 CMR 590.000: State Sanitary Code Chapter X – Minimum Sanitation Standards for Food Establishments, 310 CMR 7.00: Air Pollution Control, M.G.L. c. 94G, §  $4(a\frac{1}{2})(xxvi)$ , 935 CMR 500.105, 935 CMR 500.130, 935 CMR 500.160, and 21 CFR 1.908(c) and that protect the safety of our customers, our surrounding community and our employees.

Pursuant to 935 CMR 500.105(3), TEN-TEN has developed the following requirements for the handling of marijuana:

TEN-TEN shall process marijuana in a safe and sanitary manner. TEN-TEN shall process the leaves and flowers of the female marijuana plant only, which shall be:

- 1. Well cured and free of seeds and stems;
- 2. Free of dirt, sand, debris, and other foreign matter;
- 3. Free of contamination by mold, rot, other fungus, pests and bacterial diseases and satisfying the sanitation requirements in 105 CMR 500.000: Good Manufacturing Practices for Food, and if applicable, 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments;
- 4. Prepared and handled on food-grade stainless steel tables with no contact with bare hands; and
- 5. Packaged in a secure area.

TEN-TEN shall also comply with the following sanitary requirements:

- 1. Any marijuana establishment agent whose job includes contact with marijuana or non-edible marijuana products, including cultivation, production, or packaging, is subject to the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements;
- 2. Any marijuana establishment agent working in direct contact with preparation of marijuana or non-edible marijuana products shall conform to sanitary practices while on duty, including:
  - a. Maintaining adequate personal cleanliness; and

- b. Washing hands thoroughly in an adequate hand-washing area before starting work, and at any other time when hands may have become soiled or contaminated.
- 3. Hand-washing facilities shall be adequate and convenient and shall be furnished with running water at a suitable temperature. Hand-washing facilities shall be located in TEN-TEN's production areas and where good sanitary practices require employees to wash and sanitize their hands, and shall provide effective hand-cleaning and sanitizing preparations and sanitary towel service or suitable drying devices;
- 4. There shall be sufficient space for placement of equipment and storage of materials as is necessary for the maintenance of sanitary operations;
- 5. Litter and waste shall be properly removed, disposed of so as to minimize the development of odor and minimize the potential for the waste attracting and harboring pests. The operating systems for waste disposal shall be maintained in an adequate manner pursuant to 935 CMR 500.105(12);
- 6. Floors, walls, and ceilings shall be constructed in such a manner that they may be adequately kept clean and in good repair;
- 7. There shall be adequate safety lighting in all processing and storage areas, as well as areas where equipment or utensils are cleaned;
- 8. Buildings, fixtures, and other physical facilities shall be maintained in a sanitary condition;
- 9. All contact surfaces, including utensils and equipment, shall be maintained in a clean and sanitary condition. Such surfaces shall be cleaned and sanitized as frequently as necessary to protect against contamination, using a sanitizing agent registered by the US Environmental Protection Agency (EPA), in accordance with labeled instructions. Equipment and utensils shall be so designed and of such material and workmanship as to be adequately cleanable;
- 10.All toxic items shall be identified, held, and stored in a manner that protects against contamination of marijuana products. Toxic items shall not be stored in an area containing products used in the cultivation of marijuana. The Commission may require TEN-TEN to demonstrate the intended and actual use of any toxic items found on the premises;
- 11.TEN-TEN's public water supply shall be sufficient for necessary operations;
- 12.Plumbing shall be of adequate size and design, and adequately installed and maintained to carry sufficient quantities of water to required locations throughout TEN-TEN's facilities. TEN-TEN's plumbing shall properly convey sewage and liquid disposable waste. There shall be no cross-connections between the potable and wastewater lines;
- 13.TEN-TEN shall provide its employees with adequate, readily accessible toilet facilities that are maintained in a sanitary condition and in good repair;
- 14.Products that can support the rapid growth of undesirable microorganisms shall be stored in a manner that prevents the growth of these microorganisms;
- 15. Storage and transportation of finished products shall be under conditions that will protect them against physical, chemical, and microbial contamination as well as against deterioration

of finished products or their containers; and

16.All vehicles and transportation equipment used in the transportation of marijuana and marijuana products or edibles requiring temperature control for safety must be designed, maintained, and equipped as necessary to provide adequate temperature control to prevent the marijuana, marijuana products or edibles from becoming unsafe during transportation, consistent with applicable requirements pursuant to 21 CFR 1.908(c).

In addition to the general operational requirements for TEN-TEN required under 935 CMR 500.105, pursuant to 935 CMR 500.130, TEN-TEN has developed the following additional requirements for the handling of marijuana products:

- 1. TEN-TEN's production of edible marijuana products shall take place in compliance with the following:
  - a. All edible marijuana products shall be prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments, and with the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements; and
  - b. Any Marijuana Product that is made to resemble a typical food or beverage product must be packaged and labelled as required by 935 CMR 500.105(5) and (6).
- 2. TEN-TEN shall meet all applicable environmental laws, regulations, permits and other applicable approvals including, but not limited to, those related to water quality and quantity, wastewater, solid and hazardous waste management and air pollution control, including prevention of odor and noise pursuant to 310 CMR 7.00: Air Pollution Control, and use additional best management practices as determined by the Commission in consultation with the working group established under St. 2017, c. 55, § 78(b) or applicable departments or divisions of the EOEEA to reduce energy and water usage, engage in energy conservation and mitigate other environmental impacts.
- 3. TEN-TEN, when selling or otherwise transferring marijuana and marijuana products to another marijuana establishment, shall provide documentation of its compliance, or lack thereof, with the testing requirements of 935 CMR 500.160, and the standards established by the Commission for the conditions, including time and temperature controls, necessary to protect marijuana and marijuana products against physical, chemical, and microbial contamination, as well as against deterioration of finished products during storage and transportation.
- 4. In addition to the written operating policies required under 935 CMR 500.105(1), TEN-TEN shall maintain written policies and procedures for the production and/or distribution of marijuana and marijuana products, as applicable, which shall include, but not be limited to:
  - a. Methods for identifying, recording, and reporting diversion, theft, or loss, and for

- correcting all errors and inaccuracies in inventories. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(8);
- b. Policies and procedures for handling voluntary and mandatory recalls of marijuana and/or marijuana products. Such procedures shall be adequate to deal with recalls due to any action initiated at the request or order of the Commission, and any voluntary action by TEN-TEN to remove defective or potentially defective marijuana and/or marijuana products from the market, as well as any action undertaken to promote public health and safety;
- c. Policies and procedures for ensuring that any outdated, damaged, deteriorated, mislabeled, or contaminated marijuana and/or marijuana products are segregated from other product and destroyed. Such procedures shall provide for written documentation of the disposition of the marijuana and/or marijuana products. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(12);
- d. Policies and procedures for transportation. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(13);
- e. Policies and procedures to reduce energy and water usage, engage in energy conservation and mitigate other environmental impacts. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(15);
- f. Policies and procedures for the transfer, acquisition, or sale of marijuana and/or marijuana products between marijuana establishments;
- g. Policies and procedures to ensure that all edible marijuana products are prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments, and with the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements; and
- h. Policies and procedures for maintaining a product catalog identifying all types of marijuana products actively manufactured at the facility. The catalog shall include a description of the product, photograph or illustration, packaging design, and dosage amounts, including expected cannabinoid profile.
- 5. Notwithstanding a stricter municipal or state regulation, TEN-TEN shall identify the method of extraction (e.g., Butane, Propane, CO2) on a physical posting at all entrances. The posting shall be a minimum of 12" x 12" and identify the method of extraction in lettering no smaller than one inch in height. TEN-TEN shall also post a copy of a permit to keep, store, handle or otherwise use flammable and combustible gasses at each place of keeping, storing, handling or using such gasses within the facility.
- 6. Production of edible marijuana products shall take place in compliance with the following: a. Any edible marijuana product that is made to resemble a typical food or beverage

- product must be packaged and labeled as required by M.G.L. c. 94G, § 4(a½)(xxvi), and 935 CMR 500.105(5) and (6).
- b. The manufacture or sale of edibles in the following shapes and types is prohibited:
  - 1. The distinct shape of a human, animal, or fruit; or
  - 2. A shape that bears the likeness or contains characteristics of a realistic or fictional human, animal, or fruit, including artistic, caricature, or cartoon renderings.
- c. Edible marijuana products that are geometric shapes and simply fruit-flavored are not considered fruit and are permissible.
- 7. Sanitary Requirements: All edible marijuana products shall be prepared, handled, and stored in compliance with the requirements in 935 CMR 500.105(3) and 935 CMR 500.105(11).
- 8. Additional labeling and packaging requirements for edible marijuana products:
  - a. In addition to the requirements set forth in M.G.L. c. 94G, § 4(a½)(xxvi), and 935 CMR 500.105(5) and (6), TEN-TEN shall ensure that the following information or statement is affixed to every container holding an edible earijuana product:
    - 1. If the retail edible marijuana product is perishable or time and temperature controlled, a statement that the edible marijuana product must be refrigerated.
    - 2. The date on which the edible marijuana product was produced.
    - 3. A nutritional fact panel that must be based on the number of THC servings within the container.
    - 4. Information regarding the size of each serving for the product by milligrams, the total number of servings of marijuana in the product, and the total amount of active THC in the product by milligrams (mgs). For example: "The serving size of active THC in this product is X mg(s), this product contains Y servings of marijuana, and the total amount of active THC in this product is (X\*Y) mg(s)."
    - 5. A warning that the impairment effects of edible marijuana may be delayed by two hours or more.
- 9. Once a label with a use-by date has been affixed to a container holding an edible marijuana product, TEN-TEN shall not alter that date or affix a new label with a later use-by date.
- 10.TEN-TEN shall ensure that each single serving of an edible marijuana product is physically marked in a way that enables a reasonable person to intuitively determine how much of the product constitutes a single serving of active THC.
- 11.Each serving of an edible marijuana product within a multi-serving package of edible marijuana products must be easily separable, in order to allow an average person twenty-one (21) years of age or older to physically separate, with minimal effort, individual servings of

the product.

- 12. Each single serving of an edible marijuana product contained in a packaged unit of multiple edible marijuana product shall be marked, stamped, or otherwise imprinted with a symbol or easily recognizable mark issued by the Commission that indicates the package contains marijuana product.
- 13.TEN-TEN shall not prepare or deliver, sell or otherwise distribute an edible marijuana product with potency levels exceeding the following, as tested by an independent marijuana testing facility licensed in accordance with M.G.L. c. 94G, § 15:
  - a. For a single serving of an edible marijuana product, five milligrams (5.00 mg) of active tetrahydrocannabinol (THC);
  - b. In a single package of multiple edible marijuana product to be eaten, swallowed, or otherwise ingested, not more than twenty (20) servings or one hundred (100) milligrams (100.00 mg) of active THC; and
  - c. The THC content must be homogenous, or evenly distributed throughout the edible marijuana product. A retail marijuana product shall be considered to not be homogenous if ten percent (10%) of the infused portion of the marijuana product contains more than twenty (20%) of the total THC contained within entire marijuana product.

## **Quality Control**

TEN-TEN shall comply with the following sanitary requirements:

- 1. Any TEN-TEN agent whose job includes contact with marijuana or nonedible marijuana products, including cultivation, production, or packaging, is subject to the requirements for food handlers specified in 105 CMR 300.000, and all edible marijuana products shall be prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 500.000, and with the requirements for food handlers specified in 105 CMR 300.000.
- 2. Any TEN-TEN agent working in direct contact with preparation of marijuana or nonedible marijuana products shall conform to sanitary practices while on duty, including:
  - a. Maintaining adequate personal cleanliness; and
  - b. Washing hands thoroughly in an adequate hand-washing area before starting work, and at any other time when hands may have become soiled or contaminated.
- 3. TEN-TEN's hand-washing facilities shall be adequate and convenient and shall be furnished with running water at a suitable temperature. Hand-washing facilities shall be located in TEN-TEN's production areas and where good sanitary practices require employees to wash and sanitize their hands, and shall provide effective hand-cleaning and sanitizing preparations and sanitary towel service or suitable drying devices;
- 4. TEN-TEN's facility shall have sufficient space for placement of equipment and storage of materials as is necessary for the maintenance of sanitary operations;

- 5. TEN-TEN shall ensure that litter and waste is properly removed and disposed of so as to minimize the development of odor and minimize the potential for the waste attracting and harboring pests. The operating systems for waste disposal shall be maintained in an adequate manner pursuant to 935 CMR 500.105(12);
- 6. TEN-TEN's floors, walls, and ceilings shall be constructed in such a manner that they may be adequately kept clean and in good repair;
- 7. TEN-TEN's facility shall have adequate safety lighting in all processing and storage areas, as well as areas where equipment or utensils are cleaned;
- 8. TEN-TEN's buildings, fixtures, and other physical facilities shall be maintained in a sanitary condition;
- 9. TEN-TEN shall ensure that all contact surfaces, including utensils and equipment, shall be maintained in a clean and sanitary condition. - 13. TEN-TEN shall provide its employees with adequate, readily accessible toilet facilities that are maintained in a sanitary condition and in good repair;
- 14. TEN-TEN shall hold all products that can support the rapid growth of undesirable microorganisms in a manner that prevents the growth of these microorganisms; and
- 15. TEN-TEN shall store and transport finished products under conditions that shall protect them against physical, chemical, and microbial contamination, as well as against deterioration of finished products or their containers.

TEN-TEN's vehicles and transportation equipment used in the transportation of marijuana products or edibles requiring temperature control for safety shall be designed, maintained, and equipped as necessary to provide adequate temperature control to prevent the marijuana products or edibles from becoming unsafe during transportation, consistent with applicable requirements pursuant to 21 CFR 1.908(c).

TEN-TEN shall ensure that TEN-TEN's facility is always maintained in a sanitary fashion and shall comply with all applicable sanitary requirements.

TEN-TEN shall follow established policies and procedures for handling voluntary and mandatory recalls of marijuana products. Such procedures are sufficient to deal with recalls due to any action initiated at the request or order of the Commission, and any voluntary action by TEN-TEN to remove defective or potentially defective marijuana products from the market, as well as any action undertaken to promote public health and safety.

Any inventory that becomes outdated, spoiled, damaged, deteriorated, mislabeled, or contaminated shall be disposed of in accordance with the provisions of 935 CMR 500.105(12), and any such waste shall be stored, secured, and managed in accordance with applicable state and local statutes, ordinances, and regulations.

TEN-TEN shall process marijuana in a safe and sanitary manner. TEN-TEN shall process the leaves and flowers of the female marijuana plant only, which shall be:

- Well-cured and generally free of seeds and stems;
- Free of dirt, sand, debris, and other foreign matter;
- Free of contamination by mold, rot, other fungus, and bacterial diseases;
- Prepared and handled on food-grade stainless steel tables; and
- Packaged in a secure area.

All edible products shall be prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: Minimum Sanitation Standards for Food Establishments.

#### **Testing**

In compliance with 935 CMR 500.160(1), TEN-TEN shall not sell or otherwise market marijuana or marijuana products that are not capable of being tested by Independent Testing Laboratories, except as otherwise allowed under 935 CMR 500.000: Adult Use of Marijuana.

Pursuant to 935 CMR 500.160(1) testing of TEN-TEN's Marijuana Products shall be performed by an Independent Testing Laboratory in compliance with protocol(s) established in accordance with M.G.L. c. 94G, § 15 and in a form and manner determined by the Commission including, but not limited to, the Protocol for Sampling and Analysis of Finished Medical Marijuana Products and Marijuana-infused Products.

Pursuant to 935 CMR 500.160(1), testing of environmental media (e.g., soils, solid growing media, and water) shall be performed in compliance with the Protocol for Sampling and Analysis of Environmental Media for Massachusetts Registered Medical Marijuana Dispensaries published by the Commission.

Pursuant to 935 CMR 500.160(2), TEN-TEN's marijuana shall be tested for the cannabinoid profile and for contaminants, as specified by the Commission, including, but not limited to, mold, mildew, heavy metals, plant growth regulators, and the presence of pesticides. The Commission may require additional testing.

Pursuant to 935 CMR 500.160(3), TEN-TEN has a written policy for responding to laboratory results that indicate contaminant levels are above acceptable limits established in the protocols identified in 935 CMR 500.160(1).

Pursuant to 935 CMR 500.160(3)(a), TEN-TEN's policy includes, but is not limited to:

- 1. notifying the Commission within 72 hours of any laboratory testing results indicating that the contamination cannot be remediated and disposing of the production batch.
- 2. notifying the Commission of any information regarding contamination as specified by the Commission or immediately upon request by the Commission.

Pursuant to 935 CMR 500.160(3)(b), TEN-TEN's policy requires the notification referred to above be from both TEN-TEN and the Independent Testing Laboratory, separately and directly.

Pursuant to 935 CMR 500.160(3)(c), TEN-TEN's policy requires the notification from TEN-TEN describe a proposed plan of action for both the destruction of the contaminated product and the assessment of the source of contamination.

Pursuant to 935 CMR 500.160(4), TEN-TEN shall maintain the results of all testing for no less than one year. Testing results shall be valid for a period of one year. Marijuana or marijuana products with testing dates in excess of one year old shall be deemed expired and may not be dispensed, sold, transferred or otherwise conveyed until retested.

Pursuant to 935 CMR 500.160(5), seeds sold by TEN-TEN is not subject to the above testing provisions.

Pursuant to 935 CMR 500.160(6), clones are subject to these testing provisions, but are exempt from testing for metals.

Pursuant to 935 CMR 500.160(7), all transportation of marijuana and marijuana products to and from Independent Testing Laboratories providing marijuana testing services shall comply with 935 CMR 500.105(13).

Pursuant to 935 CMR 500.160(8), any excess marijuana and/or marijuana products shall be disposed in compliance with 935 CMR 500.105(12), either by the independent testing laboratory returning the excess marijuana and/or marijuana products to TEN-TEN for disposal, or by the independent testing laboratory disposing of it directly.

### **Quality Control Standard Operating Procedures**

TEN-TEN shall implement standard operating procedures (SOPs) relating to quality control processes to ensure product quality and safety. Once TEN-TEN's volume justifies the appointment of a Quality Assurance Manager, TEN-TEN shall appoint same, who shall be responsible for the development, implementation, oversight and updating, as necessary, of TEN-TEN's quality control processes.

In the interim, TEN-TEN's owner, Scot Trifilo, shall personally oversee TEN-TEN's on-site quality control processes, with the assistance of TEN-TEN's off-site independent testing laboratory. TEN-TEN's quality control and product safety processes shall incorporate employee, community, and customer product quality and safety considerations and shall require strict adherence in TEN-TEN's daily activities.

TEN-TEN's extensive quality control processes address a myriad of product safety requirements including, but not limited to, employee training requirements, proper equipment usage and equipment maintenance protocols, sanitation standards, cultivation protocols, component and product handling and storage, quality control testing, child-resistant packaging, product inserts, label disclosures and product traceability requirements.

TEN-TEN's SOPs shall be updated as often as necessary to ensure compliance with the laws and regulations that govern TEN-TEN. TEN-TEN's owner, Scot Trifilo, or his designate, with the support and input of his managers, shall be personally responsible for updating TEN-TEN's SOPs to incorporate any additions or amendments to the laws and regulations affecting TEN-TEN, as well as incorporating any guidance or directives published by regulatory agencies as they apply to TEN-TEN.

All employees shall be required to have proper training on the SOPs applicable to their duties. Each employee shall be required to demonstrate their understanding of the critical processes which apply to

their duties and responsibilities. Additionally, all third-party contractors shall be required, by contract, to perform their duties in compliance with TEN-TEN's policies and procedures and regulatory agency regulations.

Any employee or contractor who fails to perform their duties in compliance with TEN-TEN's policies and procedures and regulatory agency regulations shall be reprimanded and/or terminated, depending on the severity of the offense. All employees and contractors shall be required, as a condition of employment and/or contract, to report any observed compliance issues to the appropriate TEN-TEN manager.

### Overview of TEN-TEN's Personnel Policies including Background Checks

TEN-TEN LLC ("TEN-TEN") has established policies and procedures regarding recordkeeping and record retention in order to ensure the maintenance, safekeeping, and accessibility of critical documents

To ensure confidentiality, written personnel records shall be stored in a locked area designated for record retention. Electronic records will be password protected and shall be stored on the TEN-TEN server, in on-site and off-site backup, and in the cloud, as necessary. All written and electronic records shall be available for inspection by the Commission upon request in compliance with 935 CMR 500.105(1).

The Personnel (Staffing) Records will be kept in compliance with 935 CMR 500.105(9)(d), including but not limited to, written and/or electronic records of:

- Job descriptions for each agent, as well as organizational charts consistent with the job descriptions;
- Personnel records for each marijuana establishment agent. Such records shall be maintained for at least twelve (12) months after termination of the agent's affiliation with TEN-TEN and shall include, at a minimum, the following:
  - All materials submitted to the Commission pursuant to 935 CMR 500.030(2);
  - Documentation of verification of references:
  - The job description or employment contract that includes duties, authority, responsibilities, qualifications, and supervision;
  - Documentation of all required training, including training regarding privacy and confidentiality requirements, and the signed statement of the individual indicating the date, time, and place he or she received said training and the topics discussed, including the name and title of presenters;
  - Documentation of periodic performance evaluations;
  - A record of any disciplinary action taken; and
  - Notice of completed responsible vendor and eight-hour related duty training.

TEN-TEN's Written Operating Policies and Procedures are in compliance with 935 CMR 500.105, and include, but are not limited to:

- TEN-TEN is an alcohol, smoke, and drug-free workplace, pursuant to 935 CMR 500.105(1)(k);
- Any TEN-TEN agent or employee shall be immediately terminated, pursuant to 935 CMR 500.105(1)(m), who has:
  - Diverted marijuana, which shall be reported to law enforcement authorities and to the Commission;
  - Engaged in unsafe practices with regard to TEN-TEN's operations, which shall be reported to the Commission; or
  - Been convicted or entered a guilty plea, plea of nolo contendere, or admission to sufficient facts of a felony drug offense involving distribution to a minor in the Commonwealth, or alike violation in any other jurisdiction.
- TEN-TEN's job descriptions comply with 935 CMR 500.105(9)(d)(1);
- Background Checks: All agents, employees, and owners of TEN-TEN will undergo a detailed background investigation by the Cannabis Control Commission ("CCC") and/or TEN-TEN, prior to being granted access to a TEN-TEN facility or beginning work duties;
- TEN-TEN's Staffing plan is in compliance with 935 CMR 500.105(9)(d) and 935 CMR 500.105(1)(i):
  - Until licensed and in full operation, not all positions detailed below will be filled. Instead, a limited number of individuals will assume the responsibilities of the unfilled positions. The job descriptions for potential positions are provided below.
    - CULTIVATION (INDOOR) STAFFING PLAN:
      - Initially, four (4) individuals and eventually eight to ten employees, including a Cultivation Manager, Cultivation Associates, and required Security Personnel.
    - CULTIVATION (OUTDOOR) STAFFING PLAN:
      - Initially, the staff from the Indoor Cultivation will be utilized for the Outdoor growth as that will primarily be for Mothers plants to be exposed to natural sunlight, and required Security Personnel. Eventually, there will be six to eight employees for the Outdoor Cultivation in addition to
    - RETAIL STAFFING PLAN:
      - Six to eight employees to open the Retail Establishment including a Retail Manager, Retail Associates, and required Security Personnel.
    - PRODUCTION STAFFING PLAN:
      - Two to four employees to begin the Production Establishment including a Production Manager, Production Associate, and required Security Personnel.

### <u>Job Descriptions in compliance with 935 CMR 500.105(9)(d)(1):</u>

<u>Security Manager</u>: Under the supervision of senior management, the Security Manager is responsible for the safety and security of TEN-TEN's owners; employees; agents; visitors,

vendors, and contractors while on TEN-TEN property; TEN-TEN's property, facilities, assets, inventory, raw materials, equipment, and waste; TEN-TEN's host community, as affected by TEN-TEN's safety and security. The Security Manager is also responsible for the development, implementation, administration, maintenance, and management of TEN-TEN's Security Policies and Procedures. The Security Manager supervises the security staff (once hired) and performs their duties and responsibilities until the security staff is hired, and subsequent to their hiring, as necessary. In addition, the Security Manager shall be responsible to:

- With the Human Resource Manager, ensure that TEN-TEN performs and maintains the records of the required background checks, in accordance with M.G.L c. 6 § 172, 935 CMR 500.029, 935 CMR 500.030, 803 CMR 2.00: Criminal Offender Record Information (CORI), and 935 CMR 500.105(9)(d)5.
- With the Retail Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.050(8)(b) and 935 CMR 500.140.
- With the Human Resources Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(1).
- With the Human Resources Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(2)(a) and (2)(b).
- With the Inventory Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(8).
- Ensure that TEN-TEN is in compliance with 935 CMR 500.110(1) or (2), 935 CMR 500.110(4) to 935 CRM 500.110(7), and 935 CMR 500.110(9) and (10).
- With the Retail Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.140(2).
- Ensure that TEN-TEN is in compliance with its Plan for Restricting Access to Age 21 or Older and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Safety and Security Plan and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Plan for Prevention of Diversion and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Storage and Waste Disposal Plan and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Shipping, Receiving and Transportation Plans and update those plans as necessary.
- Ensure that TEN-TEN is in compliance with its Inventory Procedures and update those procedures as necessary.
- Ensure that TEN-TEN is in compliance with its Retail Establishment Procedures and update those procedures as necessary.
- Ensure that TEN-TEN is in compliance with its Qualifications and Intended Trainings for Owners, Managers and Marijuana Establishment Agents and update as necessary.

- Ensure that TEN-TEN is in compliance with all safety and security requirements contained in the relevant CMRs and in TEN-TEN policies and procedures which are not referenced above and update TEN-TEN's policies and procedures as necessary.
- Develop, implement and update and health and safety policies, procedures, programs and responsibilities for the security agents.
- Train the security agents in the health and safety policies, procedures, programs and responsibilities for security staff.
- With the Human Resources Manager, assist the management staff in developing, implementing, updating and training staff in health and safety policies, procedures, and programs for their respective areas, ensure those policies, procedures, and programs are implemented and followed, including, but not limited to conducting regular and random health and safety checks.
- Hire, train, oversee, promote, discipline, and terminate security staff, with the assistance of Human Resources.
- Assume the responsibilities of the Inventory Manager and the Compliance Manager, until
  such time as TEN-TEN's business operations are of such size that TEN-TEN is able to fill
  those positions.
- Perform any and all other duties, as directed by senior management.

**Security Agent:** The duties and responsibilities identified below will be performed by the Security Manager until the Security staff has been hired, and, subsequent to their hiring, as necessary. Security staff supports the Security Manager in the performance of his or her duties, monitors TEN-TEN's security systems, including but not limited to the alarm and surveillance systems, and monitors and maintains the access control systems. Security staff are responsible for ensuring that only authorized individuals are permitted access to TEN-TEN's facilities by verifying ID cards and other forms of identification. In addition, security staff perform the following duties and any and all other duties, as assigned:

- Investigate, communicate, and provide leadership in the event of an emergency, such as an intrusion, fire, or other threat that jeopardizes TEN-TEN staff, agents, customers, visitors, vendors, and contractors and TEN-TEN'/s host community.
- Respond to and investigate security situations and alarm activations; clearly document any incidents in written reports.
- Oversee the entrance to TEN-TEN's facilities and verify the credentials of each person seeking access to TEN-TEN facilities.
- Manage the flow of staff, agents, customers, visitors, vendors, and contractors, including maintaining the visitor log and issuing and collecting visitor badges.
- Escort authorized visitors, vendors, and contractors while in restricted access areas.
- Answer routine inquiries.
- Perform security and health and safety checks at designated intervals and at random.

• Escort TEN-TEN agents, employees, visitors, vendors and contractors from TEN-TEN's facility to their vehicles during non-business hours.

Inventory Manager: The Inventory Manager is responsible for implementing inventory controls, maintaining inventories of in-process and finished marijuana and marijuana products using the BiotrackTHC (or its equivalent) and metrc systems on a day-to-day basis, as well as performing and/or overseeing the performance of the shift, daily, weekly, monthly, quarterly and annual inventory counts. The Inventory Manager is also responsible for maintaining inventories of raw materials, supplies, equipment, and physical assets. The Inventory Manager is responsible for labeling, tracking, and reporting on inventories of in-process and finished marijuana and marijuana products, as well as of raw materials, supplies, equipment, and physical assets. Further, the Inventory Manager is responsible for maintaining all records relating to TEN-TEN's inventory. Additionally, the Inventory Manager, along with the other Managers, is also responsible for ensuring the Commission's storage and waste disposal requirements are implemented and maintained. The Inventory Manager shall perform any and all other duties, as directed by senior management. In addition, the Inventory Manager shall be responsible to:

- With the Security Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(8).
- Ensure that TEN-TEN is in compliance with 935 CMR 500.105 (9), and (13).
- Ensure that TEN-TEN is in compliance with its Plan for Prevention of Diversion and update that plan as necessary.
- Ensure, with management counterparts, that TEN-TEN is in compliance with its Storage and Waste Disposal Plan and update that plan as necessary.
- Ensure that TEN-TEN is in compliance with its Shipping, Receiving and Transportation Plans, and update that plan as necessary.
- Ensure, along with management counterparts, that TEN-TEN is in compliance with its Inventory Procedures and update those procedures as necessary.
- Ensure, along with the Retail Manager, that TEN-TEN is in compliance with its Retail Establishment Procedures and update those procedures as necessary.
- Develop, implement, and update and health and safety policies, procedures, programs, and responsibilities for the inventory associates.
- Train the inventory associates in the health and safety policies, procedures, programs, and responsibilities for the inventory associates.
- Hire, train, oversee, promote, discipline, and terminate inventory associates, with the assistance of Human Resources.

<u>Inventory Associate</u>: Inventory associates support the Inventory Manager in the performance of his or her responsibilities.

<u>Human Resources Manager</u>: TEN-TEN's Human Resources (HR) Manager will support the senior management and the line managers to ensure effective implementation of all personnel policies and procedures for TEN-TEN, including TEN-TEN's hiring processes. The HR Manager will develop, implement, update, and enforce TEN-TEN's Personnel Policy Manual, and will ensure that TEN-TEN adheres to the policies herein. Until such time as TEN-TEN's businesses have grown large enough to support the hiring of an HR Manager, the HR responsibilities will be handled by Scot Trifilo, TEN-TEN's owner, or his designee. Additionally, the HR Manager will:

- With the Security Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(1).
- With the Security Manager, ensure that TEN-TEN is in compliance with 935 CMR 500.105(2)(a) and (2)(b).
- With the Security Manager, ensure that TEN-TEN performs and maintains the records of the required background checks, in accordance with M.G.L c. 6 § 172, 935 CMR 500.029, 935 CMR 500.030, 803 CMR 2.00: Criminal Offender Record Information (CORI), and 935 CMR 500.105(9)(d)5.
- Oversee hiring, training, promotions, management, disciplinary actions and terminations of TEN-TEN personnel.
- Ensure that TEN-TEN is in compliance with the Diversity Plan submitted to the Commission, and update that plan as necessary.
- Ensure that Ten-Ten is in compliance with the Plan to Positively Impact Areas of Disproportionate Impact submitted to the Commission and update that plan as necessary.
- Develop, implement and update trainings, training policies and training schedules for TEN-TEN's employees.
- With the Security Manager, assist the management staff in developing, implementing, updating and training staff in health and safety policies, procedures, and programs for their respective areas, ensure those policies, procedures and programs are implemented and followed, including, but not limited to conducting regular and random health and safety checks.
- Ensure compliance with any and all workplace laws, rules, and regulations, including but not limited to state and federal anti-discrimination statutes and Equal Employment Opportunity Commission (EEOC) requirements; state and federal leave laws and regulations; state and federal workplace safety laws and regulations, state and federal workers compensation laws and regulations; state and federal minimum wage requirements; and any and all other applicable local, state, or federal employment laws, rules, or regulations.
- Perform any and all other duties, as directed by senior management.

<u>Cultivation Manager</u>: TEN-TEN's Cultivation Manager will be responsible for the operations and maintenance of TEN-TEN's Indoor and Outdoor Cultivation facilities. Additionally, the Cultivation Manager will:

- Ensure, with the Production Manager, that TEN-TEN is in compliance with the Policies and Procedures for Cultivation submitted to the Commission and update those policies and procedures as necessary.
- Ensure, with the Production Manager, that TEN-TEN is in compliance with the general operational requirements under 935 CMR 500.105 and the additional operational requirements under 935 CMR 500.120.
- Ensure, with the Production Manager, that TEN-TEN is in compliance with the minimum energy and equipment standards as promulgated by the Commission.
- Ensure, with the Production Manager, that TEN-TEN is in compliance with the Marijuana and Marijuana Product Quality Control Processes, Product Safety Plans, and Testing Procedures submitted to the Commission and update those processes, plans and procedures as necessary.
- Ensure, with management counterparts, that TEN-TEN is in compliance with the Storage and Waste Disposal Plans submitted to the Commission and update those plans as necessary.
- Develop, implement, and update policies and procedures for the operations and maintenance of the cultivation facilities, including but not limited to the HVAC and dehumidification systems.
- Train the cultivation associates in the operations and maintenance of the cultivation facilities, including but not limited to the HVAC and dehumidification systems.
- Develop, implement and update health and safety policies, procedures, programs, and responsibilities for the indoor and outdoor cultivation facilities.

- Train the cultivation associates in cleaning, maintenance, planting, irrigation, fertilization, pruning, trimming, potting, re-potting, integrated pest management (IPM), lighting and harvesting policies, procedures and schedules.
- Train the cultivation associates in marijuana, soil and growth media testing policies, procedures and schedules.
- With the Production Manager, develop, implement, and update policies and procedures to transition harvested plant material from the cultivation rooms to the trim room.
- Train the cultivation associates in the policies and procedures to transition harvested plant material from the cultivation rooms to the trim room.
- With the Production Manager, develop, implement, and update policies and procedures to ensure prompt transfer of marijuana trim to the production of pre-rolled joints.

- Train the cultivation associates in the policies and procedures to ensure prompt transfer of marijuana trim to the production of pre-rolled joints.
- Develop, implement, and update policies and procedures for storage and waste disposal for TEN-TEN's cultivation facilities.

- Coordinate with the Production Manager to ensure a steady flow of marijuana to meet TEN-TEN's needs.
- Maintain a database of information regarding indoor and outdoor cultivation environmental conditions, including but not limited to temperature, humidity, precipitation, irrigation, lighting, fertilization, pruning, trimming, potting, re-potting, pests and integrated pest management (IPM), and biological contaminants.
- Maintain a database of information regarding quantity and quality of indoor and outdoor harvests of flower and trim.
- Cross-reference the two databases to allow the Cultivation Manager, Production Manager and senior management to develop, implement and update the most effective strategies to produce the highest possible number and quality of crops, considering quality, quantity and consistency of flower and trim produced.
- Perform any and all other duties, as directed by senior management.

<u>Cultivation Associate</u>: Cultivation associates assist the Cultivation Manager in the performance of his or her responsibilities as above, as well as:

- Operate and maintain the cultivation facilities, including but not limited to the HVAC and dehumidification systems.
- Follow the health and safety policies, procedures, programs, and responsibilities for the indoor and outdoor cultivation facilities.
- Follow the cleaning, maintenance, planting, irrigation, fertilization, pruning, trimming, potting, re-potting, integrated pest management (IPM), lighting and harvesting policies, procedures and schedules.
- Follow the marijuana, soil and growth media testing policies, procedures and schedules.
- Follow the policies and procedures for storage and waste disposal.
- Perform all other duties as assigned.

<u>Production Manager Marijuana and Production Manager Marijuana Products</u>: For the purposes of this policy, the duties and responsibilities of the Production Manager for Marijuana and those of the Production Manager for Marijuana Products are combined. TEN-TEN, at its option, may choose to divide those duties and responsibilities, based on TEN-TEN's business

needs. The Production Manager is responsible for all post-harvest handling of marijuana and the manufacturing of all marijuana products. The Production Manager coordinates with the Cultivation Manager to ensure a steady flow of marijuana to meet TEN-TEN's needs. The Production Manager will be responsible for the: operation and maintenance of TEN-TEN's trim room and drying room; marijuana packaging; pre-rolled joints and packaging of pre-rolled joints; and marijuana product production and marijuana product packaging, as well as will:

- Ensure, with the Cultivation Manager, that TEN-TEN is in compliance with the Policies and Procedures for Cultivation submitted to the Commission and update those policies and procedures as necessary.
- Ensure, with the Cultivation Manager, that TEN-TEN is in compliance with the general operational requirements under 935 CMR 500.105 and the additional operational requirements under 935 CMR 500.120.
- Ensure, with the Cultivation Manager, that TEN-TEN is in compliance with the minimum energy and equipment standards as promulgated by the Commission.
- Ensure, with the Cultivation Manager, that TEN-TEN is in compliance with the Marijuana and Marijuana Product Quality Control Processes, Product Safety Plans, and Testing Procedures submitted to the Commission and update those processes, plans and procedures as necessary.
- Ensure, with management counterparts, that TEN-TEN is in compliance with the Storage and Waste Disposal Plans submitted to the Commission and update those plans as necessary.
- Ensure that TEN-Ten is in compliance with the Types of Products Manufactured and the Methods to Produce Products submitted to the Commission and update those submissions as necessary.
- Develop, implement, and update policies and procedures for the operations and maintenance of the trim room and drying room, including maintaining a sterile environment and safe use of mechanical and manual marijuana trimmers.
- Train the production associates in the policies and procedures for the operations and maintenance of the trim room and drying room, including maintaining a sterile environment and safe use of mechanical and manual marijuana trimmers.
- Develop, implement and update health and safety policies, procedures, programs, and responsibilities for production facilities.
- Train the production associates in the health and safety policies, procedures, programs, and responsibilities for production facilities.
- Develop, implement and update a rigid cleaning schedule for production facilities, to ensure and maintain product quality.
- Train the production associates in the rigid cleaning schedule for production facilities, to ensure and maintain product quality.
- With the Cultivation Manager, develop, implement, and update policies and procedures to transition harvested plant material from the cultivation rooms to the trim room.

- Train the production associates in the policies and procedures to transition harvested plant material from the cultivation rooms to the trim room.
- With the Cultivation Manager, develop, implement, and update policies and procedures to ensure prompt transfer of marijuana trim to the production of pre-rolled joints.
- Train the production associates in the policies and procedures to ensure prompt transfer of marijuana trim to the production of pre-rolled joints.

- Develop, implement, and update policies and procedures for the creation of marijuana products, including, but not limited to creating raw Super Critical CO2 (SCCO2) concentrate and creating distilled, high-purity concentrate, in accordance with the Types of Products Manufactured and the Methods to Produce Products submitted to the Commission, updating those submissions as necessary.

- Train the production associates in policies and procedures to create marijuana products, including, but not limited to creating raw Super Critical CO2 (SCCO2) concentrate and creating distilled, high-purity concentrate.
- Develop, implement, and update policies and procedures to manage inventory and periodic automatic replenishment (PAR) levels of all concentrate and marijuana products, including integration into BiotrackTHC (or its equivalent) and metrc.
- Train the production associates in policies and procedures to manage inventory and periodic automatic replenishment (PAR) levels of all concentrate and marijuana products, including integration into BiotrackTHC (or its equivalent) and metrc.
- Develop, implement, update and maintain an extraction schedule, based on the availability of marijuana flower and trim.
- Hire, train, oversee, promote, discipline and terminate production staff, with the assistance of Human Resources.
- Perform all other duties as assigned by senior management.

**Production Staff:** Production associates assist the Production Manager in the performance of his or her responsibilities as above, as well as:

- Operating and maintaining the production facilities, including but not limited to the trim room, drying room and production rooms, including maintaining a sterile environment and safe use of mechanical and manual marijuana trimmers.
- Drying and grinding cultivated material in preparation for SCCO2 extraction.
- Unpacking and cleaning the SCCO2 extractor.
- Cleaning and sanitization of all glassware, kitchen cookware and utensils, and the distillation still.
- Performing scheduled maintenance on all equipment.
- Packaging completed marijuana product and concentrates.
- Following the health and safety policies, procedures, programs, and responsibilities for the production facilities.
- Following the cleaning and maintenance policies, procedures and schedules.
- Following the policies and procedures for storage and waste disposal.
- Performing all other duties as assigned.

**Retail Manager:** The Retail Manager is responsible for operating and maintaining TEN-TEN's Retail Establishment. Additionally, the Retail Manager will:

- Ensure TEN-TEN is in compliance with the Retail Establishment Procedures submitted to the Commission and update those procedures as necessary.
- Ensure that TEN-TEN is in compliance with the Plan for Restricting Access to TEN-TEN's Marijuana Retail Store to Consumers Age Twenty-one (21) and Older submitted to the Commission and update that plan as necessary.

- Ensure that TEN-TEN is in compliance with the Plan for Prevention of Diversion submitted to the Commission and update that plan as necessary.
- Ensure that TEN-TEN's Retail Vault is in compliance with the Storage and Waste Disposal Plan submitted to the Commission and update that portion of the plan as necessary.
- Ensure, along with the Inventory Manager, that TEN-TEN is in compliance with the Inventory Procedures submitted to the Commission and update those procedures as necessary.
- Ensure that TEN-TEN is in compliance with the Records related to Recording Sales portion of the Recordkeeping Policies and Procedures submitted to the Commission and update that portion of those policies and procedures as necessary.
- Ensure TEN-TEN is in compliance with the General Requirements of a Marijuana Retailer under 935 CMR 500.050(8), the additional requirements under 935 CMR 500.101(3)(e), the Marketing and Advertising Requirements under 935 CMR 500.105(4) and (6), the Cash Handling and Transportation Requirements under 935 CMR 500.110(7), the Additional Operational Requirements for Retail Sale under 935 CMR 500.140, the requirements set forth in M.G.L. c. 94G, § 4(a½)(xxvi), the Marketing and Advertising Requirements under 935 CMR 500.105(6), the Additional Labeling and Packaging Requirements for Edible Marijuana Products under 935 CMR 500.150(3), and the Dosing Limitations for Edible Marijuana Products under 935 CMR 500.150(4).

- Actively listening to ensure understanding of customer needs, and answer customer
  questions regarding products including, but not limited to: flower, pre-rolled joints,
  concentrates, extracts, tinctures, and edibles, including but not limited to their use, potency,
  active tetrahydrocannabinol (THC) levels, dosing, labeling, packaging, and paraphernalia
  required for use.
- Maintaining and enhancing product display and merchandising, in accordance with TEN-TEN policies and procedures, while maintaining product security in compliance with Commission requirements.
- Ensuring that all transactions are properly weighed, packaged, recorded and entered into the point-of-sale (POS) system, BiotrackTHC (or its equivalent) and metrc.

- Ensuring that all cash is properly handled, and that credit card transactions are properly authorized and processed.
- Reviewing and evaluating individual sales and gross margin performance vs. plan and adjusting individual behaviors accordingly.
- Learning and following the appropriate health and safety policies and procedures.

- Participating in ongoing training and professional development as required.

# RENEWAL 7-27-21 TEN-TEN's Recordkeeping Policies and Procedures

#### General Overview

TEN-TEN LLC ("TEN-TEN") has established policies and procedures regarding recordkeeping and record retention in order to ensure the maintenance, safekeeping, and accessibility of critical documents. Written records shall be stored in a locked room designated for record retention. Electronic records shall be stored on the TEN-TEN server, in on-site and off-site backup, and in the cloud, as necessary. All written and electronic records shall be available for inspection by the Commission upon request.

### Recordkeeping in compliance with 935 CMR 500.105(9):

Written records that are required and are subject to inspection include, but are not necessarily limited to, all records required in any section of 935 CMR 500.000, in addition to the records identified below.

To ensure that TEN-TEN maintains and retains all records as required by this policy, a review by management of Corporate Records, Business Records, Personnel Records, and Financial Records to ensure completeness, accuracy, and timeliness of said records shall occur quarterly. Financial recordkeeping is addressed in a separate section of the Management and Operations Profile.

In addition, TEN-TEN's operating policies and procedures shall be updated, as needed, on an ongoing basis, and undergo a review by management on an annual basis. Updated policies and procedures shall be provided to the Commission pursuant to 935 CMR 500.104(2).

TEN-TEN's records include, but are not limited to:

- Corporate Records, which are those records may require, at a minimum, annual reviews, updates, and renewals, including but not limited to:
  - o Insurance:
    - Directors & Officers Policies
    - Product Liability Policies
    - General Liability Policies

    - Motor Vehicle Policies
    - All other policies, as necessary

- Certificates of insurance naming TEN-TEN as an additional insured
- Third-Party Testing Laboratory Contracts
- Contracts for the Purchase and/or Sale of Marijuana and Marijuana Products
- Transportation Contracts
- All other contracts
- Commission Requirements:
  - Annual Agent Registration
  - Annual Marijuana Establishment Registration
  - Policies and Procedures
- Local Compliance:
  - Host Community Agreements
  - Certificates of Occupancy
  - Special Permits
  - Variances
  - Site Plan Approvals
  - As-Built Drawings
- Corporate Governance:
  - Annual Reports
  - Secretary of State Filings
- Business Records in compliance with 935 CMR 500.105(9)(e), including but not limited to, written and/or electronic records of:
  - Assets and liabilities:
  - Monetary transactions;
  - Books of accounts, which shall include journals, ledgers, and supporting documents, agreements, checks, invoices, and vouchers;
  - Sales records including the quantity, form, and cost of marijuana products;
  - Salary and wages paid to each employee, or stipend, executive compensation, bonus, benefit, or item of value paid to any persons having direct or indirect control over the marijuana establishment.
- Personnel Records in compliance with 935 CMR 500.105(9)(d), including but not limited to, written and/or electronic records of:
  - Job descriptions for each agent, as well as organizational charts consistent with the job descriptions;
  - Personnel records for each marijuana establishment agent. Such records shall be maintained for at least twelve (12) months after termination of the

agent's affiliation with TEN-TEN and shall include, at a minimum, the following:

- All materials submitted to the Commission pursuant to 935 CMR 500.030(2);
- Documentation of verification of references;
- The job description or employment contract that includes duties, authority, responsibilities, qualifications, and supervision;
- Documentation of all required training, including training regarding privacy and confidentiality requirements, and the signed statement of the individual indicating the date, time, and place he or she received said training and the topics discussed, including the name and title of presenters;
- Documentation of periodic performance evaluations;
- A record of any disciplinary action taken; and
- Notice of completed responsible vendor and eight-hour related duty training.
- A staffing plan that demonstrates accessible business hours and safe cultivation conditions;
- o Personnel policies and procedures; and
- All background check reports obtained in accordance with M.G.L c. 6 § 172, 935 CMR 500.029, 935 CMR 500.030, and 803 CMR 2.00: Criminal Offender Record Information (CORI).
- Records of Testing of marijuana and marijuana products in compliance with 935 CMR 500.160(3).
- Inventory Records in compliance with 935 CMR 500.105(8)(b), including but not limited to:
  - Real-time inventory maintained as specified by the Commission and in 935 CMR 500.105(8)(c) and (d) including, at a minimum, an inventory of marijuana plants; marijuana plant-seeds and clones in any phase of development such as propagation, vegetation, and flowering; marijuana ready for dispensing; all in-progress and finished marijuana products; and all damaged, defective, expired, or contaminated marijuana and marijuana products awaiting disposal.
  - The record of each inventory shall include, at a minimum, the date of the inventory, a summary of the inventory findings, and the names, signatures, and titles of the agents who conducted the inventory.

- Seed-to-Sale Tracking Records in compliance with 935 CMR 500.105(9)(c) and as required by 935 CMR 500.105(8)(e).
- Incident Reporting Records in compliance with 935 CMR 500.110(9), including, but not limited to:
  - Written notice provided to the Commission by TEN-TEN within ten (10) calendar days of any incident described in 935 CMR 500.110(9)(a), by an incident report, in the form and manner prescribed by the Commission, which details the circumstances of the event, any corrective action taken, and confirmation that the appropriate law enforcement authorities were notified.
  - All documentation related to an incident that is reportable pursuant to 935 CMR 500.110(9)(a) shall be maintained by TEN-TEN for not less than one year or the duration of an open investigation, whichever is longer, and made available to the Commission and law enforcement authorities within their lawful jurisdiction on request.
- Waste Disposal Records in compliance with 935 CMR 500.105(9)(f) & in compliance with 935 CMR 500.105(12)(d), including, but not limited to:
  - When marijuana, marijuana products or waste are disposed of or handled, TEN-TEN shall create and maintain an electronic record of the date, the type and quantity disposed or handled, the manner of disposal or other handling, the location of disposal or other handling, and the names of the two TEN-TEN agents present during the disposal or handling, with their signatures. TEN-TEN shall keep these records for at least three (3) years. This period shall automatically be extended for the duration of any enforcement action and may be extended by an order of the Commission.
- Security Records in compliance with 935 CMR 500.110, including, but not limited to:
  - 935 CMR 500.110(4)(e): All outside vendors, contractors and visitors shall obtain a visitor identification badge prior to entering a limited access area and shall be escorted at all times by a TEN-TEN agent authorized to enter the limited access area. All visitors must be logged in and out and that log shall be available for inspection by the Commission at all times.
  - 935 CMR 500.110(5)(a)(5): Recordings from all video cameras which shall be enabled to record 24 hours each day and be available for immediate viewing by the Commission on request for at least the preceding 90 calendar days or the duration of a request to preserve the recordings for a specified period of time made by the Commission,

whichever is longer. Video cameras may use motion detection sensors to begin recording, so long as the motion detection sensor system provides an alert to designated employees of TEN-TEN in a manner established in TEN-TEN's written security procedures and approved by the Commission or a Commission Delegee. If a TEN-TEN receives notice that the motion detection sensor is not working correctly, it must take prompt action to make corrections and document those actions. Recordings shall not be destroyed or altered, and shall be retained as long as necessary if TEN-TEN is aware of a pending criminal, civil or administrative investigation or legal proceeding for which the recording may contain relevant information.

- o 935 CMR 500.110(5)(b) and 935 CMR 500.110(6)(b): All security system equipment and recordings shall be maintained in a secure location so as to prevent theft, loss, destruction and alterations.
- 935 CMR 500.110(5)(e) and 935 CMR 500.110(6)(d): A current list of authorized agents and service personnel that have access to the surveillance room shall be made available to the Commission upon request.
- 935 CMR 500.110(6)(a)(5): 24-hour recordings from all video cameras that are available for immediate viewing by the Commission on request and that are retained for at least ninety (90) calendar days. Recordings shall not be destroyed or altered, and shall be retained as long as necessary if TEN-TEN is aware of a pending criminal, civil or administrative investigation or legal proceeding for which the recording may contain relevant information.
- All documentation related to an incident that is reportable pursuant to 935 CMR 500.110(9)(a) shall be maintained by TEN-TEN for not less than one year or the duration of an open investigation, whichever is longer, and made available to the Commission and law enforcement authorities within their lawful jurisdiction on request.
- Transportation Records in compliance with 935 CMR 500.105(13), including, but not limited to:
  - 935 CMR 500.105(13)(a)(11): In the case of an emergency stop during the transportation of marijuana and marijuana products, a log must be maintained describing the reason for the stop, the duration, the location, and any activities of personnel exiting the vehicle.
  - 935 CMR 500.105(13)(b)(1): TEN-TEN agents must document and report any unusual discrepancy in weight or inventory to the Commission and law enforcement authorities not more than twenty-four (24) hours following the discovery of such a discrepancy.

- 935 CMR 500.105(13)(b)(2): TEN-TEN agents shall report to the Commission and Law Enforcement Authorities any vehicle accidents, diversions, losses, or other reportable incidents that occur during transport, not more than twenty-four (24) hours following such accidents, diversions, losses, or other reportable incidents.
- 935 CMR 500.105(13)(c)1: Records that a vehicle used for transporting marijuana and marijuana products is owned or leased by TEN-TEN and properly registered, inspected, and insured in the Commonwealth, which shall be made available to the Commission on request.
- 935 CMR 500.105(13)(e)8: The originating location must have a
   Marijuana Establishment Agent assigned to monitoring the GPS unit and
   secure form of communication, who must log all official communications
   with TEN-TEN agents transporting marijuana products.
- o 935 CMR 500.105(13)(f)(5): TEN-TEN shall retain all transportation manifests for no less than one (1) year and make them available to the Commission upon request.
- Records of Responsible Vendor Training in compliance with 935 CMR 500.105(2)(b)5, including, but not limited to:
  - TEN-TEN shall maintain records of Responsible Vendor Training Program compliance for four (4) years and make them available to inspection by the Commission and any other applicable licensing authority on request during normal business hours.
- Records following closure, in compliance with 935 CMR 500.105(9)(g), including, but not limited to:
  - All records shall be kept for at least two (2) years at TEN-TEN's expense in a form (electronic, hard copies, etc.) and location acceptable to the Commission. In addition, TEN-TEN shall communicate with the Commission during the closure process and accommodate any additional requests the Commission or other agencies may have.
- Written Operating Policies and Procedures in compliance with 935 CMR 500.105, including but not limited to:
  - Written Operating Procedures: TEN-TEN shall have and follow a set of detailed written operating procedures which shall be updated on an ongoing basis, as necessary and undergo a review by management on an annual basis.
  - Operating procedures shall include, but need not be limited to the following:

- Security measures in compliance with 935 CMR 500.110;
- Emergency policies and procedures for securing all product following any instance of diversion, theft or loss of marijuana and marijuana products, and conduct an assessment to determine whether additional safeguards are necessary, in compliance with 935 CMR 500.110(1)(m);
- Employee security policies, including personal safety and crime prevention techniques;
- A description of TEN-TEN's hours of operation and after-hours contact information, which shall be provided to the Commission, made available to law enforcement authorities on request, and updated pursuant to 935 CMR 500.000;
- Storage and waste disposal of marijuana and marijuana products in compliance with 935 CMR 500.105(11);
- Description of the various strains of marijuana to be cultivated, processed or sold, as applicable, and the form(s) in which marijuana will be sold;
- Price lists for marijuana and marijuana products and any other available products;
- Procedures to ensure accurate recordkeeping, including inventory protocols for transfer and inventory in compliance with 935 CMR 500.105(8) and (9);
- Plans for quality control, including product testing for contaminants in compliance with 935 CMR 500.160;
- A staffing plan and staffing records in compliance with 935 CMR 500.105(9)(d);
- Emergency procedures, including a disaster plan with procedures to be followed in case of fire or other emergencies;
- Alcohol, smoke, and drug-free workplace policies;
- A plan describing how confidential information and other records required to be maintained confidentially will be maintained;
- A policy for the immediate dismissal of any TEN-TEN agent or employee who has:
  - Diverted marijuana, which shall be reported to law enforcement authorities and to the Commission;
  - Engaged in unsafe practices with regard to TEN-TEN's operations, which shall be reported to the Commission; or
  - Been convicted or entered a guilty plea, plea of nolo contendere, or admission to sufficient facts of a felony drug offense involving distribution to a minor in the

Commonwealth, or a like violation in any other jurisdiction.

- Policies and procedures for the handling of cash on TEN-TEN's premises including, but not limited to, storage, collection frequency, and transport to financial institution(s), to be available on inspection;
- Policies and procedures to prevent the diversion of marijuana and marijuana products to individuals younger than twenty-one (21) years old;
- Policies and procedures for energy efficiency and conservation that shall include:
  - Identification of potential energy use reduction opportunities (including, but not limited to, natural lighting, heat recovery ventilation and energy efficiency measures), and a plan for implementation of such opportunities;
  - Consideration of opportunities for renewable energy generation including, where applicable, submission of building plans showing where energy generators could be placed on the site, and an explanation of why the identified opportunities were not pursued, if applicable;
  - Strategies to reduce electric demand (such as lighting schedules, active load management and energy storage);
     and
  - Engagement with energy efficiency programs offered pursuant to M.G.L. c. 25, § 21, or through municipal lighting plants.
- Policies and procedures to promote workplace safety consistent with applicable standards set by the Occupational Safety and Health Administration, including plans to identify and address any biological, chemical or physical hazards. Such policies and procedures shall include, at a minimum, a hazard communication plan, personal protective equipment assessment, a fire protection plan, and an emergency action plan.
- An operational plan for the cultivation of marijuana, including a detailed summary of the policies and procedures for cultivation, consistent with state and local law including, but not limited to, the Commission's Guidance on Integrated Pest Management effective November 1, 2019.

- Written policies and procedures for the cultivation, production, transfer or distribution of marijuana and marijuana products, as applicable, which shall include but not be limited to:
  - Methods for identifying, recording, and reporting diversion, theft, or loss, and for correcting all errors and inaccuracies in inventories.
     The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(8);
  - Policies and procedures for handling voluntary and mandatory recalls of marijuana and marijuana products. Such procedures shall be adequate to deal with recalls due to any action initiated at the request or order of the Commission, and any voluntary action by TEN-TEN to remove defective or potentially defective marijuana or marijuana products from the market, as well as any action undertaken to promote public health and safety;
  - Policies and procedures for ensuring that any outdated, damaged, deteriorated, mislabeled, or contaminated marijuana or marijuana product is segregated from other marijuana and marijuana products and destroyed. Such procedures shall provide for written documentation of the disposition of the marijuana and marijuana products. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(12).
  - Policies and procedures for transportation. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(13);
  - Policies and procedures to reduce energy and water usage, engage in energy conservation and mitigate other environmental impacts. The policies and procedures, at a minimum, must be in compliance with 935 CMR 500.105(15).
  - Policies and procedures for the transfer, acquisition, or sale of marijuana and marijuana products between Marijuana Establishments;
  - Policies and procedures to ensure that all marijuana products are prepared, handled, and stored in compliance with the sanitation requirements in 105 CMR 590.000: State Sanitary Code Chapter X: Minimum Sanitation Standards for Food Establishments, and with the requirements for food handlers specified in 105 CMR 300.000: Reportable Diseases, Surveillance, and Isolation and Quarantine Requirements; and
  - Policies and procedures for maintaining a product catalogue identifying all types of marijuana products actively manufactured

- at the facility. The catalog shall include a description of the product, photograph or illustration, packaging design, and dosage amounts, including expected cannabinoid profile.
- Records related to Recording Sales, in compliance with 935 CMR 500.140(5)(d), 830 CMR 62C.25.1: Record Retention and DOR Directive 16-1 regarding recordkeeping requirements, including, but not limited to:
  - A retailer shall conduct a monthly analysis of its equipment and sales data to determine that no software has been installed that could be utilized to manipulate or alter sales data and that no other methodology has been employed to manipulate or alter sales data. A marijuana retailer shall maintain records that it has performed the monthly analysis and produce it on request to the Commission.

# RENEWAL 7-27-21 TEN-TEN's Maintenance of Financial Records

TEN-TEN LLC.'s ("TEN-TEN") operating policies and procedures ensure financial records are accurate and maintained in compliance with 935 CMR 500.105(9)(e). Financial records maintenance measures include policies and procedures requiring that:

- Confidential information shall be maintained in a secure location, kept separate
  from all other records, and shall not be disclosed without the written consent of

- All sales recording requirements under 935 CMR 500.140(5) are followed, including:
  - Utilizing a point-of-sale (POS) system approved by the Commission, in consultation with the DOR, and a sales recording module approved by DOR;
  - Ensuring that sales data is not manipulated or altered;
  - Conducting a monthly analysis of TEN-TEN's equipment and sales data to determine that no software has been installed that could be utilized to

- manipulate or alter sales data and that no other methodology has been employed to manipulate or alter sales data;
- Maintaining records that TEN-TEN has performed the monthly analysis and produce them on request to the Commission;
- If TEN-TEN determines that software has been installed for the purpose of manipulation or alteration of sales data or other methods have been utilized to manipulate or alter sales data:

  - TEN-TEN shall cooperate with the Commission in any investigation regarding manipulation or alteration of sales data; and
  - TEN-TEN shall take such other action directed by the Commission to comply with 935 CMR 500.105.
- Complying with 830 CMR 62C.25.1: Record Retention and DOR Directive 16-1 regarding recordkeeping requirements;
- Adopting separate accounting practices at the point-of-sale for marijuana and marijuana product sales, and non-marijuana sales;

  - Fines or penalties, if any, paid under 935 CMR 500.550 or under any other section of the Commission's regulations.

# TEN-TEN's Qualifications and Intended Trainings for Owners, Managers and Marijuana Establishment Agents

Pursuant to 935 CMR 500.101(1)(c)9, TEN-TEN LLC ("TEN-TEN") provides below a detailed description of the minimum qualifications and intended training(s) for marijuana establishment agents who shall be employees.

#### **Minimum Qualifications**

Pursuant to 935 CMR 500.030(1), all employees of TEN-TEN shall:

- (a) be 21 years of age or older;
- (b) have not been convicted of an offense in the Commonwealth involving the distribution of controlled substances to minors, or a like violation of the laws of Other Jurisdictions; and
- (c) be determined suitable for registration consistent with the provisions of 935 CMR 500.802.

Pursuant to 935 CMR 500.802, all employees of TEN-TEN shall meet the suitability standards for registration as a marijuana establishment agent for a marijuana retail establishment, as these are the most stringent suitability standards:

- (1) In accordance with M.G.L. c. 94G, § 4(a½)(iii), the Commission has established qualifications for licensure and minimum standards for employment that are directly and demonstrably related to the operation of a marijuana establishment and similar to qualifications for licensure and employment standards in connection with alcoholic beverages as regulated under M.G.L. c. 138; provided, that a prior conviction solely for a marijuana-related offense or for a violation of M.G.L. c. 94C, § 34 shall not disqualify an individual or otherwise affect eligibility for employment or licensure in connection with a marijuana establishment, unless the offense involved the distribution of a controlled substance, including marijuana, to a minor.
- (2) For purposes of determining suitability based on background checks in accordance with 935 CMR 500.030 and 935 CMR 500.101:
  - (a) All conditions, offenses, and violations are construed to include Massachusetts law or like or similar law(s) of other jurisdictions.
  - (b) All criminal disqualifying conditions, offenses, and violations include the crimes of attempt, accessory, conspiracy and solicitation.

Qualifications and Intended Trainings for Owners, Managers and Marijuana Establishment Agents 1

- (c) Juvenile dispositions shall not be considered as a factor for determining suitability.
- (d) Where applicable, all look back periods for criminal conditions, offenses, and violations included in 935 CMR 500.801: Table B commence on the date of disposition; provided, however, that if disposition results in incarceration in any institution, the look back period shall commence on release from incarceration.
- (e) Unless otherwise specified in 935 CMR 500.801: Table B, a criminal condition, offense or violation shall include both convictions, which include guilty pleas and pleas of *nolo contendere*, and dispositions resulting in continuances without a finding or other disposition constituting an admission to sufficient facts, but shall exclude other non-conviction dispositions. All suitability determinations will be made in accordance with the procedures set forth in 935 CMR 500.800. In addition to the requirements established in 935 CMR 500.800, the Commission shall:
  - 1. Consider whether offense(s) or information that would result in a presumptive negative suitability determination under 935 CMR 500.801: Table B renders the subject unsuitable for registration; and
  - 2. Consider appeals of determinations of unsuitability based on claims of erroneous information received as part of the background check during the application process in accordance with 803 CMR 2.17: Requirement to Maintain a Secondary Dissemination Log and 803 CMR 2.18: Adverse Employment Decision Based on CORI or Other Types of Criminal History Information Received from a Source Other than the DCJIS.
- (3) Registered agents shall remain suitable at all times a license or registration remains in effect. An individual subject to 935 CMR 500.802 shall notify the Commission in writing of any charge or conviction of an offense that would result in a presumptive negative suitability determination or mandatory disqualification under 935 CMR 500.801: Table B within ten (10) days of such individual's arrest or summons, and within ten (10) days of the disposition on the merits of the underlying charge. Failure to make proper notification to the Commission may be grounds for disciplinary action. If the Commission lawfully finds a disqualifying event and the individual asserts that the record was sealed, the Commission may require the individual to provide proof from a court evidencing the sealing of the case.

If TEN-TEN determines that one of TEN-TEN's registered marijuana agents has not properly notified the Commission in accordance with 935 CMR 500.802(3), or has otherwise become unsuitable for registration as a retail marijuana establishment agent and/or employment as a marijuana establishment agent, TEN-TEN shall immediately terminate the marijuana establishment agent's employment and shall notify the Commission within one (1) business day that the marijuana establishment agent is no longer suitable for registration as a retail marijuana establishment agent and no longer associated with TEN-TEN.

#### **Training**

As required by 935 CMR 500.105(2)(a), TEN-TEN shall ensure that all of TEN-TEN's agents has successfully completed a comprehensive training program that is tailored to the roles and

responsibilities of their job, prior to performing their job functions, including, but not limited to the Responsible Vendor Training Program. Agents responsible for tracking and entering product into the Seed-to-sale SOR must receive training in a form and manner determined by the Commission. At a minimum, TEN-TEN staff shall receive eight hours of on-going training annually.

In compliance with 935 CMR 500.105(2)(b)(1), at the time of licensure, all of TEN-TEN's current owners, managers, and employees shall have attended and successfully completed a Responsible Vendor Training Program operated by an education provider accredited by the Commission to provide the annual minimum of two hours of Responsible Vendor Training to marijuana establishment agents.

In compliance with 935 CMR 500.105(2)(b)(2), TEN-TEN's new owners, managers, and non-administrative employees shall complete the Responsible Vendor Training Program within ninety (90) days of the date they are hired.

In compliance with 935 CMR 500.105(2)(b)(3), TEN-TEN's owners, managers, and non-administrative employees shall successfully complete the program once every year thereafter.

TEN-TEN shall also encourage employees who are not owners, managers, or who do not handle or sell marijuana, to take the Responsible Vendor Training Program on a voluntary basis.

In compliance with 935 CMR 500.105(2)(b)(5), TEN-TEN shall maintain records of Responsible Vendor Training Program for at least four (4) years and made them available during normal business hours for inspection by the Commission and any other applicable licensing authority upon request.

In compliance with 935 CMR 500.105(2)(b)7, and as part of the Responsible Vendor Training Program, TEN-TEN's owners, managers, and non-administrative employees shall receive yearly training on a variety of topics relevant to marijuana, marijuana products, and marijuana establishment operations, including but not limited to the following:

- a. Discussion concerning Marijuana's effect on the human body. Training shall include:
  - i. Scientifically based evidence on the physical and mental health effects based on the type of Marijuana Product;
  - ii. The amount of time to feel impairment;
  - iii. Visible signs of impairment; and
  - iv. Recognizing the signs of impairment.
- b. Diversion prevention and prevention of sales to minors, including best practices;

- c. Compliance with all tracking requirements;
- d. Acceptable forms of identification. Training shall include:
  - i. How to check identification;
  - ii. Spotting false identification;
  - iii. Provisions for confiscating fraudulent identifications; and
  - iv. Common mistakes made in verification.
- e. Other significant state laws and rules affecting operators, such as:
  - i. Local and state licensing and enforcement;
  - ii. Incident and notification requirements;
  - iii. Administrative and criminal liability;
  - iv. License sanctions:
  - v. Waste disposal;
  - vi. Health and safety standards;
  - vii. Patrons prohibited from bringing marijuana onto licensed premises;
  - viii.Permitted hours of sale;
  - ix. Conduct of establishment;
  - x. Permitting inspections by state and local licensing and enforcement authorities;
  - xi. Licensee responsibilities for activities occurring within licensed premises;
  - xii. Maintenance of records;
  - xiii.Privacy issues; and
  - xiv.Prohibited purchases and practices.
- f. Such other areas of training determined by the Commission to be included in a Responsible Vendor Training Program.

Pursuant to 935 CMR 500.105(9)(d)2(d) and (g), TEN-TEN shall maintain documentation of all required training, including training regarding privacy and confidentiality requirements, and the signed statement of the individual indicating the date, time, and place he or she received said training and the topics discussed, including the name and title of presenters, as well as a notice of completed responsible vendor and eight-hour related duty training.

# RENEWAL 7-27-21 TEN-TEN LLC's Safety and Security Plan

#### Overview

The TEN-TEN LLC (TEN-TEN) safety and security plan details extensive policies and procedures to ensure compliance with 935 CMR 500.000, including, but not limited to 935 CMR 105, 935 CMR 500.110, and 935 CMR 500.140(2), to be implemented through local security companies and their Security Directors, and by TEN-TEN's Security Manager. The primary and backup security providers (TBD) shall be security providers who have routinely performed security installation and monitoring for numerous companies.

Security policies and procedures at TEN-TEN's indoor and outdoor facilities include, but are not limited to:

- Full compliance with all regulatory and law enforcement agency regulations and requirements
- Full compliance with local emergency services regulations and requirements
- Measures to protect the TEN-TEN premises, employees, consumers and the general public. 935 CMR 500.110(1)
- Measures to deter and prevent unauthorized entrance into areas containing marijuana and marijuana products and other limited access areas at TEN-TEN facilities. 935 CMR 500.110(1)
- Measures to deter and prevent theft of marijuana and marijuana products at TEN-TEN facilities. 935 CMR 500.110(1)
- Measures to positively identify individuals seeking access to TEN-TEN premises, to limit access to those individuals twenty-one (21) years of age and older. 935 CMR 500.110(1)(a)
- Procedures to prevent loitering and ensure that only individuals engaging in activity expressly or by necessary implication permitted by 935 CMR 500.00 and statute are allowed to remain on TEN-TEN premises as established within 935 CMR 500.105. 935 CMR 500.110(1)(b)
- Procedures to dispose of marijuana in accordance with 935 CMR 500.105(12) in excess of the quantity required for normal, efficient operation as established within 935 CMR 500.105. 935 CMR 500.110(1)(c)
- Procedures ensuring all entrances to TEN-TEN premises are secured to prevent unauthorized access. 935 CMR 500.110(1)(d)
- Procedures establishing limited access areas pursuant to 935 CMR 500.110(4), accessible only to specifically authorized personnel, limited to only the minimum number of employees essential for efficient operation. 935 CMR 500.110(1)(e)
- Procedures ensuring the storage of all finished marijuana products in a secure, locked safe or vault to prevent diversion, theft, and loss. 935 CMR 500.110(1)(f)
- Procedures to ensure that all safes, vaults, and any other equipment or areas used for the

production, cultivation, harvesting, processing, storage, disposal, transportation and/or sale of marijuana and marijuana products are securely locked and protected from entry, except for the actual time required to remove, replace, or dispose of marijuana products. 935 CMR 500.110(1)(g)

- Procedures to ensure that indoor and outdoor areas are not readily accessible to unauthorized individuals and to prevent and detect diversion, theft or loss of marijuana
- Procedures to ensure all locks and security equipment are kept in good working order. 935 CMR 500.110(1)(h)
- Procedures to ensure keys are never left in locks or stored or placed in locations accessible to persons other than specifically authorized personnel. 935 CMR 500.110(1)(i)
- Procedures to ensure access to security measures, such as combination numbers, passwords and/or access to electronic and/or biometric security systems, is limited to specifically authorized personnel. 935 CMR 500.110(1)(j)
- Procedures to ensure that the outside perimeter of TEN-TEN's premises is sufficiently lit to facilitate surveillance. 935 CMR 500.110(1)(k)
- Procedures to ensure that all marijuana products are kept out of plain sight and are not visible from a public place outside of the marijuana establishment without the use of binoculars, optical aids, drones or other aircraft. 935 CMR 500.110(1)(1)
- Emergency policies and procedures for securing all marijuana products following any instance of diversion, theft or loss. 935 CMR 500.110(1)(m)
- Policies that, following any instance of diversion, theft or loss of marijuana product, require a thorough assessment to determine whether additional safeguards are necessary, and implementation of any and all additional, necessary safeguards. 935 CMR 500.110(1)(m)
- Implementation of additional safeguards, as required by the Commission, if TEN-TEN's premises are deemed to present special security concerns. 935 CMR 500.110(1)(n)
- Sharing TEN-TEN's security plan and procedures with law enforcement authorities and fire services. 935 CMR 500.110(1)(q)
- Periodically updating law enforcement authorities and fire services if TEN-TEN's plans or procedures are modified in a material way. 935 CMR 500.110(1)(q)
- Safety protocols to protect the host community, TEN-TEN's site, facilities, and employees, vendors, contractors, visitors, customers, and the general public
- Procedures for identifying, recording, and reporting diversion, theft, or loss, and for correcting all errors and inaccuracies in inventories in compliance with the Commission regulations
- Development of strong partnerships with local law enforcement agencies and the local fire services by TEN-TEN's Security Manager
- Procedures to ensure regulatory and law enforcement agency reporting requirements are met
- Procedures to ensure the implementation of information technology security measures

#### Narrative

TEN-TEN understands that security is of paramount importance in the operation of TEN-TEN's facilities. TEN-TEN is keenly aware of the added security challenges that a business in this space

faces, and has taken extensive measures to have professionally-vetted policies, procedures, and systems in place to provide comprehensive protection, not only for TEN-TEN's physical plant and inventory but also for the host community, TEN-TEN's employees, vendors, contractors, visitors, customers, and the general public.

TEN-TEN shall implement and continuously update state-of-the-art policies and procedures that take advantage of the security industry's best practices and most current technology, to ensure that TEN-TEN's facilities operate at the highest level of security and emergency preparedness.

It is the responsibility of every TEN-TEN employee to support TEN-TEN's security through prevention, awareness, reporting, and responsible incident management, including regular security training.

TEN-TEN employees must also actively protect themselves and fellow employees by situational awareness and incident prevention, management and reporting. Ongoing training, information-sharing between TEN-TEN employees and TEN-TEN's Security Manager and security personnel, between TEN-TEN's Security Manager and Security Managers of other Marijuana Establishments, and response coordination protocols shared with Sheffield's law enforcement agencies and emergency responders support the protection of the host community, the general public, TEN-TEN's assets, employees, vendors, contractors, visitors, and customers, and the safety and security of TEN-TEN's facilities.

TEN-TEN's security policies and procedures shall be implemented using Risk Based Performance Standards (RBPS) to comply with the Department of Homeland Security (DHS) Anti-Terrorism Standards for high-risk facilities. These standards include, but are not limited to: an effective restricted area perimeter, site-specific design features to control approved access and prevent unauthorized access, determination of and protection of the areas where TEN-TEN's critical assets are located, and the utilization of control, deter, detect and delay concepts in the site plan, as well as an integral part of the safety and security policies and procedures.

All finished marijuana and marijuana products shall be stored in a secure, locked safe or vault, in such a manner as to prevent diversion, theft and/or loss. A complete vaulting system by Custom Vault shall be utilized for the security of finished products.

TEN-TEN is cognizant of the serious risk of fire associated with the growth and processing of marijuana and marijuana products. TEN-TEN's Security Manager is responsible for liaising with Sheffield's emergency services providers to ensure that TEN-TEN's systems, policies, procedures and trainings sufficiently protect TEN-TEN's site and facilities, the host community, the general public, TEN-TEN's assets, employees, vendors, contractors, visitors, and customers.

TEN-TEN understands that safe and secure sites and facilities require well-prepared contingency plans and employees trained in their execution. Under the leadership of our Security Manager and with input from appropriate local agencies and enforcement authorities, TEN-TEN shall develop a comprehensive Emergency Response Plan.

The Emergency Response Plan shall include contingencies for non-security related emergencies such as medical emergencies, bomb threats, fires, explosions, chemical release, and weather-related disasters to ensure an appropriate and orderly response. This shall prevent non-security related emergencies from becoming aggravated security emergencies as well. Emergency procedures and PRODUCTION Safety and Security Plan

emergency contact numbers shall be provided in writing to all employees and posted prominently in all areas of the facility.

TEN-TEN's Security Policies and Procedures are overseen by TEN-TEN's Security Manager. Transportation Security is addressed separately in the Transportation Policies and Procedures. The preventive measures included in these policies and procedures are intended to minimize TEN-TEN's physical plant and inventory security and safety exposure, protect the public and TEN-TEN's host community, and protect TEN-TEN's assets, employees, vendors, contractors, visitors, and customers.

TEN-TEN is confident that, in the unlikely event that there is any breach of security, TEN-TEN's comprehensive response capabilities shall ensure the incident is detected quickly, contained, and resolved at the appropriate response level.

#### **FACILITY SECURITY**

The security at TEN-TEN's facility is designed to reduce the likelihood of security breaches and trigger an immediate and appropriate response in the unlikely event a breach does occur. In addition, TEN-TEN's facility security is designed to control access to all indoor and outdoor areas where marijuana and marijuana products are produced, cultivated, harvested, processed, stored, disposed of, transported and/or sold, or where cash is kept, secured and processed, limiting access to those areas to ONLY authorized and properly identified and accompanied employees, vendors, contractors, visitors, and customers.

# **Hours of Operation**

TEN-TEN's facilities shall have daily operating hours as follows:

TEN-TEN's Retail store shall be open from 10:00 a.m. to 8:00 p.m.

TEN-TEN's Indoor Cultivation shall be staffed from 8:00 a.m. to 8:00 p.m.

TEN-TEN's Outdoor Cultivation shall be staffed from 8:00 a.m until dusk, during growing season.

TEN-TEN's Manufacturing operations shall be staffed from 8:00 a.m. to 8:00 p.m.

Pursuant to 935 CMR 500.110(3), the distance between a school's property and TEN-TEN's property has been measured in a straight line from the point of the property line of said school nearest to TEN-TEN's property to the point of TEN-TEN's property line nearest to the school. TEN-TEN's host community, Sheffield, MA, has not adopted an ordinance or bylaw that reduces this distance requirement.

Detailed site plans showing TEN-TEN's indoor and outdoor existing and planned facilities shall be provided to the Commission.

TEN-TEN's existing facilities shall be customized to ensure that they meet, at a minimum, all of the Commission regulations

TEN-TEN's custom-designed and built facility shall have the following internal configurations:

Indoor areas where marijuana and marijuana products are produced, cultivated, harvested, processed, and stored shall have no external doors or windows and shall be accessed only from within the facilities. All main access point door hinges shall be equipped with hinge-pin-locking screws to increase security. These configurations yield optimal conditions for security and surveillance. These design elements shall not only make unauthorized access extremely unlikely but also act as a deterrent to discourage theft.

#### Floor Plan

Detailed interior and exterior floor plans of TEN-TEN's facilities shall be provided to the Commission, as required.

#### Lighting

Studies and statistics demonstrate that criminal activities are less likely to occur in well-lit areas, as well-lighted facilities are an excellent deterrent to illegal activities. Security lighting is one of the most practical and effective ways to deter crime in and around commercial facilities.

The primary objective of TEN-TEN's facilities' security lighting systems is to illuminate dark areas, allowing detection and recognition of movement in the protected area, and allowing clear video tracking and recording of detected individuals. The best quality video tracking and recording using outdoor lighting is obtained from downward directed and shielded security lighting that is continuously on, supplemented with instant-on lighting triggered by motion detectors. TEN-TEN shall ensure that sufficient lighting is provided between dusk and dawn, and during the day, should there be insufficient sunlight for the best quality video tracking and recording.

TEN-TEN facilities' exterior lighting shall include, but shall not be limited to, high lumen floodlights and spotlights. All parking lots and walkways to and from TEN-TEN facilities shall be well illuminated to maximize safety, security, visibility, and video capture. Lighting shall be operated automatically by a photoelectric sensor, ensuring optimal lighting conditions at all times.

TEN-TEN's interior and exterior lighting shall comply with the Commission's requirements for energy usage and efficiency.

#### Security Personnel

Upon the commencement of construction of TEN-TEN's facilities, TEN-TEN's Security Manager shall either contract with a private security company to provide security personnel or shall employ security personnel. Unarmed security personnel shall be on-site monitoring TEN-TEN's facilities during the hours of operation.

All security personnel shall be thoroughly vetted, screened, trained, and strictly supervised by TEN-TEN's Security Manager, to ensure they are of the highest caliber.

During operating hours, TEN-TEN shall have on-site security personnel at each indoor and outdoor exterior entrance and exit that is in-use.

On-site security personnel are responsible for ensuring that all emergency egress points from TEN-TEN's facilities are accessible when TEN-TEN's facilities are occupied and that all ingress and egress points to TEN-TEN's site and facilities are secured outside TEN-TEN's business hours.

#### Security Systems Maintenance, Inspections, Testing and Audits

All security equipment shall be maintained in good working order and shall be inspected and tested by TEN-TEN's Security Manager, who shall perform and keep records of having performed routine regular inspections of all security systems, barriers, gates, doors, and locks, immediately documenting and reporting any malfunctioning or compromised security feature and/or system. Any malfunctioning or compromised security feature and/or system shall be addressed immediately by the Security Manager.

TEN-TEN shall notify appropriate regulatory and law enforcement agencies of any breach of security immediately and, in no instance, more than twenty-four (24) hours, following discovery of said breach, pursuant to 935 CMR 500.110(9)

TEN-TEN's Security Manager and the Security Directors of TEN-TEN's security system providers shall audit TEN-TEN's security systems at regular intervals, at a minimum every thirty (30) calendar days, and upon any changes, upgrades, repairs and/or failures.

The security systems shall be audited annually, at TEN-TEN's expense, by a vendor approved by the Commission. A report of said audit, in a form and manner prescribed by the Commission, shall be submitted no more than thirty (30) calendar days after the audit is conducted. If the audit identifies concerns related to TEN-TEN's security systems, TEN-TEN must also submit a plan to the Commission to mitigate those concerns within ten (10) business days of submitting the audit, PRODUCTION Safety and Security Plan 6

## **Backup Power**

TEN-TEN's primary and backup security systems and access control system (ACS) shall be supported by a commercial back-up generator which shall start automatically in the event of a power failure and which is supported by sufficient fuel capable of providing power for all of TEN-TEN's requirements during a forty-eight (48) hour power outage.

#### **Security Systems**

All alarm controls shall have a duress alarm function with a specific code to alert TEN-TEN security, TEN-TEN's security monitoring companies and local law enforcement that a TEN-TEN employee is being required to disable the alarm system under duress. There shall be panic alarms throughout facility to create visual and audible alarms that an emergency is in progress requiring an evacuation and/or response by TEN-TEN personnel, law enforcement and emergency responders. Employees working with visitors or the public shall be required to wear a wireless transponder allowing for manual initiation by the employee or use a "man-down" feature, which is activated when the transponder is tilted more than a pre-programmed angle limit, and which shall alert TEN-TEN security, TEN-TEN's security monitoring companies and local law enforcement.

These provisions are accomplished by installing a UL listed, commercial-grade, state of the art, intrusion system head-end control panel. This panel shall manage the feeds from all alarm locations, detectors, sensors, arm/disarm keypads, and panic alarms, and shall have the capability to process alarms and events by individual point ID and zone, and report those events, by point ID and zone, to the on-site surveillance room and off-site "Central Stations" for dispatch of security and first responder personal as needed.

The security system shall have the capability to accept multiple, point and zone input devices, such as push buttons, foot rails, palm buttons, etc. These input devices can be programmed for either silent or audible operation.

The safety and security system control panels shall be located in TEN-TEN's surveillance room. Access to TEN-TEN's surveillance room shall be limited to persons that are essential to surveillance operations, regulatory and law enforcement agencies, and security system service personnel. A current list of authorized employees and service personnel who have access to the surveillance room shall be made available to the Commission and law enforcement agencies upon request. The surveillance room at TEN-TEN shall remain locked and shall not be used for any other function.

Trees, bushes and other foliage outside the TEN-TEN facilities shall be maintained so as to prevent a person or persons from concealing themselves from sight.

Security plans and procedures shared with law enforcement agencies shall, at a minimum, include a description of the location and operation of the security system, including but not limited to the location of the premises central controls, a schematic of the security zones, the name of the primary PRODUCTION Safety and Security Plan

and back-up security alarm companies and monitoring companies and their contact information, the name of TEN-TEN's Security Manager and his backup, and their twenty-four (24) hour contact information, and a floor plan or layout of the facility in a manner and scope as required by Sheffield and/or the applicable law enforcement and/or the local emergency services agencies.

#### Perimeter Security

TEN-TEN shall secure the perimeter of its facilities to prevent unauthorized intrusion. TEN-TEN plans to employ, as appropriate, one or more of the following critical elements, in combination with other critical elements, to secure the perimeter of their indoor and outdoor facilities: security fencing, security guards, and electronic surveillance, including, but not limited to round-the-clock manned and/or alarmed camera surveillance and electronic intrusion detection.

The perimeter of each TEN-TEN indoor and outdoor facility shall be also secured by video surveillance and outside security lighting, as above. During non-operational hours, all entrances, exits, and windows shall be externally covered by additional locked security gates and/or locked security fencing.

In addition to the above facility security fencing, the perimeter of TEN-TEN's property shall also be surrounded by appropriate security fencing. All entrances and exits to the security fencing shall be secured by commercial-grade locks.

All outdoor and indoor facility entrances, exits and windows shall have contacts designed to trigger internal and external primary and backup alarms should any entrances, exits and windows be breached, either from the interior or the exterior of the facilities. Additionally, motion detectors shall monitor the inside of all entrances, exits and windows, which are designed to trigger internal and external primary and backup alarms should any motion be detected.

All outdoor and indoor interior spaces shall also be monitored by motion detectors designed to trigger internal and external primary and backup alarms should any motion be detected, to alert TEN-TEN security personnel to intrusion through fences, walls and roofs.

The perimeter and interior space motion detectors shall be separate from the video camera motion detectors.

#### **Internal Access Controls**

Movement within TEN-TEN's facilities shall be tightly controlled. All entrance and exit doors to outdoor and indoor facilities, as well as access to the surveillance room, safes, vaults, sales areas, and areas where marijuana and marijuana products are cultivated, harvested, processed, prepared, stored, handled, sold, and/or disposed of, or where cash is kept, secured and processed, shall be controlled by TEN-TEN's access control system (ACS), which requires keycards or fobs and electronic passcodes.

#### Access Control to TEN-TEN's Premises, Facilities, and Limited Access Areas, Visitors

TEN-TEN has identified limited access areas, to which only properly authorized and properly PRODUCTION Safety and Security Plan 8

identified and accompanied employees, regulatory and law enforcement agency personnel acting within their jurisdictional authority, and emergency responders shall be permitted. These limited access areas include, but are not limited to the surveillance room, safes, vaults, sales areas, and areas where marijuana is cultivated, harvested, processed, prepared, stored, handled, sold, and/or disposed of, or where cash is kept, secured and processed

Only authorized Marijuana Establishment Agents may access limited access areas (areas where marijuana and marijuana products are cultivated, harvested, processed, prepared, stored, handled, sold, and/or disposed of, or where cash is kept, secured and processed). The Security Manager is responsible for assigning and recording access rights under the Access Control System (ACS).

TEN-TEN intends to utilize the Medeco XT Intelligent "Key" System (ACS) to control all access to limited access areas. The ACS provides the ability to program key cards and/or fobs to limit employees' access to the particular limited access areas the employees are required to access to perform their jobs, as determined by the Security Manager. The ACS offers a cloud-based, webmanaged database, and allows TEN-TEN's Security Manager to update an employee's access via smartphone.

Access cards or fobs are programmable by the Security Manager to allow Marijuana Establishment Agents and employees the appropriate, predetermined level of access. The ACS tracks access by all users, allowing for access to limited access areas to be tracked and logged. Access cards or fobs can be easily deactivated locally or remotely, if necessary. The use of keys for routine entry and/or exit is eliminated.

TEN-TEN's ACS ensures that the limited access areas are accessible only to properly authorized and properly identified and accompanied employees, regulatory and law enforcement agency personnel acting within their jurisdictional authority and emergency responders.

Upon employment by TEN-TEN, the Security Manager shall scan each employee's approved government photo identification card into the ACS, and the Security Manager shall issue each employee a TEN-TEN photo identification badge which shall be worn at all times when the employee is in any TEN-TEN facility and/or transporting marijuana products, to identify the individual as an employee, as well as a key card or fob which allows the employee, through the ACS, access to the particular limited access areas the employee is required to access to perform his job, as determined by the Security Manager. The Security Manager shall maintain a log of the issued TEN-TEN employee photo identification badges and key cards or fobs. The ACS tracks each entry and exit from a limited access area.

All TEN-TEN employees shall provide the Security Manager the year, make, model, color, and license plate number of all vehicles they intend to use for transportation to TEN-TEN's site. The employee is responsible for immediately notifying the Security Manager of any changes to the above information.

All TEN-TEN photo identification badges and key cards or fobs must be collected from on-duty security personnel by each employee at the beginning of their shift and shall be returned to on-duty security personnel at the end of each shift. Security personnel shall verify the employees are in possession of their Commission issued Marijuana Establishment Agent card, and shall log the collection and return of each employee's TEN-TEN photo identification badge and key card or fob. The returned TEN-TEN photo identification badges and key cards or fobs shall be retained in the PRODUCTION Safety and Security Plan

safe in the surveillance room until the employees return to work for their next shift.

Employees not in possession of their Marijuana Establishment Agent cards shall be denied entrance to TEN-TEN's facilities and may be subject to TEN-TEN's progressive discipline policy, which includes disciplinary actions up to and including termination of employment.

No employees shall be permitted to leave TEN-TEN's premises with their TEN-TEN photo identification badges and key cards or fobs, with the exception of those TEN-TEN Marijuana Establishment Agents who are required to wear their TEN-TEN photo identification badges while transporting marijuana and/or marijuana products.

All employees of TEN-TEN shall visibly display a TEN-TEN employee photo identification badge at all times while on TEN-TEN's site, while in any TEN-TEN facility and/or while transporting marijuana products.

All Marijuana Establishment Agents must be in possession of their Cannabis Control Commission-issued Marijuana Establishment Agent card at all times while on TEN-TEN's site, while in TEN-TEN's facilities while transporting marijuana and marijuana products, and while conducting business on TEN-TEN's behalf.

Loss and/or theft of a TEN-TEN photo identification badge and/or a key card or fob shall immediately be reported to the Security Manager, who shall immediately deactivate the key card or fob, and who shall create an incident report documenting the details of said loss and/or theft.

Employees who, without prior authorization from the Security Manager, remove their TEN-TEN employee photo identification card from TEN-TEN premises shall be subject to TEN-TEN's progressive discipline policy, which includes disciplinary actions up to and including termination of employment.

Employees who lose and/or experience the theft of their TEN-TEN photo identification badge and/or a key card or fob shall be subject to TEN-TEN's progressive discipline policy, which includes disciplinary actions up to and including termination of employment, at TEN-TEN's sole discretion.

Employees who lose or experience theft of their Marijuana Establishment Agent card shall be denied entrance to TEN-TEN's facilities, are responsible for reporting said loss or theft to the Commission and may be subject to TEN-TEN's progressive discipline policy, which includes disciplinary actions up to and including termination of employment.

Upon termination of employment, the employee shall immediately return the TEN-TEN photo identification badge and the key card or fob to the Security Manager. The Security Manager shall indicate in the log that the TEN-TEN employee photo identification badge and key card or fob have been returned. All returned ACS key cards or fobs shall be immediately deactivated and, along with returned TEN-TEN employee photo identification badges, retained in the safe in the surveillance room by the Security Manager, in case they are required in the future.

All limited access areas shall be identified by the posting of a sign at the ingress and egress points that shall be a minimum of twelve inches by twelve inches (12" x 12") and which states in **bold** type: "**Do Not Enter—Limited Access Area—Access Limited to Authorized Personnel and Escorted Visitors Only**" in lettering no smaller than one inch (1") in height. (935 CMR 500.110(4)(a))

All limited access areas shall be clearly described by the filing with the Commission of a diagram of the licensed premises, in the form and manner determined by the Commission, reflecting entrances and exits, security stations, the surveillance room, walls, partitions, counters, propagation, vegetation, flowering, processing, production, storage, shipping, receiving, disposal and retail sales areas. (935 CMR 500.110(4)(b))

Access to Limited Access Areas shall be restricted to employees and agents specifically permitted by the TEN-TEN, agents of the Commission, Commission Delegees, and state and local Law Enforcement Authorities acting within their lawful jurisdictions, police and fire departments, and emergency medical services acting in the course of their official capacity. (935 CMR 500.110(4)(c))

Employees of TEN-TEN shall visibly display an employee identification badge issued by TEN-TEN at all times while at TEN-TEN or transporting Marijuana. (935 CMR 500.110(4)(d))

All outside vendors, contractors and visitors shall obtain a visitor identification badge prior to entering a limited access area and shall be escorted at all times by a Marijuana Establishment Agent authorized to enter the limited access area. The visitor identification badge shall be visibly displayed at all times. All visitors must be logged in and out and that log shall be available for inspection by the Commission at all times. All visitor identification badges shall be returned to TEN-TEN on exit. (935 CMR 500.110(4)(e))

Individuals under the age of twenty-one (21) are not allowed on TEN-TEN's premises or in TEN-TEN's facilities. TEN-TEN shall employ security policies and procedures to ensure that individuals under the age of twenty-one (21) do not gain entry to TEN-TEN's premises and facilities unless those individuals have a legitimate business purpose for access to TEN-TEN's premises and facilities.

All TEN-TEN premises and facilities shall have a sign posted at their entrances and exits that shall be a minimum of twelve inches by twelve inches (12" x 12") and which states in **bold** type: "No one under twenty-one (21) years of age permitted. All persons shall present a valid, current government-issued photo identification card with a clearly visible, unaltered date of birth." in lettering no smaller than one inch (1") in height.

Security personnel shall verify that the age of every visitor is twenty-one (21) years or older, and log information regarding the visitor, including but not limited to the visitor's name, contact information, and numbered visitor identification badge issued, time of arrival and departure, purpose of visit, facilities and areas to be accessed, the names of any employees visited, as well the names of the Marijuana Establishment Agent or Agents escorting the visitor. If the visitor is a regulatory agent, a law enforcement agent, or an emergency responder visiting TEN-TEN on a non-emergency basis, the visitors' log shall also reflect their badge number. The visitors' log shall be available for inspection by the Commission and law enforcement agencies at all times.

Visitors entering limited access areas shall be escorted at all times by one or more Marijuana Establishment Agents authorized to enter the limited access area. In the event of an emergency, regulatory and law enforcement agency personnel and emergency responders may enter limited access areas without Marijuana Establishment Agent escorts.

Following an emergency, TEN-TEN security personnel shall request the regulatory and law enforcement agency personnel and emergency responders provide proper government-issued identification, and their information shall be entered in the emergency response log.

The numbered visitor identification badge shall be worn and visibly displayed at all times while the visitor is in any TEN-TEN facility. All visitors and numbered visitor identification badges shall be logged in and out as above by on-duty security. All numbered visitor identification badges shall be returned to TEN-TEN on-duty security upon departure from TEN-TEN premises. When not in use, numbered visitor identification badges shall be retained in the safe in the surveillance room. Any visitor or customer refusing to leave the premises should be considered a security incident and dealt with accordingly. Sheffield law enforcement shall be contacted immediately.

All visitors are prohibited from touching any unpackaged marijuana or marijuana products located in a limited access area.

#### **Retail Customers**

On entry to TEN-TEN's Marijuana Retail store, a TEN-TEN Marijuana Establishment Agent will immediately inspect each consumer's identification to ensure the individual is twenty-one (21) years of age or older, pursuant to 935 CMR 500.140(2). An individual shall not be admitted to TEN-TEN's Marijuana Retail store unless a TEN-TEN Marijuana Establishment Agent has verified that the individual is 21 years of age or older.

At point of sale, a TEN-TEN Marijuana Establishment Agent shall again inspect each consumer's identification to ensure the individual is twenty-one (21) years of age or older

TEN-TEN reserves the right to refuse service to anyone, for any legal reason.

Acceptable identification documentation is a valid, unexpired, government-issued driver's license/ID, passport, passport card, a United States military identification card, or any other identification card issued by a state or the federal government that bears a picture of the person, their name, their date of birth and their physical description. Individuals presenting identification that appears to be forged and/or tampered with shall not be admitted to TEN-TEN's Marijuana Retail store.

#### Video Surveillance

TEN-TEN shall employ state-of-the-art external and internal cameras, each with a minimum resolution sufficient to allow facial identification of anyone inside TEN-TEN's facilities or on TEN-TEN's site. All cameras shall be equipped with motion detection and shall have infrared technology for low light conditions, capable of identifying individuals and activity at night and in unlit rooms. All camera placement shall conform to the Commission requirements.

Interior cameras shall include IP megapixel technology, digital pan/tilt/zoom capability and light finder day/night capability. All cameras shall have a wide dynamic range for light/dark filtering and accuracy of imagery. Exterior cameras shall have digital pan/tilt/zoom capability and also have the ability to auto-track and zoom to a point and/or event, while maintaining full coverage of the camera area, with perimeter camera coverage of a minimum of twenty feet (20'). Each camera shall apply a date and time stamp to its video feed that shall not obstruct the image. All cameras shall be equipped with SD cards that shall record for up to seventy-two (72) hours, in the event that the primary and backup video surveillance recording systems are down.

Camera placement and selection shall be given careful consideration. Camera placement and camera type shall be based on maximizing the cameras' ability to positively identify TEN-TEN employees and MREA's, positively identify unknown individuals, and capture the license plate information on vehicles entering and departing TEN-TEN's site.

Cameras shall be placed at the entrance gate, up the drive to the facility, and before gated entry into the facility, before entering into a secured, controlled entryway (a "Sallyport"), observing parking areas with CCTV coverage as well as being capable of license plate recognition. Cameras shall also be equipped with infra-red illuminators to supplement lighting conditions.

All video live feeds, and all video recordings shall conform to the Commission requirements. Video recordings shall be retained both on-site in the surveillance room (see below), and in an off-site, cloud-based backup, for the periods prescribed by the Commission's regulations.

TEN-TEN's video surveillance system shall include, but not be limited to external video surveillance which shall provide continuous coverage of all areas of possible ingress and egress, including the site perimeters, the site entrance gate, the driveway to the facilities, the employee and visitor parking lots, prior to gated entry to the facilities, the secured, controlled entryways ("sally ports"), internal video surveillance which shall provide continuous coverage of all rooms and areas of possible ingress and egress to rooms within TEN-TEN's facilities, including the surveillance room, security areas, all areas containing safes and vaults, as well as all areas where marijuana and marijuana products are cultivated, harvested, processed, prepared, stored, handled, sold, and/or disposed of, or where cash is kept, secured and processed.

#### Surveillance Room

The primary and backup security systems and the video surveillance and recording systems shall be kept in a locked and secured room with limited access and with its own independent security system (surveillance room). Access to the surveillance room shall be limited by the Security Manager to persons essential to surveillance operations, regulatory and law enforcement agency personnel, and security system and video surveillance and recording system service personnel.

Twenty-four (24) hour recordings from all video cameras that are available for immediate viewing by regulatory and law enforcement agencies upon request shall be located in the surveillance room. These recordings shall be retained for at least ninety (90) calendar days or as required by the Commission, whichever is longer. Recordings shall not be destroyed or altered and shall be retained as long as necessary if TEN-TEN is aware of any pending criminal, civil or administrative investigations or legal proceedings for which the recordings may contain relevant information.

A current list of authorized employees and service personnel that have access to the surveillance room shall be maintained by the Security Manager and shall be made available to the Commission and law enforcement personnel upon request.

#### Product Security and Vault

All packaged marijuana and marijuana products shall be kept in the vault. The vault shall be under twenty-four (24) hour video surveillance and shall be equipped with motion detectors. The modular vault shall have an outer and inner steel-framed door. Outer doors shall be activated by the ACS PRODUCTION Safety and Security Plan

and/or biometrics, and the inner doors shall be accessed by security code lock and/or biometrics.

The storage vault shall be equipped with measures to prevent any infestations of insects or animals and shall be equipped with all necessary lighting, ventilation and temperature controls. The vault shall be cleaned, organized and given a preventative maintenance inspection weekly. Vault access shall be controlled and limited by the Security Manager. Access codes to the vault door, if required, shall be, at a minimum, changed twice a year at the discretion of the Security Manager.

# **Third-Party Monitoring**

TEN-TEN anticipates contracting with primary and backup vendors to supplement TEN-TEN's onsite security and video surveillance systems to help deter, detect, and document security events at TEN-TEN's facilities from a remote location. The vendors shall monitor for smoke, fire, carbon monoxide, propane gas, and for internal and external security breaches of TEN-TEN's property and facilities.

Trained professionals from the remote monitoring centers shall monitor TEN-TEN's safety, security, and video surveillance systems at all times and shall report any suspicious activity to the TEN-TEN Security Manager and/or backup Security personnel, and logthe reported activity. TEN-TEN's Security Manager shall work with the vendors to establish guidelines for suspicious activity and to ensure compliance with all Commission, law enforcement and emergency response regulations and requirements.

### SECURITY AND ALARM REQUIREMENTS

# Security and Alarm Requirements for TEN-TEN's Indoor Operations

Pursuant to 935 CMR 500.110(5)(a), TEN-TEN's facilities, which are located outdoors and in buildings, greenhouses or other enclosed areas, shall have an adequate security system to ensure that indoor and outdoor areas are not readily accessible to unauthorized individuals and prevent and detect diversion, theft or loss of marijuana and/or marijuana products, unauthorized intrusion, utilizing commercial grade equipment which shall, at a minimum, include:

- A perimeter alarm on all building entry and exit points and perimeter windows, if any. 935 CMR 500.110(5)(a)(1)
- A perimeter security fence designed to prevent unauthorized entry to the outdoor cultivation facility with signs notifying observers that it is a limited access area
- Commercial-grade, nonresidential locks on the entrances and exits to the perimeter security fence
- A security alarm system that shall be continuously monitored by TEN-TEN security personnel and/or by a monitoring company or by other means determined to be adequate by the Commission
- A notification system that provides an immediate audible and/or telephone and/or email and/or text message and/or visual notification of any alarm
- A failure notification system that provides an audible, text, or visual notification of any failure in the surveillance system. The failure notification system shall provide an alert to TEN-TEN's Security Manager, TEN-TEN's primary and backup security system providers,

- and other designated TEN-TEN employees within five (5) minutes after the failure, by telephone and/or email and/or text message. 935 CMR 500.110(5)(a)(2)
- A duress alarm, panic alarm or hold-up alarm connected to local public safety or law enforcement authorities. 935 CMR 500.110(5)(a)(3)
- Video cameras in all areas that may contain marijuana or vaults or safes for the purpose of securing cash, at all points of entry and exit, and in any parking lot which shall be appropriate for the normal lighting conditions of the areas under surveillance. The cameras shall be directed at all safes, vaults, sales areas, and areas where marijuana is cultivated, harvested, processed, prepared, stored, handled, sold, and/or disposed of, or where cash is kept, secured and processed. Cameras shall be angled so as to allow for the capture of clear video and certain identification of any person entering or exiting TEN-TEN's facilities or the surrounding area. 935 CMR 500.110(5)(a)(4)
- Recordings from all video cameras, which shall be enabled to record twenty-four (24) hours each day, and shall be available for immediate viewing by the Commission and law enforcement agencies on request for at least the preceding ninety (90) calendar days or the duration of a request to preserve the recordings for a specified period of time made by the Commission, whichever is longer. Video cameras may use motion detection sensors to begin recording, so long as the motion detection sensor system provides an alert to designated TEN-TEN employees in a manner established in the TEN-TEN's written security procedures and approved by the Commission or a Commission Delegee. If TEN-TEN receives notice that the motion detection sensor is not working correctly, it shall take prompt action to make corrections and shall document those actions. Recordings shall not be destroyed or altered and shall be retained as long as necessary if TEN-TEN is aware of a pending criminal, civil or administrative investigation or legal proceeding for which the recording may contain relevant information. 935 CMR 500.110(5)(a)(5)
- The ability to immediately produce a clear, color still photo, whether the image the photo is taken from is live or recorded. 935 CMR 500.110(5)(a)(6)
- A date and time stamp embedded in all recordings, which shall be synchronized and set correctly at all times and shall not significantly obscure the picture. 935 CMR 500.110(5) (a)(7)
- The ability to remain operational during a power outage for a minimum of four (4) hours and, if it appears likely that the outage will last for more than four (4) hours, TEN-TEN shall take sufficient steps to ensure security on the premises, in consultation with the Commission. 935 CMR 500.110(5)(a)(8)
- A video recording that allows for the exporting of still images in an industry-standard image format, including .jpg, .bmp and .gif. The ability to archive exported video in a proprietary format that ensures authentication of the video and guarantees that no alteration of the recorded image has taken place. The ability to save exported video in an industry-standard file format that may be played on a standard computer operating system. The ability to erase or destroy all video recordings and still photographs prior to the disposal of any storage media. 935 CMR 500.110(5)(a)(9)

All security system equipment and recordings shall be placed in the surveillance room, a secure location, to prevent theft, loss, destruction, and alterations to the security system equipment and recordings. 935 CMR 500.110(5)(b)

In addition to the above minimum requirements, TEN-TEN shall maintain a back-up alarm system, with all the capabilities of the primary system, provided by a company supplying commercial grade PRODUCTION Safety and Security Plan

equipment, which shall not be the same company supplying the primary security system. 935 CMR 500.110(5)(c)

Access to surveillance areas shall be limited to persons that are essential to surveillance operations, Law Enforcement Authorities acting within their lawful jurisdictions, police and fire departments, security system service personnel, and the Commission. 935 CMR 500.110(5)(d)

A current list of authorized employees and service personnel that have access to the surveillance room must be available to the Commission on request. TEN-TEN's surveillance room shall be locked at all times and shall not be used for any other function. 935 CMR 500.110(5)(e)

All security equipment shall be maintained in good working order and shall be inspected and tested at regular intervals, not to exceed thirty (30) calendar days from the previous inspection and test. 935 CMR 500.110(5)(f)

Trees, bushes and other foliage outside TEN-TEN's facilities shall be maintained to prevent a person or persons from concealing themselves from sight. 935 CMR 500.110(5)(g)

Pursuant to 935 CMR 500.110(1)(o), security plans and procedures shall be shared with law enforcement authorities pursuant to and shall, at a minimum include:

- a description of the location and operation of the security system, including the location of the central control on the premises
- a schematic of security zones
- the name of the security alarm companies and monitoring companies
- a floor plan or layout of the facility in a manner and scope as required by the municipality
- a safety plan for the manufacture and production of marijuana products as required pursuant to 935 CMR 500.101(3)(c)3.

#### Security and Alarm Requirements for TEN-TEN's Outdoor Operations

Pursuant to 935 CMR 500.110(6), TEN-TEN's outdoor facilities shall implement adequate security measures to ensure that outdoor areas are not readily accessible to unauthorized individuals and to prevent and detect diversion, theft or loss of Marijuana which shall, at a minimum, include:

- A perimeter security fence designed to prevent unauthorized entry to the cultivation facility with signs conforming to 935 CMR 500.110(4)(a) notifying observers that it is a limited access area. 935 CMR 500.110(6)(a)(1)
- Commercial-grade, nonresidential locks. 935 CMR 500.110(6)(a)(2)
- A security alarm system that shall be continuously monitored, whether electronically, by a monitoring company or other means determined to be adequate by the Commission and provide an alert to designated TEN-TEN employees within five minutes after a notification of an alarm or a system failure, either by telephone, email or text message. 935 CMR 500.110(6)(a)(3)(a-b)
- Video cameras at all points of entry and exit and in any parking lot which shall be appropriate for the normal lighting conditions of the area under surveillance. The cameras shall be directed at all safes, vaults, sales areas, and areas where marijuana is cultivated,

- harvested, processed, prepared, stored, handled, transferred, sold, and/or disposed of, or where cash is kept, secured and processed. Cameras shall be angled so as to allow for the capture of clear video and certain identification of any person entering or exiting TEN-TEN's facilities or the surrounding area. 935 CMR 500.110(6)(a)(4)
- Recordings from all video cameras, which shall be enabled to record twenty-four (24) hours each day, and shall be available for immediate viewing by the Commission and law enforcement agencies on request for at least the preceding ninety (90) calendar days or the duration of a request to preserve the recordings for a specified period of time made by the Commission, whichever is longer. Video cameras may use motion detection sensors to begin recording, so long as the motion detection sensor system provides an alert to designated TEN-TEN employees in a manner established in the TEN-TEN's written security procedures and approved by the Commission or a Commission Delegee. If TEN-TEN receives notice that the motion detection sensor is not working correctly, it shall take prompt action to make corrections and shall document those actions. Recordings shall not be destroyed or altered and shall be retained as long as necessary if TEN-TEN is aware of a pending criminal, civil or administrative investigation or legal proceeding for which the recording may contain relevant information. 935 CMR 500.110(6)(a)(5)
- The ability to immediately produce a clear, color still photo, whether the image the photo is taken from is live or recorded. 935 CMR 500.110(6)(a)(6)
- A date and time stamp embedded in all recordings, which shall be synchronized and set correctly at all times and shall not significantly obscure the picture. 935 CMR 500.110(6) (a)(7)
- The ability to remain operational during a power outage for a minimum of four (4) hours and, if it appears likely that the outage will last for more than four (4) hours, TEN-TEN shall take sufficient steps to ensure security on the premises, in consultation with the Commission. 935 CMR 500.110(6)(a)(8)
- A video recording that allows for the exporting of still images in an industry-standard image format, including .jpg, .bmp and .gif. The ability to archive exported video in a proprietary format that ensures authentication of the video and guarantees that no alteration of the recorded image has taken place. The ability to save exported video in an industry-standard file format that may be played on a standard computer operating system. The ability to erase or destroy all video recordings and still photographs prior to the disposal of any storage media. 935 CMR 500.110(6)(a)(9)

All security system equipment and recordings shall be placed in the surveillance room, a secure location, so as to prevent theft, loss, destruction, and alterations to the security system equipment and recordings. 935 CMR 500.110(6)(b)

In addition to the requirements listed in 935 CMR 500.110(5)(a) and (b) and 935 CMR 500.110(6)(a) and (b), TEN-TEN shall have a back-up alarm system, with all the capabilities of the primary system, provided by a company supplying commercial grade equipment, which shall not be the same company supplying the primary security system. 935 CMR 500.110(6)(c)

Access to surveillance areas shall be limited to persons that are essential to surveillance operations, Law Enforcement Authorities acting within their lawful jurisdictions, police and fire departments, security system service personnel and the Commission. A current list of authorized employees and service personnel that have access to the surveillance room must be available to the Commission on request. TEN-TEN's surveillance room shall be locked at all times, and shall not

be used for any other function. 935 CMR 500.110(6)(d)

All security equipment shall be maintained in good working order and shall be inspected and tested at regular intervals, not to exceed thirty (30) calendar days from the previous inspection and test. 935 CMR 500.110(6)(e)

Pursuant to 935 CMR 500.110(1)(o) and 935 CMR 500.110(6)(e), security plans and procedures shall be shared with law enforcement authorities pursuant to and shall, at a minimum include:

- a description of the location and operation of the security system, including the location of the central control on the premises
- a schematic of security zones
- the name of the security alarm companies and monitoring companies
- a floor plan or layout of the facility in a manner and scope as required by the municipality
- a safety plan for the manufacture and production of marijuana products as required pursuant to 935 CMR 500.101(3)(c)3.

### **Cash Handling and Transportation Requirements**

Pursuant to 935 CMR 500.110(7), TEN-TEN has established and implemented security measures and procedures for safe cash handling and cash transportation to financial institutions or DOR facilities to prevent theft and loss and to mitigate associated risks to the safety of employees, customers, and the general public. TEN-TEN will contract with a financial institution that shall pick up and transport cash and check deposits on a periodic basis, to be determined in consultation with that financial institution. TEN-TEN's security measures include:

An on-site secure locked safe or vault maintained in an area separate from retail sales areas used exclusively for the purpose of securing cash. 935 CMR 500.110(7)(a)1

Video cameras directed to provide images of areas where cash is kept, secured, handled and packaged for transport to financial institutions or DOR facilities, provided that the cameras may be motion-sensor activated cameras and provided, further, that all cameras be able to produce a clear, still image, whether live or recorded. 935 CMR 500.110(7)(a)2

A written process for securing cash and ensuring transfers of deposits to the TEN-TEN's financial institutions and DOR facilities on an incremental basis consistent with the requirements for deposit by the financial institution or DOR facilities. 935 CMR 500.110(7)(a)3

Use of an armored transport provider that is licensed pursuant to M.G.L. c. 147, § 25 (watch, guard or patrol agency) and has been approved by the financial institution or DOR facility. 935 CMR 500.110(7)(a)4

TEN TEN is not seeking an alternative security provision under 935 CMR 500.110(2), however, should it become necessary for TEN-TEN to request an alternative security provision under 935 CMR 500.110(2) for purposes of cash transportation to financial institutions and/or DOR facilities, the approved alternative security provision shall be included in the security plan shared with the Sheffield law enforcement and periodically updated as required under 935 CMR 500.110(1)(q).

This alternative safeguard shall include, but may not be limited to:

- 1. the use of a locked bag for the transportation of cash from TEN-TEN to a financial institution or DOR facility pursuant to 935 CMR 500.110(7);
- 2. the transportation of cash in an unmarked vehicle pursuant to 935 CMR 500.110(7);
- 3. two registered Marijuana Establishment Agents employed by TEN-TEN to be present in the vehicle at all times during transportation of deposits pursuant to 935 CMR 500.110(7);
- 4. the real-time GPS tracking of the vehicle at all times when transporting cash pursuant to 935 CMR 500.110(7);
- 5. two-way communications between the transportation vehicle and TEN-TEN pursuant to 935 CMR 500.110(7);
- 6. TEN-TEN will not transport Marijuana or Marijuana Products at the same time that cash is being transported for deposit to a financial institution or DOR facility pursuant to 935 CMR 500.110(7); and
- 7. approval of the alternative safeguard will be obtained from the financial institution or DOR facility pursuant to 935 CMR 500.110(7).

Pursuant to 935 CMR 500.110(7)(c), all written safety and security measures developed under 935 CMR 500.110(7) shall be treated as security planning documents, the public disclosure of which would jeopardize public safety.

# **Incident Reporting**

Pursuant to 935 CMR 500.110(9), TEN-TEN shall notify appropriate law enforcement authorities and the Commission of any breach of security or other reportable incident as defined below immediately and, in no instance, more than twenty-four (24) hours following discovery of the breach or incident. Notification shall occur, but is not limited to, the following occasions:

- Discovery of inventory discrepancies. 935 CMR 500.110(9)(a)1
- Diversion, theft or loss of any marijuana product. 935 CMR 500.110(9)(a)2
- Any criminal action involving or occurring on or in TEN-TEN's premises or affecting TEN-TEN's Licensees and/or Agents. 935 CMR 500.110(9)(a)3
- Any suspicious act involving the sale, cultivation, distribution, processing or production of marijuana by any person. 935 CMR 500.110(9)(a)4
- Unauthorized destruction of marijuana. 935 CMR 500.110(9)(a)5
- Any loss or unauthorized alteration of records related to marijuana. 935 CMR 500.110(9)(a)6
- An alarm activation or other event that requires response by public safety personnel, including but not limited to local law enforcement, police and fire departments, public works or municipal sanitation departments, and municipal inspectional service departments, or security personnel privately engaged by TEN-TEN. 935 CMR 500.110(9)(a)7
- The failure of any security alarm system due to a loss of electrical power or mechanical malfunction that is expected to last more than eight hours. 935 CMR 500.110(9)(a)8
- Any other breach of security. 935 CMR 500.110(9)(a)9

ten (10) calendar days, provide written notice to the Commission of any incident described above by submitting an incident report in the form and manner determined by the Commission which details the circumstances of the event, any corrective action taken, and confirmation that the appropriate law enforcement authorities were notified. 935 CMR 500.110(9)(b)

TEN-TEN shall retain all documentation related to an incident that is reportable pursuant to the above for not less than one (1) year or the duration of an open investigation, whichever is longer, and made available to the Commission and law enforcement authorities within their lawful jurisdiction on request. 935 CMR 500.110(9)(c)

#### **Security Audits**

TEN-TEN shall, annually, at its own expense, obtain a security system audit by a vendor approved by the Commission. A report of such audit must be submitted, in a form and manner determined by the Commission, no later than thirty (30) calendar days after the audit is conducted. If the audit identifies concerns related to TEN-TEN's security system, TEN-TEN must also submit a plan to mitigate those concerns within ten (10) business days of submitting the audit. 935 CMR 500.110(10)

#### **Security Manager**

As all of TEN-TEN's facilities are co-located on a single site at a single address adjacent to each other in Sheffield, TEN-TEN shall designate a Security Manager as the individual in charge of security for all of TEN-TEN's facilities.

The Security Manager shall have responsibility for the implementation of the security policies and procedures. As the individual responsible for implementation, the Security Manager shall report to the General Manager. In addition, the Security Manager shall have oversight responsibility to review and update the security policies and procedures on a regular basis as required, or, at a minimum, annually, to ensure continued compliance with the Commission regulations.

TEN-TEN shall utilize the relationships that it has fostered with local law enforcement and emergency services officials who serve Sheffield to obtain their further input and cooperation in the design and construction of TEN-TEN's indoor and outdoor facilities, and in the refinement and implementation of TEN-TEN's safety and security systems and safety and security policies, procedures, and training.

TEN-TEN's Security Manager, in cooperation with TEN-TEN's primary and backup security system vendors, and the local law enforcement officials who serve Sheffield, shall develop and implement an on-site and off-site professionally monitored UL listed security system. A test signal shall be transmitted to the monitoring locations every twenty-four (24) hours. At a minimum, the system shall provide coverage of TEN-TEN's site, all TEN-TEN facility entrances and exits, all rooms in TEN-TEN facilities with exterior windows, all rooms in TEN-TEN facilities with exterior walls or walls, all roofs and roof hatches, skylights, the vault, the surveillance room, and all rooms that contain marijuana and marijuana products. The alarm system shall also provide coverage of all offices, production areas, storage areas, and retail areas.

TEN-TEN's Security Manager shall also engage local law enforcement and emergency services officials who serve Sheffield to support TEN-TEN's security policies and procedures through PRODUCTION Safety and Security Plan 20

collaborative training and exercises, preventive patrols, rapid responses to incidents and proactive meetings. Local and regional fire services shall be provided with a list and location of all equipment and chemicals utilized within TEN-TEN's facilities, as well as the average number of employees on-site and their usual locations.

TEN-TEN's Security Manager shall also develop, implement, and update TEN-TEN's security training. TEN-TEN employees shall complete an initial training course designed specifically for TEN-TEN and taught by TEN-TEN's Security Manager or his designee. No TEN-TEN employees shall begin performing their duties at TEN-TEN prior to completing this training. TEN-TEN's Security Manager shall document and retain the attendance records for all trainings, and shall make the records available to the Commission, law enforcement agents and emergency responders upon request.

TEN-TEN's initial training shall include, but not be limited to safety, security and compliance as an integral part of TEN-TEN's operations, premises and facility safety and security, potential security threats, fire, medical emergencies, and chemical spills, armed robbery, burglary, theft, and other possible criminal acts, cybercrime prevention, proper use of employee photo identification cards and the ACS, limited access areas, video surveillance, the existence of TEN-TEN's primary and backup alarm systems and the location and use of the duress alarms, fire alarms, smoke alarms, carbon monoxide and gas alarms, panic alarms and/or hold-up alarms, TEN-TEN's visitor policies and procedures, TEN-TEN's policies prohibiting individuals under the age of twenty-one (21) from TEN-TEN's premises, proper use of the METRC system, proper handling of marijuana and marijuana products, proper recordkeeping, preventing, detecting and reporting the diversion, theft and loss of marijuana and marijuana products, and disciplinary actions in cases of noncompliance.

TEN-TEN shall also conduct job-specific training for employees, which shall be developed by the Security Manager and the Managers of TEN-TEN's facilities, including, but not be limited to: safety and security for areas where marijuana and marijuana products are cultivated, harvested, processed, prepared, stored, handled, sold, and/or disposed of.

TEN-TEN's Security Manager shall initially issue and maintain logs of the issued TEN-TEN employee photo identification cards and initially program, issue, and log ACS cards or key fobs, working with each employee's Manager to determine and appropriately manage each employee's access requirements to limited access areas.

TEN-TEN's Security Manager shall regularly update and revise TEN-TEN's security policies and procedures and issue said updates to Managers and employees, as appropriate to their specific roles in TEN-TEN's organization. TEN-TEN's Security Manager shall regularly conduct training on said updates, as required. Updated policies and procedures shall be provided to the CCC within five (5) business days pursuant to 935 CMR 500104(2).

TEN-TEN's Security Manager shall maintain, distribute and post, as necessary, a list of emergency and non-emergency law enforcement agencies and emergency responder contacts and shall maintain regular communication with said agencies, advising them of any revisions to TEN-TEN's safety and security policies and procedures.

TEN-TEN's Security Manager shall be responsible for maintaining access control, biometric data, and access logs for the surveillance room and the vault, as further detailed below.

TEN-TEN's Security Manager shall be responsible for maintaining TEN-TEN's cybersecurity.

TEN-TEN's Security Manager shall notify the Commission no more than one (1) business day after a Marijuana Establishment Agent ceases to be associated with TEN-TEN. The Marijuana Establishment Agent's registration shall be immediately void when the Marijuana Establishment Agent is no longer associated with TEN-TEN.

Until such time as TEN-TEN achieves a sufficient volume of sales to justify the hiring of a Compliance Manager, the TEN-TEN Security Manager shall be responsible for the responsibilities of the Compliance Manager.
