

Waiver Request Form: Agent Registration CORI Report Requirement

Under 935 CMR 500.700, a Marijuana Establishment may request a waiver for Criminal Offender Record Information (CORI) report, which is otherwise required for individuals applying for registration as a marijuana establishment agent. 935 CMR 500.030(3). Written documentation is required to evaluate the waiver request. The request must be filled out and signed by an individual with authority or control over the management and operations of the Marijuana Establishment (Marijuana Establishment Representative). Before it is submitted, the request must be notarized and uploaded with the application for agent registration.
