

## Guidance on Home Cultivation for Adult Use

The following is not legal advice. Please consult an attorney if you have any questions regarding the law regarding marijuana for adult use.

## Can I grow my own marijuana in my home?

• Yes. The law allows an individual over 21 years of age to grow up to six plants in their home.

## **Important Restrictions**

- A home cultivator must be at least 21 years old;
- A home cultivator may only grow up to six plants in their home;
- If there is more than one individual over 21 years of age living in the residence who wish to grow at home, the maximum number of plants that may be grown in a residence is 12 plants;
- The plants must be grown in an area that is equipped with a lock or security device;
- The plants cannot be visible from a public place without the use of binoculars, aircraft or other optical aids;
- An individual cannot manufacture at home marijuana or hemp by means of any liquid or gas, other than alcohol, that has a flashpoint below 100 degrees Fahrenheit; and
- A violation of the law regarding home cultivation is subject to a fine of up to \$300 and forfeiture of the marijuana.

An individual under 18 years old found	Civil penalty of not more than \$100

An individual under 17 years old found	Civil penalty of not more than \$100
cultivating 12 marijuana plants or less.	+
	Completion of a drug awareness program

	Notification of parent or legal guardian
	Failure to complete drug awareness program within 1 year of offense may be basis for delinquency proceedings
