

MTC (RP201883)

The MTC business will be co-located with the adult-use business in Holliston. The MTC has a Final Certificate of Registration for dispensing, cultivating and processing.

- 7. The applicant and municipality executed a Host Community Agreement on August 20, 2018.
- 8. The applicant conducted a community outreach meeting on September 13, 2018 and provided documentation demonstrating compliance with Commission regulations.
- 9. The Commission received a municipal response from the municipality on April 24, 2019 stating the applicant was in compliance with all local ordinances and bylaws.
- 10. The applicant proposed the following programs for its Positive Impact Plan:
 - a. Implement Mayflower CLONE Program (Cannabis Learning Opportunities New England) to provide skills, training and education in industry and business-applicable areas to facilitate in resume building and employment seeking;
 - b. Offer a Paid Fellowship Program with a focus on operations, cultivation, product manufacturing, marketing and branding, and business management; and
 - c. Partner with neighborhoods in areas of disproportionate impact to identify and develop gardens and green spaces within their community.

SUITABILITY REVIEW

- 11. There were no concerns arising from background checks on the individuals or entities associated with the application.
- 12. There were disclosures of any past civil or criminal actions, occupational license issues, or marijuana-related business interests in other jurisdictions. None of the disclosures raised suitability issues.

MANAGEMENT AND OPERATIONS REVIEW

- 13. The applicant states that it can be operational within four (4) months of receiving its provisional license.
- 14. The applicant's proposed hours of operation are the following:

Monday – Sunday: 5:00 a.m. – 9:00 p.m.



- 15. The applicant submitted all applicable and required summaries of plans, policies, and procedures for the operation of the proposed establishment. The summaries were determined to be substantially compliant with the Commission's regulations.
- 16. The applicant proposed the following programs for its Diversity Plan:
 - a. Host four (4) career fairs annually within the cities of Worcester, Lowell, and Boston with a preference for hiring minorities, women, veterans, people with disabilities, and people of all gender identities and sexual orientations;

 - c. Utilize vendors and suppliers who are also committed to diversity and inclusion.

- 3. The applicant shall cooperate with and provide information to Commission staff;
- 4. Provisional licensure is subject to the payment of the appropriate license fee; and
- 5. Final license for MPN281480 (Product Manufacturer) is subject to the applicant amending its list of products to include more specific information on each item, i.e. types and flavors.

The applicant has demonstrated compliance with the laws and regulations of the Commonwealth and suitability for licensure. Therefore, the applicant is recommended for provisional licensure.
