Minutes:

The Commission entered executive session at 1:42pm. Commissioner McBride discussed procedures for cash handling at retail marijuana establishments. Commissioner McBride asked the enforcement staff to discuss the procedures for the final licensees on the agenda.

Director of Investigations Patrick Beyea discussed the security plans for the marijuana establishments. Commissioner Flanagan asked about changes to any plans. Commissioner Doyle noted any changes to applications must be disclosed to the Commission. Commissioner McBride noted that not all applicants disclose cash handling procedures, applicants disclose security plans. Commissioner McBride noted any updates to operations should be verified by the inspection staff.



Commissioner Doyle noted most plans are inspected on site. Chairman Hoffman asked if notifications of updates are applicable to all licenses. Commissioner McBride said likely yes, all the written operations procedures are reviewed prior to commencing operations, and any updates should be provided before commencing operations.

Commissioner Doyle asked about the licensees that have gone forward. Commissioner McBride said we should have the conversation with the current operators. Chairman Hoffman thought this may be an area where we need to draft regulations.

Commissioner Title asked about verification of these types of plans. Director Beyea discussed the investigative techniques the Commission could use. Commissioner Title asked about incidents reported.

Commissioner McBride discussed making a motion in public session for any written operations plan required by regulations, that are updated prior to the issuance commence operations, would be shared with the Commission. Commissioner Doyle inquired about non-retail cash handling.

Chairman Hoffman noted conversations have been ongoing with licensees. Executive Director Collins supported the language proposed by Commissioner McBride. Chairman Hoffman noted we could draft a guidance document. Commissioner McBride said this is about being notified prior to the issuance of commence operations.

Chairman Hoffman asked for a motion to adjourn from executive session. Commissioner McBride made the motion, seconded by Commissioner Doyle.

The Chairman took a roll call vote:

Minutes:

- Chairman Hoffman opened the Executive Session and introduced Commissioner McBride because of her request to schedule this session.
- Commissioner McBride introduced the topic noting that a fairly momentous event occurred earlier this week. Earlier in the week there were incidents of vandalism with Pure Oasis, Mayflower in Alston, and Patriot Care, Commissioner McBride wanted to discuss what was known at this time.
- Commissioner Flanagan has concerns about where products were stored, how this happened, and how there's \$200,000 worth of product missing.
- The Executive Director said he will not intentionally withhold any information but does not want to muddy waters with incomplete information.
- Executive Director said that the Commission is reacting to the news of the events of that evening. In the case of Patriot Care, there was attempted access, but the access was only gained to a common area of the building and not into the dispensary itself. In the case of



Mayflower, there was vandalism, but access was not gained. These incidents were documented appropriately under the regulations.

- In the case of Pure Oasis, inspectors were dispatched to the site and it was evident that access was gained to that facility and product was taken. Video was obtained by the Boston Globe. The Commission is trying to ascertain what happened, when it happened, if/what product went missing, and how it happened. The Commission's primary question is whether product was being stored in a compliant manner, and if not, had it been properly stored, whether this incident would have still occurred. The break in at Pure Oasis occurred approximately 1:49 a.m. Intruders entered through a broken window by way of a broken rock then kicked through a limited access door. Currently using Metrc to ascertain what might have been missing and approximate value. We are reviewing footage and we are cooperating with the Boston Police Department. The licensee has been cooperative, but there are more questions. Commission staff will work with the licensee and conduct a full security audit of the facility and a full inventory audit, and updating the licensee's Standard Operating Procedures, specifically with updated security requirements. The upcoming meeting with the licensee will be treated as an inspection by the Commission and recorded appropriately.
- Commissioner McBride confirmed that the initial breach was through a front window.
 - The Executive Director confirmed that it appears as though a rock was thrown through the front window.
 - Commissioner McBride asked about the current state of security of the licensee's Premises, for example whether the front door/window was fixed, and the space has been secured from the outside. She expressed concern about the pictures she saw and whether the building was secured.
 - The Executive Director said that the licensee is operational. The rock was thrown through a front window, which has been boarded up. Product was stored in a room that it would not ordinarily have been stored in but is now being stored in a vault.
- Commissioner Flanagan asked what investigation the Boston Police Department (BPD) doing in addition to the Commission's investigation and what the outcome be of that type of investigation.
 - The Executive Director said that the BPD is investigating the matter as a crime for the break-in and theft, compared with the Commission's investigation as a civil/administrative matter. Given this is a marijuana establishment, and the associated security requirements, the BPD has a lot of evidence to work with and information sharing is ongoing among the licensee, BPD, and the Commission.
 - Chief of Investigations and Enforcement (CIE) Gyebi confirmed he is coordinating with the detective assigned the matter.
- Commissioner Flanagan expressed her concern that a news outlet already had video footage and she wanted to ensure that the licensee understood the severity of the issue and is fulfilling its obligations with the Commission's investigation.



- Commissioner McBride whether there is a value assessment of product loss or damage and whether Commission investigators had the access needed. Commissioner McBride also wondered, given the Commission is in a regulatory review process, whether the Commission needs to address any issues in the regulations.
 - The Executive Director noted that it is early, so a lot is left to be determined. Commission staff was on site that same day. The Commission has been combing through Metrc, but certain products,. The work the Commission at this moment is to discover where this product was taken from, how access was gained, and whether any circumstances would have prevented it. The commission does have the tools it needs to conduct an investigation.
- Commissioner Flanagan asked whether the Commission will be asked to take any enforcement action.
 - The Executive Director said it depends on the outcome of the investigation and the level that would rise to. At the lowest level, a notice of deficiency could be issues, which would require a corrective action plan to be submitted to Commission staff. If the licensee's non-compliance warranted, then a draft Order to Show Cause could result in a Dispute Resolution and both would go before the Commission.
- Commission McBride asked what proportion of the licensee's product was taken and what was left on hand.
 - CIE Gyebi said that a lot of flowers, some edibles, some concentrates but a majority of what was taken was flower.
 - The Chairman asked to clarify the loss in terms of value and the percentage of the licensee's entire inventory.
 - The Executive Director said that it is not clear yet what total inventory on hand was at the time of the incident, but that will be part of the investigation. That being said, the licensee was open for business on Monday, so it had sufficient product remaining on hand to make sales. The Executive Director noted that there are initial numbers that approximate the value of lost product, but further investigation will confirm the accuracy of those numbers.
- Commissioner McBride asked whether the Commission has provided BPD with information that would be useful for them to identify the product if they came across it, recognizing that flower and pre-rolls would be harder to do in this case.
 - CIE Gyebi said that Commission staff has reached out to the detective around cooperation and noted there are issues of evidence custody that need to be sorted out.
 - The Executive Director added that, since this entity wholesales from a variety of businesses, so ascertaining more information about the sources and types of products may help in that regard.
- Commissioner Title asked whether there is any way to know if the three acts are related.
 - CIE Gyebi said that is unknown.



- Commissioner Title asked to confirm that, noting that the Commission requires licensees to have insurance, the Commission does not have any role in terms of an insurance claim made by the licensee to its insurance carrier.
 - The Executive Director confirmed this, noting that some of the information the Commission requires may be helpful to file an insurance claim.
 - Commissioner McBride noted that their insurance coverage would not extend to lost product.
- Commissioner Title noted that based on public commentary and video footage, it may appear that the people who broke in knew what they were doing and therefore indicate an inside job. Commissioner Title asked whether the Commission had any information to that effect.
 - The Executive Director said that the Commission would have to work with the licensee to figure that out, noting that all Limited Access Areas are labeled, so a perpetrator could identify those spaces, but whether or not someone would know that there was product to take in a given area is a different question.
- Commission Title asked the Executive Director to restate the circumstances in which this issue would come before the Commission.
 - The Executive Director stated that it would come to the commission if regulatory noncompliance rose to the level of an Order to Show Cause or led to a Dispute Resolution Conference in the context of a settlement of the matter through a deficiency notice.
 - Chairman Hoffman reiterated that the Executive Director will keep Commissioners updated on the investigation the best as he can without sharing assumptions.
- Commissioner McBride asked whether the Commission has requested or obtained any video footage from the establishments where the incident did not result in gaining entry and have we asked for any surveillance footage.
 - CIE Gyebi said he would follow up to determine that, but at the moment, the focus is on the Pure Oasis.
 - The Executive Director noted that the media did not obtain any information or materials from the Commission.
- Commissioner McBride is really concerned whether the Commission is confident that the boarded up front window is adequate from a security perspective.
 - The Executive Director said that he is certain that during business hours it should be sufficient. After hours, if product is properly stored, no one should be able to access inventory.
- Commissioner Flanagan moved to adjourn the meeting from executive session.
- Commissioner McBride seconded the motion.
- The Chairman took a rollcall vote.
 - Commissioner Flanagan – Yes

- The Chairman gave an overview of the topic and noted that minutes are being taken.
- The Chairman provided the history of the topic, including the research that went into the calculation of the Executive Director's compensation to date.
- The Chairman gave an overview of the Executive Director's performance evaluation.
- Chief Operating Officer gave an overview staff performance management process.
- Commissioner Stebbins provided a comparison and contrast with the Executive Director position at the Gaming Commission.
- The Chairman discussed the parameters of a new compensation adjustment in the context of the last adjustment given by the Commission.
- Commissioner Stebbins noted that there should be an optics consideration associated with increasing the Executive Director's compensation.
- The Chairman noted that there is room in the budget to increase the Executive Director's compensation.
- Commissioner Camargo asked about the Commission's process for the Executive Director's performance management.



- The Chairman described the process and that he delivered the evaluation to the Executive Director in January.
- Commissioner Camargo clarified that if that document were to be shared with the full Commission, it would become a public document.
 - The Chairman confirmed this as his understanding.
- Commissioner Camargo asked, with respect to the current Executive Director compensation adjustment being considered, what that means with respect to compensation for the next Executive Director.
 - The Chairman shared his view that the compensation for the current Executive Director does not create a floor for the next Executive Director.
 - Commissioner Camargo said that she believes the Commission should be mindful of that factor.
- Commissioner Camargo asked about Cost of Living Adjustments and how that impacts the Executive Director.
 - The Chief Operating Officer said that the Executive Director has not been included on the Cost of Living Adjustments made to date. Staff has received them, and it is tied to expected rate of inflation.
- Commissioner Camargo asked about what the Governor's compensation might be.
 - The Chairman gave an overview of various state positions and their salary.
 - The General Counsel shared that all salaries can be looked up through-on CTHRU the Commonwealth's financial records transparency ~~websiteplatform;~~ CTHRU
- Commissioner Concepcion asked about the hiring-in range initially contemplated for the position.
 - The Chairman said that to his recollection, it was between \$130,000 - \$150,000.
- Commissioner Camargo asked about the compensation increases for staff as well, and how the two will be in relation.
 - The Chief Operating Officer said that there is a fund set aside for merit pay raises in a range between 0-4%.
- The Chairman discussed the Executive Director's performance evaluation, the corresponding compensation adjustment, and what that would mean in terms of annual compensation.
- Commissioner Camargo asked whether a compensation adjustment should be considered as a percentage or a dollar amount.
 - The Chairman said there is no set standard.
- Commissioner Stebbins asked about the justification for the increase in 2019.
 - The Chairman shared that the decision was made by the Commission, based on the Executive Director's work to date at the time.
- Commissioner Stebbins noted the quandary of the new Commissioners to be fair to the Executive Director and fair to the current Commissioners and suggested a smaller increase now and consider an additional increase down the line.
- The Chairman suggested conducting a performance evaluation for the Executive Director with the new Commissioners to give an additional adjustment.
- Commissioner Camargo asked if this has to be voted on today.



- The Chairman said it does not have to be voted on at this meeting and recognized the complexity of the situation and the new information for the three other Commissioners to think about.
- Commissioner Camargo said she would like the opportunity to connect with Human Resources prior to making a decision.
- The Chairman said he is comfortable postponing the vote until the next meeting, and the discussion can be scheduled earlier in the meeting to make sure everyone is fresh and has had the opportunity to prepare for the discussion.
- The Chairman invited the Executive Director to discuss the plan ahead.
- Executive Director Collins joined the meeting at this point.
- Commissioner Stebbins moved to adjourn executive session and reconvene in open session.
- Commission Camargo seconded the motion.
- The Chairman took a roll call vote.

- The Chairman gave an overview of the conversation from the executive session at the June public meeting.
- The Chairman discussed the performance management process under the previously constituted Commission. The Chairman asked that this conversation be specific to the compensation and save conversations regarding a forward looking performance management process for another conversation.
- Commissioner Stebbins shared some thoughts and analysis with respect to the Executive Director's compensation. Commissioner Stebbins gave a comparison of compensation for Executive Directors across the Commonwealth, noting an average compensation among 13 agencies is \$170,000. Commissioner Stebbins noted his view that he is happy to recognize the hard work of staff through compensation raises. Commissioner Stebbins noted that he is concerned about the negative public attention that may result if the Executive Director's compensation exceeds a certain amount. Commissioner Stebbins



recommended using a dollar amount, rather than percentage, to balance these considerations.

- Commissioner Stebbins volunteered to lead developing a new performance review process after this consideration for compensation adjustment, including a schedule for review goals, an effort to be more transparent in a new process, and other aspects of a timeline for performance review.
- The Chairman thanked Commissioner Stebbins for his work and leadership on this matter.
- Commissioner Camargo thanked Commissioner Stebbins and expressed support for developing a new process for moving forward. Commissioner Camargo went over the merit rating scale, indicating she would be comfortable with a 3% raise.
- Chief People Officer noted that a 3% raise would approximately \$5,800/year and a gross salary \$201,880/year.
- The General Counsel gave advice on the parameters for the discussion that can occur in executive session.
- Commissioner Camargo suggested 3% raise, based on the information received about the Executive Director's performance evaluation.
- Commissioner Concepcion asked whether the scale shared by Commissioner Camargo is the compensation adjustment scale that will ultimately be used for all staff.
 - The Chief People Officer confirmed that was the case.
- Commissioner Roy expressed her confidence in the performance evaluation previously done and would be comfortable with a 3% increase.
- Commissioner Stebbins said he could stand by a 3% increase, but again reiterated the incoming criticism that may come in as a result of the Executive Director's compensation exceeding \$200,000.
- The Chairman said he supports a 3% increase because it is justified by the performance evaluation. The Chairman thinks it is a defensible position.
- Commissioner Roy noted that the Commission is a revenue generating agency, which a lot of other agencies are not, which may balance some of the optics considerations.
- Commissioner Camargo thanked Commissioner Stebbins for his work.
- Chief People Officer asked when the effective date of the compensation increase would be, noting the performance evaluation year ending December 31.
 - The Chairman agreed that the compensation adjustment should be backdated.
- The Chief People Officer noted that staff would receive their first consideration for compensation raises in December 2021, which would put the Executive Director's third pay raise on schedule when all other staff are being considered for their first pay raise.
- Commissioner Camargo asked additional questions regarding the logistics of forward looking performance evaluations.
- Commissioner Concepcion asked a clarifying question about Commissioner Stebbins' suggestion earlier in the meeting with respect to calculating a compensation adjustment.
 - Commissioner Stebbins described his thinking in developing that suggestion.
- Commissioner Camargo thanked her fellow Commissioners for their work and insights.



- Commissioner Camargo asked about the paperwork memorializing the decision of the Commission.
- The Chief People Officer gave an overview from the record keeping perspective.
- The Commission invited Executive Director Collins to join the executive session.
- With Executive Director now participating, Commissioner Stebbins gave an overview of the discussion so far, subject to a vote in open session.

4) Executive Director's Report – 0:08:18

- The Executive Director gave an overview of licensing data, as laid out on [page 218 of the meeting packet](#).
- The Chairman asked a clarifying question with respect to the estimated applicants for the Marijuana Research Facility license type.
 - The Executive Director notes that several applications have previously applied under the old scheme, so those applications are still pending. He further noted that the Commission has notified these applicants during the transition that the Commission will be reviewing their applications in the new context and actively trying to get these applicants into the new environment.
- The Chairman asked a question regarding the number of certified active patients and whether these have plateaued.
 - The Executive Director noted that there has been a slowdown from last year's high but confirmed that more patients are actively being added.
- Commissioner Camargo asked a clarification question regarding the four denials listed in the presentation and what happens after denial.
 - The Executive Director noted that this is a historical number and confirmed the reason why the applications were denied. The Executive Director further explained the reconsideration process and options for denied applicants.
 - The Chairman noted that the applications were denied around 2019 and that one applicant started the application anew.
- The Chairman asked a question regarding the Third-Party Transporter license type and the sufficiency of transportation supply as the industry continues to expand.
 - The Executive Director noted the difference between a Third-Party Transporter and a Marijuana Transporter with other existing ME license types and clarified that each license type allows the ability to move your inventory as a component of the license. Thus, he noted that licenses are currently able to efficiently move their inventory between and amongst themselves.
- Commissioner Roy asks a clarifying question on the supply chain on the islands off Cape Cod.
 - The Executive Director noted the unique situation, specific constraints, and special accommodations faced by licenses on Martha's Vineyard and Nantucket. The Executive Director noted the work of the Commission's licensing team and the fact that until federal law changes, licensees on the islands will have to continue to be vertically integrated and be subject to alternative testing requirements.



- Commissioner Roy asked a follow-up question regarding the goal of having an independent testing laboratory in the islands to conduct a full panel of testing.
 - The Executive Director noted the market-scale challenges that an independent testing lab may face on the Islands but noted that these challenges might be alleviated by potential federal legalization.

a) Regulation Implementation Process

- The Executive Director gave an update with respect to the regulation implementation process resulting from the 2020 regulatory amendments.
- The Chairman asked a clarifying question on the timeline of implementation of hardship cultivation.
 - The Executive Director noted the work that the staff has already done and holds off on providing a timeline to negate the need to have to modify it in the future.
- Commissioner Conception asked a clarifying question regarding hardship cultivation implementation and what it entails.
 - The Executive Director provided an overview of that hardship cultivation license type and specifically the special circumstances faced by this license type and what the Commission is working through to implement this in an accessible way that respects the dignity of caregivers and patients.

b) Social Equity Program

- The Executive Director gave an update with respect to the Social Equity Program.
- The Executive Director clarified that benefits associated with the program accrue immediately upon acceptance into the program.

c) Fiscal Year 2022 (FY22) Budget

- The Executive Director gave an overview of the FY22 budget.
- The Executive Director noted that the Legislature enacted the Commission's request for the FY22 budget, and the Governor approved the request.

d) Hiring

- The Executive Director noted that this is the most staff that the Commission has ever onboarded at the same time.

9) Commission Discussion and Votes

a. Diversity Guidance

- The Chairman commended both Commissioner Stebbins and Commissioner Camargo for their leadership on the topic. He also thanked former Commissioner Title and Commissioner Flannigan, for their previous contributions regarding the topic.
- Commissioner Camargo, Licensing Specialist Tiixa Chukwuezi, Project Coordinator Rebecca Kwakye, and Commissioner Stebbins presented the Diversity Guidance.
- Commissioner Camargo thanked and acknowledged the Cannabis Advisory Board and business owners for reviewing the Diversity Guidance prior to it coming up for a vote.
- Commissioner Concepcion thanked Commissioner Camargo, Commissioner Stebbins, and the team and asked if they are any new requirements for Diversity plans beyond the new requirements that every Diversity Plan contains at least two goals.
 - Commissioner Stebbins reaffirmed that beyond requiring that every applicant submit at least two goals as a part of their Diversity Plan the guidance also provides examples of what the goals might be and urges applicants to think about diversity as applicants are building out their facility, and also submit a plan that is unique to their facilities.
 - Commissioner Camargo noted that this new guidance clarifies language that is vague in the Commission's regulations and now asks for a minimum of two goals for Diversity Plans.



- Commissioner Roy thanked Commissioner Camargo, Commissioner Stebbins, and the team for their leadership and hard work on the Diversity Guidance.
- The Chairman noted the necessity of this guidance and hopes that this new guidance will limit the need to add additional conditions on both provisional and renewals. The Chairman also commended the working group for seeking input from both internal and external stakeholders in the process of drafting this guidance.
- Commissioner Roy noted that the new metrics and measurables in the guidance will make a difference when holding various stakeholders accountable as the Commission approximates the legislative mandates to uphold diversity and equity in the industry.
- Commissioner Camargo recommended that licensees reach out with any questions or comments they may have and asked that licensees use the graph provided in the guidance to help them display their hiring process.
- Commissioner Concepcion noted that she will also use the guidance when reviewing applications and recommends that other stakeholders also review and use this guidance to guide their work.
- The Chairman suggested a motion that approves the guidance up until the reference page to limit the need for the reference page to come up for Commission vote and consideration when it is subsequently updated by staff.
- Commissioner Camargo clarified that the Diversity Guidance is separate and distinct from the reference and resources page and clarified that they will each be published on different pages of the Commission's website after approval.
- Commissioner Camargo moved to approve the Diversity Guidance.
- Commissioner Stebbins seconded the motion.
- The Chairman took a roll call vote:

b. Executive Session Minutes and Review Process

- Chairman Hoffman thanked Commissioner Stebbins, and General Counsel Baily, for their work and leadership on the topic.
- Commissioner Stebbins presented the executive session minutes and review process.
- The Chairman noted that the motion up for commission vote is whether to approve the General Counsel's recommendation on which of the seven executive session minutes should be realized, and which should continue to be withheld. He further clarified that if the motion passes the minutes recommended for release by the General Counsel will come up for Commission vote and consideration at the next public meeting.
- General Counsel Christine Baily provided further clarification on the implication of approving the motion and the proposed process.



- The Chairman provided further clarification on the process and implications of the motion.
- The Chairman asked a question regarding the number of executive sessions that have occurred in the history of the Commission.
 - General Counsel Baily noted that there have been previous executive session minutes that have been released, but for the purposes of the discussion and vote, the Commission is only looking at seven sets of executive session minutes, which have been withheld to date. General Counsel Baily clarified that the recommendation, if approved, would only result in the withholding of executive session minutes that relate to pending, or ongoing matters.
- Commissioner Stebbins moves to accept the General Counsel's recommendation regarding the release and withholding of prior executive session minutes.
- Commissioner Roy seconded the motion.
- The Chairman took a roll call vote:
 - Commissioner Camargo – Yes
 - Commissioner Concepcion – Yes
 - Commissioner Roy – Yes
 - Commissioner Stebbins – Yes
 - Chairman Hoffman – Yes
- The Commission unanimously approved the recommendation.

c. Timeline for Regulatory Review

- The Chairman gave an overview of the topic and thanked the Legal team for their leadership on the topic.
- The Executive Director gave a high-level overview of a proposed timeline.
- Commissioner Concepcion asked a clarifying question regarding the end goal stated in the timeline.
 - The Chairman noted that the timeline as of yet is arbitrary and notes that this term is anticipated to end on August 31st, 2022, and thus, has a desire to have the process done by August. The Chairman suggested thinking about things in terms of certain number of months than being tied to exact dates.
- Commissioner Concepcion clarified that in order to meet the proposed timeline, the work of a regulatory review would have to start in September 2021.
- .
 - The Chairman provided further clarification on the timeline and noted that the timeline is arbitrary, and what is currently marked as "September 2021" should be thought of as "month one" instead.
- The Chairman requested that the current conversation be limited to the process and not whether the Commission should move to embark on a regulatory review process.
- Commissioner Stebbins asked a question regarding the need to schedule additional public meetings while conducting regulatory review and promulgation.



- The Executive Director noted that historically the Commission has scheduled special meetings to discuss regulatory review but has also folded these types of discussions and votes into the regularly scheduled monthly public meetings.
- Commissioner Concepcion asked about the impact a regulatory review process would have on staff's workload.
 - The Executive Director provided an overview of staff's workload but noted that it is a sample meant to encompass staff's complete workload.
 - The Chairman noted that the scope of the proposed regulatory review process, which would inform the impact on staff, still needs to be clarified, whether it will be all-encompassing or more surgical in nature. He further clarified that he would prefer that the proposed regulatory review process be more surgical in nature. The Chairman also noted that, from his perspective, there is no distinction between "day jobs" and drafting regulations, as working on regulations is ordinary business of the agency. Therefore, all work of the agency should be managed and planned in the aggregate, rather than treating regulations as an add on.
- Commissioner Concepcion asked a clarifying question regarding the scope of the last round of regulatory review.
 - The Chairman noted that the last round of regulatory review and promulgation had a broader scope, noting that delivery was certainly one of the more difficult issues to work through. The Chairman said that he believed this round could be narrowed to fewer topics and noted some topics that he might suggest when that discussion arises.
 - The Executive Director described how a more surgical regulatory review would impact the process, in particular with respect to engaging external stakeholders.

The Commission took a two-minute break at the request of Commissioner Camargo, returning at 4:06:40.

- Commissioner Camargo asked the Chairman for clarification with respect to the process for deciding to do a regulatory review.
 - The Chairman clarified that his preference would be to discuss the process to ensure that Commissioners understand what goes into a regulatory review process. , The Chairman said that at a subsequent meeting, the Commission would vote on if and when the Commission should start another round of regulatory review process and, if so, what should be included in that. The Chairman said his aim of this initial conversation was to ensure that each Commissioner has enough information and context to have a subsequent informed discussion and requested that his fellow Commissioners let him know when they are ready to discuss further.
- Commissioner Roy stated that from her perspective, starting a regulatory review process next month would be ambitious, especially given that she is new to the Commission and requested that the Executive Director and staff provide a guidance document outlining Commissioner rolls, timelines, and deadlines for regulatory work before moving forward.



- Commissioner Stebbins thanked the staff and noted that from previous experience there comes a point when regulations mature, that feedback from different stakeholders help effectuate the efficiency of the Commission’s work. He also requested that Commissioners think about separating the regulatory changes that would be “nice to do” from what is imperative as the Commission moves forward on the topic.
- The Chairman provided further clarification on next steps.

d. Legislative and Executive Branch Outreach

- The Chairman gave an overview of the topic and thanked Commissioner Concepcion and Director of Government Affairs Matt Giancola for their leadership on the topic.
- Commissioner Concepcion and Director of Government Affairs Giancola and Policy provided a high-level overview of the proposed process for how the Commission engages with the legislative and executive branches.
- Commissioner Stebbins thanked Director of Government Affairs Giancola and Commissioner Concepcion for their leadership on the topic. He further noted that he appreciated the uniformity that this process would bring. Commissioner Stebbins added that it would be his preference, if an issue is discussed and voted on with respect to legislative outreach, it should be understood that all Commissioners would be required to stand behind that final position.
- Commissioner Camargo thanked Commissioner Concepcion and Director of Government Affairs Giancola for their leadership on the topic and echoed Commissioner Stebbins sentiment that this process brings much-needed uniformity and give the Commission one voice on legislative affairs, but also noted that this process also allows Commissioners to agree to disagree on certain topics.
- Commissioner Roy thanked Commissioner Concepcion and Director of Government Affairs Giancola for their leadership on the topic and agrees with Commissioner Camargo sentiment that there might be times where Commissioners may disagree on a topic, but this approach provides the Commission with the ability to speak with one voice when addressing the Legislature and other parts of Commonwealth government.
- The Chairman noted that a vote is not needed at this point and asked that General Counsel or the Executive Director provide further insight.
 - The Executive Director confirmed that a vote is not needed at this time.
- The Chairman also noted that although this process would give the Commission the ability to speak with one voice, it does not limit an individual’s Commissioners ability, or prerogative to speak individually, but request that when this occurs, Commissioners make it clear that they are not speaking on behalf of the Commission and make Director of Government Affairs Giancola aware of such instances as to allow him the ability be the clearinghouse on these matters.
- Commissioner Camargo asked a clarifying question regarding how the Commission plans to notify the Legislature of the new process.
 - The Executive Director clarified that the Director of Government Affairs Giancola will notify both the Legislative and Executive branches.
 - Director of Government Affairs Giancola confirmed that he will be communicating the new process.



- Commissioner Roy asked a clarifying question regarding keeping Commissioners informed on the Legislative affairs.
 - The Chairman noted that he has access to State House news.
 - The Executive Director clarified that she will be updated on State House news access.
- Commissioner Roy asked specifically keeping up with when hearings are occurring on particular legislative matters and when Commissioners are providing testimony or attending hearings, especially in light of the open meeting law.
 - Director of Government Affairs Giancola confirmed that this will be provided to Commissioner Roy going forward.
 - Commissioner Concepcion noted that Director of Government Affairs Giancola currently provides Commissioners with regular updates when it comes to legislative matters and affairs.

e. Outdated Guidance Document Recission

- The Executive Director presented on the retirement of the Guidance for Registered Marijuana Dispensaries Regarding Transportation of Marijuana Guidance.
- The Chairman asked for questions or comments.
- Chairman moved to rescind the Guidance for Registered Marijuana Dispensary Regarding Transportation of Marijuana effective February 11th, 2022. Furthermore, the Commission moves to allow Commission staff to update the current version of this guidance document on its website to include the following disclaimer: “The Commission has approved the rescission of this guidance document effective February 11th, 2022. All MTCs shall take the necessary steps to account for this rescission and ensure full compliance with Commission regulations 935 CMR 501.00 Medical – Use Marijuana by that date.”
- Commissioner Concepcion seconded the motion.
- The Chairman took a roll call vote:

BACKGROUND:

The commission adopted a Performance Management System (PMS) across the entire organization in fall of 2020. The purpose of the new PMS was to allow managers and employees to create three to four Specific Measurable Achievable Relevant Time Bound (SMART) objectives and two to three professional development goals for each team member of the commission. This first stage of the PMS was labeled as Planning and projected to take place within a January/February timeframe of each calendar year. Additional stages of the PMS are a Mid-Year review in June and a Final Review in December.

To assist with the coordination and development of the SMART objectives, it is essential for the commission to approve the goals of the Executive Director in a timeframe consistent with the PMS process. These goals can then be translated into each department's corresponding SMART objectives for management and staff. Approval of the Executive Director's goals also allows the commission to conduct a performance review of the Executive Director on a similar annual schedule.

Though I continue to work with the Chairman and an internal team to consider the current performance review process of the Executive Director, I felt it appropriate to share this background so we can set and approve dates for the presentation and approval of the Executive Director annual goals.

RECOMMENDATION:

The commission should adopt a schedule that includes the following:



- **November Commission Meeting** – Presentation and consideration of annual performance goals by the Executive Director. The Executive Director can seek input from each commission directly on his/her goals prior to his presentation. Commissioners may elect to vote on the goals if further discussion is not required.
- **December Commission Meeting** – Commission will have final approval of Executive Director goals on this meeting agenda.

Subject: Commission Consideration of Options to Extend or Reissue COVID-19 Curbside Order and the Telehealth Bulletin

In response to Governor Charles D. Baker's declaration of a state-of-emergency due to COVID-19,¹ the Executive Director took certain actions on behalf of the Commission to issue the Curbside Order and Telehealth Bulletin. The issue before the Commission is whether it should exercise its broad authority to extend these prior actions following the rescission of the Governor's declaration and in recognition of the continuing risks posed by COVID-19.² To facilitate its consideration, this memo discusses the Commission's statutory authority and potential rationales supporting these extensions, and if there is a vote, proposes motion language.

In considering whether to reissue the Curbside Order and Telehealth Bulletin, this memorandum focuses on the following options:

1. Allow Medical Marijuana Treatment Centers (MTCs) only to conduct curbside transfers for the sale of medical-use marijuana or marijuana products; and
2. Allow Certified Healthcare Providers to submit a new waiver request under 935 Code Mass Regs. § 501.850 (2), specifically, a waiver of the requirement that the provider conduct an in-person visit for the initial patient certification. 935 Code Mass Regs. § 501.002. If the waiver were granted, a provider would through telehealth establish a *bona fide* healthcare provider-patient relationship, conduct a full assessment of the patient's medical history and current medical condition(s), and explain the potential benefits and risks of medical-use marijuana. See id.

Both options will be considered in turn.

Consideration of whether the Final Administrative Order Allowing Curbside Operations, dated, June 14, 2021³ (Curbside Order), associated with the medical-use program should be extended until [a date certain⁴]. The Commission has the authority to interpret the medical-use statute, G. L. c. 94I and relevant regulations, to allow for the curbside transfer of medical-use marijuana and marijuana products to patients and caregivers.⁵ There are no provisions in c. 94I that require in-person sales. Moreover, a decision to extend this order would be consistent with its legislative mandate to promote patient access and protect patient and caregiver safety⁶ by mitigating the continuing risks posed by COVID-19.

To extend the Curbside Order, the Commission would need to interpret the order to be consistent with its existing regulations, including those pertaining to sales of medical-use marijuana and marijuana products and security of MTCs.⁷ For example, the regulations require sales to be conducted within an MTC's premises. Licensees should continue to conduct sales, including cash transactions, in accordance with the regulations. Thus, an extension of this order is legally supportable, and does not require a regulatory change.

Consideration of whether the Telehealth Bulletin on Telehealth Consultations for Patients, date June 14, 2021⁸ (Telehealth Bulletin) should be extended until [a date certain⁹]. The Commission can rely on its general waiver authority to allow a certifying healthcare provider to apply for a waiver under 935 Code Mass. Regs. § 501.850, specifically,

the regulatory requirement that the initial in-person visit be performed via telehealth.¹⁰ The provider would need to submit written documentation and the Executive Director, or his delegates, would need to make certain findings.¹¹

A waiver would maintain the *status quo* as the risks posed by the spread of COVID-19, and the professional standards regarding telehealth evolve. For one, the Massachusetts Department of Public Health (DPH) recognizes in its current face covering advisory, “in light of the Centers for Disease Control and Prevention’s updated guidance, . . . [m]asks are still mandatory . . . in healthcare facilities and in other settings hosting vulnerable populations.”¹²

¹⁰Under G. L. c. 94I, a provider must establish a “*Bona fide* healthcare professional-patient relationship,” which includes conducting a “clinical visit,” which is undefined:

“a relationship between a registered healthcare professional, acting in the usual course of his or her professional practice, and a patient in which the healthcare professional has conducted a clinical visit, completed and documented a full assessment of the patient’s medical history and current medical condition, has explained the potential benefits and risks of medical use of marijuana, and has a role in the ongoing care and treatment of the patient.”

Relatedly, under the definition of “Clinical Visit,” which was clarified in this last round of regulatory amendments, a certifying healthcare provider’s initial visit with a patient must be performed in-person:

“Clinical Visit means an in-person or telehealth visit during which a Certifying Healthcare Provider establishes a *Bona Fide* Healthcare Provider Patient Relationship and conducts a full assessment of the Patient’s medical history and current medical condition, including the Debilitating Medical Condition, and explains the potential benefits and risks of Marijuana use. A Clinical Visit for an initial Certificate of Registration shall be performed in-person.”

Thus, by allowing for a waiver of this requirement, providers may not have performed an initial in-person visit and or an in-person visit on renewal for some registered patients. In addition, since the Governor's declaration of a state-of-emergency, the Commonwealth of Massachusetts' Board of Registration in Medicine (BORIM) has recognized that the practice of medicine includes telehealth in its Policy on Telemedicine in the Commonwealth, i.e., Policy 2020-01, amended June 25, 2020:¹³

"The practice of medicine shall not require a face-to-face encounter between the physician and the patient prior to health care delivery via telemedicine. The standard of care applicable to the physician is the same whether the patient is seen in-person or through telemedicine."^{14, 15}

Relatedly, the Massachusetts Health Policy Commission has issued an interim report on the Impact of COVID-19 on the Massachusetts health care system, and identified the need for more study:

"While telehealth offers considerable opportunities for continued integration into care models after the pandemic, many questions remain about optimal usage, how to reduce disparities due to internet access and other factors, and appropriate payment models. The HPC's final report will focus on how telehealth use has changed over the course of the pandemic, disparities in telehealth access, and framing the opportunities and challenges that telehealth presents."¹⁶

While the Commission is not bound by the policy positions of other healthcare agencies, allowing waivers for the initial in-person visit would allow the Commission to recognize the continuing risks posed by COVID-19 and gather evidence as to the scope of a *bona fide* healthcare relationship and the ability of certified healthcare providers to establish that relationship via telehealth.

The FSMB noted that measures should be employed to "uphold patient safety in the absence of traditional physical examination" and that the use of telemedicine to prescribe be "in accordance with current standards of practice and consequently carry the same professional accountability as prescriptions delivered during an encounter in person."

Commission Consideration and Vote

If the Commission were to vote in favor of these extensions, I recommend that the vote recognize the prior delegation of authority to the Executive Director, and offer the following motion language:

Relying on its authority under G. L. c. 94G, § 4 (a), c. 94I, and the associated regulations, and in recognition of the continuing risks posed by COVID-19, the Commission votes to extend the availability of medical curbside operations and the telehealth waiver process. Consistent with its prior delegation of authority,¹⁷ the Commission directs the Executive Director, and his delegates, to take all necessary steps to reissue the following:

1. The Final Administrative Order Allowing Curbside Operations, which would allow Medical Marijuana Treatment Centers (MTCs) only to conduct curbside transfers for the sale of medical-use marijuana or marijuana products, to [a date certain]; and
2. The Bulletin on Telehealth Consultations for Patients, which would allow Certifying Healthcare Providers to submit a new waiver request under 935 Code Mass Regs. § 501.850 (2), specifically, a waiver of the requirement under 935 Code Mass Regs. § 501.002, that the provider conducts an in-person visit for the initial patient certification, to [a date certain].

As noted above, as an alternative to identifying a date certain, the Commission could request that the Executive Director monitor certain events, e.g., the rescission of DPH's current face covering advisory, and report back to the Commission, which would allow for greater flexibility as the status of COVID-19 evolves. If the Commission were to support this approach, the motion could be modified to include the following language – “to a date to be determined when the public health risks posed by Covid-19 are resolved so as not to pose a risk to patients and caregivers.”

The type of objects used are called Infogadgets, which include intro and summary videos with tabbed text and graphic information. To maintain engagement with the training, trainees are presented questions within several infogadgets that they must answer and receive feedback before they can move on in the training. Subject: Discussion on adding Lawrence to the current DIA list

The Massachusetts Cannabis Control Commission (Commission) has conducted two studies to “*Identify Massachusetts Communities Disproportionately Impacted by the War on Drugs*” referred to as the Disproportionate Impact (“DI”) study. The first study “*Impact of the Drug and Marijuana Arrest on Local Communities in Massachusetts*” was completed and approved in January of 2018 by Dr. Jon B. Gettman Ph.D. Associate Professor, Criminal Justice Shenandoah University, which identified 29 cities and towns as disproportionately impacted.

For the past three years, the Commission has used this study to identify cities, towns, and communities that have been disproportionately affected by cannabis prohibition - while upholding the equity mandate in the Commonwealth. Dr. Jon B. Gettman’s study concluded what the agency currently identifies as [Areas of Disproportionate Impact](#) (DIA): **See list of towns:** Abington, Amherst, Boston, Braintree, Brockton, Chelsea, Fall River, Fitchburg, Greenfield, Haverhill, Holyoke, Lowell, Lynn, Mansfield, Monson, New Bedford, North Adams, Pittsfield, Quincy, Randolph, Revere, Southbridge, Spencer, Springfield, Taunton, Walpole, Wareham, West Springfield, and Worcester.

In the 2018 study, the City of Lawrence was not designated as a DIA due to limited data. Lawrence is in the Merrimack Valley and has the highest Hispanic/Latinx population in the state ranking them at number one with 8.2% of the Commonwealth’s Hispanic/Latinx population. According to the 2019 census, Lawrence’s [Latinx population](#) represents 82% of its residents, with a median income of \$44,618, and it [ranks 9th](#) in cities that release the most inmates back into their community (top ten include, Boston, Springfield, Worcester, New Bedford, Brockton, Lynn, Fall River, Lowell, Lawrence, Haverhill).



In March of 2021, a second study labeled [*Identifying Disproportionately Impacted Areas by Drug Prohibition in Massachusetts*](#) conducted by the University of Massachusetts Donahue Institute research team was presented to the Commission. Again, the city of Lawrence was not accounted for in this new study due to “lack of data.” Similar data limitations exist within Boston; however, the agency was able to resolve these data limitations and ensure Boston’s consideration through proactive outreach to municipal officials.

Several research reports conducted by the Commission, clearly highlight Black and Hispanic individuals as the subject of overenforcement of drug policy, comments on research that notes “several components in the legal cannabis market that pose greater challenges to Black and Hispanic/Latino cohorts compared to their White counterparts,” and outlines that “Research shows that marijuana prohibition and enforcement disproportionately affects Black and Hispanic/Latino people,”

One of the most impactful uses of the DIA designation is eligibility criteria for programming that reduces the barriers to entry for communities that have been disproportionately impacted by the War on Drugs, including African American/Black and Hispanic/Latinx populations. The Social Equity Program (SEP), a technical assistance and training program that provides access to exclusive license types and reduced fees and waivers, is one of the many tools we use to deploy our equity programming. The Commission has raised awareness of the program and delivered curriculum to two cohorts of the SEP and is in process of raising awareness of Cohort Three. However, the SEP’s Hispanic/Latinx enrollment doesn’t represent the disproportionate impact that the War on Drugs has had on this community. While the Commonwealth’s Hispanic/Latinx community represents 12% of the state’s population, only 11% of Cohort One’s population identified as Hispanic/Latinx, with a modest increase in Cohort Two with 20% of the enrollment identifying as Hispanic/Latinx. Considering the impact of the War on Drugs on Hispanic/Latinx and African American/Black communities, we must ensure that our equity programming significantly outpaces the Commonwealth’s demographics for these disproportionately harmed communities.

In comparison, the extended outreach to Boston has proven critical in ensuring that many of Massachusetts’ largest African American/Black communities (e.g., Mattapan, Roxbury, Dorchester, etc.) are represented in the Commission’s DIA list. As a result, the agency’s community outreach efforts have enabled appropriately high participation from the African American/Black community, with 37% of Cohort One participants identifying as African American/Black and 40% of Cohort Two participants identifying as African American/Black, despite representing approximately 7% of the state’s population.

Lawrence's omission from the DIA list and the absence of intentional municipal outreach to resolve the noted data limitations has left a significant eligibility gap in the Commonwealth's largest Hispanic/Latinx community. The eligibility gap in Lawrence risks widening inequalities in the legal cannabis industry and participation in our Social Equity Program for the Hispanic/Latinx community.

In conclusion, the City of Lawrence has been excluded but the Commission can promote greater participation from Hispanic/Latinx communities by expanding the DIA list to 30 municipalities with the inclusion of Lawrence.

The inclusion and impact of Lawrence residents goes beyond eligibility for our Social Equity Program, it would also benefit Positive Impact Plans and Diversity Plans and fill the eligibility gap for a community that is critical to our mission. The Commission must take this brave and bold step in repairing the damage done to individuals and a community most impacted.

Commission Updates

- Medical Sales now in Open Data
 - MTCs have conducted **\$583M** in sales to Registered Qualifying Patients and Caregivers over past 2 years. This data includes 2020 sales of **\$270M** and 2021 year-to-date sales of **\$205M**.
 - As noted earlier, there are 83 operating MTCs in the Commonwealth, along with 10 MTCs that currently possess final licenses and 43 that have been granted and currently possess provisional licenses from the Commission.

 - Application deadline extended until November 15th.

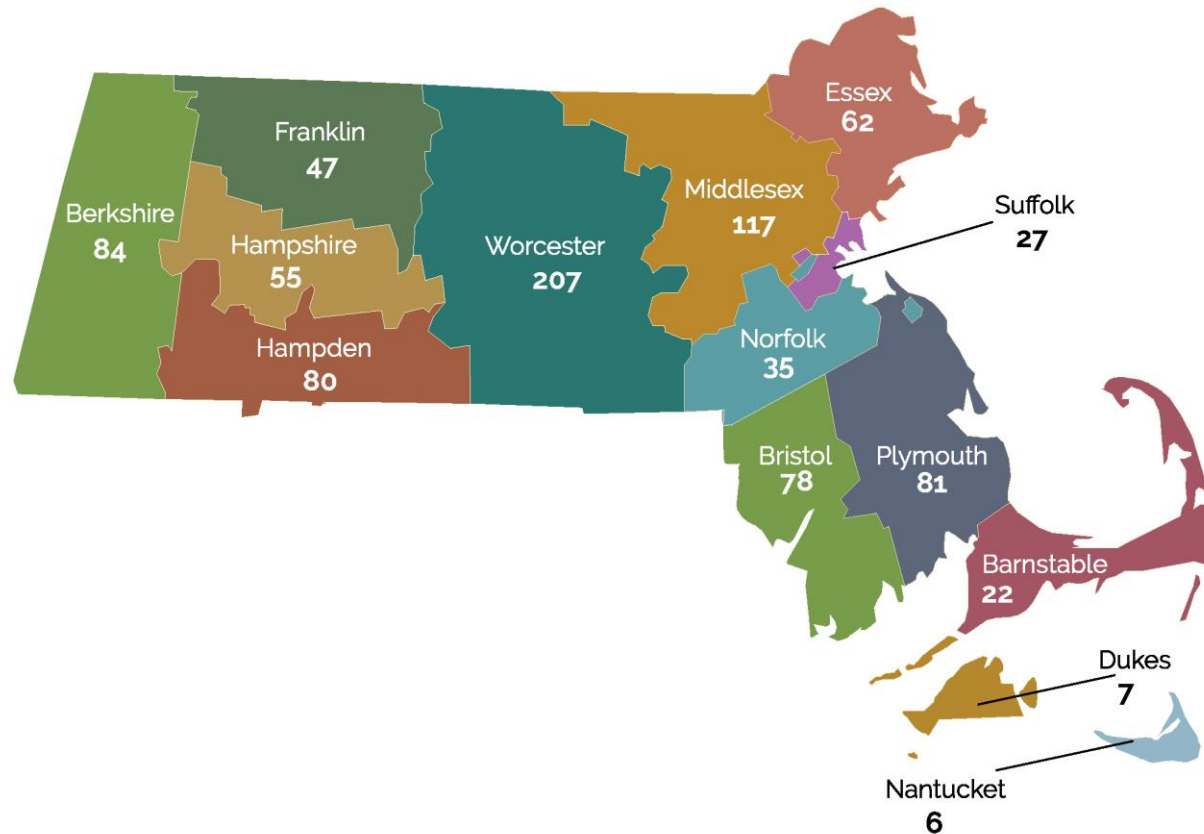

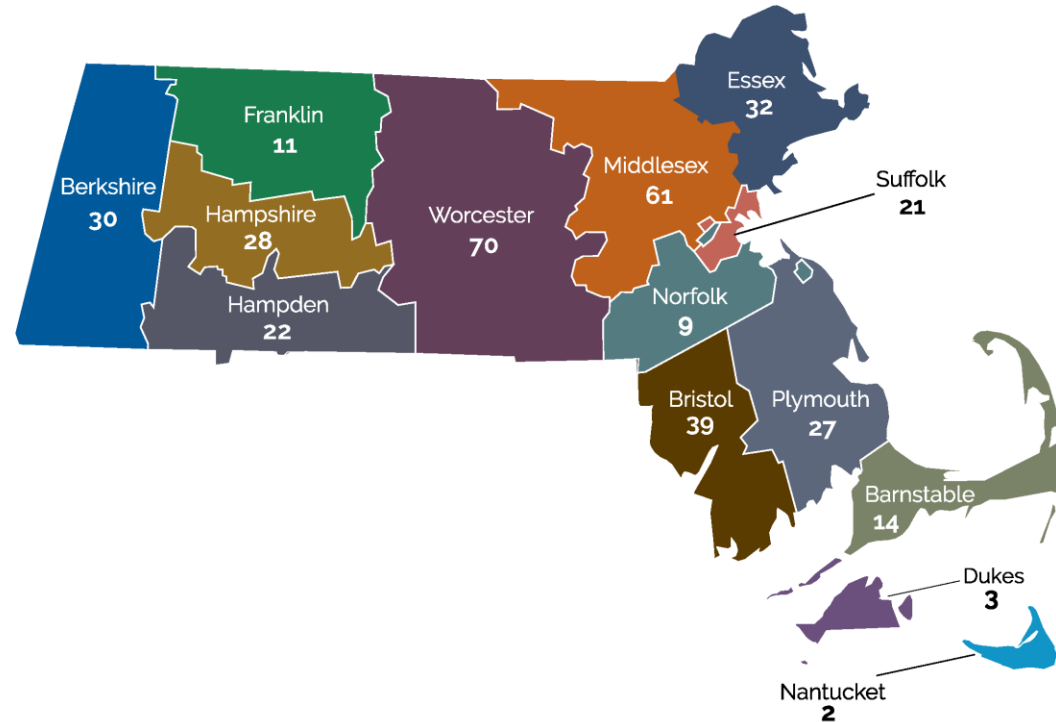

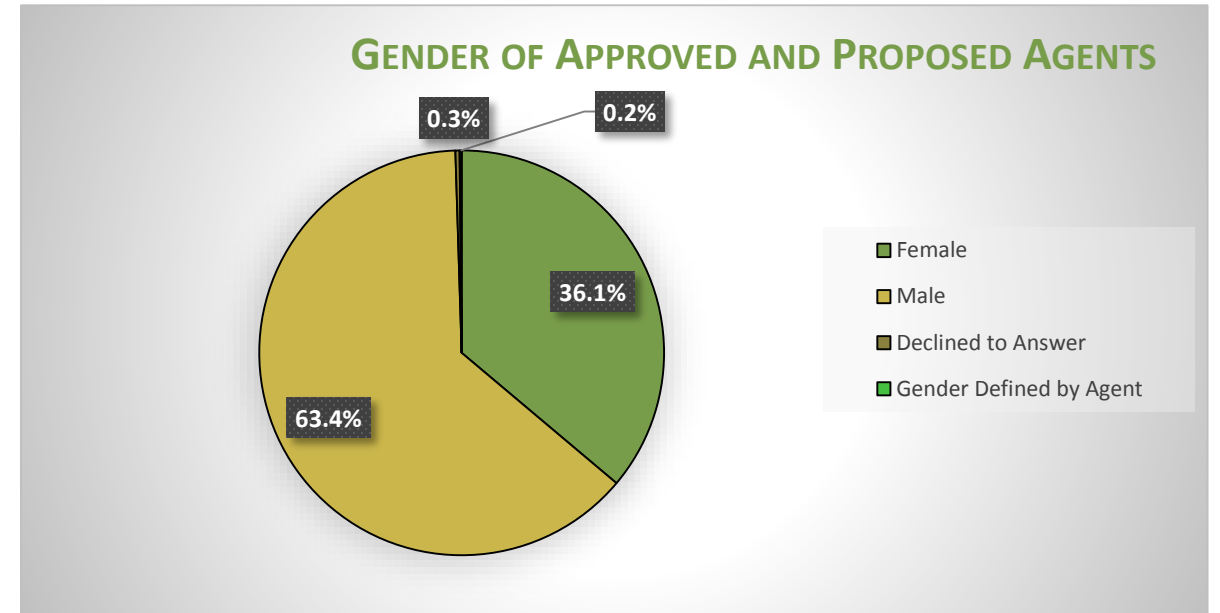

Demographics of Approved and Pending Marijuana Establishment Agents

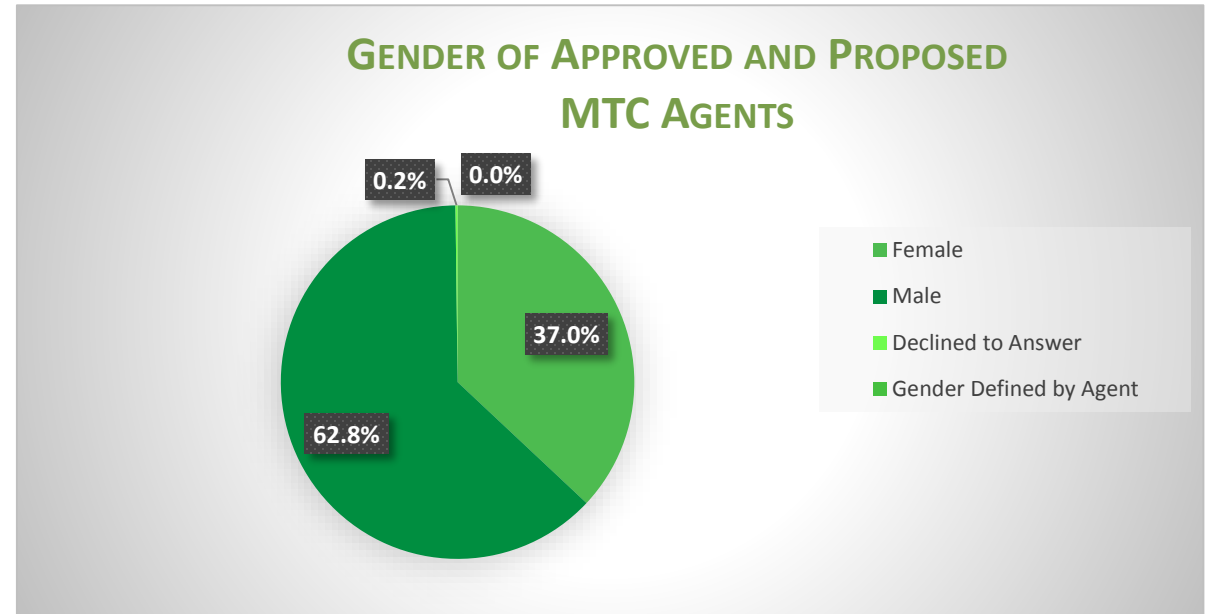

Demographics of Approved and Pending Medical Marijuana Treatment Center Agents

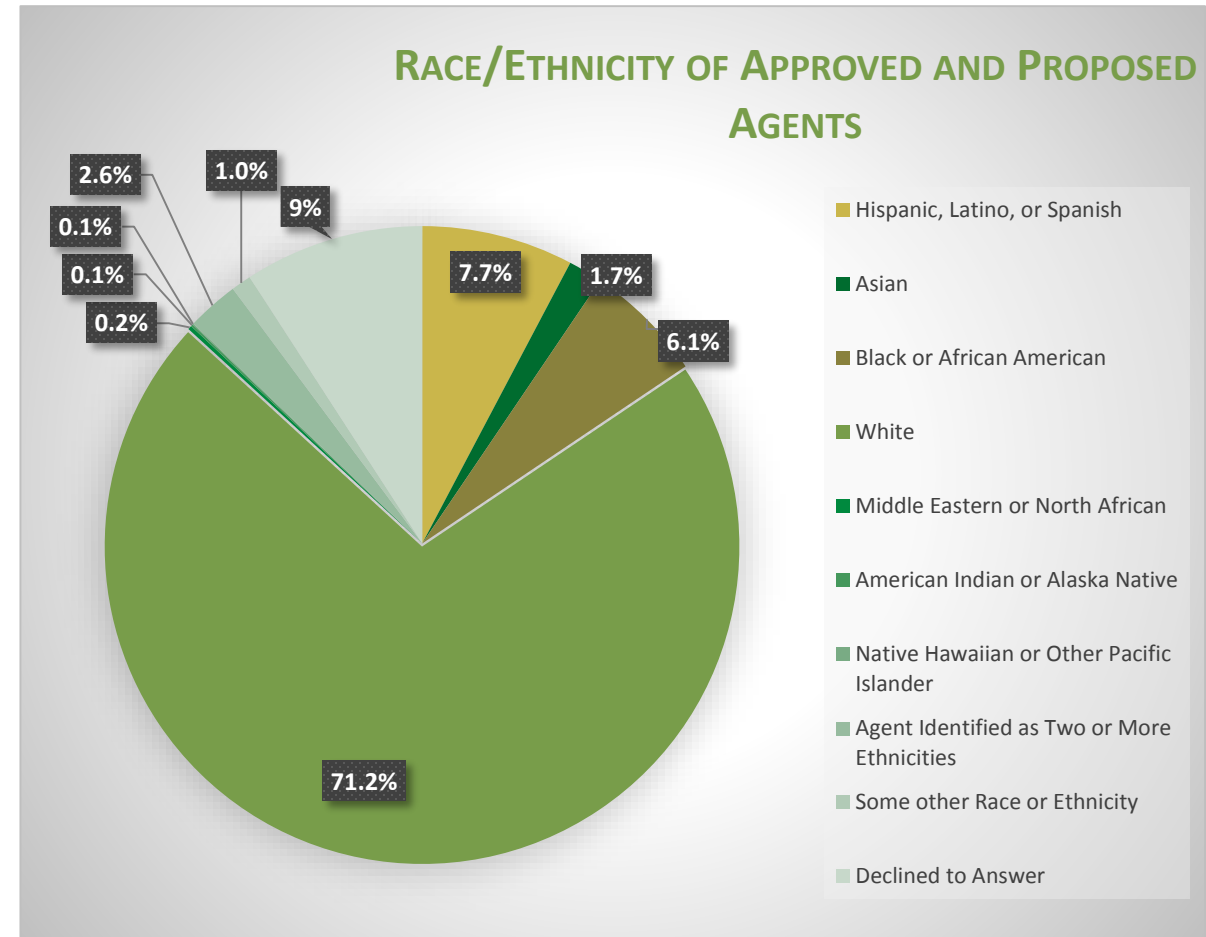

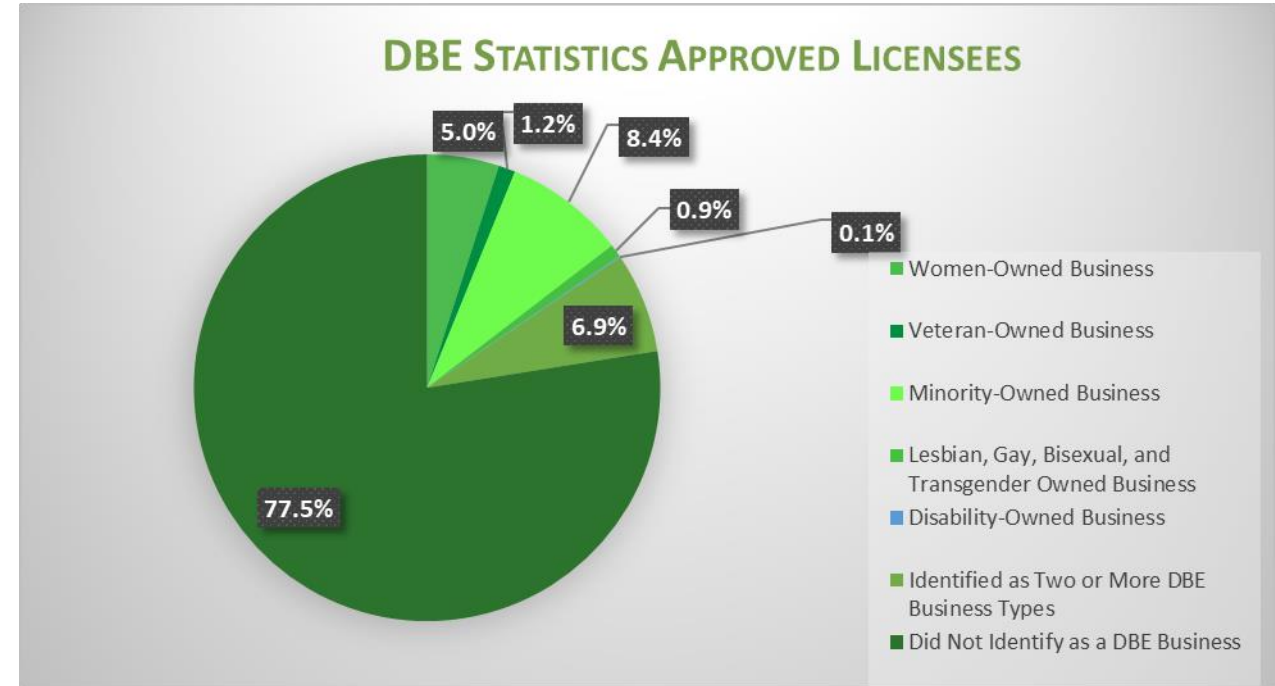

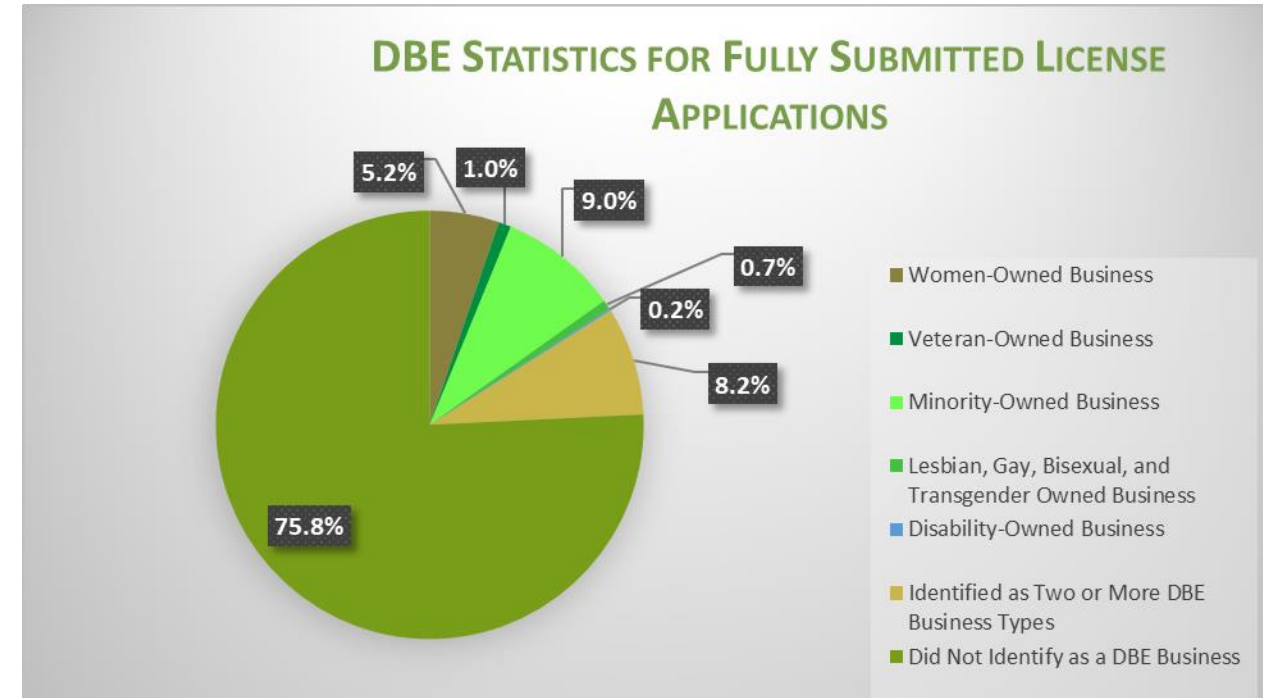
