Minutes:

- 1) Call to Order
 - The Chair recognized a quorum and called the meeting to order.
 - The Chair gave notice that the meeting is being recorded.
 - The Chair gave an overview of the agenda.
- 2) Chair's Comments and Updates 00:02:13
 - Commissioner Stebbins thanked the Commission staff for their work related to helping prep for the Public Meeting. He also thanked the Legislature for their work on passing Bill S.3096, An Act Relative to Equity in The Cannabis Industry, prior to the end of the legislative session. He also thanked the Commission's staff and stakeholders for their work related to the passage of the Bill.
 - Commissioner Roy thanked the Commission staff for their work related to helping to ensure a safe, secure, and equitable cannabis industry in the Commonwealth. She also specifically thanked her fellow Commissioners, the Executive Director, Director of Government Affairs and Policy, Matt Giancola, and Manager of Government Affairs Policy, Ernesto Reyes Hernandez, for their work related to the passage of Bill S.3096. She also thanked the leadership in the Massachusetts State House and Senate, the Baker Administration, and the Joint Committee on Cannabis Policy for meeting with the Commission throughout the process. She highlighted the work of the Cannabis Advisory Board Research Subcommittee, which she serves as a liaison, thanked Dr. Marion McNabb for her work and leadership, and noted the critical role that Independent Testing Labs play in the industry.
 - Commissioner Camargo echoed her fellow Commissioner's comments and thanked the Commission's Licensing staff for their work related to reviewing licensing applications and materials before the public meeting. She referenced the updated Diversity Guidance and noted her pressure to see licensees are using it and incorporating it into their plans for provisional license applications. She also thanked the Licensing Department's renewal team for their work reviewing renewals, especially concerning the Positive Impact Plans and Diversity plans. She also thanked the Massachusetts State House and Senate, past and present Commissioners,



- community advocates, and stakeholders for their work related to the passage of Bill S.3096. She noted the Commission's Legislative outreach process, which improved teamwork and coordination with the Legislature. She also noted the Commission's work related to the Governance project, highlighted the work being undertaken and noted her excitement for the process of building a strategy that would outlast the current Commissioner's tenure at the Commission.
- Commissioner Concepcion noted that for the first time since the creation of the Commission in 2017, the Legislature had passed major cannabis reform and emphasized the significance and magnitude of the passage. She noted that the Commission is the only agency in the Commonwealth mandated to address the harms caused by the War on Drugs and pointed out that each month the Commission's decisions impact thousands of people. She thanked her fellow Commissioners for voting to approve the Legislative Outreach strategy she spearheaded. She noted the work that still needs to be done to address issues in the industry but noted that the passage of Bill S.3096 is still a massive step forward. She also noted the work of the Diversity Equity and Inclusion, Access and Equity group and their work related to the Disproportionate Area Study and noted her participation in the 6th Annual Meeting for the Research Society on Marijuana (RSMj) around identifying areas that were most impacted by Cannabis Prohibition and enforcement and noted the industry's positive impact on those areas through the Positive Impact Plans and Diversity Plans.
- The Chair noted that Britney Grinder was arrested for carrying .7 grams of cannabis oil in her luggage and was sentenced to 9.5 years in a Russian penal colony and noted that this highlights the inequities around cannabis policy in the international and national realms. She also thanked the Massachusetts Legislature for the passage of Bill S.3096 and noted that the Legislation ensured that social equity remains an integral part of the industry in the Commonwealth and noted the work that the Commission has already begun to do and the work that remained ongoing to implement the Bill.

 - Commissioner Camargo moved pursuant to M.G.L. c. 10 § 76 (J) and M.G.L. c. 94G § 6 (a) to delegate to the Executive Director the Commission's authority to extend a license expiration date administratively up to 120 calendar days. During an administrative extension, the licensee shall continue to comply with the Commission's requirements for licensure and will also be required to pay a prorated license fee to cover the extension.
 - Commissioner Roy seconded the motion.

4. Executive Session Minutes and Review Process

- General Counsel Christine Baily gave an update and overview on the topic.
- Commissioner Stebbins thanked General Counsel Christine Baily (General Counsel Baily) for her work and leadership on the topic. He noted the additional Executive Sessions since the recommendation was submitted to Commissioners; he pointed out that those would be covered at the following bi-annual Executive Session Minutes and Review Process. He also acknowledged that as Commission Secretary, he would review the minutes for the executive sessions recommended for release to ensure accuracy before the Commission votes at the September public meeting.

5. Executive Upcoming Public Meeting Topics

- Commissioner Stebbins and the Chair gave an update and overview on the topic.
- Commissioner Roy thanked Commissioner Stebbins for his work and leadership on
 the topic and noted that she saw agenda items falling into two buckets: the routine
 business that happens every year and discussions and votes on unique agenda items.
 She stated that she believed the routine items should adopt the proposed process but
 noted a need for further discussion regarding adopting the proposed process for
 unique agenda items.
 - Commissioner Stebbins agreed with the description, noted how the process worked during his time at the Massachusetts Gaming Commission, and



- explained how the process would allow Commissioners and the public to look ahead of what was being presented in future public meetings.
- Commissioner Concepcion thanked Commissioner Stebbins for his work and leadership on the topic and noted that the proposed process recommended that a Commissioner works with the Executive Director and the Chair to formulate a final presentation and asked why it was not framed as a requirement.
 - Ocommissioner Stebbins noted the need for the process to be informative and nimble to accommodate topics that suddenly became a priority. He explained that the recommendation would allow Commissioners to work with the Executive Director and the Chair to present at upcoming Commission public meetings while allowing other commissioners to be informed on upcoming topics.
 - Commissioner Camargo thanked Commissioner Stebbins for his work and leadership on the matter, asked if there was a timeline for when Commissioners should be expecting the calendars for upcoming topics, and provided an explanation on why she was asking the question.
- Commissioner Camargo thanked Commissioner Stebbins for his work and leadership on the matter and asked if there was a timeline for when Commissioners should be expecting the calendars for upcoming topics and provided an explanation on why she was asking the question.
 - Commissioner Stebbins provided further clarity on how the process allowed two ways for Commissioners to place topics on upcoming public meetings agendas, noted that Commissioners would have the opportunity to discuss upcoming topics at Commission Public Meetings, and noted that the process would allow for feedback from the Executive Director and key staff people.
- Commissioner Camargo asked if additional language should be adopted in the proposed process to explain how topics being worked on will be communicated to Commissioners and the timeline related to when the calendar will be disseminated to commissioners.
 - Commissioner Stebbins clarified that upcoming topics or calendar items would be discussed at public meetings and that Commissioners would have the opportunity to discuss agenda items with the Chair and the Executive Director.
 - o Commissioner Camargo asked for language to be included in the process that clarified the ways that topics could be discussed amongst Commissioners.
- Commissioner Roy asked where the calendar would be found and disseminated to Commissioners.
 - Commissioner Stebbins noted that his original intent was that the calendar would be part of the Commission public meeting agenda and available in the public meeting packet and noted that the Chair recommended that the Commission work with the Communications department to figure out where it would live in the Commission's website to allow the public to understand what will be discussed at upcoming Commission meetings.



- The Chair asked the Executive Director to weigh in on the ability of the Commission to make the calendar of upcoming topics on the website.
 - The Executive Director noted that it was feasible to make the schedule of upcoming meeting topics available on the Commission's website but noted the static nature of the calendar and work needed to not allow for the schedule to become stale and the need for a disclaimer that the schedule is not an official calendar and subject to change.
 - o The Chair noted her agreement with the Executive Director's comments.
- Commissioner Concepcion noted that she liked the process for topics discussed every year but noted her want to understand the utility of the process further as it relates to unique topics that Commissioners would like to discuss.
 - Commissioner Stebbins echoed Commissioners Roy comments related to topics falling into two buckets and provided an example of how the process would work.
- Commissioner Stebbins noted that he would work with the Chair to further refine the process and adopt language proposed by Commissioner Camargo.
