• The Chairman noted that renewal applications are treated as a roster, unless requested for individual treatment by a Commissioner. There will be four rosters: (1) All Adult-Use licenses, except for two from which Commissioner Title has recused herself; (2) Adult-Use licenses from which Commissioner Title has requested to recuse herself; (3) All Medical-Use licenses, except for one, from which Commission Title has recused herself; (4) Medical-Use license for which Commissioner Title has requested to recuse herself.



First Roster

- Commissioner Flanagan requested two universal conditions for all adult use licenses.
 - Proposed conditions:
 - Within 90 days of the removal of the State of Emergency declaration all adult use licensees must notify the Cannabis Control Commission of updated actions taken on the Plans to Positively Impact Disproportionately Harmed People.
 - Within 90 days of the removal of the State of Emergency declaration all adult use licensees must notify the Cannabis Control Commission of updated actions taken on the Diversity Plans.
 - The Chairman confirmed with Commissioner Flanagan that the conditions were worded correctly.
- Commissioner McBride moved to approve the roster of adult use licenses, subject to the conditions requested by Commissioner Flanagan.
- Commissioner Title seconded the motion.
- The Commission unanimously approved the roster, subject to the conditions requested by Commissioner Flanagan.

Second Roster.

- Commissioner McBride moved to approve the Temescal Wellness renewal applications, subject to the conditions requested by Commissioner Flanagan.
- Commissioner Flanagan seconded the motion.
- The Commission approved the renewals by a vote of three in favor (Flanagan, Hoffman, McBride) and one recusal (Commissioner Title), subject to the conditions requested by Commissioner Flanagan.

11) Commission Discussion and Votes

• The Chairman gave an overview of the topics for discussion and votes.

a. Regulatory Policy Discussion: Receivership

- The Chairman gave an overview of the topic to date.
- General Counsel Baily led the discussion on funding of receivership.
 - Commissioner McBride asked with respect to the bond requirement, which is the amount equal to the licensing fee, whether that was enough. It was the intent of that requirement to cover a receiver type scenario. Commissioner McBride said that she does not think there needs to be a separate funds set aside but asked whether the bond requirement needs to be increased.



- The General Counsel suggested that regulations could be drafted that would allow the Executive Director would have the authority to assess the scenario as they develop to determine whether it is appropriate to set aside additional funds.
- o Commissioner McBride agreed that the Executive Director would be involved in the proceedings.
- The Executive Director echoed this and noted that that much of these types of proceedings would be unique and nature and so would require a flexible approach.
- Commissioner Title clarified that the requirement that additional funds be set aside would be on a case by case basis, rather than a blanket requirement. Commissioner Title also asked when that determination would be made.
- The General Counsel clarified that the original bond/escrow may be used as an initial matter, but as the work of the receiver develops, there may be a court determination, perhaps subject to the Executive Director's suggestion of the appropriate set aside.
- o Commissioner McBride agreed that receiver will be in communication with the court and it makes sense that the Executive Director take cues from the receiver and court.
- Commissioner Title moved to give the Executive Director to authority and discretion to approve
 or extend the use of the bond/escrow requirements to cover the cost of a receivership or other
 judicial proceeding on a case by case basis.
- Commissioner Flanagan seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner Flanagan moved to authorize the Executive Director to require or authorize the use of additional funds, on top of the Bond requirement, to cover the cost of receivership or other judicial proceedings on a case by case basis.
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner Flanagan moved that the Commission shall require a request from the receiver or a court order to authorize use of funds set aside prior to expending such funds.
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- The General Counsel discussed the Executive Director's authority to seek a receivership or other judicial appointee to address issues of health, safety and welfare.
- Commissioner McBride suggested that the Commission spell out how this authority will be used and what information and what the standard is for commencing such an action.
- Commissioner Title agreed with Commissioner McBride. Documenting what situations would be important, but in other parts of the regulations the word "danger" rather than "threat" to the public health, safety, or welfare.
- The Chairman suggested that when the Commission wants to initiate receivership, there could be a Commission decision, rather than the Executive Director.
 - o Commissioner Flanagan asked whether the Commission would determine whether there was a threat to public health safety or welfare?



- The Chairman clarified that in such an instance, the ED would come before the Commission to present his case and have the Commission vote to approve that action.
- o Commissioner McBride asked if the authority currently delegated is sufficient to address certain concerns until the Commission could vote.
- The Executive Director said that all the tools would be used in concert, not just one by one.
 Also, with respect to the petition, the court would have to approve it, so it could not be done frivolously.
- Commissioner McBride moved to authorize the Executive Director the authority to petition the court for a receivership or other judicial proceeding if there is an immediate threat or danger to the public health, safety, or welfare.
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- The General Counsel gave an overview of the topic of Executive Director pre-approval of certain changes pursuant to the oversight of a judicial appointee. Commission would not be ceding final authority.
- The Chairman expressed strongly that the Commission cannot cede authority over the changes in ownership and control over license and is uncomfortable delegating this authority, noting the Commission's ability to call emergency meetings.
- Commissioner McBride asked for clarification on what would be a minor change compared to the major change.
 - The General Counsel said that items that would otherwise be delegated to the Executive Director in the ordinary course would be minor, and items that would require Commission approval in the ordinary course would be a major decision.
 - o The Chairman said transfer of property is one thing, but the transfer of ownership or license should stay with the Commission.
 - Commissioner McBride said she agrees with the Chairman. Perhaps in emergency situations, the disposal or transfer of Marijuana and Marijuana products, the Executive Director can act, but circumstances need to be narrowed and for other items otherwise authority should remain with the Commission.
 - o The General Counsel provided thoughts on ability of Executive Director to make approvals on an emergency basis except in those areas determined by the Commission.
 - o Commissioner Title asked for clarification around the use of "preapproval"
 - o The General Counsel suggested removal of the preapproval concept.
- The General Counsel gave an overview of the topic of approval of minor changes.
- The Chairman noted that he wants transfer of ownership or licenses should stay at the Commission level.
- Commissioner Title moved to grant the Executive Director authority and discretion to approve minor changes, and changes that need to be made on an emergency basis, provided that the Commission retain the authority over changes it would decide in the ordinary course.
- Commissioner Flanagan seconded the motion.



- The Commission unanimously approved the motion.
- Commissioner McBride asked about when notice of the judicial proceedings would be required and suggested that there is a credible threat or the filing of a petition, to give the Commission as much notice as possible.
- b. Regulatory Policy Discussion: Delivery Tiering, Repackaging and Reprocessing 3:53:00
- The Chairman gave an overview of a proposed process dealing with the potential development of an expanded delivery license type, including an additional comment period above and beyond what is required by law.
- Commissioners generally expressed support for this process.
- Commissioner McBride gave an overview of the concept of tiering and compliance.
- The Chairman noted the policy purpose of tiering for cultivation and its impact on the cost to the commission of ensuring compliance and in this case, that concept does not seem to apply. The Chairman did note that allowing a delivery licensee that is purchasing at wholesale to repackage or process products would create a heightened compliance cost for the Commission.
- Commissioner Title noted that one benefit of tiering is that it gives an indication of the size of the business and whether such a licensee would be a "small business" or not, which municipalities, consumers and other stakeholders may want to know. Commissioner Title wondered if there was a way to indicate whether a delivery licensee was a small business.
- Commissioner Flanagan agreed with Commissioner Title that it may be helpful to understand the seize of the business but indicated that it is more important to not over complicate the process.
- The Chairman asked whether collecting business size data would satisfy Commissioner Title's concern.
 - Commissioner Title indicated it would differentiate size of the business and how they were treated.
- The Executive Director indicated that there would have to be some thought as to how to collect that data, and working with the Research Department, but noted that the exclusivity period is intended to be based on Commission findings, so data will have to be collected for that purpose.
- Commission Title asked whether the Commission tracks wholesale pricing between Marijuana Establishments.
 - The Executive Director said that it is collected, but not for every transaction, but only
 when between separate businesses, but is not currently tracked within a vertically
 integrated business. There is worked to capture that information industry wide through
 Metrc.
- The Chairman indicated his support for a license type that allows for purchase at wholesale and white labeling, but not allowing for repackaging and reprocessing.
- Commissioner McBride expressed her support in this business model.
- Commissioner Title indicated her preference to allow Repackaging as defined in the draft regulations. Commissioner Title indicated her preference to allow Repackaging for delivery licenses if it is allowed by retail licensees.



- Commissioner Flanagan indicated that she is more comfortable with white labeling than repackaging.
- Commissioner McBride indicated that from her perspective, allowing Repackaging creates compliance concerns, so white labeling is a middle ground.
- The Executive Director noted the security implications under the regulations with respect to Repackaging, including conducting such activities in sight of a security camera.
- The Chairman asked whether there is difference in compliance cost for a retailer on Repackaging or a delivery wholesaler licensee Repackaging.
 - O The Executive Director indicated that it may depend, and if the repackaging is happening in the licensees' warehouse, it should cost the same, but would increase costs in terms of having more facilities to monitor. It also creates intricacies with respect to tracking product through Metrc.
- Commissioner Title expressed her belief that for the sake of equity and balancing out the lack of
 diversity in the industry, delivery licensees should be able to Repackage, to put them on equal
 footing with retails.
- Commissioner McBride moved that wholesale delivery license regulations be drafted to allow for white labeling, but not repackaging or reprocessing.
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner Title that there may be different definitions of white labeling and wanted to clarify that it would say both the name of the delivery business as well as the origin.
- Commissioner McBride read allowed a proposed definition of white labeling.
- Commissioner Title stated preemptively that the Commission may get comment with respect to caps on the business revenue or quantities, and that she strongly opposes those types of caps.
- Commissioner McBride agreed that there may be a need to make sure there are no large players dominating or manipulating the market, so to the extent that becomes an issue, it may need be applied to delivery.
- 12) New Business the Chair Did Not Anticipate at the Time of Posting There were no last-minute items.



 - The Chairman gave notice that the meeting is being recorded.
- 2) Chairman's Comments and Updates 0:39
 - The Chairman gave an overview of the meeting agenda and the overall regulations process.
 - The Chairman acknowledged the need for additional public comment and today's process for Commissioners to make motions on the regulations prior to final approval.
 - The Chairman thanked Commissioner McBride for her leadership on the complex issues surrounding delivery.
- 3) Commission Discussion and Votes 4:53
 - The Chairman deferred to Commissioner McBride to present the topic.
 - Commissioner McBride thanked the Writing Team for their help in preparing the draft.



a. Draft Regulations: Delivery

- Commissioner McBride gave an overview of all of the proposed changes in the drafts circulated, creating new types of delivery licenses, license fees and noting that she would make additional motions in order to further amend that language.
- Commissioner Title clarified that holding a delivery license does not preclude folks from holding a retail license as well.
- Commissioner McBride moved that the definition of Marijuana Wholesale Delivery License as it appears in the draft of 935 CMR 500.002 be amended by inserting after the word "Consumers" the words: "but shall not operate a storefront under this license."
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner McBride moved that the definition of White Labeling as it appears in the draft of 935 CMR 500.002 be amended by inserting after the words "comply with" the following words: 935 CMR 500.105(5): "Labeling of Marijuana and Marijuana Products, 935 CMR 500.105(6): Packaging of Marijuana and Marijuana Products,"
- Commissioner Flanagan seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner McBride moved that 935 CMR 500.105(5)(a)(10) be amended by striking out the final two words, "Delivery Agreement" and inserting in place thereof the following words: "Wholesale Agreement."
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner McBride moved that 935 CMR 500.105(5)(b)(18) be amended by striking out the final two words, "Delivery Agreement" and inserting in place thereof the following words: "Wholesale Agreement."
- Commissioner Flanagan seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner McBride moved that subsection (5) of 935 CMR 500.145 be amended by striking out clause (a) in its entirety and replacing it with the following clause: "A Wholesale Delivery Licensee shall require any Consumer making a purchase for delivery to have the valid government-issued identification card a Consumer intends to use to verify her or his age at the time of delivery examined and authenticated by the Wholesale Delivery Licensee prior to the first Individual Order."
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner McBride moved to amend sub-section 935 CMR 500.146(7) by adding at the end of sub-clause (b) the following sentence: "A Licensee shall obtain the written authorization of the Commission prior to commencing White Labeling." And further, that sub-section (7) be amended by adding a new sub-clause as follows: "(c) The Wholesale Delivery Licensee may submit the



label to be used for White Labeling to the Commission in accordance with 935 CMR 500.105(7): *Packaging and Labeling Preapproval.*"

- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner McBride moved that 935 CMR 500.101(3)(h): Additional Specific Requirements be amended in subclause 5. by striking reference to subclause (g) and inserting in place thereof subclause (h).
- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner Title said she thinks the names of the licenses may be confusing, recommending the wholesale license be "delivery operator license" and for "limited delivery license" to "courier."
- Commissioner McBride said she thinks the names are clear as is.
- Commissioner Flanagan agreed.
- Commissioner Title cited municipalities as confused about the activities of a "wholesaler," when that delivery license is doing retail sales.
- Commissioner McBride indicated that, because this is being treated as a separate license from retail, the Commission has to be careful in not confusing that distinction through naming the license.
- Commissioner Title moved to change the title of the "Delivery Wholesale License" to "Delivery Operator License."
- Commissioner Flanagan seconded the motion.
- The Commission voted two in favor and two apposed, therefore the motion does not carry.
- Commissioner Title noted that this could create confusion for municipalities.
- The Chairman clarified the use of the verb "wholesale" that tends to mean that a business is selling to a retailer. But using the phrase "purchase at wholesale" is the activity the retailer takes when purchasing products from a supplier.
- Commissioner Title moved to modify the definition to replace the verb "wholesale" to "purchase at wholesale."
- Commissioner McBride seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner Title moved to insert into 935 CMR 500.050(1(b) the language "no person having direct or indirect control in a Marijuana Retail License or shall obtain or be granted more than a combined total of three marijuana retail licenses and/or delivery wholesale licenses."
- Commissioner McBride seconded the motion.
- The Commission unanimously approved the motion.
- Commissioner Title asked, with, with respect to Additional Requirements for Delivery Applicants, why the Commission asks for information and documentation relating to agreements with third-party platforms, rather than asking for the agreements themselves.



- Commissioner McBride indicated that agreements may not be executed at that point in the process and deferred to Director Potvin for his perspective.
- Director Potvin indicated that the concern was disclosure, so he was comfortable with agreements and some form of disclosure.
- Commissioner McBride reiterated the concern that applicants may not be prepared with agreements at the time of a provisional license, and we may not want to stop the application process before they are able to enter into an agreement.
- Commissioner Title said she would like to see agreements as soon as they are available, including during precertification.
- Director Potvin clarified that, as currently drafted, delivery precertification applicants do not need to submit any third-party platform agreements. Those agreements are required to be submitted as part of the provisional license phase. The rationale for that is that it is rare to have those agreements in place early in the process.
- Commissioner Title moved to amending 935 CMR 500.101(3)(c)(h)(3) to read: "As part of a provisional license application, information and documentation regarding any agreements, and agreements if applicable, with Third-Party Technology Platforms pursuant to 935 CMR 500.145(1)(d) and (e)."
- Commissioner McBride seconded the motion.
- The Commission approved the motion by a vote of three in favor (McBride, Hoffman, Title) and one against (Flanagan).
- Commissioner Title noted that in the adult-use regulations, it includes language that "topicals and ointments shall not be subject to a limitation on daily sales for adult-use." A patient mentioned during public comment, that the regulations do not limit topicals and ointments for adult but do for medical.
- The Executive Director said his suspicion said that this is part of the 60-day supply requirements in medical, which is tracked, and every purchase must be counted against that supply limit. In adult, however, there is not a same 60-day supply limitation.
- Commissioner Title noted she was raising this for the record in order to be explored as part of future regulatory review.
- Commissioner Title asked about the requirements regarding the equipment and software obligations to avoid manipulation of sales data.
- Commissioner McBride indicated this was part of previous delivery-only regulations and was being carried over.
- Commissioner Title registered her discomfort with respect to White Labeling, which she was unable to articulate at the previous meeting. The concern is an identical product is going to be produced by a cultivator or product manufacture, but sold, potentially with different branding or a different price, by various retailers. Commissioner Title wanted to raise as matter for public comment.
- Commissioner McBride moved to approve the draft regulations, subject to modifications approved by the Commission.



- Commissioner Title seconded the motion.
- The Commission unanimously approved the motion.


